Zambia has recorded 119 new cases of COVID-19 and five deaths in the last 24 hours, bringing the country's cumulative total to 6.347

Meanwhile, Mulalelo has insisted that people should avoid weddings, funerals and drinking places to lower the risk of infection.

Speaking during the daily COVID-19 briefing in Lusaka, Sunday, Mulalelo said 40 patients were currently on oxygen support.

"The 119 cases are in Lusaka and cases include: 76 cases identified through healthcare facility screening in Lusaka, 23 contacts to known positive cases in Lusaka, 13 individuals identified routine community screening in Lusaka, three health care workers screened in Lusaka and four BIDs in Lusaka. Amongst the active cases, we have 40 patients on oxygen support, five of whom are in the ICU. Today we have discharged 363 persons, this brings the cumulative recoveries to 4,493 since the beginning of the outbreak," Mulalelo said.

Matero PF bans Kaziya from speaking to the media, as Kamba warns Kapeso

finally resolved.

Meanwhile, PF provincial secretary for Lusaka Kennedy Kamba says Deputy Inspector General of Police Bonny Kapeso is maliciously dragging the ruling party into an aggravated robbery case involving its Eastern Province chairman Emmanuel Banda, popularly known as Jay Jay.

Speaking at a press briefing in Lusaka, Wednesday, Kabole announced that both Kaziya and Chinyanta should not speak to the media until their ongoing quarrel over illegal land allocations in the constituency was resolved.

"Over the issues, which have transpired in Matero, as a constituency, we took up steps. We wrote to the Honourable MP and the councillor to exculpate themselves against what was going on in the press. And about that, we are waiting for the seven days from which we are going to act. We even advised the MP and the councillor that they are not supposed to speak to the media until this issue is resolved. And that is why, as a judge, because it's us, the constituency, that are going to make a decision, we are just waiting for the seven days to elapse, that is when we are going to make a decision. Both the MP and the councillor are not supposed to talk to the media. In fact, we don't allow the people to speak to the media. We have got systems of speaking to the media," Kabole said.

He said the concerns raised by Kaziya were internal and that the ruling party had channels of airing out grievances rather than resort to using the media.

"The issues which the MP is raising are internal matters and the party has got structures in which all the issues can be conveyed. We don't go to the press. We have got channels. This is a very well established party where we have got a system of doing things. All we are appealing to the MP is that if he has got any other information, he

should use the constituency and we will be able to take this information to the higher authority or take action. So, I am appealing to Honourable Kaziya that we are still waiting for his exculpatory letter. We have already received the exculpatory letter from the councillor and as a party. It's from this that we will be able to make a decision," Kabole said.

Meanwhile, speaking at the same briefing, Kamba urged Kapeso to stop dragging the PF into the aggravated robbery case involving Jay Jay when the suspect should be investigated as an individual.

'We take strong exception to the remarks made by the Deputy Inspector General of Police Bonny Kapeso, who is seemingly dragging the ruling party, the PF, in the case involving Eastern Province Youth chairperson Emmanuel Jay Banda, popularly known as Jay Jay. The Deputy Inspector General of Police Bonny Kapeso featured on a Radio Programme at UNZA Radio where he said PF members know where Jay Jay, who is facing aggravated robberyrelated cases, was hiding. We strongly feel Mr Kapeso is maliciously dragging the PF, as a ruling party in the alleged misconduct of individuals, who must personally face the law if found wanting rather than dragging the entire party into the misdeeds of a few individuals," Kamba said.

He insisted that Jay Jay's criminal conduct did not have the ruling party's blessings.

"It is not so long ago that we had a meeting with the police command where we assured them that the PF was not above the law or reproach. We assured the police of utmost respect in the discharge of their duties and that no PF supporter, member or leader was expected to undermine the police or police officers. The cases facing 'Jay Jay' or any of the PF members, who were accused of raiding the Lusaka Central Police Station, had no blessings of the party and Mr Kapeso knows this very well. If one or two members of the PF have crossed paths with the law, the police must deal with those individuals without dragging the party into such matters," Kamba said.

And he warned Kapeso not to force party members to demonstrate against some officers, who he said had been "working against the ruling party."

"To demonstrate how we respect the law and police officers as a party, President Lungu on Saturday during the Central Committee meeting directed Home Affairs Minister Stephen Kampyongo to make sure 'Jay Jay' was brought to book to face the law. Why, then, should Mr Kapeso turn to the PF and its general membership and say, 'we know where Jay Jay is hiding?' Such comments are sheer slander and malicious against the PF! Mr Kapeso should not force us to demonstrate against some police officers whom we know are working against the PF! Jay Jay or any other person, who has issues with the police have no backing of the party and will not be shielded. The police should deal with the matter without involving the PF. The PF is a distinguished party headed by a distinguished man, President Edgar Lungu, who respects the law and the custodians of it," said Kamba.

UPND Spokesperson Charles Kakoma says the ruling Patriotic Front (PF) will be badly defeated in the 2021 elections because it will not have the resources to bribe every voter like it has at the moment.

And Kakoma says his party is happy with its performance in the just ended local government by-elections in Western, North Western in Luapula Provinces, because it gave PF a good run for its "stolen money".

Meanwhile, Kakoma has lamented that UPND leader Hakainde Hichilema is technically on house arrest, giving him no option but to use social media to connect with the voters.

In an interview, Kakoma said it did not matter that PF won 10 out of the 15 ward by-elections because the most important thing was that the UPND had begun penetrating the ruling party strongholds and registering good numbers of votes.

"We are happy that we performed very well because the PF thought that they would sweep all the local government by-elections. But we won in Chavuma central ward and we lost one in Kasempa and we won another one in Mufumbwe. So in that stronghold in North-Western Province, we actually beat the PF pants down. In Western Province, they were targeting Mongu and Limulunga ward, we also beat them. You will recall that in the past in Mongu, it has been a problem because the PF has been winning those ward elections which they have been inducing. But this time around, they've not had it that easy. So they must be very embarrassed, especially looking at how much effort they put in and the amount of money they spent. The relief food meant for disasters which they took

there, but they still lost. This shows that if they can even still lose by-elections while they are still in power, then in the general elections, they will be wiped out," Kakoma

"For us, even in the PF strongholds like Chiengi, we are very proud of our performance there because the numbers are really very interesting. Those are difficult places where we could even get zero votes from a polling station. But now we are even getting more than 500 votes from one ward, so that is encouraging for us. So we are happy about our performance and only the PF should be worried about their performance. For us, we would therefore like to congratulate ourselves and thank all our people that campaigned and took part in the elections, they did a very commendable job under very difficult circumstances."

And Kakoma said UPND was not worried about the way it performed in the byelections because it gave PF a good run for its "stolen money".

"We are not worried. The fact is that we have given PF a good run for their stolen money. They thought they would have it easy and get everything but they failed lamentably. I think next time they will think twice before buying any more councilors because they will not have it easy. They've seen that it's not easy, and basically, they are just cheating themselves because they can't base their popularity on winning ward by-elections. By-elections are very deceiving because the whole system descends on a ward; ministers, Permanent Secretaries, DCs... all of them using government resources, like using DMMU and the relief food which is meant for relief food for campaigns, that is serious abuse of national resources. So even if they think they've won now, they cannot be celebrating such a win and in a general election, some of those things will be impossible to implement. Where will they find the mealie-meal

to give to everyone in a general election? So they will be walloped very badly. With us, we have no access to relief food but we still win elections, meaning that we have a better formula for winning the elections than

themselves," Kakoma said.

Meanwhile, commenting on concerns by some UPND followers on social media that the party was not reaching out to the electorate in the remotest areas, Kakoma said UPND was using all the

necessary channels to reach out to the people.

He said it was difficult for Hichilema to physically reach out to the people because the police would arrest him.

Behavioural change an effective social vaccine for COVID-19 - UNZA Don

BEHAVIOURAL change is the effective social vaccine for COVID-19, says University of Zambia founding Dean for Centre Health System, Metrics and Evaluation in the school of Public Health, Professor Charles Michelo.

And Professor Michelo says the fact that cases are increasing shows that as a country, there is something that we are not doing right.

Meanwhile, Ministry of Health Assistant Director for Health Promotion Dr Kalangwa Kalangwa says 80 percent of people who test positive for COVID-19 show only mild or no symptoms at all, but warns that people should not treat the virus as a

The two were speaking when they featured on Diamond TV's Night Live program, Friday, with the topic "COVID-19 and Health".

program The sponsored by News Diggers and Open Society Initiative for Southern Africa (OSISA).

Professor Michelo urged Zambians to embrace behavioural change, saying the fact that cases were increasing showed that as a country, there was something that we were not doing right.

"It is not easy to between differentiate common flu and COVID-19] especially in a time and period like now when you have an outbreak. One way in which we are able to tell is by testing. The fact that the cases keep going up means there is something we are not doing well. And we should be asking ourselves 'what is it we are not doing well in the response'? It maybe that there's something we are not doing well now but it also means there is something we did not do well before at the time that we got exposed. What this is telling us is that there is community transmission going on," said Prof Michelo.

'The vaccine that we have been talking about will take time. But we have something in our hands. Let's describe this as a social vaccine, behavioural change."

And Dr Kalangwa called on Zambians to up their game and sustain the COVID-19 preventive measures, saying the battle was not yet over.

He said 80 percent of people who tested positive for COVID-19 showed only mild or no symptoms at all, but warned that people should not treat the virus as a hoax.

"When we started with the response, we had good adherence to the public health measures. [But] there is a time when people started feeling that this COVID-19 is a hoax, it doesn't exist and we saw relaxation in terms of people observing measures; masking, social distancing and handwashing. People have lowered their guard, but we are saying the battle is not yet over. This is the time people need to up their game. People have been asking that 'how come in the beginning we had few cases'? We had few cases because people were doing very well. As soon as they lowered their guard we [have] seen cases going up. We are saying that this is the time when people need to sustain the preventive measures," Dr Kalangwa said.

"In terms of COVID-19, over 80 percent of the people who actually get the infection tend to have mild or no symptoms. So when we say someone has gotten COVID-19, people should not expect the worst outcome

from everyone. If you look at the number of people who tend to actually get serious complications, we have people who are in the risk groups, the eldery and people with underlying conditions. So if someone hears that their neighbour has COVID-19 and they were not admitted or had serious complications, that should not be taken as the disease not being serious. So the stages of the infection will differ in different individuals."

Dr Kalangwa explained that COVID-19 was a respiratory virus which spread through droplets produced when someone was sneezing, coughing or talking. "The

virus

[coronavirus] is a respiratory virus. Meaning that it spreads via droplets which are produced when someone is sneezing, coughing or talking. If someone coughs or sneezes and is within a short distance next to another person [and] if they (droplets) land in someone's eyes, nose or mouth and they inhale, they are able to get it. The other way is, if someone coughs into their hands, for example and then shakes [another person's] hands, while shaking hands if you touch your mouth, nose or eyes, you are able to get the virus," he said.

And on the notion that the virus could be transmitted through the air, Dr Kalangwa maintained that COVID-19 was transmitted through droplets.

"From recent studies which were conducted and the guidance, is that the transmission is droplet based. So the virus in terms of the weight is not able to go beyond a metre. So in terms of transmission, when you say it's airborne, for example TB, it means if someone coughs from this end, it can spread on a larger area. But for COVID-19, it's droplet based. That's why we are saying people should observe social distancing of one metre," said Dr Kalangwa.

Lungu's govt an Animal Farm - Kambwili

NATIONAL Democratic (NDC) Congress leader Chishimba Kambwili says President Edgar Lungu's decision to fire David Mabumba is proof that government is being run like Animal Farm.

In an interview, Kambwili noted that other ministers were not punished for anything.

"It's Animal Farm, that's what is happening. I have been saying it and the inconsistencies have continued. On mere allegation, I was fired. Kabanshi, on mere allegation, she was fired. Chitalu Chilufya, not fired. Chitotela, not fired. Mabumba, fired. Lawrence Sichalwe, on a similar case of pornography, not fired. So it's Animal Farm, who you know, who you eat with, that's the order of the day and it is very, very unfortunate. I think people need to be treated fairly," said Kambwili.

Mabumba had appeared in an obscene video that went viral last Tuesday in which he was seen fondling with his private parts during what appeared to be a WhatsApp video call with an unknown

OVER 200 contractors have threatened to take the law into their own hands and confiscate whatever assets they can to recover the US \$18 million owed to them by Mabiza Resources, operators of Munali Nickel Mine in Southern Province.

The contractors say they have finally arrived at this decision because they have exhausted almost all the formal avenues, including the courts, but still nothing fruitful has come out of it.

But Consolidated Nickel Mines (CNM) chief executive officer Anton Mauve has stressed that he is doing everything possible for the company to dismantle the outstanding debt, explaining that the huge stock of arrears was as a result of reckless management, who allowed the mine to access supplies on

In an interview, suppliers' representative Andy Mtonga, who was flanked by Richard Mwenya and Brian Chanda, appealed to government to take over the mine, similar to Konkola Copper Mine (KCM) if the current owners had failed to run it.

"We can assure you if government is interested in this and not even the government, the President (Edgar Lungu) or the (Mines) Minister (Richard Musukwa) takes supervision of that mine, they will pay. If government took supervision, the way they did with KCM, we will see how things will turn around. There won't even be a week that will go by, all of us will be paid. So, it's better if government takes over, that's all. We are doing business with KCM and things have changed at KCM, we know that they are struggling, but they are paying, they are on current. If they delay, it's

90 days, but they are paying," Mtonga said.

"After we had the meeting in March, they said, 'in May they will start paying, they will clear most of the debt...' Today is July and they have not paid even one cent! So, we have decided, we have been to the Ministry of Mines and nothing has come out of it so we decided to write to the British High Commissioner (Nicolas Woolley), we did that last week, and we have heard nothing from them. We also sent that copy to the Ministry of Mines, we heard nothing from them. So, yesterday, we sent a letter to the PF secretary general (Davies Mwila) because the next thing, now, is we are going there and we are going to grab what we have to grab! We are going to close down that business! So, we don't want to be seen to be working against government, no. We want this to come to an end and the only way it's going to come to an end is government intervention or we take things into our own hands!"

He alleged that the Mazabuka-based mine was generating sufficient revenues

amid high Nickel prices on the London Metal Exchange (LME), which had leaped to US \$13,716 per tonne from over US \$11,055 by March 31, this year.

"The actual price of Nickel on the LME is twice the price of copper. So, we can see on a minimum, every month, they are making US \$5.4 million, this is a worst-case scenario. There is no way the mine can be producing one truck a day, they do more! And the problem is that they are not banking in the country so government can't see what they are making because they are banking in the UK or whatever and they only talk about bringing US \$500,000 to pay salaries and stuff like that when we know for a fact that why are making more than US \$5 million," argued Mtonga.

"So, now, you see the situation that these guys have been, like he said, from January, 2019, we financed the mine until they started selling; their first truck left the mine in May, 2019, the moment they started selling the concentrates in May, they started kicking out all those, who had invoices building up and they started slowly phasing out and they are now dealing with new suppliers. So, every time there is a rift between the supplier and them, they fail to pay, they don't engage the supplier, they look for an alternative supplier and continue. So, that supplier is kicked out and the money is not paid and that's the situation. We understand it's their business decision to change suppliers, fine, but then, those that have done the business should be paid."

In a letter addressed to Mauve, the contractors gave him an ultimatum of five days to respond to their concerns or risk having the aggrieved contractors use their own means to recover their funds from the mine.

"Our position for a long time we have listened to your updates and endured your arrogance, crookedness and silence. You have been given an opportunity to redeem yourself using amicable means, Mr Mauve, but you have chosen otherwise. You have your strategy, and we have ours. The suppliers have resolved as follows: We will obtain our funds by

formal or informal means! It is our money. We are almost exhausting all formal avenues, sending an official letter to you is also one of the steps. Though it is the most preferred approach, please note that our success is not dependent on your response. We are not settling for anything other than 100 per cent settlement for each supplier. We are not interested in creating opportunities for further engagements with your team. You have proved to be very unreliable with the opportunity you have been given. In the settlement of our debt, all suppliers shall be treated equally without discrimination," read the letter

in part. "Mr Mauve, we have given your office an ultimatum of five working days from tomorrow, Friday July 31, 2020, to respond to this letter after which date, all doors for potential negotiation will be closed! At that point, we will take it upon ourselves to recover the funds. Your response to this letter should be officially signed and in writing. You will utilise the below stated e-mail address

and contacts. Yours faithfully, Disgruntled Mabiza Suppliers Committee (Zambia)."

But when contacted for a comment, Mauve bemoaned the poor manner in which the operation was managed during the time the debt was accrued, and disclosed that new management, in collaboration with him, had come up with a plan to ensure that the debt was restructured and dismantled as quickly as possible.

He explained that the company was prioritising the recovery of the suppliers' cash and a plan to have the funds paid was likely to be approved unanimously by the board with only three members left to vote on the plan.

"...And so, obviously, the plan needs to be funded and that is where you are basically asking the investors to dig deep and put some more money in the restructure plan for debt. But it looks like that is being accepted by the board. It hasn't been resolved yet, but it does look bright. I am on a call again this (Thursday) afternoon, I'm on a call every single day to try and get these guys over the line, and I have agreed and three of my other directors have agreed, but we need three more to have a unanimous position and then that will trigger the mechanics of the plan we put together. That is, we will give all the press the details of the plan, but firstly, we have to put the details to the owners of the money, they have to decide if they accept that plan or not and so the expectation is that this should be done within the next couple of days and most of the groundwork has been done to make sure that the plan is sound. It can be well-communicated and it is something that the mine can afford and that meets suppliers' expectations," said Mauve in a separate interview.

"I have been here since November, last year, trying to rectify some very poor management that occurred since the restart, which was in December, 2018. It is irresponsible of the previous management to have got as much debt as that. What you are basically doing is you are taking supply of certain goods in credit then stretching that credit to ridiculous levels, and a mine this size, if we look at our cash flow model, shouldn't carry more than US \$8 million. And so, when you have a debt of US \$18 million that the previous management didn't even realise they had accrued, it's unforgivable and we've been very harsh with those guys! I can only sympathise with the suppliers and through people like you (the media), make it very clear that we are actually committed until we are forced to close because we simply cannot meet expectations or until we are super successful and able to very rapidly pay it all off."

I wasn't in Kafue during kidnapping incident, Kaizer's co-defendant tells court By Zondiwe Mbewe

I WAS not in Kafue, but in Mkushi, Central Province on the day when the kidnapping and assault incident allegedly took place, Kaizer Zulu's

friend and acquaintance Mpange Kachingwe, has told the Lusaka High Court.

Kachingwe states that he was out of Lusaka Province from September 5 to 8, 2019, attending to a business transaction in Mkushi District and, therefore, was not privy to whatever transpired in

In this matter, four Lusaka men: Bernard Nshindo, Sengelwayo Jere, Saul Masikoti and Mason Mweemba sued President Edgar Lungu's former special assistant for political affairs Kaizer Zulu and his two acquaintances; Kachingwe and Raffiq Rashid in September, last year, for allegedly beating and kidnapping them on accusations that they were taking pictures of Zulu's speed boat at Chita Lodge, in Kafue.

Others sued are Chita Lodge Limited and Bella Mwanza, an employee of the said lodge.

However, in their defence, Chita Lodge and Mwanza denied being aware of the alleged assault on the plaintiffs, nor participating

They argued that Zulu and his two acquaintances were admitted into the premises as visiting guests, and that if at all the assault took place, which is denied, they acted in their individual capacities as

And in his defence filed in the Lusaka High Court, July 30, 2020, Kachingwe denied

the kidnapping and assault allegations, stating that he was out of Lusaka on the said day when the incident allegedly took place.

He stated that he was in Mkushi on September 7, 2019, inspecting mining projects the-then Mkushi District Commissioner Luka Mwamba.

Kachingwe, however, admitted to the Court that Zulu was his friend and acquaintance.

"The second defendant (Kachingwe) will that he was out of Lusaka Province from September 4 to 8, 2019, attending to a business transaction in Mkushi Province. The second defendant will further aver that on September 7, 2019, he was in the company of then Mkushi District Commissioner Luka Mwamba in Mkushi where they inspected mining projects and only returned on September 8, 2019," he stated.

Kachingwe, who represented by Dickson Jere and Associates, further stated that he could not make any comment on what happened in Kafue on the material day as he was not at the said place and, therefore, not privy to whatever transpired.

"The second defendant denies each and every allegation put forth in the statement of claim as if the same was traversed seriatim," he stated.

In their statement of

claim, the four plaintiffs claimed that while at Chita Lodge in Kafue on September 7, 2019, they were approached by Zulu, Kachingwe, Rashid, Mwanza and other unknown acquaintances, who accused them of taking pictures of

Zulu's speed boat.

They stated that they denied taking any such pictures, but offered to delete all personal pictures taken on the phones, while at Chita Lodge to satisfy the demands of Zulu and his acquaintances.

The plaintiffs stated that at this point, Zulu, Kachingwe and Rashid, while armed with pistols, immediately proceeded to begin to physically assault the second plaintiff, Jere, leading to Masikoti and Mweemba attempting to drive out of Chita Lodge's establishment.

They claimed that it was Mwanza, an employee of the lodge, who ordered security guards of Chita Lodge to close all exits at the establishment leading to the apprehension and unlawful detention of Masikoti and Mweemba.

The plaintiffs added that this was after a car chase characterised by gun shots fired by Zulu, Kachingwe and Rashid.

They claimed that Zulu in particular fired several shots in the air and from time to time pointed his pistol at their heads with the threats of killing them on an allegation that they were assassins sent to kill him.

"I THINK our approach is to use all protocols or means of communicating; those that we can manage to communicate with on social media, fine, and the message is going and it is having an impact. Obviously some people want to see HH physically in the areas that they are concerned about, but time for that will come for now I think what is doing is enough ground work, he's talking to the people somehow. At the moment we are battling with things like COVID-19 situation. You know HH is the most popular politician in Zambia and wherever he goes, he will draw crowds. You can imagine if HH appeared in Zambezi district today, the whole town will come to a standstill, how are we going to manage such a situation under this COVID? The other thing is that we have this funny piece of legislation called the Public Order Act (POA) which the police are abusing. Technically speaking, HH is under house arrest, if he comes out to go to a particular place, the police will descend on him. So we are finding other ways of beating them at their own game; there are so many HH's but for them they are just looking at one HH, but there are so many other HH's that are on the ground and meeting people."

COVID-19 and Tobacco Linkages with Chileshe G.Mange



COVID-19 and Tobacco Linkages

N OUR previous article we introduced the Tobacco Products and Nicotine Products Control Bill 2018 (the "Tobacco Control Bill"), a domestication and codification of the World Health Organisation Framework Convention on Tobacco Control ("WHO FCTC") to which Zambia became a signatory in May of 2008.

The article highlighted the burden that tobacco consumption imposes on health systems and local economies. According to the Ministry of Health (2018), tobacco related illnesses and deaths cost the Zambian economy approximately ZMW 2.8 billion, which equates to 1.2 % of the GDP. The Ministry of Health has further reported that there are over 7, 000 tobacco related deaths yearly with youths and adolescents being the most at risk. The number of tobacco related deaths in 2020 is expected to reach 7,312. In addition, tobacco appears to be the most labour-intensive agricultural crop and a conduit for child labour.

The Centre for Trade Policy and Development (CTPD) holds the view that the Tobacco Control Bill in its current form is comprehensive and addresses diverse issues under one statute- including taxation; prevention of illicit trade; licensing; strategies to curb/prevent tobacco consumption; mechanisms to remedy harmful effects of tobacco exposure.

This week's article makes a further case for the Tobacco Control Bill in light of the COVID 19 pandemic with a focus on the Zambian context.

COVID 19 and tobacco consumption
The pandemic has once again shed light
on the fundamental importance of health
to development, the global economy and
every other aspect of human life, including
social interactions. Since the outbreak of
COVID-19, the Secretariat of the WHO FCTC
has intensified its efforts to support parties
(countries) to the convention that are willing
to work, to the extent possible, in creating
a healthier environment for their citizens by
implementing the WHO FCTC or the country
specific domestications thereof.

Tobacco use kills more than 8 million people globally every year and negatively

impacts the lung health of countless others. While the science of COVID-19 is evolving, the limited evidence available shows that smoking worsens outcomes for COVID-19 patients. And while the media has reported on research examining the relationship between tobacco use and the risk of contracting COVID 19, those studies are of variable quality and do not support a solid definitive conclusion.

It has been observed that COVID-19 fatalities are higher among people with pre-existing conditions including noncommunicable diseases (NCDs) such as cardiovascular and chronic respiratory conditions, cancer, and diabetes. Tobacco use is the main common risk factor linked to all of these diseases.

South Africa, which has the highest incidence of COVID 19 infections and fatalities in the Southern African region took a sweeping stance by banning all cigarette sales earlier this year in an effort to contain and prevent the spread of COVID 19. Although, the tobacco industry has since pushed back through legal action, the South African government has stood its ground, which is commendable especially when one considers the combined effect of COVID 19 and tobacco related illnesses on the health system and overall economy.

Tobacco Industry Interference

Another concern that has emerged with the COVID 19 pandemic is the increased interference by the tobacco industry in policy matters. The tobacco industry, as it has been stated in many high-level political fora, has an irreconcilable conflict of interest with public health.

Article 5.3 of the WHO FCTC and its implementation guidelines requiremember states to protect public health from the vested commercial interests of the tobacco industry and of those who work to further those interests. The tobacco industry appears to once again be taking advantage of the vulnerable situation of many member states under the guise of philanthropy or corporate social responsibility through donations of money, personal protective equipment, ventilators and other resources, in an effort to make the industry look good and enhance its reputation. Here in Zambia specific tobacco companies have made donations of COVID 19 preventive materials and equipment towards

the fight against the pandemic.

While it is recognized that governments may face a moral dilemma in these challenging times as there is an urgent need to save as many lives as possible with limited resources and capacity, the fact remains that tobacco companies have a clear record of working against public health interests.

The paradox is glaring - thetobacco industry produces and aggressively markets an addictive product that kills up to half of its users and increases the incidence of NCDs which worsen outcomes of COVID-19 patients, and at the same time offers help to the government through meagre donations. The risk is that by claiming to provide support to governments during the pandemic, tobacco companies have an opening to then pressurize or interfere with the efforts of the governmentto strengthen tobacco control.

Considering the lives that have been lost both here in Zambia (over 154) and globally (679,000), as well as the implications on trade and financial markets there has never been a more appropriate time to support and protect, to the extent possible, the advances made in tobacco control including passing relevant legislation. The Tobacco Control Bill specifically addresses measure to prevent the tobacco industry from interfering in tobacco control policies by minimizing interaction with state actors and other policy makers.

CTPD therefore, remains steadfast in its support and advocacy for the Tobacco Control Bill to eventually be passed into legislation. In the meantime the government is encouraged to strictly implement smoke-free environments; ban on all forms of tobacco advertising, promotion and sponsorship; and increasing taxes and prices on tobacco products which have been defined by WHO as very cost-effective measures to prevent and control NCDs. Furthermore, tobacco taxation increases revenues for governments (therefore addressing the issue of resource constraints), avoids future health-care costs and eases the burden on health-care systems.

MINISTRY of Health permanent secretary in charge of administration Kakulubelwa Mulalelo says Dr Chitalu Chilufya's corruption case has not affected the fight against COVID-19 in any way.

And Mulalelo says donations from corporations and well wishers had slowed down because there were no daily COVID-19 updates, not because of fears of misappropriation.

Meanwhile, Mulalelo has insisted that delays in the release of COVID-19 results is as a result of shortages of reagents.

Mulalelo, who struggled to categorically determine whether or not Dr Chilufya's corruption case had negatively affected the COVID-19 fight, was speaking when she appeared before the Budget Committee in Lusaka, Thursday.

The committee is currently scrutinising the K15.1 billion supplementary budget unveiled by Finance Minister Dr Bwalya Ng'andu last Wednesday.

Mulalelo was responding to Chairman of the Committee, who is also Mbala PF member of parliament Mwalimu Simfukwe, who asked if Dr Chilufya's court case had any impact on the Ministry's fight against COVID-19 following her earlier revelation that donations towards tackling the virus had reduced.

"PS, you have mentioned that donations have reduced. obviously, there are reasons behind that. But we have been receiving a lot of concern from members of the public as a Committee and it has been a shared concern in this Committee that you have your commander, your general of the COVID war, attending court sessions. The top leader of the campaign against COVID has got matters, now, you are saying the donations have dried up. Would you reassure us, PS, as controlling officer that the fact that the very hard working Minister has been brought before

court on matters some of which appear to connect to financial aspects has not affected the battle against COVID now that the top leader of this campaign has to attend to court and also has to command the troops against the COVID battle? Please assure the Committee and the nation that the court matters has not affected the campaign against COVID," Simfukwe asked.

In her response, Mulalelo observed that the reduced donations were as a result of the reduced daily updates where most donations were made.

"Honourable chair, we have systems that are in place, we have a command centre under Zambia National Public Health Institute that runs with the response. When I made reference to donations reducing, you may have observed that there was a period within which updates were not being given out and most of the donations that we were receiving were as a result of various corporate entities that were making donations through the updates. Ever since we resumed the updates, our corporate entities have been coming forward and the various donations have been announced and mostly in the form of sanitizers and PPEs," Mulalelo replied.

But Simfukwe, who was not satisfied with the response, repeated his question on whether the struggle to contain COVID-19 had been affected by Dr Chitalu's corruption case in

"Has the battle against COVID-19 been affected by your top leader, the Minister of Health's matters with the courts?" he asked.

After a brief, uncomfortable silence and what seemingly sounded like a technical glitch, Mulalelo insisted that the Ministry remained committed to upholding good governance.

"Honourable chair, as a Ministry, we are committed to uphold good governance in the response towards COVID and....," she replied, before being cut off by another technical glitch.

"Honourable chair, I did state that we have the Zambia National Public Health Institute that is responsible..."

After a failed second attempt

to address his main concern, Simfukwe stressed on the need for Mulalelo to categorically reply and provide clarity to the nation on the state of the country's health systems.

"Honourable PS, I know that the Honourable Minister is the political head of the campaign against COVID, but you have technocrats like yourself everywhere, we are aware of that. What I am asking is: has his court matters, some of which appear to link to financial matters, have those slowed down the COVID campaign or affected the COVID campaign in any way? If not, the nation would like to be assured that everything remains the same and the campaign is in full throttle, there is no problem, that's all we want to know and we want to reassure the country. Your campaign against COVID, has it been affected positively or negatively by the fact that the Minister of Health is undergoing a court process and with matters that are connected with resources. Please just give us the situation as it is at the Ministry of Health, and we are reading reports in the media that the health system

has collapsed! So, when you have a chance like now when the whole country is watching, it's a chance to reassure the nation that everything is okay or not," emphasised Simfukwe.

And in response, Mulalelo said Dr Chilufya was not affected by his ongoing corruption case as they were unrelated to the Ministry, but again failed to provide a categorical response as to whether or not it had affected government's COVID-19 response.

response.

"Honourable chair, thank you very much. Like I said, the Ministry of Health is committed towards good governance, and the Honourable Minister is not affected in any way by the matters that are in court as they are not related to the Ministry of Health. And in response towards the COVID fight, it's being handled under a multisectoral approach and is going as expected," she argued.

Meanwhile, Mulalelo highlighted the cost of testing kits as she outlined the need for adequate resources to effectively support the COVID-19 relief efforts.

"Honourable chair, I will

give just some indicative costs of some of the items that we use in the process. For example, one swab costs approximately US \$4 together with the transport medium. One test kit costs between US \$20 to US \$30 and for that test to be done, we need to extract, and an extraction kit consisting of 250 extractions costs about K48,000. So, on those costs, I have not added that cost, for example, of the platforms that are required for us to process the testing. Those platforms, including the reagents, the laboratory reagents, those have not been costed that's why you see that this whole process requires adequate resources in order to

"The PPEs (Personal Protective Equipment) that we distributed are those that we received following donations from various corporate entities, those are the ones that we gave

to the various MPs to assist us in terms of distribution across the country. Honourable members, I am sure you have noticed that the number of donations have reduced from our corporate entities, hence the reason why they also suspended distribution through the various constituencies. When the donations do improve, we will also be in a position to support the constituencies in terms of giving them additional PPEs for distribution," she said.

Meanwhile, Mulalelo reported to the Committee that the average time for one to get results was three to four days and that delays were only caused by lack of testing reagents.

"The average lead time is three to four days. We have received reports of it taking much longer and we are looking into expediting the process of processing the tests. Sometimes, it takes longer because we run out of reagents to process. Otherwise, the average time is three to four days," said Mulalelo.

LUSAKA High Court Judge Catherine Lombe Phiri has granted Lusaka lawyer Linda Kasonde's law firm, LCK Chambers, permission to withdraw as advocates for Prime Television.

This is in a matter where the television station is challenging government's decision to cease all cooperation with it.

"The application for LCK Chambers to withdraw as advocates for the petitioner is granted. There's no order as to costs," Justice Phiri said in her ruling.

In this matter, Prime Television has petitioned the Lusaka High Court for an order quashing Information and Broadcasting Services Minister Dora Siliya's decision to cease all cooperation with the station.

The television station, which has cited the Attorney General, TopStar Communications Company Limited and Multichoice Zambia Limited as respondents, is seeking an order declaring government's decision to cease

all transactions and business with it, unconstitutional.

Prime Television further wants an order that all media houses have the right to access and disseminate information from government without undue hindrances and an order that TopStar and Multichoice Zambia cannot remove it from their platforms at the direction of government.

LCK Chambers had, however, applied for leave to withdraw as advocates for Prime Television in the matter due to receiving insufficient instructions.

This was according to an affidavit in support of summons for an order for leave to withdraw as advocates sworn by Kasonde.

"I am counsel on record representing the petitioner (Prime Television) under the name and style of LCK Chambers. That we have

ceased to receive sufficient instructions from the petitioner, and as such, we would like to withdraw from the record," she stated.

Last month Lusaka High Court Judge, Catherine Lombe Phiri ordered that the proceedings be stayed and accordingly referred the case to arbitration.

This was after Topstar applied to have the matter stayed and referred to arbitration.

It argued that the arbitration clause had not been exhausted by Prime TV and that the proceedings were, therefore, in conflict with the said clause and, thus, improperly before court.

Topstar stated that the relationship between it and Prime TV was commercial in nature and governed by a Service Level Agreement.

It submitted that where an arbitration clause is contained in an agreement and a party decides to institute court proceedings, then the said party would be said to be in breach of the Agreement.

However, Prime Television's proprietor Gerald Shawa asked the Court to proceed and hear the matter on its merit.

He argued that the Service Level Agreement between the Television station and TopStar was a commercial dispute agreement.

Shawa submitted that TopStar did not invoke the Arbitration clause when it wrote to the television station on March 27, this year, informing it that it was being removed from the TopStar platform following a directive from the Minister of Information and Broadcasting Services that all government institutions should desist from engaging with Prime TV.

He added that the Service Level Agreement between the station and TopStar did not extend to constitutional matters such as the ones before

But ruling on the same, Justice Phiri granted TopStar its application to stay proceedings and refer the matter to arbitration.

Media regulation Bill was drafted without research

N 2018 when the Zambian government announced a move to start hippo culling in the Luangwa River on grounds that the animals were destroying crops and dying from anthrax due to overpopulation, former US Ambassador to Zambia Daniel Foote raised a very wise argument. Despite being a conservationist, the diplomat did not condemn the Cabinet decision, instead he challenged the government to provide scientific proof showing that the grounds for culling were researched and factual.

"With all due respect to Zambia's sovereignty, and I am not telling Zambia what to do, but reports today that Cabinet has approved a hippo cull on Luangwa River leaves me confounded. I have heard different reasoning. including anthrax and environmental degradation, carrying capacity of the valley, and now I'm hearing that it damages crops. I have heard all kinds of different reasons, all of which could be viable reasons, but I think anytime that we are talking about culling animals, we need to produce and publish the analysis and science behind that as to how that will lead to better sustainability of the species and better environmental balance

before proceeding. As I said before, culling can be a viable conservation too, but there is a science behind it. I think it's important to go through the scientific steps and to publish the results before carrying out culls," said Ambassador Foote.

Like Ambassador Foote, news that last week's Cabinet meeting approved the Statutory media regulation bill has left us disturbed. We are not here to simply rubbish the proposed Zambia Council for Journalists Bill in Parliament, which they say will provide for the establishment of a "selfregulatory professional body for journalists". We are here to ask what research they did before arriving at this Bill.

We have heard all kinds of different reasons for this decision, some of which look like they make a lot of sense at a glance. We have heard that there is too much fake news being spread with the aid of social

media; we have heard that iournalism standards have fallen to unrecognisable standards; we have heard that the profession has been hijacked by unscrupulous individuals who abuse press freedom to perpetuate hate speech; we have heard that there is no professional body which oversees the conduct of journalists or an institution where people can report their complaints against journalists or media institutions.

Unfortunately, all this rhetoric is nothing but propaganda meant to deceive people who do not understand the media landscape in our country; people who are gullible enough to believe that the Patriotic Front government means well with this agenda. We say this because there is no research that has been done for the movers of this Bill to understand the level of qualifications among journalists in these media houses. There is no research that has

been done to understand the trends in the spread of fake news - how it originates and what mediums are used. Our Ministry of Information and Broadcasting has not done a research to know why well-qualified journalists engage in unethical conduct such as taking brown envelopes to publish propaganda. If we ask our government leaders today how they think media houses survive and how much they pay their journalists per month, their answer will be a guess.

So we wonder why they want to impose statutory regulation in an industry that they have little knowledge about. Yes, we are saying they want to "impose" because this Bill has not come from journalists but from themselves. The consultation process which they refer to is an event where they transported iournalists from all over the country, paid for their accommodation and food before asking them to

state, by a show of hands, if they were in support of the Bill that the government was proposing.

Like the American Envoy said, when you make policies as government leaders, they should be backed by research and proof indicating that your decision is viable and sustainable. This Bill that they wish to take to Parliament, according to what they have told us, will dictate that all journalists affiliated to this council should have a prescribed level of qualification, without which, they will not be issued with a practicing licence. We have also been told that erring journalists will be punished by this council, which punishment could include withdrawal of the practicing licence.


This says everything that one needs to know about the agenda behind this bill. The target here is private media, and it has nothing to do with fixing the said lack of

professionalism in the media. If they were displeased with the manner in which public media upholds journalism ethics, they would simply pick a call and give orders. But they don't see anything wrong with how the public media operates, their issue is us the private media journalists. We are the target and they will not rest until they wield the power to give and take our rights to report news independently.

But we will not get tired reminding the Patriotic Front that these laws they are enacting will haunt them soon when they leave power. Good laws are those that you make for the benefit and enjoyment of ordinary people who are outside government because public service is not permanent. This particular statutory media regulation law being proposed is bad because it will be a subject of abuse once enacted. The current Minister of Information can claim to have good intentions, and maybe she means her words, but how much time is she remaining with in that office before another person takes over the instruments of power? What is the guarantee that the next minister will resist the temptation of abusing the law?

Dear readers, the Patriotic Front is up to no good with this Bill, mark our words.





OPPOSITION United Party for National Development (UPND) president Hakainde Hichilema's followers took to social media to express their dissatisfaction at his silence over the party's loss in the just ended local government byelections.

Speaking during the daily COVID-19 briefing in Lusaka, Sunday, Mulalelo said 40 patients were currently on oxygen support.

"The 119 cases are in Lusaka and cases include: 76 cases identified through healthcare facility screening in Lusaka, 23 contacts to known positive cases in Lusaka, 13 individuals identified community routine from screening in Lusaka, three health care workers screened in Lusaka and four BIDs in Lusaka. Amongst the active cases, we have 40 patients on oxygen support, five of whom are in the ICU. Today we have discharged 363 persons, this brings the cumulative recoveries

for testing globally, there is no production capacity in Zambia or Africa for required diagnostic reagents, reagents consumables as well as PPEs; there is limited availability of high-through-put laboratory equipment. ZUFIAW drags Barclays, Absa to court

ZAMBIA Union of Financial Institutions and Allied Workers (ZUFIAW) general secretary Msiska Chingati has sued Barclays Bank Zambia and ABSA Bank Zambia, seeking a declaration that the unilateral and non-consensual transfer of unionised employees of Barclays Bank to the new entity, ABSA Bank, is unlawful, null and

Chingati also wants a declaration that the so-called name change from Barclays Bank Zambia to ABSA Bank Zambia is a sham intended to mask the real nature of the corporate transaction, being a transfer of the business undertaking from Barclays Bank Zambia to the ABSA Group Limited and therefore unlawful. null and void.

He wants a declaration that the unilateral and non-consensual transfer of the employees of Barclays Bank to ABSA Bank is a terminating event entitling the employees of Barclays Bank Zambia to payment of redundancy benefits under the applicable Collective Agreement being 4.7 months' pay for each year served.

Chingati is further seeking an order for the payment of all other accrued benefits and rights being among others, pension benefits, long service award, leave days and repatriation allowance under the applicable Collective Agreement.

According to a statement of claim filed in the Lusaka High Court, July 20, 2020, Chingati stated that ZUFIAW represented all unionised Banking and Financial Institutions employees in Zambia as well as allied institutions in the Finance and Banking sectors.

He added that the union commenced this action on behalf of all its members, being unionised employees working for Barclays Bank Zambia Plc, pursuant to the Recognition Agreement signed between the bank and the

Chingati stated that ABSA Bank Zambia was a newly created Zambian subsidiary of ABSA Group Limited of South Africa, having its registered office in Lusaka.

"In terms of context, the plaintiff (Chingati) shall state at trial that Barclays Bank UK Plc of the United Kingdom (UK) (henceforth the parent company) has served on the African Banking market for over a century now. The parent company was the Holding Company of all Barclays Banks operating on the African continent. For operational efficiency, the Parent Company incorporated a subsidiary in Africa called Barclays Africa Group Limited through which it owned all Barclays banking entities on the African continent which included Barclays Bank Zambia," read the claim.

Chingati stated that the Parent Company held majority shares in Barclays Africa Group Limited and therefore had the controlling voice in all Barclays Banks on the African continent.

He further stated that all the Barclays banking entities in Africa collectively belonged to "the Barclays Group" of Banks, adding that Barclays Bank Zambia being a member of the Barclays Group was a subsidiary of the Parent

Chingati stated that the Parent Company had however, reduced its presence on the African Banking market by selling its majority shareholding stake in its African subsidiary, Barclays Africa Group Limited, by remaining with only 14.9 percent minority shareholding and simultaneously disposing of its majority shareholding stake to ABSA Group Limited of South Africa.

He stated that therefore, the sale by the Parent Company of its majority stake in Barclays Africa Group Limited, through which it owned all Barclays entities in Africa, had inevitably resulted in the said Barclays Bank UK Plc ceasing to be the Parent company of all Barclays entities in Africa.

Chingati stated that instead, ABSA Group Limited has now become the Parent Company of all Barclays entities in Africa which includes Barclays Bank Zambia Plc.

He stated that ABSA Group Limited, being the new Parent Company of all Barclays banking entities in Africa, had embarked upon the process of integration of all former Barclays entities in Africa into its group structure.

Chingati stated that the integration process involves among others, extinguishing and transferring Barclays Bank Zambia to a newly created subsidiary of ABSA Group Limited, which is ABSA Bank Zambia.

"The extinguishment and permanent transfer of Barclays Bank Zambia Plc to the ABSA Group of Companies has been masked and camouflaged in Zambia as a mere name change from Barclays Bank Zambia Plc to ABSA Bank Zambia Plc. The alleged name change is a facade or camouflage and is intended to mask the actual real transfer of a separate and independent legal entity being Barclays Bank Zambia Plc to a new entity the ABSA Group of Companies through its local subsidiary ABSA Bank Zambia," read the claim further.

He stated that further, the integration process also entailed permanently transferring all employees, customers and assets from the extinguished Barclays Bank Zambia Plc to the newly created separate and independent legal entity ABSA Bank Zambia Plc.

Chingati stated that ABSA Bank Zambia had also assumed all legal obligations which fell upon the shoulders of the extinguished Barclays Bank Zambia such as the payment of all statutory contributions on behalf of Barclays Bank.

He stated that at the time of the alleged name change, ABSA Group Limited existed as a separate and independent legal entity operating in 12 African countries.

Chingati stated that the so-called name change from Barclays Bank Plc to ABSA Bank Zambia Plc was a sham intended to disguise the actual transfer of the employees' contracts of employment.

He is now seeking, a declaration that the unilateral and non-consensual transfer of the Unionised employees of Barclays Bank Zambia Plc to the new entity ABSA Bank Zambia Plc is unlawful and null and void for breaching Sections 28 and 55 (I) (c) of the Employment Code Act No. 3 of 2019 and the Recognition Agreement.

Chingati further wants, among other claims, damages for the unilateral and adverse alteration of the existing Conditions of Service, interest, costs and any other relief in favour of the employees.

Barcelona will not sign Lautaro or Neymar this summer, admits Bartomeu

BARCELONA will be unable to complete a deal to sign either Laurato Martinez from Inter or Paris Saint-Germain attacker Neymar this summer, according to president Josep Maria Bartomeu.

Although both players have long been linked with a switch to Camp Nou - in particular the Argentina attacker - Bartomeu has admitted that the coronavirus crisis has put the club's finances into a state of uncertainty to the extent that they cannot complete a deal for either.

Barca fans had been hoping that the offensive line would be reinforced this summer after looking threadbare at times last season, with Martin Braithwaite signed from Leganes as emergency cover due to an injury crisis at the club. Bartomeu has now indicated that it is simply not possible.

"Barca have spoken to Inter about Lautaro over the last few weeks but the conversations have been put on hold by mutual consent. The current situation doesn't allow for major transfer fees," he admitted to Sport before confessing that Brazil star Neymar is similarly out of reach.

"In the current situation, no. PSG don't want to sell either, which makes sense as he's one of the best players in the world. Last summer we tried really hard to sign him but this summer we won't even try.

"The club lost €200 million (£180m/\$235m) between March and June. If the situation doesn't improve, there won't be people in the stands, at the museum or the shops and we'll keep losing money. This will cause us to revise our spending plans and which ones can wait. We have

to adapt.

"All the big European clubs have been impacted by this and we are all working to adapt. This won't be for just one year, it could be for up to three or four years."

Bartomeu, meanwhile, did take time to assess the one signing that the club have completed - Miralem Pjanic from Juventus, with Arthur going the other way.

"We've been following him for a while but every time we moved for him it wasn't possible because his club didn't want to sell," he said. "He was always excited about the chance of coming to Barca. This isn't a surprise signing. He's going to be an important player for us." GOAL

Going into the match, Nkana players were privy to the fact that their opponents for the final day, Nakamba Leopards, were most unlikely to travel as their COVID-19 situation did not allow them to.

That meant Nkana being handed three points and three goals, which further implied that the Kitwebased side would have gone into the final day of the campaign on top of the table, guaranteeing them a title.

Arrows' Joseph Phiri opened the score charts when he hit the back of the net within five minutes before veteran striker, James Chamanga, added another shortly after the interval.

Nkana needed inspiration to overcome the burden before them and they found it through skipper Idris Mbombo who scored twice to save his side from a painful defeat. "We didn't start well, we conceded very early in the game, we wanted to win this game in order to have a realistic chance of winning the

title. It's so painful to give away points in such a manner. Now we just have to play well against Nakambala and see how results go elsewhere," Mbombo told reporters after the match.

In others games on Saturday, Zesco benefited from an own goal to claim victory against Lusaka Dynamos. The current champions have since stormed the top four.

Elsewhere, Kabwe Warriors claimed a 1-0 victory over Lumwana Radiants.

The match between Kansanshi Dynamos and Green Eagles was

postponed at the request of the hosts and it is unclear at this stage what will happen with those points.

Napsa Stars' win on the other hand catapulted them into the lead on the table with 48 points from 26 matches.

The league will come to an early close on match day 27 after the Football Association of Zambia revealed that there was no capacity from the Ministry of Health to conduct COVID-19 tests on time. The last games will be played on Wednesday and Thursday.


