In its petition filed in the Constitutional Court, the nongovernmental organisation argued that government had breached the Constitution by implementing the issuance of National Registry Cards (NRC) in a manner that contravenes the Constitution. It relied on Article 128

(1)(b) of the Constitution of Zambia and alleged that the actions taken by government and ECZ were a violation of the Constitution and thus the court had jurisdiction to determine the petition.

Chapter One further relied on Article 128 (3)(b) of the Constitution and alleged that the decision made in the exercise of the legislative mandate to register citizens and register voters was unconstitutional and violates the Constitution.

It stated that the actions, decisions and measures taken by the respondents do not show an application of the

national values and principles.

## **PF promoting illegality by taking NRC** issuance as party programme – Andyford

By Natasha Sakala PEOPLE'S Alliance for Change (PAC) president Andyford Banda has warned the PF against tampering with the operations of the Ministry of Home Affairs in the issuance of National Registration Cards (NRCs) as it borders on the country's national security.

In an interview, Banda alleged that the PF wanted to enlist foreigners to register as voters ahead of the 2021 general election.

Banda was commenting on PF secretary general Davies Mwila's announcement that the ruling party would adopt the NRC issuance exercise as a party programme.

"The PF has promoted illegality at a number of points. I think what Davies Mwila is saying is not different to the warning that Mr Bonny Kapeso gave to PF cadres to stop taking over security for the President because that is the job of the State. So, what Mr Davies Mwila is saying is that he wants to take over some of the works of the Ministry of Home Affairs, which is a security wing. The reason why this issue is done by the Ministry of Home Affairs is because it's sensitive. They want to bring people from Congo, from Tanzania to come and register as voters and that's why they want to take it like a party programme. What we want to warn them is they should not disrupt the operations of the Ministry of Home Affairs to register as many voters as possible. We want to tell them to let that work be done professionally and ensure that all the screening of those that will be getting NRCs is done," Banda said.

He said the issuance of NRCs was not a PF programme and must be spread across the country without favour.

"This is not a PF programme, this is a national programme. Every person who is eligible, as a Zambian citizen, must take an NRC. Whether they support PF or they don't support PF. And we are not happy that the PF are trying to get as many registered voters as possible in their strongholds leaving out other provinces. We want to make sure that the exercise is spread across the country without favour," he said.

Banda also warned Mwila that attempts to take over government functions was just promoting illegality.

"So, Mr Mwila must know that the idea of taking over the work of the government is promoting illegality. The government and a party are two different things," said Banda.

Earlier this week, Mwila, during his tour of Kasama District, Northern Province, announced that he wanted to see PF functionaries involved in the NRC issuance exercise so that the ruling party could register as many voters as possible in the forthcoming registration exercise.

# Zambia records 21 BIDs in a single day

THE Ministry of Health has announced that the country has recorded 142 new COVID-19 cases with 23 related deaths in the last 24 hours.

And the Ministry of Health says it is discouraging that the few people who are wearing masks are not using them correctly.

Speaking during the daily COVID-19 briefing, Thursday, Ministry spokesperson Dr Abel Kabalo said of the 23 deaths, 21 were Brought In Dead (BID) and two were institutional deaths at the Levy Mwanawasa isolation centre, bringing the cumulative number of deaths to 199.

"We also recorded 21 BIDs in Lusaka; UTH recorded 20 and Kanyama recorded one. Among the cases, we have 80 patients currently admitted to our isolation facilities, 37 of these are on oxygen support, six patients are admitted to the intensive care unit, we also have some relief where 119 persons have been discharged in the last 24 hours across the country. This brings our total cumulative recoveries 5,786 since the beginning of the outbreak. In addition to the BIDs, we have recorded two new COVID-19 related

facility deaths, one 85-year-old male with severe COVID-19 pneumonia and underlying hypertension and diabetes, one 52-year-old male patient with severe pneumonia. Both deaths occurred at the Levy isolation centre. This brings the cumulative number of COVID-19 related deaths to 199. The 21 deaths are yet to be classified," Dr Kabalo said.

"Zambia has recorded a total of 142 new cases of COVID-19 out of the 724 tests done in the last 24 hours. And this brings the cumulative total of COVID-19 cases to 7,164. Of these 142, the distribution is as follows; 50 individuals screened through routine screening, in Lusaka we recorded 48 and then one came from Chipata and then one came from Solwezi. 42 individuals were identified through hospital screening; 16 were identified in Solwezi, 14 in Lusaka, seven in Ndola and five in Kabwe. 29 were contacts to known cases; 28 were identified here in Lusaka and then Kalumbila gave us one."

And Dr Kabalo expressed concern over the reduced number of people using masks correctly.

"What we have noted that unfortunately is compliance levels among the public is very low and this will not help us to reduce the transmission of COVID-19. It is also disheartening to see that majority of people are not wearing masks and those doing so, majority are wearing them incom Social distancing again is not being observed, hand washing and use of hand sanitisers is increasingly becoming limited to our offices and shopping malls. This should not be the case. I therefore call for all individuals to take personal responsibility to protect themselves and others. With increasing evidence of community spread, you the public are now joined to the frontline of the Covid fight. Business owners must take responsibility not only for themselves but also for their workers and customers. Shop and restaurant owners must ensure that all their customers are appropriately masked before they enter their premises," said Dr Kabalo.

ANTI-CORRUPTION Commission (ACC) investigations officer Chipambe Manda yesterday shocked the Lusaka Magistrate's Court when he admitted that the total value of assets that Health Minister Dr Chitalu Chilufya is accused of acquiring through proceeds of crime, is less than his known legitimate income.

Manda testified that the total value of assets that the minister stands charged with as being proceeds of crime was K5,542,500, whereas his known legitimate earnings in the period under investigation exceeded K19 million.

A shocked Lusaka Chief Resident Magistrate, Lameck Mwale wondered if the witness had made a mistake in his testimony and asked: "Are you saying the assets are less than his known legitimate income or more?"

Manda then insisted that it was less, prompting the Magistrate to ask, "Then what is wrong with that?"

And asked by the defence lawyers in cross examination if he still believed Dr Chilufya committed an offence based on his findings, the State witness said no, adding that the Health Minister had the capacity to acquire all the said properties from legitimate income.

On Wednesday the ACC investigations officer had testified that Dr Chilufya's total earnings for the period 2013 to February 2020 from the National Assembly, PMEC and Henry Courtyard Limited was over K22 million.

Manda, 34, explained that from the National Assembly, Dr Chilufya earned over K7 million for the period November 2013 to February 2020; over K3 million from PMEC (Payroll Management and Establishment Control) for the period November 2013 to December 2019 and over K12 million for the period 2016 to 2019 from Henry Courtyard Limited in which he is a director and shareholder.

When the matter came up for continued trial yesterday, Manda told the court that after conducting investigations, he had to sum up the value of the properties as per indictment and analysed Dr Chilufya's earnings for the period between December 2016 to April 2019.

He said he also endeavoured establish the financial activities relating to Henry Courtyard Limited by looking at the bank statements.

Manda said the total value Dr Chilufya's assets which

after investigations was that the total value of assets the accused was alleged to have acquired through proceeds of crime was less than that of his known legitimate income during the indictment period.

In cross examination, defence lawyer Tutwa Ngulube asked Manda if after his findings, he still believed that Dr Chilufya committed an offence, Manda said no.

Asked if during his investigations he had established that apart from the amount of over K19 million which he had mentioned, Dr Chilufya had a K15 million loan which he got from Development Bank of Zambia, the witness said yes.

Asked whether the K15 million loan was part of the K19 million earnings he had mentioned, Manda said that was not clearly established.

Further asked if he had established that Dr Chilufya had obtained another loan of K2 million before the indictment period, Manda said ves.

Asked if he had a receipt to show that the accused paid K3 million to buy Sparks Guest House, the witness said no.

Further asked if he had evidence to show that the accused possessed the amounts in the indictments, Manda said no.

Manda further said Dr Chilufya cooperated during investigations and there was no belief that he hid anything.

Asked by another defence lawyer Jonas Zimba if he ever met the complainant or informant who complained against Dr Chilufya, the witness said no adding that a statement was not recorded from the informant.

Asked if his conclusion was that Dr Chilufya had the capacity to acquire the properties that he is accused of possessing illegally, Manda responded in the affirmative.

At this point Jonas asked, "if that was your conclusion, why are we in court today?"

However, the State objected to the question, saying that was for the arresting officer to answer and not Manda.

After cross examination, the State said they would not reexamine the witness based on his testimony.

On Wednesday, Manda had testified that on December 17, 2019, ACC received a report bordering on allegations of possession of property reasonably suspected to be proceeds of crime against Dr Chilufya.

He said the allegations were that Dr Chilufya owned several properties in Mansa, Luapula Province, among them Samfya Marines and Tourism Services.

Manda added that ACC received the said report from an anonymous source.

He said he proceeded to go to PACRA to establish the directors and shareholders in Samfya Marines and Tourism Services and companies in which the minister had interest in.

Manda said it was

established that Den Daas Investment Zambia Limited transferred 6,000 shares held in Samfya Marines and Tourism Services to Dr Chitalu at a consideration amount of US\$200.000.

He said Leo Jonas Ngosa Investment Limited also sold 2,000 shares in Samfya Marines and Tourism Services to Dr Chilufya at the sum of K270,000.

Manda further testified a Mr Benjamin Kabamba sold Spark Guest House to Dr Chilufya at K3,000,000.

He said he also established that Dr Chilufya had acquired a 32 seater boat imported from Dubai by a company called Bellchiz General Dealers and Suppliers Limited.

### NRC registration exercise a party programme, insists Mwila

PATRIOTIC Front secretary general Davies Mwila says his party is working on a budget so that funds can be released for members to mobilize people to get National Registration Cards.

Speaking when he met party officials in Nchelenge, Thursday, Mwila insisted that getting NRCs was a party programme.

'The NRCs exercise let us take it as the party program. Let us all get involved. Nali chita discuss naba (I discussed with the) party chairman, we are working on a budget to see if we can release some few resources so that abantu besu bali munshila bale enda bale ongola abana mukuya lembesha ama reg (our people should

mobilize people to get NRCs) because we need the numbers. Mobilization ya party that is the reason we are there," Mwila said. Mwila advised the party officials in the district to grow the party branches.

"Natwisa nama registers aya kweba ati mule lemba ama branch. Ama branch ya fwile ya fula, te kwi kala fye ati ama elections yali no kwisa (we have come with registers so that you can take note of people. The party branches need to grow, don't just be idle and wait for elections). You have to continue mobilizing the party. I will not talk about the area member of parliament because he is not here. After we have finished the elections, we are going to the general conference, that was the decision from the last meeting. We are going to sit and decide once we finish the provinces. We are going to sit and decide which way forward. Of course because of the COVID-19, what measures are we going to put in place, all those issues must be discussed. So I have brought the registers for the constituency and district," Mwila said.

"I have also brought one bail of Chitenge material for the district. But I wanted all the ward officials to be here because this is an opportunity for some of you, you have not met the secretary general. You are meeting him for the first time so that efyo tule landa not ukuya ba shimikila. Sometimes ukuyumfwila kwaliwama (whatever we are saying here, they should not be told but they should hear it for themselves)."

Meanwhile, Mwila said he would engage Minister of Infrastructure Development Vincent Mwale on plans to rehabilitate roads in that area.

"The issue the chairman raised about the township roads, we will raise it to the concerned Minister. The hospitals where you did the ground breaking I will engage the Minister of Health," said Mwila.

Earlier, Mwila donated various items towards the fight against COVID-19 to St Paul's Mission Hospital in Nchelenge and later at Mbereshi Mission Hospital in Mwansabombwe.

Shonga, however, implored the National Assembly to consider increasing the notice period that the Association is given to make submissions before the relevant committees in order to make significant contributions.

Shonga further expressed concern that, in some cases, well researched contributions by LAZ were glossed over and therefore, urged the National Assembly to apply much more consideration to the submissions.

Shonga was accompanied by two other Council Members; Sokwani Chilembo and Kampamba Kombe.

#### BIA Revenue Authority Commissioner Mineral Royalty Taxes down 6%, says ZRA

ZAMBIA Revenue Authority (ZRA) Commissioner General Kingsley Chanda says the Chamber of Mines should not alarm the nation by issuing false statements on Mineral Royalty Tax (MRT) because there has only been a marginal reduction of six per cent this year.

And Chanda says the Authority will soon be launching tax payments on WhatsApp to make it easier for Zambians to pay taxes.

Speaking when he officially opened the ZRA Service Centre at the ECL Shopping Mall in Kitwe, Thursday, Chanda announced that there was a reduction of six per cent in Mineral Royalty Tax and not a 20 per cent reduction as reportedly stated by the Chamber.

He insisted that there had been a 27 per cent increase in payments of overall taxes from the mining industry.

"From January to July,

2019, and 2020 Mineral Royalty Tax for the same period, the mining companies have paid K2.53 billion in 2020. In 2019, K2.5 billion, so there is a marginal decrease, a reduction of six per cent,

not the 20 per cent that the Chamber of Mines talked about! There is a reduction of six per cent in Mineral Royalty Tax comparing January, 2019, to January, 2020. If you go to income company tax for the mining industry, in 2020, they have paid K3.2 billion; in 2019, they paid K1.6 billion. So, there is an increase of 98 per cent in company income tax. When you go to Pay As You Earn (PAYE), there is a

# Chambeshi Water accumulated K31.1m in NAPSA penalties – AG

By Natasha Sakala THE Auditor General has revealed that Chambeshi Water and Sewerage Company (ChWSC) Limited had accumulated NAPSA penalties in amounts totalling around K31.1 million as at December 31, 2019, due to non-payment of statutory obligations.

And the Auditor General further revealed that the company was distributing water that was below the quality standards set by NWASCO, the national regulator.

According to the Auditor General's report on the Accounts of Water and Sanitation Companies for the financial year ending December 31, 2018, the utility accumulated over K31 million in NAPSA penalties, among other unremitted statutory obligations.

"As at 31st December, 2019, ChWSC owed the Zambia Revenue Authority (ZRA) and the National Pension Scheme Authority (NAPSA) amounts totalling K2,128,813 in unremitted statutory obligations, contrary to the Income Tax Act Chapter 323 of the laws of Zambia and the National Pensions Scheme Authority Act No. 7 of 2015. As a result of non-payment of statutory obligations, the Company had accumulated NAPSA penalties in amounts totalling K31,093,673 as at 31st December, 2019," the report read. The Auditor General further revealed that the utility owed over K4.9 million to 243 members of staff in salary arrears, long-service bonuses, among others. "ChWSC owed amounts totalling K4,925,878 to 243 staff in respect of gratuity, leave pay, long-service bonus, salaries and wages and other terminal benefits for periods ranging from one to seven years. As a result of non-payment of benefits, 11 separated officers continued drawing salaries

and had been paid amounts totalling K497,906 as at 31st December, 2019," the report read.

It was also revealed that during the period under review, the company was owing amounts totalling K65.9 million and around US \$3.7 million to 11 contractors in delayed payments.

"During the period under review the Company entered in 11 contracts with various contractors for consultancy, construction, and rehabilitation of water systems in Northern and Muchinga provinces at a total contract sum of K459,500,319 and US \$12,486,526.80. The following were observed: Delayed Payments to Contractors - A review of contract documents revealed that certificates of payments were to be settled within 28 days after being issued. However, as at 31st December, 2019, the Company had unpaid interim payment certificates in amounts totalling K65,902,136 and US \$3,741,850.25 owed to 11 contractors, which were outstanding periods for

exceeding 28 days. Expired Performance Bonds: Section 52.1 of the contract provided that the performance security shall be valid until a date 28 days from the date of issuance of a completion certificate in case of a bank guarantee and until one year from the date of issuance in case of a performance bond. Contrary to the section, performance bonds for three projects that were still in progress were not renewed after their expiry," it read.

And the Auditor General stated that the struggling utility was distributing water that was below the required quality standard.

"Water quality is important due to the health impact it has on the consumers. The overall compliance for water quality is assessed through a sequential three step process namely confidence level, number of samples tested in relation to the minimum required and number of tests meeting the national drinking water standard. The benchmark for acceptable water quality set by NWASCO is a score greater or equal to 95 per cent. During the period under review, ChWSC failed to meet the minimum required water quality as the overall assessment was below 80 per cent," the report read.

The company is further said to have incurred a loss of revenue amounting to over K54.6 million in Non-Revenue Water (NRW).

"NRW is the difference between the quantity of treated water distributed in the network and quantity of water actually billed. NRW consists of technical (leakages) and commercial losses (illegal connections, unbilled customers, wastage on unmetered customers' premises). According to NWASCO, the accepted level of NRW is from 20 per cent to 25 per cent of the quantity of treated water distributed in the network. However, the Company's NRW ranged from 44 per cent to 51 per cent resulting in a cumulative revenue loss of K54,663,405. The NRW deprived the company of the revenue to help improve its operations," narrated the marginal reduction of three per cent, but this is a given because PAYE is paid by employees," Chanda said.

"We have had some members of staff in the mining sector laid off. We have had some reduction in staff at Mopani (Copper Mines) and reduction in staff at Chambeshi Metals, which is on care and maintenance and other mining companies. So, if you have a reduction in the number of staff, it is inevitable that the PAYE goes down. But there are marginal differences not to the extent that the Chamber of Mines... overall, the mining sector in Zambia in 2020 have contributed K6.94 billion in January, 2020, to July. For the same period in 2019, they contributed K5.47 billion. So, overall, there has been a 27 per cent increase in payments of taxes from the mining industry."

He argued that the "alarming statements" issued by the Chamber of Mines were malicious and designed to destabilise the Zambian economy. "What I want to say to the Chamber is that, they must tell the truth! They may hate the leaders of this country, they may hate ZRA, but they must not hate the country. We have a country to protect. If you issue such alarming statements and discourage investments in this country, it is not just those people in leadership you hate who will suffer, it is all Zambians. I also want to state that there is no country that does not have confidentiality, but when you want to speak about confidential issues, because tax matters are confidential and they are between the tax authority and the taxpayer. But when you choose to talk about confidential things, tell the truth, say facts not myths, not lies! I consider that statement by the Chamber to be malicious and was designed to destabilise the Zambian economy," Chanda complained.

He added that ZRA service centres at shopping malls had improved service delivery.

"Evidence further suggests that the service centres have significantly improved service delivery to

our taxpayers and enhanced revenue collection. You may wish to note that service centres, which were opened in the last quarter of 2018, have already attended to more than 200,000 taxpayers as at the end of July, 2020. This shows the value that is being realised by our taxpayers through a 360-degree service experience from tax payer education, tax advice, tax registration, tax compliance checks and actual tax payments. Please note that all ZRA services are offered free of charge," Chanda said

"Despite our presence here in Kitwe at Nchanga House, the Authority has decided to open this service centre so that taxpayers can have a chance of interacting with us as they do their normal shopping. This is all aimed at giving taxpayers a friendlier, convenient, simpler, faster and thrilling tax experience. In terms of costs, the Authority has invested K1 million in this infrastructure including the furniture and it equipment."

And Chanda disclosed that the Authority would launch tax payments on the popular WhatsApp social media platform, which would make it easier for Zambians to pay taxes.

"Within the next few days, we shall be launching tax payments on WhatsApp, which is a communication phone application, but using it to make tax payments. This is the first for Zambia because you will now pay your taxes using WhatsApp on your phones and this will bring convenience, efficiency, comfort and simplicity. This is what we mean when we say, 'taxpayer focus.' We respond to the business needs of the taxpayers. We shall, again, later roll out another product, which is the Tax on App to supplement the alreadyexisting tax on phones and offer taxpayers a choice in terms of TPIN registration, return filing and payment. All these initiatives the Authority is making will be meaningless if our taxpayers don't support them," said Chanda.

Efforts to get to the Chamber of Mines to respond to Chanda's assertion on the variance of MRT recorded in 2020 compared to the corresponding period last year 2019 did not yield a response by press time.

Bizeck Phiri says the recent by-election results may not be a true reflection of what is likely to happen in next year's general election.

In an interview, Prof Phiri argued that the July 30 poll results, which saw the PF emerge victorious in 10 out of 15 ward by-elections, may not be a true reflection of what was likely to happen in next year's general election due to the ever-changing political dynamics and numbers of voters, which are usually more in a general election.

He, however, said that the numerous developmental projects around the country may have had an influence on voters' decisions in voting for the ruling party in by-elections.

"The period in which we are where we have this Coronavirus and movements are somewhat restricted and we are seeing some challenges that could be part of the explanation. Another explanation is that there could be certain things that are happening that have led people to begin to change their perception of the political parties and hence the result as we are seeing. If you look at what is happening in the country, now, you see a lot of development that is taking place; the road construction, hospitals and schools and because of that, that can also influence the way in which people cast their vote. Also what is significant is that when you look at the number of people that actually go to vote, it is relatively much less than the number of registered voters where we are seeing these by-elections," Prof Phiri said.

"The analysis, which I looked at, when you look at the margins in terms of the total number of votes, the margin is very narrow between the ruling party and the opposition. So, come 2021, what has happened in the by-elections may not be a true reflection of what is likely to happen unless things remain constant, but things may change. But my analysis is that as we go into 2021, we need a fair playing ground. Let the different political parties that are participating have access to the people on the ground and tell the people what their message is."

And Prof Phiri, a political historian, observed that most voters were still undecided on who to vote for, which was what usually determined

the outcome of election results.

"What normally determines the outcome of an election is what people are looking at during the period of the campaign and that is what makes people decide to say, 'I am not going to vote for this party, I will vote for this party.' Remember, when you are talking about elections, there are people who are in between and when elections are approaching that is when they make up their mind on who to vote for. What is significant in Zambian politics is that people are not attached to a particular party that is why we hear so many people have defected from one party to another party. So, there is no strong attachment to a party and that also reflects the results when elections take place. People are not committed, they move up and down," said Prof Phiri.

# THE ADMISSIBILITY OF DERIVATIVE EVIDENCE IN ZAMBIA IN LIGHT OF HUMAN RIGHTS OBLIGATIONS AND THE NEED TO DISCARD LISWANISO VERSUS THE PEOPLE (1976) ZR 272 (SC) PART TWO

#### JOSEPH CHIRWA D. THE Role of the Judiciary in the Protection of Human Rights

The right to privacy is one of the most important fundamental rights and as such Courts must ensure that it is protected. The Constitution has guaranteed the right to privacy that outlaws illegal entry, search and seizure and it is up to the courts to protect this right. This right includes the right not to be subject to searches on one's person, home or property; seizure of private possessions; or interference with private communications, including mail and all forms of telecommunications.

The learned author adds that:

Police officers [and other law enforcement agencies] are required to obtain a search warrant from a magistrate before they proceed to invade a person's privacy. Magistrates must carefully consider the evidence given by the police [and other law enforcement agencies] and ascertain whether or not there are reasonable grounds for the application. It should not just be a matter of signing search warrants as the right to privacy is highly valued in any civilized society.

It is the solemn duty of courts to protect fundamental freedoms, liberties and rights as provided under the Zambian Bill of Rights. Are there any grounds in which these constitutionally protected rights, such as the right to privacy, may be infringed? Dr. Julius Bikoloni Sakala, a seasoned lawyer opines that:

.... the protection is not limitless. The protection can also be denied if the action is reasonably justified in a democratic society are somewhat nebulous and therefore difficult to define. Consequently, the powers of courts in protecting human rights in this sphere are seriously restricted.

However, the Courts in the case of Kachasu v Attorney-General attempted to define the concept of what is justified in a democratic state, which may be stated with confidence that it did not arise in the Liswaniso case. Blagden, CJ upon descending and sitting as a puisne judge opined that:

Reasonably justifiable in a democratic state and was authorized by laws which were both reasonably required in the interests of defence and for the purpose of protecting rights and freedoms of other persons. If we mirror the Liswaniso case to the foregoing, we find that it does not fall within the permissible derogations outlined above. The holding is a blatant enemy to constitutionalism and protection of human rights as it outrightly allows violation of a protected right without any reservations or direction to deal with matters on a case by case basis. celebrated case of R v Looseley defined entrapment in the following way:

Entrapment occurs when an agent of the State – usually a law enforcement officer or a controlled informer- causes someone to commit an offence in order that he should be prosecuted.

However, it must be noted that the Loosely case set out what are known as the 'Loosely Tests of Entrapment' which are used by courts to determine as to whether to allow evidence obtained through entrapment. These are:

• Reasonable suspicion – there must be a reasonable suspicion leading to an investigation of an accused person. Arbitrary investigations into citizens selected at random is considered an unworthy form of state abuse.

• Supervision – the act of entrapment must be one that is such that it is permitted under the law. The purpose of supervision is to remove the risk extortion, corruption or abuse of power by law enforcement officers without proper supervision.

• The nature and extent of State participation in the crime – the state must not create a crime and help the accused to commit it and must not induce and persuade the commission of the crime.

## B. Entrapment in the Anti-Corruption Crusade in Zambia

Reading the news and case records will show that most prosecutions by the corruption watchdog, the Anti-Corruption Commission (ACC), are based on entrapment. The case of Liswaniso show that the accused was trapped into receiving a bribe an issue that the Supreme Court found as a matter of fact and that the law enforcement officer lied under oath whilst asking the court to issue a warrant.

The case of the People v Peanos Luzendi is another case in point. In this case, the accused, an officer under the Drug Enforcement Commission (DEC), was arrested, arraigned and convicted for committing an offence contrary to the provisions of the Anti-Corruption Act No. 3 of 2012. The day he was arrested, he was laid into a trap set up by the ACC working together with the person who was given 'bait' money to give to the accused.

that she would pay some money for helping her. Mr. Shawa claimed that upon meeting with the said Ms. Tembo, he was arrested by the ACC and charged with the offence of corruptly soliciting K1, 000 from Ms. Tembo as an inducement or reward not to fail her in the said examination. He claimed that the phone call to meet with Ms. Tembo was initiated by the ACC who availed the K1, 000 to her for purposes of procuring an offence to be committed, leading to his arrest on the strength of the K1, 000 made available. Mr. Shawa complained that the plan to arrest him was conducted by the ACC and that it was an entrapment to lure unsuspecting citizens into procuring the commission of an offence. [Emphasis supplied]

These and many unreported stories and cases show the extent to which entrapment has been institutionalized by law enforcement agencies in Zambia. Unsuspecting citizens are lured, motivated and persuaded to commit crimes and later on arrested by the same motivators and persuaders. The practice can be alluded to the 1976 judgement in the Liswaniso case which has legalized illegalities by law enforcement officers in the collection of evidence.

#### C. The Supremacy of the Constitution, Human Rights and The Liswaniso Holding

By giving law enforcement agencies the authority to obtain evidence through illegal and unconstitutional means, Justice Peter Chitengi noted 20 years ago that the Court had "given the lee-way to [law enforcement agencies] to tap phones, search homes illegally and torture [suspects] with impunity." The Judge called on the Supreme Court, to which he later sat on its bench, to "revisit the judgment as it perpetuated violations of human rights."

In most mature ad progressive jurisdictions that uphold the supremacy of the constitution and prioritize the human rights agenda, the holding of Liswaniso cannot stand. It is imperative that the Liswaniso law, which is bad law, is either thrown into the bins of legal history or it is modified to take matters on a case by case basis as has been done in other countries. The Liswaniso judgement, as it stands, violates both domestic and international obligations that the Zambian state has in upholding the right to privacy and Article 18 rights such as that of fair trial and self-incrimination.

THE LISWANISO CASE AS A CATALYST TO ENTRAPMENT IN THE ANTI-CORRUPTION CRUSADE

#### CONCLUSION

It must be stated that the Liswaniso case reverses everything that the framers of the Constitution intended. It appears that the intention of the framers of the Constitution, and most importantly the will of the Zambian people from whom the framers derived their authority, was to protect the right to privacy and to prevent abuse of process by law enforcement agencies by using bait to induce citizens to commit crimes and also violating the law and disregarding the privacy of persons and homes in gathering evidence. It is in this regard that, in totality of what has been submitted especially in the face of a pro-human rights world, Liswaniso was and is bad law.

# NAPSA sues IMS for remitting late monthly contributions

NATIONAL Pension Scheme Authority (NAPSA) has sued Intelligent Mobility Solutions Limited (IMS) in the Lusaka High Court, claiming payment of K141,000 in respect of penalty arrears, for allegedly remitting monthly contributions late.

NAPSA is claiming payment of K141,760.07 in respect of penalty arrears as a result of none or late contribution of penalty arrears.

It also wants interest, damages, costs and any other relief the Court may deem fit.

In a statement of claim filed in the Lusaka High Court, Thursday, NAPSA stated that it was a statutory body whose principal function was to implement policy relating to the National Pension Scheme and control and administer the Scheme.

It added that it was by law mandated to collect monthly statutory contributions from contributing employers.

NAPSA stated that IMS was a statutory body established under the provisions of the Road Traffic Act No. 11 of 2002.

It stated that it shall state at trial that IMS was a contributing employer registered as a Tax Payer with contracts of service with employees under the National Pension Scheme Act No. 40 of 1996.

NAPSA further stated that IMS was mandated to pay to the National Pension Scheme a contribution in respect of its employees in its employment at the end of each month.

"That if the aforementioned payment is not made within the stated time limit, such a payment would attract a 20 per cent cumulative penalty for each month. IMS has been remitting monthly contributions, albeit late, as a result IMS has accumulated debt in penalty arrears in the sum of K141,760.07," read the claim.

It stated that despite several reminders and written correspondence that IMS effect its mandatory requirement to comply with the law, IMS had neglected or failed to pay the sum of K141,760.07.

Agriculture can actually improve the incomes of this country better than what the mines are doing. Few people are employed in the mines, many people are employed in the agricultural sector. dealing with one commercial farmer because by then, if you multiply two hectares by about 30 farmers, you have 60 hectares and then they can diversify that 60 hectares because you are teaching them as one big commercial farmer. Diversifying a small plot of two hectares by an individual farmer to bigger production levels is next to impossible. In their own way, they have already diversified as farmers, let's just know the opportunities that exist."

And Dr Kayula warned that allowing call boys to run markets remained a breeding ground for lazy youths, who just wanted to earn a living, and called for the creation of better jobs for youths in the country.

"In fact, if we are not careful, by allowing the kaponyas (call boys) to man those markets, that is a breeding ground for lazy youths, who want to make quick money at the expense of depressing the producer. We need to find something good that these youths are supposed to be doing [rather] than putting them in the market and when farmers arrive, they grab the products from them. They make more money, reducing drastically on disposable incomes among farmers and travellers. There are ways of ensuring youths are facilitated to get better jobs than kaponya jobs. Youths should also wake up to the fact that these kaponya jobs will not help them in old age. Have you ever seen an old kaponya? Where do they retire to? They just disappear into extreme poverty, which they prepared for when they worked as kaponyas. These guys need better jobs," said Dr Kayula.

excuses for load shedding, the UPND excuses for losing elections keep evolving. For the past 10 years, they have been saying, "by-elections are not a good measure of popularity." By the way, that point is only applicable to the ruling party.; if the UPND wins a given by-election, it means they are gaining popularity. Apart from that excuse, we have also heard about the rigging schemes of the PF. "They have been stealing our votes!" Then we have also heard about the abuse of the Public Order Act, and most recently, we heard that they are not allowed to campaign due to COVID-19.

Bembas say, "uwawa, tabula akabepesho" loosely translated as "a failure never runs out of excuses." Mr Hakainde Hichilema has stood as a presidential candidate

in the years 2006, 2008, 2011, 2015 and 2016 and is expected to stand for the sixth time in 2021. Only in the years 2015 and 2016 did he manage to come close to winning; losing by only 27.757 votes in 2015. During the 2006, 2008 and 2011 presidential elections, Mr Hichilema was lacklustre, stiff and appeared as if he was lecturing and complaining to his audiences, rather than asserting his political will power. Today, we are witnessing the same "I will fix it/everything" campaign.

So, ahead of 2021, the question is whether much has changed in the years past about the strongest challenger of the incumbent, or he still portravs himself as some 'boardroom calculator genius' who views his ascendance to the **Republican Presidency** as an entitlement owed

to him by the Zambian people. Will he win the next elections or the PF will simply lose power and the Presidency will fall in his hands? That, we don't know.

What we can say with confidence about the political state of affairs in Zambia is that we have no government and we, guite honestly, have no opposition. The past looks horrifying for the UPND and the future looks doomed for the PF. There has never been a scandalriddled government like the Patriotic Front in history, yet there are still hundreds of thousands of undecided voters. There is certainly something wrong in the opposition, beyond just the UPND. They seem to lack a winning strategy.

Mr Hichilema has generated a lot of social media traffic and that's good, but in an analogue society, you need to

analyse that traffic and see how much of it has actual electoral value. If someone thinks that traffic directly translates into votes, then forget it. To borrow Seer1's words, "vou can sav Bally this, Bally that, but there is nothing you are 'ballying' because on that day, Bally will be nowhere on the ballot." If there is no realistic youth mobilization strategy run by the substantive party structures under the Secretariat, Bally will be buried, leaving his party more divided than it has already been.

Gaining ground on social media is great, but there is no electronic voting in Zambia, at least not for 2021. There is a difference between showing off popularity among those who have access to the Internet and securing actual votes. A thousand comments in one minute on a Facebook post


mean nothing to the Electoral Commission of Zambia (ECZ). The winner of the 2021 presidential election is that politician who knows what really counts; that politician who is out there in the bush, strengthening the grassroot structures.

But what do we know? As we are told, when PF wins elections, it's not the UPND that loses, but the people of Zambia; and they'll keep losing until they liberate themselves like Malawians did. More like a man who says to a woman: "it's your loss if you continue rejecting my marriage proposal!" Why do you keep proposing if you have nothing to lose? Such remarks lack the required humility from a potential next president.

Unfortunately, both front-runners in next year's election have ego problems. They are difficult to advise. On one hand, the incumbent wants power at all costs and doesn't want any suggestions against his candidature, while on the other hand, the opposition front-runner feels he has already won and needs to start working on his Cabinet structure. LOL!







PEOPLE in Beirut have expressed anger at the government over what they say was negligence that led to Tuesday's huge explosion.

President Michel Aoun said the blast was caused by 2,750 tonnes of ammonium nitrate stored unsafely in a warehouse.

Many have accused authorities the of corruption, neglect and mismanagement.

The blast killed at least 137 people and injured about 5,000 others, while dozens are still missing. A two-week state of emergency has begun.

How ship's deadly cargo ended up at Beirut port

French architect Jean-Marc Bonfils, involved in rebuilding the city after the civil war, and firefighter Sahar Fares, one of the first responders at the scene, were among the first fatalities to be named. A German diplomat was also among the dead.

French President Emmanuel Macron - the first world leader to visit since the tragedy - was mobbed as he walked through the city on Thursday, with residents imploring him to help and denouncing their leaders.

"Help us, you are our only hope," one resident called out. "Please don't give money to our corrupt government," said another, before adding: "We can't take this any more."

At a press conference, Mr Macron said a new political order was needed in Lebanon. "The anger I saw in Beirut today also showed signs of hope for the future," he said.

He said France would help organise international aid to Lebanon. Funding was available, he said, but political reforms had to take place before it could be sent.

He vowed that there would be no blank

cheques for Lebanon's leaders, but cautioned that he could not tell the Lebanese government what to do. France is the former colonial power in Lebanon.

Filmmaker Jude Chehab told the BBC: "Beirut is crying, Beirut is screaming, people are hysterical and people are tired."

Chadia Elmeouchi Noun, a resident currently in hospital, said: "I've known all the time that we are led by incompetent incompetent people, government... But I tell you something - what they have done now is absolutely criminal."

On Wednesday, the government announced that a number of port officials were placed under house arrest pending an investigation into the explosion.

The country's Supreme Defence Council insisted that those found responsible would face the "maximum punishment". Meanwhile, Amnesty

International and Human

Rights Watch (HRW) have called for an independent investigation into the blast. In a statement, HRW said it had "serious concerns

about the ability of the Lebanese judiciary to conduct a credible and transparent investigation on its own". BBC

# Fire in India Covid hospital kills eight in critical care

SENIOR fire department official Rajesh Bhatt told BBC Gujarati that the blaze had spread after a staff member's PPE kit caught fire due to a short circuit.

"The staffer started running around the critical care unit in panic and the fire spread as a result," he said.

Police have detained one director of the hospital and begun investigation.

The incident took place at 03:00 local time (21:30 GMT).

Mr Bhatt said that the fire had been brought under control after about an hour and that 40 other patients in the hospital had been transferred to a different facility.

He added that he and his team would have to undergo quarantine as they had come in close contact with many Covid patients.

Prime Minister Narendra Modi who served thrice as chief minister of Gujarat state

- of which Ahmedabad is the capital - tweeted that he was "saddened" by the incident, adding that "administrative support" would be provided to the families of victims.

Current Chief Minister Vijay Rupani also tweeted, offering condolences promising and an investigation.

Meanwhile, family members of some victims alleged that the hospital had delayed calling the fire department and had also not informed some family members about the fire. "Hospital staff members did not give us any information. Noone is talking about how the fire started and what happened," one man, who preferred to remain anonymous, told BBC Gujarati. Police have been given three days to determine who was responsible for the incident. They have registered a case of accidental death and detained one director. BBC

# Scientists in Rwanda identify drug resistant Malaria parasite

A DRUG-resistant strain of the samples from patients in Rwanda. highly significant moment. Today combination of two

parasite that causes malaria has been identified by scientists in Rwanda.

The study, published in Nature, found the parasites were able to resist treatment by artemisinin - a frontline drug in the fight against the disease.

This is the first time scientists have observed the resistance to the drug artemisinin in Africa.

The researchers warns that this "would pose a major public health threat" in the continent.

Scientists from the Institut Pasteur, in collaboration with the National Malaria Control Program in Rwanda (Rwanda Biomedical Center), the World Health Organization (WHO), Cochin Hospital and Columbia University (New York, USA) analysed blood

They found one particular mutation of the parasite, resistant to artemisinin, in 19 of 257 - or 7.4% - of patients at one of the health centres they monitored. Evolution of parasites

In the journal article the scientists warned that malaria parasites that developed a resistance to previous drugs are "suspected to have contributed to millions of additional malaria deaths in young African children in the 1980s".

When the first malaria drug, chloroquine, was developed, researchers thought that the disease would be eradicated within years. But since the 1950s the parasites

have evolved to develop resistance to successive drugs.

This is a deeply worrying and

marks a setback in the fight against the malaria.

Resistance to artemisinin is not new as it has been in parts of South East Asia for more than a decade.

In some regions there, 80% of patients are now infected with malaria parasites that resist treatment.

But Africa has always been the biggest concern - it is where more than nine in 10 cases of the disease are.

It appears as though the resistance evolved in malaria parasites in Africa rather than spreading from South East Asia to the continent.

The result, however, is the same malaria is getting harder to treat.

Malaria infection is now treated commonly with

а

artemisinin and piperaquine.

But then malaria parasites started developing a resistance to artemisinin as well - this was first recorded in 2008 in South East Asia. At the time scientists they feared that resistance to artemisinin could also occur in Africa and have devastating consequences

The research indicates that these fears may have been realised. In 2018, African countries accounted for over 90% of the more than 400,000 deaths from malaria recorded.

When the Court of Arbitration for Sport (CAS) panel lifted Manchester City's two-year ban from the Champions League, it represented a seismic and humiliating defeat for UEFA.

The European governing body had taken a year to investigate the Premier League club and concluded they had committed "serious breaches" of Financial Fair Play (FFP) regulations between 2012 and 2016.

A three-day hearing by the independent CAS, however, dismissed the punishment.

The credibility of UEFA's investigation was only held together by the fact that City were "strongly condemned" for failing to assist the investigation and fined €10 million (£9m/\$11m) for their obstruction - reduced from €30m (£27m/\$33m).

# **Forest Rangers back in title race**

"The committee therefore made the following ruling: Your appeal is upheld and the decision of the disciplinary committee is set aside. Therefore, the game between yourselves and Zanaco FC must be replayed and the result of the match be taken into account when the final league standings are compiled."

As of yesterday, the permutations were such that Nkana were set to win the league after the Forest win but with the ruling,

the Kitwe giants will have to wait for the game on Sunday.
