And Hichilema says Health Minister Dr Chitalu Chilufya's acquittal is a sign that the PF has continued mocking and intimidating the judiciary and law enforcement agencies.

Commenting on President Lungu's remarks that he would now take charge of the economy because it was shutting down in some sectors, Hichilema argued that removing the latter would be the first step to reviving the economy.

"Now he has eight months to go, what economy can he run in eight months? He has been a disaster to this country's leadership, hence the collapse to the country's economy. He has no capacity to run an economy, he knows that. Am I the one who is accusing him? No, who has said that? Himself. So, let us all agree that there is failure under his leadership, disaster under his leadership; corruption has gone up, debt has gone up, nothing is working," Hichilema said.

"So, as Zambians, let us

pack that debate because we have been debating whether PF will run the economy better or will improve the economy. The next issue is which party is the alternative? It is the UPND. We must settle the debate, no more arguments, including him where Lungu sits, he knows that UPND is a superior alternative to him in terms of running the country. Now is another time for us to work together to help this country, to retrieve this country by the confession of Mr Lungu from the total collapse where it is now."

Hichilema questioned how President Lungu could fix an economy he had failed to run from the time he took over office.

"His comment to start with is a clear indication that he accepts that the economy is in a bad shape, that the economy has deteriorated so much. So, there is no argument about that. I think before, the PF were claiming the economy was doing well, there is

no economy that is doing well, everything is down, growth is down. When he inherited this economy, he found it growing at six percent by 2019, it was down to 1.9 percent. Year end, we are going to be in a serious recession, the first in over 20 years, the growth will be negative. So he acknowledges that, that is good news," Hichilema said.

"The question is that he is saying he is now going to take charge of the economy, so the second acknowledgement from that statement is that he was never running the economy from the day he took over. So what has he been doing for these seven years? What has he been doing? He has been playing around, his government has been engaging in corruption; buying expensive fire tenders, buying himself a \$65 million jet which is only driven by extremely rich people. He has been spending taxpayer money at the expense of keeping children in school, at the

expense of creating jobs for the youths." And Hichilema said Dr Chilufya's acquittal was no

> surprise. "On Chitalu Chilufya's acquittal, everybody knew it was coming, that he was going to be acquitted. He never respected the courts, he went with a horde of youths and took over the Magistrates' Court Complex. A Minister in the UPND government, can he do a thing like that? No! But in the PF, under Mr Lungu, yes you can do that because birds of the same feathers flock together," Hichilema said.

"So abuse of the judicial system, what else did they do, we expected him to have resigned during the process of prosecution to give a fair adjudication, to allow the judiciary, the Judge the Magistrate and the Judicial system there to operate independently, that did not happen. So there was actually an intimidatory behavior that was exhibited which took away the freedom of the court to adjudicate in a fair manner. If he shouldn't have resigned, he should have been removed, he should have been at least suspended and that will be happening in the UPND government.nYou are going through a court process after investigations, not before you have to take leave of absence from office if you don't, you will be suspended to allow that fair adjudication." ARC Tours sues Kaizer over outstanding K132,665 in unpaid air tickets

ARC Save Travel Tours and Car Hire Limited has sued President Edgar Lungu's former special assistant for political affairs Kaizar Zulu seeking payment of over K132,000 owed to it in outstanding air tickets.

ARC Save Travel Tours and Car Hire is claiming K132,665 being monies owed for air tickets as well as damages for loss of use of funds.

It's further seeking interest at the BoZ short deposit rate from date of issue of writ to date of judgement and thereafter at the commercial bank lending rate and costs.

According to a statement of claim filed in the Lusaka High Court Commercial Registry, ARC Save Travel Tours and Car Hire stated that Zulu engaged it between October 25 and November, 27, 2017 for the provision of air tickets for various individuals on his account.

It stated that Zulu was issued some invoices on the account, but added that the remaining balance in the sum of K132,665 on his account had not been settled to-date.

ARC Save stated that it, through one of its directors, engaged Zulu on several occasions reminding him of his indebtedness, but to-date he had not settled his dues to the company.

Mulopoto, the managing director of GOSVIN Engineering Ltd stated that upon applying for land in Ndola, the applicants were allocated two pieces of land and subsequently issued with Certificates of Title in January, 2019. He stated that the pieces of land still remain registered in the

He further stated that they have not permitted Lusambo to undertake these works nor, indeed, enter their said land.

Mulopoto added that Lusambo's blatant entry and excavation with impunity was illegal and ought to be stopped to obviate their suffering irreparable damage.

"That due to the negative response by the defendant (Zulu), the plaintiff (ARC Save), through its advocates Messrs Andrew & Partners, wrote a letter of demand to the defendant on June 12, 2020, which letter has not been received by the defendant as he has been avoiding phone calls from the law firm," read the claim.

"All efforts to locate the whereabouts of the defendant have proved futile even after engaging a courier service to locate the defendant at his last known place of business."

ARC Save stated that Zulu had made promises via WhatsApp messaging to one of the directors, a Ms Jessy Lengwe, but to-date hasn't fulfilled his promises. It added that Zulu had since refused, neglected and/or denied to have the balance of K132,665 on his account cleared.

ARC Save stated that as a result, it had suffered grave loss and inconveniences.

"First and foremost, the UPND don't exist in Northern Province because they don't have candidates.

That is the more reason they picked a reject. They were supposed to ask us, PF, why we rejected Mulenga. He is a reject! We rejected him, we didn't want to adopt him

because there are too many skeletons in his cupboard. So, that is the more the reason we rejected him and they picked a rejected person. It means that they are not there in that province," Mwila said.

"The UPND is not on the ground, they don't have the structures, they don't have the people. That is the more reason they didn't have a candidate. All of a sudden in less than two weeks, someone is rejected, you just go and pick him, which means that they are not even ready for the election."

And Mwila said the party was not threatened by the NDC's decision to support the UPND in the upcoming by-elections, as the PF were guaranteed victory in all the by-elections.

"When it comes to the Alliance, it is not a threat, NDC's Chishimba Kambwili in his own mouth said, 'we are going to form government.' If they are going into an alliance, how are they going to form government? It means that he wants help from the UPND; individually, they cannot defeat the PF that is what it means. So, it is a weak party and the NDC is now finished! It is nowhere that is why they can't field candidates. They now want to be helped by UPND, but they will be swallowed by the UPND! They can't field candidates, they want to be supporting another political party," argued Mwila.

"We will carry the day in Mwansabombwe as well as Lukasyha. We have to win all the upcoming by-elections, including the wards, because the people of Zambia want development and PF is delivering development, that is what people want. You saw what happened in Chilubi (constituency), that is what will happen in Lukashya. We have penetrated in Western Province out of six, we won five. In North-Western, out of seven, we won three. So, we have continued winning and we have five in Lufwanyama, which is the stronghold for UPND. We expect to get all of them."

Speaking when he featured on Spring24 TV news live programme, Wednesday, Ngulube said as the Minister's lead counsel, he was working round the clock to ensure that his client is not victimised again.

"They are entitled to arrest him if they have got evidence that he has done something wrong. They are entitled to come up with new allegations and he will be called upon to answer. And if they have facts, I don't think we can stop them because they are just doing their job. They are mandated by law to arrest, and to take cases to court. But we can simply say that as Dr Chitalu Chilufya's lead counsel, I am actually working 24/7 to make sure that our client is not victimised again on all these offences. And one other important thing is that if he wanted, Dr Chilufya can sue and claim a lot of money because his reputation was damaged, he was called a thief and the ACC were parading him, they held press conferences, they demeaned him as an internationally recognised medical doctor who is also Minister of Health and also a businessman. They can pay him no less than K10 million kwacha," Ngulube said.

"They can pay him a lot of money because the damage they caused him is huge. At the moment, we don't want to sue because Dr Chilufya is a very peaceful man and he is not even contemplating to sue anybody but if they begin to harass him, it will be option number one. We may have to take them in so that we can actually recover something from them." He said it is sad that government institutions like the ACC were relying on social media propaganda to prosecute people. "The defence team is very happy with the outcome of the proceedings because we were anticipating that result. We know that from the beginning, Dr Chilufya was innocent and he should

not even have been tried in the first place. It's sad that now, we have government institutions relying on social media reports and social media propaganda and people can just wake up today and say 'Tutwa Ngulube has stolen' and the ACC stands up and starts prosecuting me. We must only take cases to court where there is evidence. And so we want to state that our client was in very high spirit, he was very strong in court [and] he never faked any illness as we have seen when politicians are in court because he knew that he was innocent. And that is why you saw even his caliber, his demeanour and everything showed that he had nothing to hide," Ngulube said. Ngulube described

Dr Chilufya's case as an academic exercise, saying the ACC lacked evidence from the onset.

"We can state that it was an academic exercise just from the day they did a warn and caution statement. The ACC could not clearly state what offence they were going to present in court and that is why you saw the back and forth, the dilly dallying. The ACC got five witnesses and amongst the witnesses, it was the evidence that they presented that was not equal to the charge which they gave him. The arresting officers, the investigators and everyone they called was actually saying that they did not see anything wrong. So how else would they have presented that case if the investigators themselves say that 'when we analyse all the earnings, Dr Chilufya cannot fail to have K270,000 kwacha in five years? Dr Chilufya cannot fail as a businessman or as a minister to have US \$200,000 in a period of seven years? And that US \$200,000 was nonexistent. It was never there and the witnesses themselves said 'we never saw it, we just heard on social media.' So, how were you expecting the courts to convict a person when there is no evidence to support the claim?" he wondered. He said the Minister's acquittal was never related to the Contempt of Court charge against ACC director General Rosemary Kuzwayo. "And the contempt of court case against ACC

director general Rosemary Kuzwayo was only related to one witness who was suspended. It didn't relate to the rest of the witnesses. And I don't think you can get acquitted because of contempt of court. It's not possible," he said.

And Ngulube demanded that the ACC reinstates Manda, insisting that his suspension was illegal.

"It's illegal to continue keeping him on suspension because... the Penal Code clearly states that 'you cannot discipline someone based on what he has said in court.' We hope and trust that [the ACC] can lift his suspension so that he gets back to work. He was just an investigator and he told the court the whole truth. It was wrong for the acting DG to come out in that way because as far as we know, witnesses have immunities. And we are demanding the immediate reinstatement of Chipampe Manda as an investigating officer so that the matter can all die and we can forge ahead and look elsewhere," he said.

Meanwhile, Ngulube urged the ACC to avoid personalising matters. "We also want to urge

the ACC that before you arrest, kindly investigate. Remember how they came so strong on the allegations against Dr Chilufya? Even when he had been diagnosed with COVID-19 and he was sick, they still insisted that he appears before them. Even when he was not feeling too well, they really mistreated him and made him look like he was a criminal when in actual fact there was no such a thing. So, we want to urge the ACC to emulate other government agencies. Let them look at how the police, DEC, NPA and so on deal with suspects. It is wrong for the ACC to personalise matters and deal with matters as though they are dealing with someone who has already been found guilty," said Ngulube.

Inflation slows to 15.5%

THE annual rate of inflation has marginally decreased to 15.5 per cent in August, down from 15.8 per cent recorded in July, mainly induced by price decreases in food items, according to the Zambia Statistics Agency (ZSA).

Announcing Zambia's annual rate of inflation for the month of August, ZSA Interim Statistician General Mulenga Musepa said that the reduced inflation this month was largely attributable to reduced food prices.

"The year-on-year inflation rate as measured by the all items Consumer Price Index (CPI) for August, 2020, decreased to 15.5 per cent from 15.8 per cent recorded in July, 2020. This means that on average, prices of goods and services increased by 15.5 per cent between August, 2019, and August, 2020. The slowdown in the annual rate of inflation was attributed to price decreases in food items," Musepa told journalists via video conference in Lusaka, Thursday. He added that the reduction in the annual food inflation rate, which dampened the overall annual rate of inflation, was largely driven by price reductions in mealie meal and vegetables.

compared to 16.1 per cent recorded in July, 2020, indicating a decrease of 0.6 percentage points. This development was mainly attributed to reductions in prices of food items, such as cereals (Breakfast mealie meal, Roller meal, maize grain, millet) and vegetables sweet potatoe (rape, leaves, tomatoes, cabbage, pumpkin)," Musepa said. year-on-year "The

non-food inflation rate for August, 2020, was recorded at 15.4 per cent same as that recorded in July, 2020."

Of the total 15.5 per cent annual inflation rate recorded this month, food and non-alcoholic beverages accounted for 8.3 percentage points, while

non-food items accounted for 7.2 percentage points, according to Musepa.

ZSA data shows that Zambia's annual rate of inflation of 15.5 per cent recorded this month, peaked to a near four-year high since September, 2016, when inflation was at 18.9 per cent, reducing to 12.5 per cent in October, 2016, before it dropped to close that year at 7.5 per cent.

The BoZ projected that the country's annual rate of inflation will remain high over the forecast period of eight quarters up to the end of next year, mainly driven by high food prices, but is due to slow down on the back of a maize bumper harvest produced this year.

The case for the disbanding of the Anti-Corruption Commission and why it is a danger to national interest

By way of introduction

The arrest and acquittal of Chitalu Chilufya, the then embattled Minister responsible for health has attracted wide criticism of the Anti-Corruption (ACC) and the Director of Public Prosecutions (DPP). The events surrounding the arrest and prosecution of a sitting Cabinet Minister have surpassed the description of scandal of the century and has shown the deep rooted rot at the ACC and the National Prosecuting Authority (NPA). The turn of events are utterly shocking and a horror to witness as the levels of incompetence exhibited by the ACC in its investigations and prosecuting and the NPA, specifically the DPP, in giving consent to proceed with the prosecution are what Professor Muna Ndulo once called a "comedy of errors".

The history and metamorphosis of the ACC The history of the ACC can be traced to the preindependence era whereby investigative wings were investigating crimes and prosecuting offenders under three main pieces of legislation namely: the Penal Code, the Prevention of Corruption Act of 1916 and the Public Bodies Corrupt Practices Act of 1889. After independence, in a bid to realign the fight against corruption to the existing socio-political and economic context, the United National Independence Party (UNIP) tasked the Zambia Police Force to combat corruption. Section 56 of the Penal Code, Chapter 146 of the Laws of Zambia was the only piece of legislation that was used to prosecute offenders. This provision only concerned itself with corruption offences by persons employed in the public service and did not cover corruption in the private sector.

Enter 1971; the UNIP government under Kenneth Kaunda established the notorious and infamous Special Investigations Team on the Economy and Trade (SITET) to combat mainly corruption and economic sabotage by persons bent on stifling Zambia's economy in the mind of the party and its government. The SITET after causing mayhem and traumatizing many Zambian citizens was abolished in 1992 after the country returned to multi-party democracy and plural politics. Other than SITET, the fight against corruption in the public service was governed by the Leadership Code under the 1973 constitution. This was enforced by the Zambia Police Service and the Zambia Security Intelligence Service.

In 1980, the Corrupt Practices Act No. 14 of 1980 was enacted by the Zambian Parliament which established the ACC as we know it today. The ACC was officially established in 1982 and its main mandate was to combat corruption in both the public and private sectors. This Act was repealed and replaced by Anti-Corruption Act No. 42 of 1996. The current legislative framework governing the ACC is the Anti-Corruption Act No. 3 of 2012. This Act was enacted by the PF majority Parliament to reinstate the abuse of offence which was removed by the Movement for Multi-party controlled Parliament that enacted Act No. 38 of 2010.

The failure of the ACC in light of its mandate The mandate as in the functions of the ACC are found under section 6 of the ACC Act of 2012. For avoidance of doubt the functions are as follows: (iv) creation of committees in institutions for monitoring corruption in the institution; and

(v) enlisting and fostering public confidence and support against corrupt practices;

(b) initiate, receive and investigate complaints of alleged orsuspected corrupt practices, and, subject to the directions of the Director of Public Prosecutions, prosecute—

(i) offences under this Act; and

(ii) such other offence under any other written law as may have come to the notice of the Commission during the investigation of an offence under this Act;

(c) investigate any conduct of any public officer which, the Commission has reasonable grounds to believe may be connected with, or conducive to, corrupt practices;

(d) be the lead agency in matters of corruption;

(e) co-ordinate or co-operate, as applicable, with other institutions authorized o investigate, prosecute, prevent and combat corrupt practices so as to implement an integrated approach to the eradication of corruption;

(f) consult, co-operate and exchange information with appropriate bodies of other countries that are authorized to conduct inquiries or investigations in relation to corrupt practices;

(g) adopt and strengthen mechanisms for educating the public to respect the public good and public interest and, in particular —

(i) create awareness in the fight against corruption and related offences;

(ii) develop educational and other programmes for the sensitization of the media;

(iii) promote an environment for the respect of ethics; and

(iv) disseminate information and sensitize the public on the negative effects of corruption and related offences.

Careful perusal of the functions of the ACC will show that the Commission is reactionary and not proactive in its fight against corruption. In a nutshell and to avoid mincing and wasting words one will see that the Commission has been inept in discharging its functions therefore doing a disservice to the tax payer and the public at large. I stand to be challenged by the Commission and indeed any observer to show me any function above that the Commission may have competently discharged.

Criminal Investigations as a science Any investigator or prosecutor and for that matter one charged with the mandate of dealing with economic crimes must know that investigations are a science. It requires a hypothesis, collection of evidence, analysis and communication before an accused can be arraigned and prosecuted. This is what is called as the "4 Stages of an Investigation". One cannot arrest an individual without evidence and then proceed to prosecute hoping to harvest evidence on the way. The lead investigator in the case testified that he did not find any wrongdoing on the part of Chitalu Chilufya as all the assets alleged to have been corruptly acquired were within the income lawfully acquired by the accused. One wonders how many people have been arraigned on frivolous charges by the ACC if they can do that to a sitting Cabinet Minister. What of ordinary citizens, are they safe? The variance of the evidence between the lead investigator and the position of the Commission as communicated to the press raises a lot of questions which require that heads roll at the Commission and radical changes made instantly. Who was lying between the investigator and the Command at the Commission as to the evidence against Chitalu Chilufya?


The ACC does not prosecute offences under the ACC Act until the DPP gives her consent. Section 64 of the Act provides that:

(1) A prosecution for an offence under Part III shall not be instituted except by, (2) Notwithstanding subsection (1), a person may be charged with an offence under Part III and may be arrested, or a warrantfor that person's arrest may be issued and executed, and the person may be remanded by the court in custody or on bail notwithstanding that the written consent of the Director of Public Prosecutions to the institution of a prosecution for the offence with which that person is charged has not been obtained.

(3) Where a person is brought before a court before the written consent of the Director of Public Prosecutions to the institution of a prosecution against that person is obtained, the charge shall be explained to the accused person but the accused person shall not be called upon to plead or with, the consent of the Director of Public Prosecutions.

Thus, the DPP must have seen the evidence before granting her consent to prosecute and if she did, why was there comedy in the handling of the case. If it was as a result of incompetence on the part of the ACC why didn't she take over the proceedings by exercising her constitutional right under Article 180 (4) (b) of the Constitution of Zambia, Chapter 1 of the Laws of Zambia as amended by Act No. 2 of 2016? In the absence of evidence to the contrary and explanations to that effect then assumptions may be made one of which is of collusion in the Donald Trump magnitude.

The arrest and prosecution of Cabinet Ministers and other political players on baseless evidence is a danger to the fabric of society. By Sipilisiwe Ncube UPND president Hakainde Hichilema yesterday took on Edith Nawakwi on radio and engaged in a strong exchange of words after the FDD leader called him a thief.

Featuring on Hot FM's Hot Seat programme, Thursday, Nawakwi said Hichilema was a rich man who lacks wisdom and is self-conceited, with no respect for anyone.

But Hichilema took exception to being labelled a thieve and challenged Nawakwi to provide evidence of her allegations so that he could respond and clear the air.

Hichilema also confronted Nawakwi on her claim that the UPND president bought his house in Sable Road from Lima Bank, saying the FDD leader was using the radio station to spread lies out of hatred.

After the radio programme, the duo later took the feud to social media, with Hichilema "Maybe she has posting: a crush on me", "When they fail to defeat you on substance, they'll resort to lies" and "Do you know what goes well with beans? Legana sausages".

Nawakwi, on the other hand posted: "Reporter: Madam President, your comment over the recent post from the young man? EZN: Well... you see, I'm a mother. I don't play games with little boys, I #fix them..", in apparent response to Hichilema.

Earlier during the Nawakwi programme, explained that Hichilema swindled the country by under-declaring assets which her ministry was selling, like Intercontinental Hotel in Livingstone, without declaring interest.

'Time and again people Hakainde Hichilema ask how he became rich? And that is the question. And he gets so upset about that question. What I noticed from his speech is that he says 'at the time of privatisation, MMD was the one in government, I was young' he says. And how could I at my age of 29 sell mines?' I want to tell the nation that if he was 29, I was 30 and I was Minister of Finance. He says he was young, and this is why government has created Katombora reformatory for young criminals. It is not because you are young that you cannot be a criminal but Katombora reformatory is there for people who are young. So, the story of him being young is not there. The behavior of Hakainde Hichilema is equivalent to Nabal in the Bible. Nabal in the Bible is a very rich man but he lacks wisdom, he is self-conceited, and he doesn't respect anyone. He doesn't create any relationships," Nawakwi said.

brought him to book for corruption over the house he illegally occupied which she claimed belonged to Lima Bank.

"If he has been lucky not to be booked by the Anti-Corruption Commission, he should just keep quiet because he should say he is lucky. As former minister of agriculture, you should ask him for my role. We wanted to restructure Lima Bank and we gave Grant Thornton the opportunity to advise government on receivership. And they went ahead and did a liquidation of Lima Bank. I just want Hakainde to answer one question. Is he able to produce the bid and the price which gave him the house in Sable Road where he has been residing until we moved to Mukamuya in Lusaka East? This is a Lima Bank house. Under our current laws and even previous laws, that is theft and corruption. You cannot give a public officer, and you are not just a public officers just because you are in government. He was advisor to government. So, to the extent that Grant Thornton was a receiver for Lima Bank and Hakainde alienates a house to himself, that is theft. He is lucky if he hasn't gone to Katombora. He is lucky if the law hasn't visited him," she said.

She said if Hichilema

said she was sleeping when she was finance minister, it is because he is also a thief who goes to steal while the owners of the house are sleeping.

"Hakainde Hichilema, under my watch as minister of finance, we were selling Intercontinental Hotel in Livingstone and the foreigners were there. He brought them as advisor. And when they had stood up, I say 'Mr Hichilema, do you think this US \$6 million is a fair price for the government?' he was a professional and young and it's not wrong for the government to trust a young man. You will think that this is a Zambian that has the interest of the country at heart. His answer was 'yes madam minister, the price of \$6 million for Intercontinental Hotel in Livingstone is a fair price'. He says I was sleeping, thieves come when you are sleeping. That is why they break in [because] they come with guns. However, the very next day when we had finished the transaction on Intercontinental Hotel and it had moved to be Southern Sun, Mr Hichilema became the chairperson of the new owners. Isn't that conflict of interest? That is why I am saying that he is lucky if he hasn't been probed. Prior to privatisation, how much money did Mr Hakainde Hichilema have? He should say that," Nawakwi charged.

Nawakwi said Hichilema must learn to build relationships in politics.

"Hakainde must learn that building bridges and relationships is important in politics. Each time that they, on their side, open their statements to talk about me, it's either 'no, Nawakwi is going to be minister of finance for Lungu, Nawakwi has defected'. I have even been appointed by websites like Koswe but this is in the attempt to try and bring others down and this should stop. You can't say that I have stolen because the owners were sleeping and you go boasting around. I think that is unacceptable. Can he actually tell us the bid price for the house in Sable road? How much he paid and why they, as Grant Thornton who were the receivers ended up sharing the houses amongst themselves?" she asked.

At this point, the interviewer played an old clip where Hichilema challenged Nawakwi and Alexander Chikwanda to explain where they were when he, a 29-year-old man was allegedly selling the mines.

The interview then asked Nawakwi to explain why the UPND leader was not prosecuted, to which

Nawakwi said the UPND leader was lucky to have evaded prison.

"So, when you say that why he wasn't visited, [it's] because in this country, the only corrupt [people] are those in government. [But] those who are outside looting and using government means are never followed. I think you saw that when we left as MMD, a lot of my colleagues were in jail and even now, the people who are being followed are those in government. Those who were advising government have never been questioned or followed. And it's a very unfair situation," said Nawakwi.

FDD The leader went on to make several other accusations against Hichilema, saying his way of raising money is by grabbing communal land and giving it to his animals for grazing.

But speaking when he called in during the programme, Hichilema challenged Nawakwi to put the allegations against him in writing so that he could exculpate himself.

"I want to make a public response since your guest there made a public accusation that I benefited from a house that belongs to Lima Bank. Let me put in on record once and maybe for all. I have never bought a house openly or dubiously though Grant Thornton from Lima Bank, never ever. Land records are very clear. The beautiful thing about land is that you can't lie. So I am afraid, Madam Nawakwi, you are telling a lie on that public radio," said Hichilema.

"I would like you to make that allegation to me in writing and I will respond to you and you can put a copy Hot FM because they are the platform you have used. I will respond and give you the details that I have never bought a house from Lima Bank. I don't steal, I will never steal and I was never brought up like that. That's malicious and damaging. I don't have time to pursue lies which are told openly out of hatred. I have no time for that. So, you are lying on that radio and it's unacceptable that you can tell lies on public radio stations. So, I would like you and I to settle this matter through Hot FM. I have never even sold a mine Edith, you know that. Thank you very much."

Meanwhile, PF deputy secretary general Mumbi Phiri also called in, urging Nawakwi not to feel intimidated but to do as Hichilema advised so that the public could see who the liar was.

"Since my sister you have been given a challenge, you talked about the Lima Bank house, and you talked about Intercontinental, and as he has challenged you, put down your data so that you tell us in details. And he has said that you come back to Hot FM and I hope that is going to help us so that this can be put to rest once and for all. And don't feel intimidated in whatever way you are called. For me, Mr Hakainde Hichilema is my son in law but do you know that he called as a woman with a lot of talk time with no substance? I challenged him and in fact, I have a list of UPND MPs who benefited from the land they call corruption Forest 27. And I repeat that I have their numbers, and their NRCs. Jack Mwiimbu got in the name of the wife, Moono Lubezhi got it and put it in a company, Musheli Mulyata got and put it in the daughters name, only [Ephraim] Belemu got it in his name because he is not dubious. You can imagine, when you are pointing a finger at somebody, be clean yourself. So, I will pray for you that you put that data together we see who is telling the truth," said Phiri.

Nyirenda was never duly elected NAREP president, Maboshe's group tells court

NEWLY-APPOINTED National Restoration Party (NAREP) president Charles Maboshe and his group are counter-claiming a declaration and order that Steven Nyirenda was never duly elected as party president as he is ineligible to assume any elective position at any level of the party in accordance with their party constitution.

Maboshe and others are further counter-claiming a declaration and order that the decision of the party's National Executive Committee of August 15, 2020 to remove Nyirenda as party president was valid and in line with the provisions of the party constitution. They also want an order compelling Nyirenda, his employees or agents to hand over control of all bank accounts of the party and that he renders an account of all money received for and on behalf of the party from the time he illegally assumed the position of party president.

its goodwill and fortunes owing to his illegal ascension to the position of party president, his divisive tendencies, alien ideologies and unilateral albeit illegal decisions in the running of the party.

This is a matter in which Nyirenda and three others have sued Maboshe and other party members in the Lusaka High Court, seeking a confirmation and declaration that the former was duly elected as NAREP president.

Nyirenda and the others further want a declaration that the decision purportedly passed by the defendants that Nyirenda is no longer NAREP president be declared null and void, as well as, damages for breach of party constitution.

But in a defence and counterclaim filed Wednesday, Maboshe and others argued that Nyirenda had never been legally or constitutionally elected as president of NAREP as he had at all material times been ineligible to ascend to the position of party president either through an election or appointment.

They further stated that Banda had never been the secretary general of NAREP and therefore, had no capacity to commence the action in any representative capacity of the party whatsoever.

Maboshe and others further want a declaration and order that all appointments and decisions made by Nyirenda, including the purported appointment of Ezra Banda as secretary general, are null and void.

They have stated in their counterclaim that Nyirenda has caused serious embarrassment to the party and eroded

Nyirenda, Banda, the party vice president Mwelwa Ngosa and national chairperson Jimmy Mubambwe have sued Maboshe, the party vice chairperson Ezra Ngulube and other members, Maybin Kabwe, Frank Sichone, Evelyn Malongo, Susan Chipeta and Thomas Kayola, as defendants.

Last week, Lusaka High Court judge Wilfred Muma granted Nyirenda and the other three plaintiffs an ex-parte order of interim injunction, restraining Maboshe and others from interfering with the administration, governance and use of the party secretariat.

Justice Muma further prohibited the defendants from issuing out statements

The defendants further submitted that Maboshe was now the legally appointed acting president of NAREP while Ngulube was the legally recognised secretary general of NAREP and not an ordinary member of the party.

They further stated that Kabwe was the legally recognized chairperson in-charge of mobilisation of the party while Sichone was the spokesperson.

Maboshe and others stated that Malongo, Chipeta and Kayola were, in fact, constitutionally recognized as members of NAREP, national committee, executive national women's chairperson and national chairman youth respectively.

THE EMPEROR'S FAULT TOOLS

By Andyford Mayele Banda INCE President Edgar Lungu assumed office in January 2015, he has worked with a record four Finance Ministers. He inherited Alexander Bwalya Chikwanda, before hiring Felix Mutati and after pushing him out to Ministry of Works a move which was clear that he was on his way out he then promoted Margaret Mwanakatwe from Commerce before firing her for Dr. Bwalya N'gandu from Bank of Zambia. That's an average of 1 year four months on the job for each Minister which is clearly a situation that doesn't demonstrate stability in a key Ministry like Finance. Just last weekend he fired the Bank of Zambia governor Dr. Denny Kalylaya in unclear circumstances.

The President now says he wants to be in charge because the economy is almost collapsing. Around 2015 at the time of deciding to form the People's Alliance for Change (PAC) party, to us the economy was already collapsing. Tell us what is happening now that was not happening then. The Zambian Kwacha depreciated beyond K10 mark for the first time, to us that was alarming. Load shedding was at its worst for the first time in the history of this country and that was alarming too. They were no clear initiatives to spur job creation and empower small businesses, medicines in hospitals were still scarce and a whole lot of other things. Seven months in the job we expected a response from a new President who would stir the country into a different direction but the response to all these challenges was less than inspiring if there was any response at all. From then on, we were convinced that at this rate the future was bleak. Yes, we knew it will be worse, and our fears have come to pass and it's a fact that the situation is worse today than it was then. Whose responsibility is it to be where we are today? Is it all the people that have been fired or it's the appointing authority? On the 29th March 2019 we wrote an article entitled "The Emperor's New Clothes" in News Diggers. The Emperor's New Clothes is a short tale written by Danish author Hans Christian Andersen. It talks about a vain emperor who cares too much about wearing and displaying clothes, such that he hires two weavers who claim they can make the most beautiful clothes and elaborate patterns. The weavers are actually

con men who convince the emperor they are using a fine fabric invisible to anyone who is either unfit for his position or "hopelessly stupid". The con lies in the fact that the weavers are actually only pretending to manufacture the clothes. Thus, no one, not even the emperor nor his ministers can see the alleged "clothes", but they all pretend that they can for fear of appearing unfit for their positions. Finally, the weavers report that the suit is finished and they mime dress the emperor who then marches in procession before his subjects. The townsfolk uncomfortably go along with the pretence, not wanting to appear unfit for their positions or stupid. Finally, a child in the crowd blurts out that the emperor is wearing nothing at all and the cry is then taken up by others. The emperor realizes the assertion is true but continues the procession.

Looking at where we are as a country, there are many similarities to this story. The President and his entire leadership are definitely in denial. Clearly from the onset, you see that the President has tried to lump the economic collapse on the Finance Ministry and now, it seems even with the appointment of Dr. Bwalya N'gandu from Bank of Zambia, the collapse doesn't seem to be slowing down. Now the tools that are faulty are at Bank of Zambia where Dr. Bwalya N'gandu came from just slightly over a year ago and his former boss is the fired Dr. Denny Kalyalya. By the way did the President consult his Finance Minister before firing his former boss? And what could have been his opinion? Laugh Out Loudly!!!

The economy cannot be isolated to a number of things happening in this country and if the President will blame individuals for what's happening in this country then he won't get it right even if he is trying to pretend to do so. To sort out an economy you cannot isolate one problem from the other. You have to be ready and brave enough to deal with every corner. Otherwise stop wasting your time getting rid of people who may be good people while you are making the situation worse for the majority Zambians just because of your selfish ambition to continue ruling. One of the reasons why the economy has collapsed is because of corruption and looting in government. Meanwhile, the matter comes up today for hearing of the motion to cancel the warrant of arrest.

On Tuesday, Lusaka Resident Principal Magistrate David Simusamba issued a bench warrant against Kambwili after he failed to appear in court when the matter came up for continued defence.

The warrant against Kambwili was returnable on September 31, this year.

Magistrate Simusamba wondered how Kambwili, who was purportedly sick, could be issuing statements through the media.

But Kaluba in an affidavit in support of notice motion stated that the accused had been sick from August 9, 2020, and was put on bed rest, which had been extended to September 1, 2020.

"The record shows that when this matter came up on August 25, 2020, the accused was not before court and I explained to this honourable court the reasons for the accused's absence. I stated that the accused had been sick from August 9 and was put on bed rest, which had been extended to September 1, 2020," Kaluba stated.

Kaluba stated that he did not produce the third medical certificate, which extended the accused's bed rest to September 1, 2020, but informed the Court that he would produce it later because it was sent to him shortly before the proceedings were about to start.

He stated that in his ruling, Magistrate Simusamba rejected the application for an adjournment on grounds that it was in the public domain that the accused was making public statements the previous day, implying that he was not sick.

when committing a crime. These people have nothing to hide. They don't care what people say. But all this pomposity shall come to pass. The same Anti-Corruption Commission which they are challenging people to report them to will grow teeth soon.

Government is not there to enrich politicians. The criminality and arrogance we are seeing will soon come to an end. Like State Counsel Wynter Kabimba rightly observed, the paupers who are stealing and boasting about their stolen wealth will soon get back to being nobodies. We hope they know the consequences of what they are doing and they have signed up to join the congestion in prison, because the money they are taking has a way of getting back to its rightful owners.

We feel sorry for these criminals who are in a looting competition

because they don't understand how political power shifts. We have warned before that when vou are a minister, it does not mean that the country's resources belong to you. When your father is the President, it does not mean that you can take everything you want from the State.

Look at what is happening in Angola! When Jose Eduardo dos Santos was president, his children took advantage of his position to loot that country's national resources. The President's daughter became Africa's richest woman. Where is she today? Investigations have documented how she amassed a fortune during her father's threedecade long presidency. In December last year, the Angolan court froze all personal and corporate bank accounts belonging to Isabel dos Santos, her husband and business partners.

Angolan prosecutors subsequently charged her with fraud and embezzlement in a bid to recover around US\$1.1 billion they claim she and her associates siphoned from that country's coffers. What happened next, following a request from Angola, Portugal also froze her considerable assets offshore. Within a few months, the richest woman in Africa has been reduced to a suspected criminal, toiling from courtroom to courtroom.

Isabel is not the only one facing justice. Just this month, her brother, José Filomeno 'Zenu' dos Santos, was convicted and sentenced to five years in prison for fraud, money laundering and influence peddling. This illustrates the downfall of the former presidential family which was once extremely powerful and wealthy. The money they bragged about cannot save them, it's useless.

The criminals in

Zambia who are serving in government must draw lessons from Angola. What is happening to Isabel and her brother is not restricted to the President's family. It can happen to anyone who abuses public office. We have seen people who feel so powerful and they are also calling themselves presidents. Since they are close to the Head of State, they have gained a false sense of confidence to think that they are small presidents managing ministries and provinces.

Political power is temporary. A President can lose elections, a President can resign, a President can die in office, and we have seen this happen more than once in Zambia. The moment a President leaves office, there is realignment of power. The forces converge and there is a new order, whether you like it or not. Look at what happened after Sata died? Who knew that

'Catastrophic' Hurricane Laura lashes Louisiana

HURRICANE Laura has struck the US state of Louisiana, causing flash floods, severe damage to buildings and power cuts to more than half a million homes.

It is one of the strongest to ever hit the US Gulf Coast, striking at category four with winds up to 150mph (240km/h).

Laura's storm surge has not reached the levels feared but is still considered life-threatening, and could spread 40 miles (65km) inland.

Half a million residents had been told to leave parts of Texas and Louisiana.

Louisiana Governor Iohn Bel Edwards said early on Thursday: "We've had daylight now for a couple of hours. It appears there is more structural damage from the wind and a little less flood damage than we anticipated."

He confirmed the first fatality in his state, adding: "I suspect that won't be the last, although I pray that we don't have more."

A spokesman for the State Office of Homeland Security and Emergency Preparedness later told CNN of another two deaths.

Governor Edwards also warned of a "chemical fire" at an industrial plant in the Lake Charles area, urging people to shelter in place and close doors and windows. Donald President Trump had spoken to the governors of Texas and Louisiana, the White House confirmed, and encouraged "all in the storm's path to listen to the safety guidance of state and local officials". Laura and another storm, Marco, earlier swept across the Caribbean, killing 24 people.

'I'll speak for myself' - Suarez breaks silence amid Barcelona exit rumours

LUIS Suarez has hit back at comments made by his former lawyer Alejandro Balbi that suggested the Uruguayan's future would be linked to that of Lionel Messi, with both players looking likely to leave Barcelona ahead of the 2020-21 season.

Messi recently rocked the football world with the revelation that he longer wishes to see out the remainder of his career at Camp Nou, expressing

his desire to leave Barca amid one of the most tumultuous periods in the club's history.

Indeed, there have been widespread calls for club president Josep Maria Bartomeu to step down, with his time in office seen as a disaster both on and off the pitch.

The appointment of Ronald Koeman, a club legend, was seen as a move to appease players and fans, but the Dutch head coach

is reported to have told Suarez to find a new team as he is not part of his longterm plans in Catalunya.

With the striker being close friends with Messi, a destructive fall-out ensued, with Balbi among those to have weighed in on where both Messi and his former client may end up come next season.

"Messi's future will have an influence on Suarez's because they are best friends, thev

get along on and off the pitch," the lawyer claimed in an interview with TyC Sports. "There is a lot of brotherly love between Messi and Suarez, they are inseparable, always together."

While there can be no doubting that Messi and Suarez, whose families have holidayed together several times, are indeed close friends, the latter took to social media on Thursday to distance himself from Balbi's comments.

"There are people talking about me or on my behalf when I have not had confirmed.

The 27-year-old had been named in the world champions' squad for upcoming fixtures against Croatia and Sweden but has now been forced out of consideration for selection.

Speaking at his press conference after the squad announcement. Deschamps said: "I was led, at the very last minute, to make a change in the list. Paul Pobga was in this list. Unfortunately for him, he took a test yesterday, which turned out positive. So at the last moment, I had to replace him with Eduardo Camavinga".

Pogba has been replaced in Deschamps' squad Rennes by midfielder Camavinga, while international teammate Tanguy Ndombele of Tottenham also misses out.

It means Pogba will have to spend 14 days in isolation - meaning he will miss the start of Man Utd's pre-season preparations, which begin next week following their extended 2019-20 season as they reached the Europa League semi-finals. However, he should be able to play in United's first game of the 2020-21 Premier League season, against Crystal Palace on September 19. The Red Devils start their domestic season a week later than most of their rivals to allow them additional rest due to their exploits in Europe.

He is said to be asymptomatic, however the positive test means Deschamps has no option but to leave out one of his key players for the first set of men's international fixtures played in Europe this calendar year.

A statement from United read: "Pogba has been replaced in the squad after testing positive for COVID-19. The midfielder will be unable to add to his 69 caps and 10 goals for his country in the games next month. Everybody at United wishes Paul a speedy recovery ahead of the new season."
