

We agree with LAZ that **ConCourt didn't deal** with eligibility, but Lungu qualifies – Mundubile

PATRIOTIC Front chairperson for legal affairs Brian Mundubile says the Patriotic Front agrees with the Law Association of Zambia (LAZ) position that the Constitutional Court did not deal with President Edgar Lungu's eligibility for the 2021 election.

Mundubile, however, insists that President Lungu is eligible to stand in 2021 because he will have only served one term of office by then.

Last week, the Law Association of Zambia (LAZ) said the Constitutional Court did not deal with the eligibility case of President Lungu.

In an interview, Mundubile said the party concurred with LAZ's position but insisted that President Lungu was eligible for 2021.

"Our position as PF Party is that President Edgar Lungu had only served one term of office as per ConCourt Judgement in the Danny Pule case. As PF party, we have consistently argued with those individuals and organisations that have been misleading the public that President Lungu was not eligible to stand in 2021 because he had already served two terms of office and is therefore barred by the Zambian Constitution. We are also alive to the fact that there

are several eligibility criteria for one to stand as President and one of them is that a Person wishing to stand as President of the Republic of Zambia must not have served two terms of office," said Mundubile.

"One side of the argument was that President Lungu was ineligible to stand in 2021 because he had served two terms of office, our side of the argument was that he was eligible because he had not served two terms of office in so far as the law was concerned and the Constitutional Court agreed with our position. We therefore agree with the position taken by LAZ that the only issue the Court dealt with decisively in its judgement was that of the term of office because questions of the other eligibility criteria were not brought before the court and in our view the other eligibility criteria may not be in issue because President Lungu will not be contesting as President for the first time."

Responding to a press query, LAZ president Abyudi Shonga said the ConCourt did not deal with any other eligibility criteria.

"It is the position of LAZ, according to the Constitution of Zambia as amended by Act No. 2 of 2016, the President of Zambia may only serve two terms. Further, it is LAZ's position that there are several eligibility criteria for a person wishing to contest for the office of the President of the Republic of Zambia. One of the criteria is that the person must not have served two terms prior to attempting to contest. It is common knowledge that the Constitutional Court was called upon, in the cases of Reverend Danny Pule and others vs Attorney General and others, to determine whether President Edgar Lungu was eligible to stand for the office of the President of the Republic of Zambia in 2021," said Shonga. from

"Apart pronouncement that the presidential term served between the 25th of January, 2015 and the 13th of September, 2016 cannot be considered a full term, it is the position of LAZ that the Constitutional Court did not deal with any other eligibility criteria. Our opinion on the qualification or lack thereof of any potential candidate can only be based on the criteria passed by the law and on being presented with certain facts that may bring the qualification of such a candidate into question. The position as at now is that the only issue we are aware of is the issue of the full term which the court dealt with decisively in its judgement which is binding."

"By copy of this letter, the National Chairman of the mobilization committee, Copperbelt Chairman and the Masaiti District Chairman are hereby informed of the decision," wrote Mwila. The mobilization committee is in conflict with the PF Copperbelt Provincial executive which feels

that the mobilization is causing confusion.

CTPD'S MONDAY OPINION

TODAYS TOPIC: CTPD's reflection on the Financial Intelligence Centre Trends Report 2019 with Ms. Chileshe G. Mange

HE Financial Intelligence Centre ("FIC") published the 6th Money Laundering and Terrorist Financing Trends Report for the year 2019 (the "Report") in August of this year. The Centre for Trade Policy and Development ("CTPD") has reviewed the Report from a civil society perspective and in particular the policy processes that need to be implemented to give further efficacy to the FIC and the financial sector as a whole. In this week's opinion we consider the findings of the Report as compared with the results of the previous financial year and attempt to identify the specific areas that warrant special attention.

The FIC is mandated by the Financial Intelligence Centre Act No. 46 of 2010 (as amended by Act No. 4 of 2016) to receive, request for, analyse and evaluate suspicious transaction reports and information from sources authorized by law to make suspicious transaction reports(including designated foreign authorities). Other functions include but are not limited to:

(a) providing advice and assistance to law enforcement agencies in furtherance of an investigations;

(b) accessing, directly or indirectly, on a timely basis, financial, administrative and law enforcement information required for the better carrying out of its functions under the FIC Act;

(c) educating the public and reporting entities of their obligations and inform them of measures to detect, prevent and deter money Laundering and financing of terrorism or proliferation.

Furthermore, one of the objects of thereport is for public consumption and to provide redacted case studies that demonstrate methods used to launder suspected proceeds of crime. The Report may influence policy formulation by Government to address money laundering and terrorist financing.

With respect to the 2019 period the Report revealed that the FIC received a total of seven hundred and ninety (790) reports comprising of seven hundred and forty (740) suspicious transaction reports. In comparison, the FIC received seven hundred and ninetynine (799) reports in 2018 of which seven hundred and twenty-four (724) were in relation to suspicious transactions. In addition, reporting entities are required to submit currency transaction reports to the FIC. One hundred and forty-nine thousand, six hundred and twenty-five (149,625) currency transaction reports were submitted in 2019 compared to seventy-five thousand, five hundred and ninety-two (75,592) in 2018. This has been attributed to improved compliance by reporting entities.

It should be noted however, that once reports are received by the FIC, they have to be analyzed in order to ascertain the value in financial terms of those reports, in other words determine how much is lost and account of what sort of illicit activity. On this basis the FIC analyzed one hundred and one (101) suspicious reports in 2019 compared to one hundred and seventy-six (176) in 2018. In 2018 the FIC revealed that Zambia incurred losses estimated at ZMW 6.1 billion due to financial crimes such as tax evasion, fraud, corruption, and money laundering activities. Of the ZMW 6.1 billion lost in 2018, an estimatedZMW 4.9 billion was lost solely due to corruption, with public procurement activities being significantly vulnerable to corruption.

In respect of the 2019 period, the Report reveals that the value of reports (in other words the total estimated losses) amounted to ZMW 948 million as compared to the ZMW 6.1 billion in 2018. The Zambia Revenue Authority assessed a total loss in revenue of ZMW 27 million on account of the Report. The value of disseminations in relation to money laundering (typically money from the proceeds of crime) for 2019 is ZMW 450 million, an increase from ZMW 195 million in 2018 according to the Report. The major offenses that contributed to the proceeds of crime and therefore laundering of money, being corruption and tax evasion.

Although there is a significant decrease in the overall value of reports from 2018, as already mentioned, the FIC analyzed less reports in 2019 in comparison withthe 2018 period. The Report also reveals that this is on account of a lack of funding available to the FIC to carry out the analysis of reports. It was also noted that the value of reports was significantly less than in the 2018 period as most of the reports involved natural persons (individuals), as opposed to corporations whose transactions are larger in value. and source of corruption, particularly involving politically exposed persons or public officials.

Public procurementis an essential tool for government considering its link with the pillars of effective governance which include, improved public service delivery, value for money, and an enabling environment for private sector-led growth thereby contributing directly to improving a country's business, investment, and social environments.

The dire state of the economy is no longer a matter of debate given the unprecedented levels and Kwacha depreciation against major currencies - a situation exacerbated by the COVID-19 pandemic. It is therefore worrying that the country continues to hemorrhage much needed monies through public procurement vis-à-vis corruption as it hinders private sector growth which is needed to spur economic growth and employment creation. This has a wider bearing on domestic and regional trade.

The CTPD is encouraged by the approval by Cabinet of the Public Procurement Bill, 2020 will repeal and replace the existing Public Procurement Act No. 12 of 2008 in an effort to strengthen enforcement mechanisms on procurement and the oversight and regulatory role of the Zambia Public Procurement Authority. However, there is need to examine holistically the legal and policy framework governing the aspect of public procurement including the Public Private Partnership Act No. 14 of 2009, which the Report has already flagged as problematic in that certain of its provisions create vulnerabilities in the procurement process. The suggested examination must also consider the financial sector regulatory framework and its direct linkages with procurement processes and in so doing suggest a policy road map that will enhance the efficacy of the FIC.

Having identified the major systemic loopholes as cited in the Report, the next article will be a discussion of the policy road map suggested in the foregoing paragraph. The discussion will be informed by an examination of the linkages between the procurement and financial sector regulatory



Despite the seeming improvement in 2019 as compared to 2018, what is evident is that the government continues to lose money due to corruption, with single sourcing of projects remaining a major source. Public procurement is therefore proving to be a perennial loophole framework.

In an interview, Chisanga, the former Law Association of Zambia president, promised the electorate in Lukashya that he would continue where the previous member of parliament, Mwenya Munkonge, left off.

Munkonge, who was an independent member of parliament, died in July, 2020.

"When the President came here, he made a clarion call to all the members of the party to make sure that we work extra hard to make sure that we deliver this constituency, not only for the victory but even for the percentage and if you have seen, almost 90 per cent of the vote came to us. "We also know, Mr Speaker, that the UPND have been misleading the Zambians to say that President Lungu wants to overstay in power. There is nothing in Bill 10 that talks about that. There is nothing in Bill 10 that even says that PF is on a ventilator. With or without Bill 10, PF can continue in power after 2021. 

"We take note of the results and I think the fairest thing to say is that even as we cast some blame on the system and the players, we also would like to say that maybe from our own end there is a lot of buttoning up to be done. But the good news is that ultimately, the reception in what you called

perceived PF stronghold was overwhelming and if the reception could turn into votes, obviously our desires would be met. This is a region where three years or less ago, it was unheard of for UPND to have a free range of activities without stones being cast at them, this time there was no single stone cast," Nkombo said.

And Nkombo said President Lungu would be remembered as a Head of State who embraced corruption-accused ministers.

"There is poverty in this country, untold poverty and that is why even when I was looking at President Lungu's state of the nation address and saying the things he was saying and the achievements of PF in the light of what I see before my face I then come to a conclusion that... and my own understanding of the law is that Mr Lungu was giving a kiss of goodbye to the presidency at that state of the nation address because he is ineligible to stand as a

President in the next election. So in his farewell bid, he said things that I personally translated as how he wants to be remembered. Now, how one wants to be remembered is totally different to how one is remembered. President Lungu in his state of the nation address enjoyed the freedom of his feelings about the achievements that PF has done. That is how it is, it ends at his feelings which he is entitled to but he is not entitled to our feelings. Our feeling is that he will be remembered as the President who was very lucky, in his own words to the country, he did not have a vision for this country and the people using the vote of pity arising from the death of President still went on and gave him a vote. He is a very lucky individual. Degeneration of law and order in the country, that is how he shall be remembered," Nkombo said.

"This is the only country where a political cadre can storm a radio station and start breaking things. This is the only country where a political cadre can order a police officer and tell him what to do. The power base has shifted from the police who are the enforcers of the law to the cadre, there is superiority of a cadre. He will be remembered as a President who nursed and harnessed ministers who are accused of corruption. In his state of the nation address, he talked about the social cash transfer and the social security plan for this country. What we remember about the social cash transfer is that it was stolen by PF through ZamPost. We have a President who criticized even the institutions that are constitutionally born; the Financial Intelligence Centre (FIC), this was born out of the act of Parliament, you know how they have been demonized."

Meanwhile, Nkombo charged that foreign nationals were being allowed to acquire national registration cards.

"There is a scandal regarding the sovereignty of this country where foreigners are being allowed to get tools that are only exclusive to citizens, bonafide citizens. If you ask Dracula if he drinks blood, he is going to tell you he doesn't drink blood. The Home Affairs Ministry under Stephen Kampyongo are the ones that are responsible for this program. We think that it is something that they are doing willfully and knowingly and if it is not the case, it means that they are incompetent. It means that they have allowed security paper to be in the hands of wrong people. Either way, it means that we are dealing with people that are dangerous because an incompetent person is a very dangerous person. If you recall, the statement made by PF secretary general Davies Mwila, he said 'this issue of NRC is a party program' and without any ounce of shame that it can never be a party programme. If it is a party programme, then it is meant for self-preservation. This is a national program and it is not a program that is going to enhance self-preservation. This is just a degeneration of the rule of law in this country where there is no respect for dignity and human life," said Nkombo.

Education), to provide the support required to facilitate the effective education of children living with disabilities, including providing reasonable accommodation, adequate equipment and individualised support measures, as well as paying teachers, who are qualified and trained to teach children living with disability regular within schools. By Sipilisiwe Ncube VICE-President Inonge Wina says government has not yet decided on which mode of action to use in dealing with the involvement of public figures in the privatisation process.

And Vice-President Wina says President Edgar Lungu has not failed to run the economy of this country following the abrupt dismissal of former Bank of Zambia (BoZ) governor Dr Denny Kalyalya last month.

Vice-President Wina was speaking in Parliament during the Vice-President Question Time, Friday, after Muchinga MMD member of parliament Howard Kunda asked her if government was considering constituting a commission of inquiry into the privatisation of State-Owned Enterprises (SOEs).

"Your Honour, the Vice President, there have been a lot of discussions and talks about the privatisation of our companies that belonged to government. I would like to find out from you as to whether you can indicate to this nation, through this August House, whether government is considering to set up a commission of inquiry into privatization, bearing in mind that this is a national issue that the Zambian people have been discussing that they have lost or they had lost money that belonged to them," Kunda asked.

In response, Vice-President Wina said the privatisation topic was a national issue, which was still being debated on.

"Mr Speaker, indeed, this is a national issue that is being debated all over the country because Zambians want to know what transpired during the privatisation exercise. The Privatization Act Chapter 386 of the Laws of Zambia was enacted by Parliament through Act 21 of 1992. And it was amended in 1994 and 1996. The Privatisation Act was to provide for the privatisation and commercialisation of State-Owned Enterprises to provide for an establishment of the Zambia Privatisation Agency and to define the functions of the agency, to provide for the sale of shares in State-owned Enterprises. Mr Speaker, again in Section 26 of the Privatisation Act, the Act provided that political leaders and public officers should publicly disclose their intention to bid for the purchase of shares in State-Owned Enterprises," Vice-President Wina responded.

She said the negotiating team of the process needed to act professionally and should have disclosed any personal

have ensured professionalism and disclose any personal or professional interests as they carried out their assignments," Vice-President Wina added.

But she announced that government had still not yet decided on which mode of moving forward to probe the privatisation saga.

"Mr Speaker, members of the negotiating team were also required and expected to uphold high standards of integrity, transparency and professionalism since they were dealing with public assets. Disclosure of personal interest was, therefore, a legal requirement. So, Mr Speaker, the people of Zambia are still debating this matter and they want their government to find a solution that will put an end to this public discussion. And government has not yet decided on the mode of moving forward regarding this matter. But when

Govt yet to decide mode of action in probing privatisation saga – Wina the time is right, government

will take action to address this very important issue that has left parts of this country in poverty, that has left many Zambians in destitution [and] that is why Zambians are very keen to know the outcomes," Vice-President Wina said.

And Itezhi-tezhi UPND member of parliament Herbert Shabula asked Vice-President Wina to explain why President Lungu fired Dr Kalyalya as Bank of Zambia (BoZ) governor last month.

"Your Honour, the Vice-President, dismissal of the Bank of Zambia governor Dr Denny Kalyalya came to us as a surprise! And the reason that was given was not clear and we are trying to guess whether he failed to manage the economy

or whatever it is. However, what is surprising is that Dr Kalyalya had two supervisors; namely, the President himself and the Minister of Finance (Dr Bwalya Ng'andu). And now we see Dr Kalyalya being dismissed for failure to manage the institution. And later on, the President admitted by saying, 'now, he will manage the economy.' The question is, is this clear admittance that the President and the Finance Minister have lamentably failed to run this nation? Is he accepting?" Shabula asked.

However, Vice-President Wina insisted that President Lungu had not failed to run the economy, but avoided shedding

further light on the matter.

"Mr Speaker, let me assure the country that the President of the Republic of Zambia, Mr Edgar Chagwa Lungu, has not failed to run the economy of this country. And as for the appointment of the Central Bank governor, that is a prerogative of the President. I cannot say much more on that issue," she replied.

On another topic, Leader of the Opposition in Parliament Jack Mwiimbu mockingly congratulated the PF for scooping the Mwansabombwe and Lukashya parliamentary constituencies, saying: "I would like to congratulate the PF, Mr Speaker, for having been in Mwansabombwe and Lukashya

constituencies campaigning and whilst they were away campaigning, the economy collapsed! Congratulations for collapsing the economy, while you were busy campaigning!"

The Monze Central UPND member of parliament then asked Vice-President Wina why there was still no substantive US Ambassador to Zambia following the controversial recalling of Daniel Foote late last year, even after the Zambian government had assured that there was nothing wrong with the relationship between the two countries.

"I just wanted to find out with Her Honour, the Vice-President last time, the Ministry of Foreign Affairs told us that there was nothing wrong with the relationship between Zambia and the United States of America when the Ambassador was recalled. I just want to find out from Her Honour, the Vice President, as to what has happened considering that most of the time, when an Ambassador of America is recalled, they appoint another Ambassador. From the time he was recalled, America has not appointed any Ambassador to Zambia. Is the relationship still strong as it used to be?" wondered Mwiimbu.

Vice-President Wina responded saying:

"Mr Speaker, the relationship between the Government of the United States and Zambia is extremely strong and very cordial. Mr Speaker, it was only last month that our Ambassador to the United States (Lazarous Kapambwe) was accredited and received at the White House by President (Donald) Trump. The fact that the (US) Ambassador has not arrived in Zambia is in the hands of the American government. And perhaps what we don't know is because of the restricted movements of persons under this COVID-19. We are not privy to the arrangements that the American government is currently making. But for all I know, the relationship between the two countries is very secure and strong."

And when asked by Roan National Democratic Congress (NDC) member of parliament Joseph Chishala if it was legal for Konkola Copper Mines' (KCM) employees to be guarantined for over a month, Vice-President Wina said government would only take action once it was

Lungu asks financial institutions to ease pressure

By Natasha Sakala PRESIDENT Edgar Lungu has called on financial institutions to relax pressure on farmers and provide incentives for them to thrive during the COVID-19 pandemic period.

Meanwhile, Agriculture Minister Michael Katambo says the Food Reserve Agency (FRA) will manage to reach the one million metric tonne maize buying target as directed by the Head of State.

The President was responding to Zambia National Farmers Union (ZNFU) president Jervis Zimba, who expressed concern over the challenges farmers faced, leading to them not being able to repay loans and meet statutory obligations.

He was speaking at Chobe Agrivision Farm in Mkushi, Friday, during the launch of the National Wheat Harvest.

"Your Excellency, how can the cost of production be held downwards? I will summarise it in two sentences: farmers are asking for assistance that they are owed huge sums of VAT refunds and they are asking for assistance so that this money can be paid to them so that they are able to pay bank loans. Another form of support, which can come is the forgiveness or cancellation of huge NAPSA penalties, which some businesses continue to carry. This will let a chain reaction of slowing down price increases because many businesses face challenges," Zimba said.

of compensating all farmers, who grew early maize to the agreed price. Today, as we are seated, over 42,000 metric tonnes are unsold and we hope that the matter will be resolved, your Excellency, but we have lost patience; we are looking for your assistance or farmers are looking for your assistance. What has caused all this is management of time as exports are time bound," he added.

He further called on government to halt the importation of edible oils as Zambia had the capacity to grow enough sunflower and soya beans, among others, to cater for the local market.

"Your Excellency, this country can grow a lot of soya beans, we can grow a lot of sunflower, cotton; then why are we importing oils in this country? For us to make sure that we are able to grow, we must create our own markets. On behalf of all farmers, I say no to importing edible oils; we can produce our own for this country," Zimba said.

He further called for a merger of ZEMA and WARMA because they were wreaking havoc for farmers.

"Your Excellency, the water issue in Mkushi has been a problem and it's becoming very costly. Your Excellency, I remember in one of your meetings, you were not happy with WARMA and ZEMA and you said, I repeat, 'if WARMA and ZEMA are going to cause problems to farmers, I will extend incentives to farmers, especially during the tough times of COVID-19. Financial institutions should come up with facilities that are tailormade for the agriculture sector as the sector requires specialised services," President Lungu said.

He added that government was committed to ensuring that Zambia's potential of being a regional bread basket was actualised.

"Government remains committed to farmers and other value chain players to ensure that we resolve the various challenges that you are facing. Time has come for us to be practical and move away from the rhetoric that Zambia has a lot of potential to become the bread basket in the region, it is time to actualise this. I wish, therefore, to reiterate the need for effective and transparent dialogue. This is the only way that government will be kept abreast with current developments in the industry and this is the only way for timely interventions. Our interest, as government, is to ensure that agriculture thrives and farmers make a meaningful return on their investment. Likewise, this is also in your interest as farmers," President Lungu added.

He further reiterated government's commitment towards crop diversification despite maize getting more attention in terms of resource allocation.

"Although there is so much attention paid to the maize crop

for export, we still remain committed to agricultural diversification. We, therefore, attach the same importance to other crops, such as wheat that we have to base. The wheat industry is very important and strategic," said President Lungu. Meanwhile, Katambo said

"The Food Reserve Agency grain purchasing is on, your Excellency. You always told us to consult all key stakeholders in the industry. Of course, there is competition with other grain traders, we shall manage the requirement with the strategies that we have put in place, your Excellency, like prompt payment to our farmers. He further said farmers were facing further losses as they were unable to sell about 42,000 metric tonnes of maize they were told to grow in the early maize project.

"Your Excellency, we got a directive to grow early maize for the nation and farmers signed up a contract with the FRA of about 130,000 metric tonnes, although the farmers grew 140,000 metric tonnes. But because we have lost in terms of timing, the farmers only supplied 30,000 metric tonnes to the FRA, the rest were told to export. Now, because the decisions came very late, we lost the market opportunities. This is a grave matter as farmers are under pressure from the banks. Government should find a way merge them.' Your Excellency, true to what you were saying, the time to merge them is now! How do we work with WARMA if whatever we want to do, they don't want to agree with us?" wondered Zimba.

In response, President Lungu said financial institutions must extend incentives to farmers to enable them survive during the COVID-19 pandemic period.

"I am aware that most farmers are struggling when it comes to meeting their obligations with financial institutions. Let me appeal to financial institutions to relax their pressure and develop mechanisms that will allow farmers to survive and thrive. I urge financial institutions to

"The Law Association of Zambia (LAZ) has followed the incidents of widespread violence perpetuated by political cadres in full view of the Police with deep concern. One such incident was filmed, and a video showing identifiable persons damaging a motor vehicle in Kasama has been brought to our attention. In the said video, police officers in uniform are seen being present at the scene. We are dismayed to note that the police officers took no action to attempt to prevent the malicious damage that was being done," Chilembo stated.

"LAZ has since written to the Inspector General of Police over the matter, and a meeting has been confirmed, at which this issue will be discussed in detail, amongst other issues that have the capacity to undermine the Rule of Law.

It is the view of LAZ that the lawlessness being exhibited in the country by political cadres cannot continue to be condoned. The Police Service is a key stakeholder in the maintenance of law and order in the country, and as such the significance of engaging the Inspector General of Police by LAZ is crucial."

Last week, Northern Province Police Commissioner Richard Mweene said the police had launched a manhunt for some PF cadres seen in a video threatening violence and damaging UPND property.

This must be encouraged...In the last few weeks, you noted we had high numbers of people in our hospitals who were very sick, we needed to mop," Dr Chilufya said. "Kudos to the clinical teams, they kept the mortality low and treated a lot of our patients who have been discharged. The reduced numbers that we see in our clinical facilities gives us yet another window to push back the interventions in the community where we must ensure transmission is

as 111 due to COVID-19, 216 due to COVID-19 related deaths and 3 others are being reviewed. As we speak today, we have seen a reduced number of cases in our COVID-19 facilities, a good indicator but that also summons us to shift the fight into the community. So 34 patients in our various facilities with 15 on oxygen."

He said the reduced community transmission was attributable to the improved use of masks in the country.

"So the understanding of the situation today with the reduced numbers in the hospitals is that cases which are coming in are going lower, the community transmission is reduced and this is attributable to the improved use of masks. Going around the country, I have seen a critical mass of Zambians wearing masks, therefore the sensitization has been working. This can be sustained only if we upscale these same measures we have been talking about, the five golden rules," Dr Chilufya said. And the Minister announced that the mode of updates would change, with live briefings only being done on Mondays and Fridays white an updatable dashboard of statistics would be released on a daily basis. "The compliance levels countrywide to health measures, generally, has improved. Positivity has gone down, today we report the lowest positivity of four percent. This is commendable and we must commend the public for adhering to the golden rules of masking up in addition to other rules. This is informing the cautious relaxation of restrictions. Going forward, as the number of cases of COVID-19 is abetting and the community is responding very well in engaging with us, the updates are going to be equally restructured. We are now going to be issuing updates twice in a week on Monday we will be reviewing the weekend and on Friday, we will be reviewing what has happened during the week but on a daily basis, there will be press releases or an updatable dashboard which will show you the new cases on a daily basis," said Dr Chilufya.

Meanwhile, Prof Mulenga said the confidence to stop children from masking up is derived from the data showing 0.05 positivity in that age group.

"We look at the age group of two years and also looked at the age group below five years and for us, we looked at the data which we have had in Zambia; those less than five years, less than 0.05 percent have been infected. So when we looked at that data, we found that the risk of acquisition is low, which can give us confidence that w can recommend no masking for those below five. However, even as we do so, we need to protect these little ones, which is why we need to have safe places in the school places so that even those who are masking up can have time to breath," said Prof Mulenga. "The recommendation for Zambia is those who are five years and above should mask up, then those who are below five years, they should not but we are advising that they should have a loose cloth around the face. Now that cloth when it's put on the face, it's largely trying to protect the individuals who they infect, it's not protecting them. It's protecting the one who is next to them, if they have COVID-19."
