

access to technology. And Sinkamba says the ECZ can hire experts from the Zambia Statistics Agency (ZSA) to clean up the existing voter register so that any deceased voter is removed rather than having to compel the entire voter population to physically verify their particulars.

In an interview, Sinkamba argued that ECZ's online voter registration process had potential to cause civil strife because around 70 per cent of the country's population lacked access to technology, such as smart phones.

"In this country, we do not have more than 75 per cent of the population connected to smart phones to do online registration. The misadventure, which ECZ is trying to move the nation to, is going to be costly and can cause civil war. So, the ECZ needs to be very careful that whatever they are doing may appear to be something of fun to them, but in essence, they are endangering their own lives and the lives of their children. I always give an example of Malawi and other African countries where the electoral commissions and their families have been victims of civil war. The electoral process where registration is going to be online is definitely not earnable in Zambia at the moment because we are talking about over 70 per cent of the population living in rural areas. And these people don't have access to smart phones, which they can be able to use," Sinkamba argued.

He stressed that there was no justification for the ECZ to abandon the old register, adding that the Constitution as well as the Electoral Act also provided for updating of the existing

register.

"The literacy levels are very low in this country, such that not everyone is able to do certain commands. We are saying that there is already a register, which has been produced in accordance with the Constitution of the Republic of Zambia. And at the moment, there is no justification whatsoever to abandon it (existing voter register) altogether. All that should happen is just to update it. That is what the Constitution and the Electoral Act say. And looking at the ECZ resources at their disposal at the moment, the resources in terms of funds and in terms of manpower, they do not have capacity to be able to produce a brand new register, which is going to have nine million, plus people. It is impossible to achieve that goal in one month or two months. The maximum they can do is 1.5 million people in six months. That is what has been proven prior," he said.

And Sinkamba proposed that ECZ hires experts from the ZSA to clean up that register.

"We want to appeal to the ECZ that let them abandon this route. This route is not helpful, it is not making any sense and we do not have the resources to be able to undertake it in terms of financial and also human resource. They gave a very fake excuse at first where they said, 'some people have died.' They were estimating almost 400 people have died. That is not a problem to clean up the register like that. Right now, the Ministry of Health has got an electronic system now, and also the police, in conjunction with the Ministry of Health and

the Department of Registration, have gone digital when it comes to registration of Broughtin-Dead (BID) people. They already have a register of people, who have died in hospital and people that have died from their homes in the last four years. All ECZ can do is to hire experts from the Zambia Statistics Agency to clean up that register so that those that have died are removed from that register. And then the political parties can come and verify the register after it has been cleaned up by experts. It is a simple job for Zambia Statistics to do. So, it shouldn't mean that the entire population of 10 million people must go and parade themselves to ECZ for ECZ to know who has died," he advised.

Sinkamba expressed disappointment in ECZ senior management for not acting in public interest.

"What the ECZ is doing is wrong. If I have already registered, I don't need to go and parade myself before ECZ, that is wrong. But if I want to change my polling station, then it is justified that I should go to ECZ. So, (Patrick) Nshindano, (Esau) Chulu and other commissioners should know that what they are doing is playing with fire! A voter register is a very sensitive document in the electoral process. And a register is a potential source of civil war in a nation if it is mismanaged. And the best they can do is to refrain from doing that as that is going to make the public lose confidence in the electoral process because of a sham register! And if they allow that situation, they will have to blame themselves for what will happen," warned Sinkamba.

Tribalism, handouts won't save PF in 2021 – Kalaba

He observed that it was now a PF principle to keep youths and the needy in society vulnerable so that they could come to their aid during election time just to solicit votes.

"The aim of every government in the world is to make its citizens prosperous. But here, if you become prosperous, they will pull you down. Look at what they did to The Post Newspaper, look at what they did to the Prime TV, and look at what they have been trying to do to CEC (Copperbelt Energy Corporation) on the Copperbelt! We saw this happening during the time of the UNIP...anyone who tries to business. THE Court of Appeal has upheld the ruling of the Lusaka High Court which quashed the decision by the Registrar of Societies to deregister Harry Kalaba's Democratic Party (DP).

The State had appealed against this decision on four grounds, but the Court of Appeal threw out the appeal, Monday, further deciding that the public authorities such as the Registrar of societies must never act wantonly and arbitrarily but must act proportionately and respect the rights of citizens.

Court of Appeal judge, Florence Lengalenga on behalf of two other judges upheld the decision of the High Court, saying the lower court was in order when it quashed the decision by Registrar of Societies to deregister the Democratic Party. Judge Lengalenga has further dismissed all grounds of appeal by the State. The decision of the court of appeal means that the high court decision that directed that the duplicate certificate be printed and given to the party has been confirmed.

In 2018, Lusaka High Court Judge Sharon Newa quashed the decision by the Registrar of Societies to deregister Democratic Party, saying their decision was not only illegal but irrational, unreasonable and procedurally improper.

Judge Newa further directed the said Registrar of Societies to issue the party with a duplicate certificate of registration.

This was the matter in which the Democratic Party, through its national secretary Precious Ntambu, commenced judicial review proceedings challenging the registrar's decision to cancel registration of the party, arguing that it was illegal.

The Registrar deregistered DP on June 6, 2018, on ground that it had not addressed the issue of why it should not be cancelled.

But delivering judgement, Justice Sharon Newa said the decision to cancel the registration of the party was illegal, irrational and procedurally improper.

"In this case, not only was the Registrar of Societies decision to cancel the registration of the applicant as a political party illegal, it was also irrational, unreasonable and procedurally improper and I declare so, and the applicant succeeds. I accordingly quash the registrar's decision and direct the registrar of societies to issue the Democratic Party with a duplicate certificate of registration. The applicant is also awarded costs to be taxed in default of agreement, leave to apply is granted," she had ruled.

And commenting on the decision by the Court of Appeal, DP Spokesperson Judith Kabemba said the Court's ruling meant that the party was legally registered, adding that they shall continue preparing for next year's general elections.

"This means that Democratic party is legally registered party and is therefore back with full force on the Registrar of Societies' register to form government come 2021. This will go in history that those in leadership should never act by the influence of those in power. It is a lesson to madam [Thandiwe] Mhende, the chief Registrar of Societies. As DP we shall continue preparing for 2021 elections especially that we have beaten PF pants down," said Kabemba.

700 EX-KCM RETIREES PENSION BENEFIT

The Trustees of Saturnia Regna Pension Fund ("Saturnia") have noted with dismay the statements issued by Mr. Ilunga Kasompe supposedly on behalf of the 700 Ex- KCM Miners regarding their pension benefits during their press briefing held on 20th of September 2020.

Mr llunga Kasompe made the following allegations at the press briefing;

- Over 700 ex KCM miners were members of the Saturnia Regna Pension Fund
- Saturnia was withholding pension benefits for these ex-miners against their will and this has caused a lot of hardship for them.
- Mr Hakainde Hichilema was unfairly holding back their pension as shareholder in the Fund and that he owned Saturnia.
- Saturnia Regna Pension Fund changed the law so as not to pay pensioners all their pension benefits.

The Trustees of the Fund would like to advise the members of the Fund, sponsoring employers, other keys stakeholder and the general public that the above allegations are untrue and unsubstantiated. The actual position on the above matters is as follows;

On Membership

The Ex KCM Miners demanding pension payment are not members of Saturnia. However, it is true that employees of KCM Plc participated in Saturnia from 2000 until 2007 when the company decided to segregate and set up their own stand-alone pension scheme. Therefore, all employees of KCM plc are accounted for under their own company pension fund which operates as a stand-alone Pension Scheme. The business of the KCM Plc Pension Trust Scheme (the Scheme), its assets (including those left in Saturnia for investment purposes), payment of member benefits and other administrative matters is presided and overseen by the Trustees of the KCM Plc Pension Scheme.

On Shareholders

Saturnia is a pension trust fund created under the Perpetual Succession Act of the laws of Zambia and does not have shareholders. The over 35 000 contributing members are the owners of the pension scheme and Trustees hold these assets on their behalf. Therefore, it's not possible under the law for any individual to own or hold shares in a trust such as Saturnia.

On Payment of Pension Benefits

Saturnia has not withheld any pension benefits unnecessarily to any of its Members. All benefits are paid within the stipulated time as long as a member has filed in their claim form and meets the necessary conditions under the law and scheme rules. There is no outstanding claim on record at this point in time that has been brought to our attention. The Trustees would be happy to receive any such information on unsettled claims to enable the resolution of such cases.

In Zambia, the law that prescribes how pensions are to be paid is clause (vii) of the Income Tax Act Cap 323 of the Laws of Zambia. This law is to be complied with by all pension schemes in Zambia.

On Changing the Law

Saturnia has not changed any law. All pension payments in Zambia are governed by the Zambian laws. The same law applies to all pension funds that are managed in Zambia. No fund is able to change the law as all laws are Acts of Parliament and only Parliament can amend them.

Conclusion

We truly believe that the above statement helps to clarify the issues identified above. Those needing more information on the same should feel free to consult the Pensions and Insurance Authority and Zambia Revenue Authority as the enforcers of the relevant laws relating to pensions.

Saturnia remains the largest multi-employer pension fund in Zambia and the most well diversified fund in terms of its distribution of assets. We would like to thank our Members and the sponsoring employers for their continued support for the fund, despite unsubstantiated and unwarranted attacks that the Fund has endured over the past few years.

Prima Reinsurance records 20% growth in premiums

By Diggers! Reporter PRIMA Reinsurance Plc has recorded a 20 per cent surge in its Gross Written Premiums (GWP) in its half-year period ending June 30, 2020, defying the adverse COVID-19 effects, and posting a net profit of over K1.7 million.

But the company says it expects a reduction in its GWP in the second half of the year on the back of severely contracted economic activity brought about by the Coronavirus pandemic.

Announcing its unaudited financial results for the period ending June 30, Prima Reinsurance stated that it earned over K30 million in its GWP, up from around K25 million in the corresponding period last year, representing an increase of 20 per cent

"The company operated in a challenging environment with the onset of the COVID-19 pandemic, where it witnessed unprecedented decline in private sector economic activity. Despite the pandemic, the company recorded growth of 20 per cent in GWP from ZMW25.35 million in 2019 to ZMW30.46 million in 2020. This was mainly as a result of a general increase in Life, Property and Engineering classes of business. Further, the Company saw an increase in the net earned premium by 37 per cent from ZMW9.07 million in 2019 to ZMW12.43 million in 2020," Prima Reinsurance stated.

million for the first half of 2020 compared to a loss of ZMW5.45 million in the first half of 2019. The increase in the profit is attributed to a reduction in operating expenses and increase in other income arising mainly as result of the devaluation of the kwacha against the US dollar."

It added that the company's financial position remained robust with total assets up at over K76.6 million in the period under review.

"The company's financial position remains robust with total assets increasing from K65.24 million to K76.62 million. The net current assets position for the half-year ended June 30, 2020, was ZMW33.63 million," it stated.

But Prima Reinsurance stated that it expected a reduction in its GWP in the second-half of the year on the back of a severely contracted economic activity brought about by the Coronavirus pandemic.

"As a result of the projected contraction in the economic activity, the company expects a reduction in the GWP in the second half of the year. The focus, therefore, will be on cost containment and financial discipline as we are committed to remaining resilient in the face of the pandemic and providing a safe work environment," stated Prima Reinsurance.

"We are pleased to announce that the Company underwent a successful capital raise in July, 2020. The capital raise was structured as a renounceable rights offer and this was underwritten by the Industrial Development Corporation (IDC), an investment holding company owned by the Government of Zambia. Following this, the company now has an authorised share capital of K75m of which K45m is paid up. IDC now has a shareholding of 28.17 per cent in the company."

There is no plan of any sort by the party. They first

misquoted Ms Nalumango that she said 'he must be replaced', which was not true she has never said and will never say that. Now they have included me, that I am also supporting the scheme, which is not true. I have never said anything."

Katuka said the party believed in Hichilema's leadership and that Hichilema was still the most happening man in the country.

"We still believe in his leadership. He has so far made this party intact up to now. If in 2006 we voted for Sakwiba Sikota there would be no UPND today. The man has kept the party together up to this time. So we must appreciate such a person. We wish to put it on record that Mr Hichilema is currently the most happening man in the country, whose popularity, which is evident for all to see, cannot be overlooked. 





Government should Treat Boards Seriously!

WO months ago, I was consulted by one statutory body to help them navigate the strategic plan formulation process. We reached a snag in our discussions about timelines because one key stakeholder responsible for the approval and successful execution of the plan was not in place. The institution had gone nearly two years without a board. The substantive board was prematurely dissolved, halfway its tenure.

If there is a change at minister level, boards usually get changed. Each minister has an own list of prospective board members for a respective entity. Unlike in the private sector, board tenure in government owned entities expires at the same time because appointments are made at the same time. In other words, there is no overlapping to ensure continuity and maintenance of memory. Worse still, when an entirely new board comes into place, it wants to formulate its own strategic plan, even if such a plan would have worked just a third of its cycle.

There are presently a few statutory bodies and parastatals running without a board. I am not privy to the reasons why this is the case though I can speculate. First, ministers are usually uncertain about their own tenure in office and will only appoint a board once one is sure they are there to stay. Second, it is just difficult to find right people. I have shared thoughts with highly experienced individuals as to why they are not sitting on public sector boards. One of them told me, 'I don't want to dent my reputation. Boards are highly politicized, and I do not want to fall for unethical conduct. In any case, you get dissolved prematurely without any reasons. Your friends will start thinking I had dipped my fingers in the company coffers.'

Others think timing is important as another shared his thoughts to me, 'Not before elections, Chibamba. There is just too much uncertainty. I will rather wait for post-elections if I have to consider a board appointment.'

Third, the security clearing process at times takes longer than expected. An appointment to a public sector board is treated as a high-risk appointment and as such, individuals must be cleared for their citizenship, criminal record, conflict of interest and (political) allegiance. At this point, there is little the minister can do to public sector entity (including private sector). There is a strong business case for corporate governance which should prompt authorities to prioritise board appointments each time they look on their desk.

SUSTANABILITY

Andrew Sherman, a governance specialist, properly summerises what is at the center of corporate governance when he blogged, 'From board selection and strategic decision making to day-to-day operations and legal compliance, corporate governance is a way for companies to create a framework for sound business practices, sustained growth, and risk management. At its core, corporate governance entails an internal control system for transparent decision-making that protects shareholders' value.'

In other words, organizations can only be sustainable and strongly look ahead for enhanced profits when there is strong oversight, largely by independent and experienced individuals. I should add here that ministers should not just look at the list before them. They should use the strength of their advisors to ascertain the level of competence for each of the people they are about to appoint.

The real risk is not so much in political appointments but from those recommended by associations such as trade unions, business and professional associations and other bodies. Are these individuals capable of guiding the organization as it seeks to sustain its operations in the long haul? My own take is that the Law Association of Zambia and the Zambia Institute of Chartered Accountants have taken this window very seriously, always seeking to recommend highly capable and skilled individuals. Others simply have a queue of members to exhaust, and they recommend people regardless of the required skills set for a given entity. Organisations with such people are currently hugely insolvent, struggling for survival.

CAPITALISATION Many private companies believe corporate governance does not exist in a vacuum but is the means to attract capital. Whether through the stock exchange platform or outright borrowing from the banks, toping the checklist for potential financiers is governance. How is the entity run and are levels of accountability strong enough?

at lower cost, strengthens corporate strategy and its implementation, clarifies accountability, enhances shareholder protection, and helps to attract and retain quality employees. All companies must have a way of reconciling divergent interests, planning for strategy and succession, accessing capital, cultivating company image in the community, and ensuring legal compliance. Corporate governance is a key tool for achieving those business goals.'

EFFECTIVE DECISION MAKING

Shareholders of one company disclosed they had decided to appoint me to the company's board because they wanted to tap into my expertise at no cost. According to them, they had an option to engage me as a consultant through which they would pay huge sums of money every time they sought my services or retain me as a board member at the cost of a small board remuneration. One way you can utilize the expertise of those highly skilled, experienced and knowledgeable individuals you cannot employ is to appoint them to a board. They will support management in effective decision making for the business. Government should be fully aware of this opportunity.

When I served as Director General of ZNBC, I had no board for 18 months. I was aware of my own limitations and though the Permanent Secretary was effective, our scope in decision making was limited. In describing the Law of Significance, leadership guru John Maxwell says 'One is too small a number to achieve greatness'. In other words, for the management teams of the government-owned entities to thrive, there must never be gaps in board appointments.

speed up the process.

Forth and most crucial factor for the delay is getting the approval from mandated authorities such as cabinet or parliament. We are all aware of a case where President Michael Sata threw back the list to a minister, demanding he extends his search for capable candidates. He was concerned the board was not balanced in terms of ethnicity. He appeared to have comprehended the national dynamics and what was expected of his office in ensuring all Zambians felt their interests were adequately represented on every board. This process can apparently take quite long too.

My concern in this article is that appointments to public sector boards takes just too long and government should treat this as a profoundly serious matter. There should be no gap whatsoever in corporate governance for any This applies to public entities too. First, they gobble taxpayer resources and everyone of us want to observe maximum standards of accountability. When these entities are accountable, the Zambia Revenue Authority will not struggle to collect what is due to government. Individuals and corporate entities are very forth coming when satisfied that financial resources are utilized efficiently.

There is even more to this, several statutory bodies can easily get direct funding from international bodies if they have robust governance systems. As for State Owned Entities, listing on the stock market, issuance of corporate bonds or outright borrowing becomes easy when there are no gaps in governance benchmarks. Mubanga Kondolo has vacated the injunction which restrained Zambia Airforce Projects Limited, Kingsland City Investment Limited, among others, from continuing works at Kingsland City.

On February 17, this year, judge Kondolo granted Chalimbana Headwaters Conservation Trust Limited and nine traditional leaders of the Soli people an injunction restraining the continued works at Kingsland City. The said injunction | restrained ZAF Projects Limited, Kingsland City Investment Limited, Drimtown Investment Limited, Shangrila Investment Limited and Datong Construction Limited from continuing works on the area covered by the decision letter issued to ZAF Projects Limited by the Zambia | Environmental Management


Agency (ZEMA) on February 7, 2019 in respect of the project entitled, "Proposed Mixed Use Infrastructure Developmental Lots 2 and 3 ZAF Twin Palm Base, Lusaka by Zambia Airforce Projects Company Limited".

However, ZAF Projects Limited asked the court to discharge the said injunction. And ruling on the same application by ZAF Projects Limited, on September 18, this year, judge Kondolo said Zambia Airforce Projects Limited had shown that it had satisfied the conditions set by the court in its judgment of February 17, for vacating the said interlocutory injunction.

"The affidavit in support of the first respondents (ZAF Projects Limited) application to discharge the injunction has shown through exhibit "EL 4 that the first respondent has satisfied the conditions set by this Court in its judgement dated February 17, 2020 for vacating the interlocutory injunction granted to the appellants," he said.

Judge Kondolo said a precondition was a condition that must be fulfilled before other things can happen or be done. He added that it was

on that basis that the Court



stated that the injunction could be vacated upon ZAF Projects Limited complying with the pre-conditions which required them to submit under paragraph 3.1.1 proof to ZEMA that they have complied with the requirements of the Water Resources Management Act No. 21 of 2011 and under 3.1.5 that it shall prepare and submit for approval comprehensive hydrological study of the Chalimbana Sub-catchment.

"The issue before the Court is not whether the first respondent is complying with the decision letter of February 7, 2019 but whether they have met the conditions prescribed in my judgement of February 17, 2020. The issues of compliance are already before the trial Court and if there are on-going infractions so grave as to warrant suspension of the entire project by an injunction, nothing prevents the applicants from seeking that specific acts or the entire project be injuncted," judge Kondolo said.

He accordingly vacated the injunction.

"The said injunction is accordingly vacated. Costs are in the cause," ruled judge Kondolo.

ZAF Projects Limited director Colonel Edgar Lungu had submitted in an affidavit in support of ex-parte summons for an order to discharge the interim injunction, that the ruling of the court of February 17, this year, specified that the injunction could be vacated by ZAF Projects Limited complying with the pre-conditions set out in the decision letter issued by ZEMA dated February 7, 2019.

He stated that in compliance with the conditions set out in the decision letter, ZAF Projects Limited on March 3, 2020 submitted a copy of the report of the Hydrological study for the Chalimbana Catchment Area and Ecological Management Plan for the Proposed Mixed-Use Development at ZAF Twin Palm to ZEMA for review and possible approval.

Col Lungu stated that by letter dated March 10, 2020, ZEMA approved the said report which was in fulfilment

UPND secretary general Stephen Katuka says the party refused to have leader Hakainde Hichilema on ZNBC's Sunday Interview programme because the national broadcaster wanted him to feature as chairperson for the privatization committee and not UPND president.

Katuka had written to ZNBC on September 10, 2020, requesting that the party be given an opportunity to respond, via the Sunday Interview, to FDD leader Edith Nawakwi's allegations against Hichilema.

However, it was reported that the UPND had turned down an invitation from ZNBC in response to their request for an interview.

In an interview, Katuka disclosed that the decision to turn down the interview was because ZNBC, in its

response to the UPND's letter, requested that Hichilema be given the platform in his capacity as chairperson of the privatization committee and not UPND president.

"We wrote to them as a party, now they were saying let Hichilema come in his capacity as chairman of that privatization thing. We wrote to them as a party and they should have responded to us as a party if they agreed to feature him. Now, they are saying he can't come there as the president of the party but that he should come as chairman of that privitization. We are not involved as a party in the privatization the party. So, if we feel that and we will not discuss issues it is not him, specifically, to deal with the issue, we can of privatization. So, if they offered us a platform for the delegate anybody to go and do interview, that platform could that. Their response was like have been used by anyone challenging him to say 'bwela from the party because it was manje tizakuona' (come here, the party that was requesting you will see)."

He added that the response given by ZNBC was not in good faith, adding that the party had information that there was a plan to disparage Hichilema on the program. "The spirit in which their response came was clear that they had something negative and we had information about their behavior. The man who was supposed to interview him was already invited to Cabinet Office. They went to grill the reporter at Cabinet Office, what has that got to do with Cabinet? We are aware they called him there to give him some fake documents that have been manufactured. They also linked that letter to the PF, I don't know why. You know that we took ZNBC to court in the last election, a matter that we won and they have not been featuring us on their programmes. If they feature us, it is in the negative," said Katuka.

"So we wrote to them and the response, I told the DG that the response to me was not in good faith. That is how my team went to meet them to explain the way that letter was written, the spirit in which it was written, I think it was not done in good faith. That is why we said that we can't operate like this. That is the issue, those who are saying the president chickened out, they are the chickens themselves."

Mwansabombwe needs

NEWLY-elected Mwansabombwe PF member of parliament Kampampi Kabaso says it is time for healing in the constituency to get rid of wrangles that engulfed the area over the past nine years.

In an interview, Kabaso said following his triumph in last Thursday's polls, it was now time to work, adding that he owed the victory to Mwansabombwe constituents.

"I owe it to the people of Mwansabombwe, it's now time to work, definitely. Looking at what we have passed through for the past nine years...there have been so many wrangles here and there, and as a constituency, we need to heal, forgiveness, togetherness and move on," Kabaso said.

The PF last week emerged victorious in the Mwansabombwe by-election, which was necessitated by Mwewa's passing after succumbing to COVID-19. Conservation Trust Limited and the nine traditional leaders of the Soli people opposed to the said application arguing that this was not a proper case to allow the discharge of the injunction as the respondents were still in breach of the conditions of the decision letter.

Robert Chimambo, the secretary of Chalimbana Headwaters Conservation Trust, stated in an affidavit in opposition that even with the Court's injunction and clear direction not to carry out any works, there was still non-compliance as the respondents continued building and allowed tenants to move into some of the properties.

He added that the said tenants were drawing water from boreholes and not using approved sewerage systems in contravention of the decision letter.

"They (respondents) have come to this court seeking the lifting of the injunction so that they can continue construction when they are in continuing breach of this However, the court of appeal has now vacated the said injunction.

In the matter before the Lusaka High Court, Chalimbana Headwaters Conservation Trust and nine traditional leaders of the Soli people, who include among others, senior headman Maoma and senior headman Nkomenshya have sued Zambia Airforce Projects Limited and Kingsland City Investment for carrying out construction works on a forest reserve.

Other companies sued include; Drimtown Investments Limited, Shangrila Investments Limited and Datong Construction Limited.

The plaintiffs have also sued ZEMA, Water Resources Management Authority and the Attorney General.

Finally, PF agrees that ConCourt did not declare Lungu eligible WO very

believe is speaking with insight. But today, we first want to comment on the PF's admission.

Honourable Mundubile makes a very interesting observation regarding President Lungu's eligibility. He says the party is aware of the fact that there are several eligibility criteria for one to stand as President, and that one of them dictates that a person wishing to stand as President of the Republic of Zambia must not have served two terms of office. He agrees with Law Association of Zambia (LAZ) president Abyudi Shonga State Counsel who explained last week that the ConCourt did not deal with the eligibility issue of President Lungu.

"One side of the argument was that President Lungu was ineligible to stand in 2021 because he had served two terms of office; our side of the

argument was that he was eligible because he had not served two terms of office. We therefore agree with the position taken by LAZ that the only issue the Court dealt with decisively in its judgement was that of the term of office because questions of the other eligibility criteria were not brought before the court," said Mundubile.

This was hard to believe. We had to listen to Honourable Mundubile's recording several times just to make sure that indeed, he was making this admission because in our view, this raises a lot of questions. This admission means the Patriotic Front also agrees that whoever wishes to challenge the eligibility of President Lungu will have every right to go back to the Constitutional Court to seek a declaration that the incumbent is not qualified to stand again in 2021, and the court

will have to make a ruling within 21 days.

whether the President is eligible or not? Why are you saying there is no more debate about Mr Lungu's eligibility when you know that no court has declared him eligible?



What is wrong with this provision of the law?

This is what we mean when we say that we are being ruled by mafias. The crooks in this government come up with false information to mislead the public and they spread lies without any shame. They have been lying that Bill 10 is about women and youth empowerment, that it is about the plight of the disabled. Luapula Hydro directors take plea in water permits matter

By Zondiwe Mbewe LUAPULA Hydropower Corporation Limited and its two directors, Brian Chisala and Katambi Bulawayo, have pleaded not guilty to the charge of failure to surrender water permits before the Lusaka Magistrates' Court.

This is a matter in which Luapula Hydropower Corporation Limited, Chisala and Bulawayo are charged with one count of failure to surrender water permits contrary to the provisions of section 86 (2) of the Water Resources Management Act No.21 of 2011.

It is alleged that Luapula Hydropower Corporation Limited, being a company incorporated in Zambia and having its registered office at Plot No. 62 Roan road, Kabulonga, Lusaka, and the two directors between August 7 and 27, 2020 in Lusaka, having been served with a Notice of Surrender of Water Permits Numbers 10371 and 10372 failed to surrender the permits as required by Section 86 of the Water Resources Management Act No.21 of 2017.

At the last sitting, WARMA in-house lawyer Chapatama Ngaba applied that the indictment be amended to add Chisala and Bulawayo as the second and third accused persons in the matter, which application was granted.

Ngaba then applied for an adjournment following the amendment of the charge sheet in order to serve the two other accused persons.

And when the matter came up before Magistrate

complained that it's unfair for the magistrate to refuse to adjourn the matter, adding that he does not understand why a magistrate can close a case when he still had two more witnesses to testify in his defence

When the matter came up for continued defence yesterday, State prosecutor Mukumi Chipawa informed the court that the accused was present and that the State was ready to proceed.

However. Kambwili's lawyers in the matter; Musa Mwenye State Counsel, Keith Christopher Mweemba, Mundia and Gilbert Phiri were not present.

At this point, another lawyer from Christopher Mundia's law firm, Jacqueline Lungu applied for an adjournment, saying Mwenye, who was in conduct of the matter, was appearing before the Court of Appeal.

In response, Chipawa reminded the court that it had at the last sitting given Kambwili the last adjournment, but added that he would leave it to the court.

Ruling on the application for adjournment, an magistrate Simusamba said he had on several occasions extended the time that he had given the defence to conclude their defence and to close the case.

He added that he had told the defence at the last sitting that he would not allow any more adjournments.

Magistrate Simusamba therefore refused to grant the application for an adjournment and proceeded to close the case. He added that he would

render his judgement in 14 days. "I now make the decision that this case is closed. Judgment will be made in 14 days," magistrate Simusamba

ordered. At this point, Lungu requested for four weeks in which the defence could file their submissions but magistrate Simusamba refused and gave them a week.

He also gave the State a

week to file their submissions after the defence had filed theirs.

Magistrate Simusamba then set October 12 as date of judgement.

But speaking to journalists, Kambwili said it was unfair for magistrate Simusamba to refuse an adjournment, adding that he does not understand why the magistrate could close the case before the defence officially closed it.

He said he still had two witnesses to testify in his defence.

Kambwili said after the case was adjourned to an agreed date last week. there was communication on Friday from the Court

Zesco requires overhaul - Eng. Chiyumbe

By Diggers! Reporter PRESIDENT Edgar Lungu must quickly act to implement urgent energy sector reforms that would lead to a professionally-run Zesco Limited and improved service provision because consumers are crying, says Engineer Geoffrey Chishimba Chiyumbe.

And Eng. Chivumbe, an energy consultant and expert, has insisted that Zesco needs a complete overhaul through the appointment of new professionals to revamp the State-run power utility to boost efficiency and provide better quality services to energy consumers.

In a statement dubbed: Zesco Inefficiencies and Mismanagement Continue Unabated, As Disgruntled Zambians Look to HH for Hope And Help in 2021, Eng. Chiyumbe, a qualified electrical engineer, urged President Lungu to implement much-needed energy sector reforms arising from a technical study, which had made recommendations to improve Zesco's performance operational back in 2017.

In 2017, Cabinet commissioned a technical which study, made recommendations to improve the operational performance of the power utility, which was chaired by then-Secretary to the Cabinet Dr Roland Msiska, who stated that the overall objective was to turn Zesco into a viable company that efficiently generates, transmits and distributes electricity to both domestic and industrial clients as well as the export market. Arising from the study report, Cabinet, at its meeting held on July 16, 2018, approved the recommendations and directed that an implementation team be constituted, the Zesco Reforms Implementation Team, to carry out the accepted recommendations, but nothing tangible had been yielded since then.

the approved implementation schedule was going to kick-start, the whole plan got shelved by the same incompetent leaders who were tasked with the responsibility to spearhead its thorough execution. Mr Mathews Nkhuwa (energy minister) for energy portfolio and then-finance minister (Margaret) Mwanakatwe are the ones answerable. Tireless efforts were made with both sector-line ministers, including IDC leadership, but all in vain, futile, fruitless, yes, indeed, a chase after the wind," Eng. Chiyumbe stated. "In the meantime, life goes on and load shedding is already officially registered as a formal, influential and key member in all our households and a leading and an active business partner in our businesses. The PF government's failure to act to arrest this negative trend is one of the things that have raised frustration levels very high among the Zambian population majority of whom at one point believed in President Edgar Lungu to salvage the situation. Mr. President, time is neutral. It's how you choose to use it. The implementation process can be initiated now. It can kick-

He stated that President Lungu must immediately make the necessary changes needed in the sector.

"Your administration is a working and listening government. When you see government-controlled а corporation, which must ordinarily be run as a viable enterprise, willy-nilly getting money from the vulnerable and already-impoverished individual citizens, without providing the services that money was paid for, the general citizenry must get very concerned. It calls not for silence, but speaking out, and bringing the matter before the attention of the appointing authority, who is the President, for immediate action, to right the wrong," Eng. Chiyumbe stated.

He lamented Zesco's failure to provide services despite consumers paying for them, coupled with ongoing load-shedding, which remained unresolved.

"We have many cases around Zambia where clients have paid money in advance

installations or connections of power to their premises, but it has taken Zesco in many instances, more than 12 months without providing the services paid for. These funds were deposited directly into Zesco accounts. Are these funds still there, lying idle? Or already utilised for something else? The citizens who paid for these pending services have been crying! In spite of the many available streams of revenue and income, the utility's financial liquidity continues to be in a mess. Because of high-gearing, the utility has been technically insolvent for years. For instance, in the financial year ended 31st December, 2016, Zesco's total liabilities outstripped its total assets," Eng. Chiyumbe stated.

"From both business and ethics perspective, it is worrying that we have an entity providing a service, collects money and fails to provide that service within the stipulated time as contractually agreed. Collecting or obtaining money in advance from unsuspecting clients in

the norms of good business practice. But the moment a business fails to deliver the paid-for product or service within the contractually agreed time frame, in my view, that becomes an act of criminality, and is tantamount to obtaining money by false pretence. This is where and the reason why we start questioning the competence of the governance and management team at Zesco. Yes, we know that the institutions is technically insolvent. But what is government, as the owner of Zesco, doing to turn the fortunes around? Why has the President kept and maintained the same underperforming team around for this long as though it's a marriage contract where some until - death - do - us - part vows have been made and entered into, for life?"

The engineer, who is currently the Trans Africa Projects (TAP) Pty Country Director, a subsidiary of Eskom, further insisted that Zesco's management needed an overhaul to revamp the State-run power utility for it to improve efficiency and provide better quality services

"If the current Zesco pard and its top management can tolerate and accept this unprofessional way of doing business as being normal, then we are in trouble as a nation. What the utility urgently needs, therefore, are the right people at the helm of leadership to take it through a financial restructuring process, which is needed for it to attain commercial credit worthiness. They say you can't fix a broken system using the same people who broke it. The whole energy sector in Zambia needs immediate flushing out," stated Eng. Chiyumbe, who is also the chairman, team leader and project manager of the Presidential Task Force on the Energy Sector Reforms in Zambia.

THE Competition and Consumer Protection Commission (CCPC) has urged schools to desist from imposing the purchase of identical face masks on parents as it is against the CCPC Act.

In a statement, Monday, CCPC senior public relations officer Namukolo Kasumpa stated that such practices eroded consumer welfare as they limited consumers' choices.

"The CCPC would like to advise some schools in the country to desist from imposing the purchase of identical face masks on pupils at the school as the practice is unfair and goes against the Competition and Consumer Protection Act (CCPA) No. 24 of 2010. The Commission has noted with concern that such practices erode consumer welfare as they limit consumers' choices and appears to tie students' and pupils' retention in these schools to the

purchasing of the face masks," Kasumpa stated. Kasumpa added that schools should desist from using protection against COVID-19 as a fundraising venture.

"In view of the foregoing, the Commission would like to remind the schools that the use of face masks is meant for the protection of individuals against contracting the Coronavirus and should not be used as a money-making venture. Therefore, the Commission wishes to warn all the schools that such unfair trading practices are punishable by law and any school that shall be found guilty will be liable to pay the Commission a fine not exceeding 10 per cent of its annual turnover. Further, the Commission is calling on all schools to allow pupils to purchase affordable face masks from sources of their preference to avoid contravening with the law," stated Kasumpa.


The centre-forward was handed a one-year contract by the Han Army, who finished sixth in the Chinese top-flight last season.

FAZ warns against misuse of COVID funds

FOOTBALL House has warned its member clubs against misusing the COVID-19 relief fund given by world governing body FIFA on non-footballing expenditure.

Following the devastating effect the global outbreak of the Coronavirus has had on football, FIFA set aside funds to help mitigate the impact of the pandemic on football clubs.

FIFA approved the decision to make available up to US\$ 1.5 billion in order to support the Member Associations through the FIFA COVID-19 Relief Plan.

Each Football Association is entitled to US\$1.5 million which will be given in three instalments of US\$500,000.

In his weekly column, Football Association of Zambia (FAZ) president Andrew Kamanga, Monday, stated that Football House had already disbursed the money to Super Division and National Division One teams.

"The first batch of USD500, 000 has already been disbursed to the 211 member associations. On our part, we have received this allocation and have proceeded to disburse it to our membership. We have been prompt in disbursing to our membership given the financial stress that the COVID-19 has caused in the game.

So far, all the Super League teams and National Division One have received their allocation while the lower division clubs have also started receiving. The delay in the lower division clubs is mainly due to the verification of bank details," Kamanga stated.

He warned against misuse of the funds.

"It must, however, be noted that these funds should not be diverted to non-football expenditure. FIFA places a high premium on transparency and accountability and we expect that our members should apply the same levels of prudency. Any misuse of these funds will attract sanctions, including the possibility of being excluded from the next cycle in January 2021," stated Kamanga.
