THE Council of Churches in Zambia (CCZ) says the unprofessional conduct of police officers against suspects perceived to be aligned to the opposition is a danger to national peace and security.

And CCZ has condemned police's inhumane treatment on incarcerated NDC leader Chishimba Kambwili's wife, Carol, and daughter, Chanda.

In a statement, Thursday, CCZ general secretary Fr Emmanuel Chikoya said failure by the police to run the service professionally was a danger to national peace and security.

"As observed by the Human Rights Commission (HRC) the Nonand Governmental Gender Coordinating Committee (NGOCC), the treatment that was given to Mrs Kambwili and her daughter was cruel, inhuman and degrading. Acts of cruel,...

ALLIANCE for Democracy and Development (ADD) president Charles Milupi says Zambia's economic recovery will only be realised when a new government is voted into power.

In an interview, Milupi said the PF government was simply unwilling to create a realistic recovery path, adding that Cabinet lacked the ability to get the country out of the economic crisis.

"They cannot put in place a plan for the economy to recover for two reasons. One, they don't have the ability to do that. Look at the Cabinet. Who is in that Cabinet that can spearhead an economic recovery plan? Who? The Ministers, who are there, were picked for other reasons other than running and growing the economy. There is no minster there whom I can point at and say, 'this one has the ability to lead the country into an economic recovery plan.' Number two, they are not willing to do that. That's not what they are in government for; they are not willing at all," Milupi said.

He said from the onset, PF had only been interested politicking rather than addressing Zambia's economic challenges.

He cited government's move to arrest political rivals at a time when the country needed an economic recovery plan as testament to the regime's inability to urgently address national issues.

"And when I say this,

# Zambia's economic recovery only possible with new govt - Milupi

I mean, look at their action right from their beginning. Look at their actions. Their actions have never been that of a government that wants to put the economy on a recovery path. They are interested in playing what they call politics. That is why they would rather arrest a political rival when they should be thinking about ways of creating an economic recovery plan. We told them when they knock out three zeroes from the currency that those numbers will come back as long the fundamentals of the economy are not right. You get the growth that you want to achieve, then you get stability in the money markets," Milupi said.

"You get stability in the fiscal arena. They have never really done that since they came to power. We are currently heading towards the Zimbabwe way. The inflation that this country is experiencing is not only worrying, it's a danger now to the economy. Just look at the budget. The Minister (of Finance) announced a budget of K119 billion. But when you look at the revenue side, only K66 billion arises from within ourselves. The rest of the money will come from borrowing. How do you sustain an economy via continuous borrowing? They have never learnt a lesson that borrowing is not good."

### Lsk police nab, transport Kang'ombe to Mpika

POLICE in Lusaka have apprehended Sesheke UPND member of parliament Romeo Kang'ombe and transported him to Mpika where he is to appear for questioning.

Kang'ombe is a suspect in a case where some UPND officials allegedly abducted two police officers and five civil servants when their party leader, Hakainde Hichilema, visited the area a week ago.

Zambia spokesperson Esther Katongo said the force had factored in

safety concerns and decided to take up the responsibility of transporting the Sesheke law maker "for his own safety".

"He came to headquarters for him to be accompanied by police officers for reasons of his safety," said Katongo.

At a media briefing last week, Home Affairs Minister Stephen Kampyongo said Kang'ombe was in the vehicle where two police officers and five civil servants were bundled after being abducted.

"The occupants of the vehicle on which the two officers were bundled included the member of parliament for Sesheke constituency, honourable Romeo Kangombe. So dear colleagues, besides the two officers, five other people including two

civil servants, an agricultural extension officer, a veterinary officer and three community members who stood by the road side were also attacked by this militia group and they sustained serious injuries and multiple deep cuts. In addition, the seven casualties recorded, the UPND militia group also stole properties which included a Lenovo laptop, a wallet, a shaving machine, cell phones and cash money amounting to K2,400. All the stolen items were valued at approximately K10,000. Furthermore, one residential house had the spare bedroom and kitchen window glass panes deliberately damaged. This damage of the residential house is yet to be ascertained," said Kampyongo.

"Government shall not entertain any form of violence any longer and whoever shall be found perpetrating political violence shall be dealt with in accordance with the law and regardless of political affiliation. Any form of violence is a criminal act that all political should condemn at all costs. In a voice note sent to News Diggers, Kamba argued that police should not be blamed for arresting Carol Kambwili because they were mandated to maintain law and

"Police officers by law are mandated to maintain law and order. It is, therefore, very imperative for every citizen to respect officers of the law. Zambia, being a democrat and a country of laws, has well laid-down procedures of handling matters, including a police officer if he/she misconducts himself. No one is above the law and no one can take the law into his own hands. We are saddened, today, that police are being called all sorts of names for arresting Mrs Carol Kambwili and her daughter, Chanda, at the Magistrates' Court. We never wish misfortunes to befall anyone and what happened at court yesterday (Tuesday) was very unfortunate," Kamba

We must, therefore, before we condemn the police, let us look at the issues objectively. We know very well that emotions were very high. The Kambwili family is going through hard times following the conviction of Mr Kambwili by the courts of law. But slapping a police officer at the Magistrates' Court was way beyond the limit. And Kamba appealed to the opposition to be fair to the police in Carol's case because the same had happened with his party cadres

"We further want to appeal to the opposition to be fair to the police and look at this matter objectively. Sometime back, PF cadres were beaten up and manhandled by the police officers, to be specific, our cadre, Mwelwa Chama, was beaten by police officers at the Magistrates' Court when they went to offer solidarity to Dr Chitalu Chilufya (Health Minister) and everyone was saying, 'well done' to the police! Now that it suits them, they want to make the police service look like it is the biggest monster? This is unfair to the

Meanwhile, Kamba stressed that it would be unfair for citizens to link President Lungu to Kambwili's conviction because the opposition leader was in conflict with the law and not with the ruling party.

"We had a meeting with the police and the opposition UPND at a similar privilege where many issues to do with respecting the officers of the law were discussed. The police and the law must be respected regardless of the perpetrator of lawlessness. The police have the mandate to prosecute and implement the dictates of the law. ### There's theft of construction material at Simon Mwansa Kapwepwe International Airport, laments AVIC

AVIC International Zambia says there is serious theft of construction material at Simon Mwansa Kapwepwe International Airport in Ndola.

AVIC Senior Consultant Lei Yingqi was speaking when the Civil Aviation Authority (CAA) board toured the airport yesterday.

In June this year, Lei reported theft of some cables on the site to Deputy Secretary to Cabinet Patrick Kangwa, who toured works on the project then.

Lei said he was worried that theft of materials had continued because it was detrimental to progression of the works at the US \$397 million project.

He said despite engaging surrounding communities, employees and police on the matter, the "unpatriotic had continued breaking the wire fence to haul a number of building materials including power generators.

"Some kind of stealing is happening here. I have tried working with the police and surrounding communities but the matter has persisted unfortunately. Unfortunately, most of the materials being stolen are imported ones," lamented Lei.

But Copperbelt Police Commissioner Charity Katanga, who was part of the tour, said there was need to enhance internal security before talking about the police.

She, however, assured that such people provided they were furnished with adequate information.

Meanwhile, Mumba says the National Day of Prayer will turn into a curse for the nation if church leaders begin to put politicians before God.

Last week, Batoka Times published an article where it was alleged that Mumba duped his fellow Opposition Alliance partners by declaring US\$40,000 out of the US\$400,000 said to be given to him by Kenyan-based law professor Patrick Lumumba whom the publication said is linked to Uganda's Lords Resistance Army rebel group.

But in an interview, Mumba said the theft allegations levelled against him were mere hallucinations. adding that Prof Lumumba had no connection to the terrorist groups as alleged.

"First of all, if you are referring to the stories by Batoka Bulls, first of all we need to find out who the Batoka Bulls are, and we have found out that they are a PF platform and we have written today to ZICTA to dig them out until we get to the person or persons behind it and then we have informed our lawvers to immediately litigate and take them to court to prove their claim. So, and this whole thing of the opposition, I can only speak for the MMD, that those are hallucinations. Mr Lumumba, in my view, has no connection to any one of the groups they are talking about. So, we are going to take them to court and we will get to the bottom of this because this type of politics is outdated. This thing of trying to defend the names of your opponents as we go towards the elections, we will make sure that we go and have it explained at court. I cannot comment on what Mr Kampyongo said because I didn't hear what he said, but for the MMD, they know that we are not involved in anything like that," Mumba said.

VETERAN politician Vernon Mwaanga says despite the country attaining 56 years of independence, Zambia's political and governance system has worsened and deteriorated.

In an interview, Mwaanga lamented that Zambia's political landscape was now characterised by greed and lust for personal wealth rather than public service.

"We are just about to mark 56 years since Zambia attained independence from Britain on 24th October, 1964. Independence came at a high price. The brave men, women and youth, sacrificed their lives, their blood, toil and sweat, to achieve independence. This would not have been possible without the support of ordinary people, who gave freedom fighters, the encouragement to

continue fighting under very oppressive conditions. The struggle knew no tribe and we all fought together and committed ourselves to uplift the living standards of our people, and I mean all the people, not just a few," Mwaanga said.

"We came up with the national motto of one Zambia, one Nation,' because it was a unifying theme. This was put in practice in terms of cabinet appointments, civil service, diplomatic and parastatal appointments. The freedom struggle was about service to the country and our people as a whole. It was not about selfenrichment. When I look at what is happening at the political level today, I shed one or two tears because of the excessive greed and lust for personal wealth, which is nearly always extended to other family members and friends."

He complained that endless insults, threats and political intimidation had become a norm on the current political landscape.

"The absence of any meaningful dialogue between

political leaders has introduced tension, hostility and even enmity, which is undesirable in what is supposed to be a democratic State. Insults, threats, intimidation, violence etc, have become the norm. There is an erosion of democracy, freedom of assembly, speech, freedom of press and human rights as we know them. This is an abomination! This is not who we are as Zambia. We represent something more noble and far better than this," Mwaanga said.

"There is something seriously wrong with this

current crop of political leaders, who are blind to the benefits of genuine political dialogue, which guaranteed us relative peace in the last 56 years. They should look at what Kenya has achieved as a result of dialogue and mutual respect among political leaders. Our recent history of national elections has been embarrassing in that we have had to deal with disputed disputed elections and aggrieved parties are not being heard in courts of law, as the Constitution of Zambia demands. The Public Order Act, as amended, is not being applied fairly to all the parties and is being subjected to very pedestrian interpretations. This has created a very uneven and unfair playing field."

Mwaanga lamented that there was nothing to celebrate about independence as high levels of poverty, unemployment debt had become unsustainable.

"We should mark 24th October as an important day. We have achieved a lot as a country in the past. There is very little for us to celebrate today, not only because of the Coronavirus pandemic, which has ravaged our country and the world, because many of our people are struggling to put food on their tables. Unemployment is high, our medical facilities are failing to give our people the healthcare they deserve," said Mwaanga.

"The high level of national debt has become unsustainable and future generations have been condemned to a debt trap, which has the potential to compromise the sovereignty of our country. Let us during the beginning of the 57th year of our independence manage our public affairs differently and better. Let us develop a spirit of love and togetherness for the sake of our country and people. Not to do so will be a dis-service and betrayal to our country, but to all those who sacrificed so much for our country to be free.'

### We'll observe independence amid extreme levels of police brutality, laments COF

CHAPTER One Foundation (COF) says Zambia has experienced a rapid weakening of the democratic system, which includes increased limitations of freedoms of expression and assembly in the past 10 years.

In a statement, Thursday, Chapter One Foundation executive director Linda Kasonde observed that this year's Independence Day celebration came at a time when most citizens were losing hope in the State's ability to protect Zambians.

"For most of our independence, Zambia has been a beacon of peace and democracy. We have exemplified peaceful transitions of power on the African continent, whilst setting a strong foundation to build accountable and responsive systems governance. Over the last 10 years, Zambia has experienced a rapid weakening of its democratic system. includes increased limitations on freedoms of expression, assembly, and association. We have also seen increases in the weaponisation of the law against individuals and groups dissenting against State actions and systems," Kasonde stated.

"This year's Independence celebration comes at a time where Zambians are losing hope in the State's ability to protect the Zambian people, physically, economically and socially. We, as a nation, are experiencing heightened corruption, lawfare and extreme levels of police brutality against civilians, which continue to go unsanctioned by the State. nationally-witnessed inhumane arrest of National Democratic Congress leader Chishimba Kambwili's wife and daughter, Carol and Chanda Kambwili, by members of the Zambian Police Service; the cancellation of Prime TV's broadcasting license 'in the interest of public safety, security, peace, welfare or good order'; and the continued extortion and intimidation of private civilians by ruling party cadres are recent examples."

Kasonde added that the selective application of the law and rampant corruption was plaguing Zambia.

"The selective application of the law and rampant corruption is plaguing the nation. Similarly, the COVID pandemic has exposed the fragility of our social systems and healthcare institutions, which threaten the social development of the Zambian people, a majority of whom live below the poverty line and are in desperate need of State support. Additionally, economic contraction observed by the rapid depreciation of the kwacha. rising inflation, the worsening public debt and increasing prices of essential goods, have greatly impacted the purchasing power of all Zambians. This has further impacted the unemployment rates, particularly among the youth, who are emerging as the most distressed group of Zambian citizens," Kasonde observed.

"As we celebrate our 56th year of Independence, it is imperative that the Zambian people and the Zambian government promote and protect progressive, democratic, civil, political, social, economic and human to improve rights

### Police finally free Chanda Kambwili

INCARCERATED NDC leader Chishimba Kambwili's daughter, Chanda, has finally been released after spending two nights in police

Confirming this in an interview, Thursday, police spokesperson Esther Katongo said the charge had been reduced from assault to conduct likely to cause breach of peace.

'She has been released. The charge was reduced from assault to conduct likely to cause a breach of peace. Officers just decided to charge her for conduct likely to cause a breach of peace. She has paid the admission of guilt fine and the matter has closed," said Katongo.

On Tuesday, police in Lusaka picked Kambwili's wife Carol and Chanda at the Lusaka Magistrates' Court on allegations that the two misconducted themselves as officers were performing their duties.

The two women were manhandled before being bundled into a police vehicle and taken to Kabwata Police Station where they were detained.

Carol was charged with conduct likely to cause a breach of peace and released a day later after paying a fine but Chanda was slapped with a more serious offence of assault and police had said they would take her to court

LUSAKA Principal Resident Magistrate David Simusamba has set Monday, October 26, for hearing of an application for bail pending appeal by incarcerated NDC leader Chishimba Kambwili, after the latter successfully filed in the documents.

Kambwili has also filed in a notice of appeal against his conviction and sentence, with 11 grounds of appeal, among them that magistrate Simusamba erred in law and fact when he convicted him and imposed what he termed as a punitive sentence, basing his conviction and sentence mainly on his erroneous finding that he (Kambwili) had shown no respect for the honourable court, an issue that was not subject of trial before court.

Earlier, Magistrate Simusamba ruled that he would not entertain Kambwili's application for bail pending appeal, until such a time that the NDC leader complied with the appeal procedure enshrined in the Criminal Procedure Code (CPC)

He said Kambwili's notice of appeal which was filed on October 14 was irregular as it was filed into court way before he could finish pronouncing both his judgement and sentence in the matter, contrary to the demands of sections 321 and 323 of the CPC.

He added that Kambwili would continue serving his sentence until further order of the court or completion of the sentence.

On October 14, this year, magistrate Simusamba convicted and sentenced Kambwili to 12 months imprisonment with hard labour on charges of forgery and uttering a false document.

He however, acquitted him on the other charge of giving false information to a public officer

But on the same October

14, Kambwili filed a notice of appeal against his conviction.

When the matter came up for a ruling yesterday, magistrate Simusamba said Kambwili's notice of appeal was irregular.

He said the procedure to follow in simple language was that after the court had delivered its last order in the case and adjourned the matter, either party to the case (the convict or the DPP), could file a notice of appeal on any lawful grounds stated under section 321.

Magistrate Simusamba said it was only after a notice of appeal had been successfully filed that section 332 of the penal code (bail pending appeal) could be invoked.

He noted that in Kambwili's case, the notice of Appeal was clearly filed before he could conclude the delivery of judgement and sentence, a position which was contrary to the demands of section 321 of the CPC.

Evidence of this fact can be seen in both the grounds of appeal in the notice of appeal and the affidavit in support of summons for admission to bail pending appeal both filed on October 14, 2020. Thus in the grounds of appeal, the convict states at ground six that "more grounds to follow upon perusal of judgement". Meaning that at the time he was making the grounds of appeal, he had not perused the judgement or he was simply not paying attention when it was being read out to him," magistrate Simusamba said.

"In addition to that, it is a requirement that the appellant signs the notice of appeal. One wonders at what point he (Kambwili) signed the appeal,

for it purports to have been signed by him, when he clearly had no such opportunity as he was listening to his judgement from the dock."

Magistrate Simusamba said it was more shocking that Kambwili had claimed in his affidavit in support of summons for bail pending appeal that he was convicted on October 12, 2020, when judgement was delivered on October 14.

He added that it was also shocking that Kambwili appealed against his acquittal on the charge of giving false information to a public officer.

"What is even more shocking is the evidence in the affidavit in support of summons for bail pending appeal. In that affidavit at paragraph three, the convict (Kambwili) states "that on October 12, 2020, I was convicted by this honourable court of the offences of forgery; uttering false documents; and giving false information to a public officer. And I'm currently in detention at Lusaka Central correctional facility". Any person who has been following these proceedings and reading the foregoing would most definitely be gripped with shock," magistrate Simusamba

"Firstly, the date cited in that affidavit is October 12, 2020 which is the date that was initially set for judgement and later postponed to October 14. Secondly and perhaps most shocking is that the convict has appealed against his acquittal on the charge of giving false information to a public officer. Despite having denied the charge at the time he took plea and through out his trial. This is quite unprecedented in my 13 years of experience on the bench and I have equally never come across literature to that effect."

Magistrate Simusamba added that Kambwili in his affidavit also purported to have been detained at Lusaka Central facility when he was in fact in court on that day and not yet been committed to the said facility.

He said his interpretation of these unusual facts was that the notice of appeal was filed into court way before he could finish pronouncing both his judgement and sentence in the case contrary to the demands of sections 321 and 323 of the CPC and therefore irregular.

"The notice of appeal being irregular I therefore hold here that there was no notice of appeal at all. Consequently, the convict cannot invoke section 332 of the CPC by applying for bail pending appeal without complying with sections 321 and 323 of the CPC. I shall therefore not entertain any application for bail pending appeal until such a time as the appeal procedure enshrined in the said CPC is fully complied with. The convict will continue serving his sentence until further order of court or completion of the sentence," magistrate Simusamba ruled as he adjourned the matter.

But Kambwili, through his lawyers, has now successfully filed in his summons for admission to bail pending appeal as well as a notice of appeal against his conviction and sentence.

Magistrate Simusamba has since set Monday, October 26, for hearing of Kambwili's application for bail pending hearing of his appeal to the High Court.

Kambwili's 11 grounds of appeal are that in view of

Article 18 of the Constitution of Zambia; Section 39 of the Anti-Corruption Act No. 3 of 2012; and Sections 3 and 6 of the Judicial (Code of Conduct) Act No. 13 of 1999, magistrate Simusamba erred in law and fact when he declined to recuse himself and proceeded to hear the matter and convict him, notwithstanding the fact that he had accused him (Kambwili) of trying to bribe him and that he (Kambwili) had as a result of the accusation sued him for defamation of character.

That magistrate Simusamba erred in both law and fact when he prematurely curtailed Kambwili's continued defence of his case and ordered immediate closure of defence notwithstanding that he (Kambwili) had applied to adjourn the matter on the ground that his Counsel was appearing before the Court of Appeal on the same date and at the same time.

That magistrate Simusamba erred in law and fact when he held that Mwamba Chishimba was a fictitious person, notwithstanding the evidence that was placed before court regarding the existence and true identity of the said Mwamba Chishimba.

Kambwili has also argued that magistrate Simusamba erred in both law and fact when he held that by signing Companies Form 71 on behalf of Mwamba Chishimba, he (Kambwili) forged the document.

Other grounds are among others, that magistrate Simusamba gravely misdirected himself both in law and fact when he convicted Kambwili against the weight of the evidence on record, and when he held that Kambwili and some

of his lawyers had no respect for the trial court and that he (Kambwili) lied to the court that he had tested positive to COVID-19.

In his affidavit in support of summons for admission to bail pending appeal, Kambwili stated that the offence he was charged with was bailable and hence his application to this court of competent jurisdiction to admit him to bail pending the determination of his appeal.

"That if bail is not granted, I am going to suffer prejudice and injustice as there is a possibility of serving the substantial part of the sentence aforesaid before the appeal is heard thereby rendering my appeal an academic exercise and of no purpose," he stated.

"I hereby make an undertaking that if bail is granted, I shall abide by and comply with all reasonable bail terms and conditions that this Honourable Court of competent jurisdiction may impose."

Meanwhile, Police officers who were manning the entrance to the Lusaka Magistrates' Court complex yesterday apprehended UPND Chikobo ward councillor Regan Mubatsa after he attempted to enter the court premises without clearance.

The armed police officers stopped Mubatsa as he attempted to enter the premises and asked him to show them the court documents which allowed him to be at court.

But Mubatsa failed to produce the documentation, a situation that forced the angry officers to bundle him in a police vehicle and whisked him away to Kabwata Police Station.

ZNBC journalist Katwishi Bwalya, who was live streaming on Facebook, was also queried as some officers grabbed his phone after he was seen capturing events using his phone.

Bwalya was only let go after the officers saw his identification card and after he told them that they were live on Facebook. Zambia,

OVER 12,000 cases of cancer are recorded every year in Zambia, says Cancer Disease Hospital senior medical superintendent Dr Lewis Banda.

And MTN Zambia chief executive officer Bart Hofker says the company is committed to look beyond its main operations and reach out to communities to help improve Zambians' lives through its corporate social investment.

Speaking when he received some detergents and food supplements donated by MTN Zambia at the Cancer Disease Hospital in Lusaka, Thursday, Dr Banda said the number of cancer cases in the country had now escalated to over 12,000 per annum.

"The Cancer Disease Hospital is the only cancer hospital that we have in Zambia, and as you may know, the numbers of cases of cancer that you are seeing in this country are everincreasing. We are seeing at a national level, over 12,000 cases of cancer every year and the bulk of the cancer apparently affects women," Dr Banda said.

"The number one cancer that we see is cervical cancer and then followed by prostate cancer. So, from the statistics, we see that it is affecting mostly women."

He added that the number of cancer cases in children were also going up.

"We still see cancer in children. We see that the numbers are going up again among children. Mostly, cancer that is common in children is cancer of the eye. This has become common as lots of children are brought a bit late and they start treatment late also," he said.

And Dr Banda lamented that government resources were insufficient to effectively fight the soaring numbers of cancer cases.

"Government resources are not enough in the same cases and we need to be helped so that we help these patients. We also have challenges with our machines, which are

of the time, they are down. We have challenges in the logistics, mostly drugs, and it is becoming very difficult to source drugs, locally, because of the COVID pandemic," said Dr Banda.

And Hofker said "As MTN MTN Zambia remained through our

social investment, we are committed to look beyond our main operation by reaching out to the communities and generally helping to improve the lives of Zambians. We believe the nation can only flourish if its citizens are in good health and if good health services are provided to citizens. We strive to help the

# Withdraw, subject NGO amendment bill to consultations, demands ActionAid

ACTIONAID country director Nalucha Ziba says the Non-Governmental Organization amendment Bill which is currently before the National Assembly does not have the blessing of NGOs because stakeholders were not consulted.

In a statement, Thursday, Ziba said the government had used the back door to try to strengthen a section on money laundering and terrorism financing which the NGOs had rejected.

"The Non-Governmental Organization Amendment Bill (2020) currently before the National Assembly does not have a blessing from the NGOs as it lacks consultations from the sector. As the NGO sector, we were taken aback to read and hear that the government is sponsoring an amendment to incorporate a section on money laundering and terrorism financing under the NGO Act No. 16 of 2009, which is currently under the process of repeal and replacement. This process of repeal and replacement of the same Act has reached a completion stage and was spearheaded by the Technical Working Group (TWG) constituted by the Government itself through the Ministry of Community Development and Social Services. The fact that the government has used a back door to undermine this process and try to strengthen the rejected Act by the NGOs, is a sign of desperation and lack of respect for stakeholders' consultations and input in legislative process," Ziba stated

And Ziba has demanded that the bill be withdrawn

from parliament and be subjected to a consultative process.

"It is on this premise that we demand for the withdrawal of the Bill from the National Assembly and be replaced by the actual comprehensive NGO Bill currently with the Zambia Law Development Commission (ZLDC). We shall not accept piece meal amendments of the Act regardless of the pressure the

government is under to fulfill the international dictates. We urge all NGOs interested in seeing a legal framework that respond positively to the growth of the sector to reject this piece-meal amendment and press for the tabling of the Bill developed by the Technical Working Group under the supervision of ZLDC and the Ministry of Community Development respectively," stated Ziba.

On Tuesday, Community

Development and Social Services Minister Kampamba Chewe presented the Non-Governmental organization amendment Bill 13 of 2020 for first reading in parliament.

And Speaker of the National Assembly Dr Patrick Matibini referred the bill to the parliamentary committee on committee on Health, Community Development and Social Services for scrutiny.

UPND national chairperson Mutale Nalumango says there is no need for the ruling PF to be scared of what her party will do when it forms government because the opposition party's goal is not to settle scores.

So, don't go and start scaring innocent people and say 'when these people come in, they will do this.' What is that? There is no way. They say ingulube bakonka ilile

umumbu (you only chase after a pig which has eaten maize). You don't start witch hunting like they are trying to find crimes that they imagine in their heads of years ago. No. no innocent person will be incarcerated. So, let them not scare innocent members of the PF who are suffering like everybody else," Nalumango said.

She said people should not fear because her party leader Hakainde Hichilema would be a president for all.

"Why is she thinking of the opposition? Is she thinking of the atrocities they have committed in government? PF should not fear and I am talking to the general PF membership. If you have not committed any crime, why should you live in fear? UPND will be there to look after everybody. We know when we win, the president Hakainde Hichilema will be president for everyone. The danger that they may be thinking about is for those who have committed atrocities. And that will be a different matter. It will not be UPND as a party like they have been doing where a PF cadre can stand up and threaten people. We shouldn't allow that," Nalumango said.

"Nothing will happen to them. The opposition will have their own space when we come in next year. So, let her not use it as a way of scaring people. Hakainde and UPND are not coming to start hunting for innocent people. They will be safe as long as they sit on the right side of the law. Nobody will be victimized under UPND. That will not happen. UPND will be run by government and not by cadres like they have been doing. Everybody will have their space. Those in government will have their own space, and the opposition will have their own space."

Nalumango asked Siliya to put her imaginations aside. "I think she should be

scared of what they are doing themselves to the people of Zambia other than worry outside her imagination. Why should she think we would do anything to the opposition? We do understand the role of the opposition and what we have been crying for is what will happen. Gary talked about people who praised government for nothing. So, how does the opposition come in? If we will have the opposition that will praise government for real, I think that's okay. But to have an opposition that is just waiting to eat from the ruling party, that is not genuine democracy. For us, we respect our Royal Highnesses all over. We are part of the traditions of our land. And they will be respected. And the respect you show to the chiefs is not to make the chiefs start clapping for you. The chief is the custodian of the people that they rule over. And we expect that our Royal Highnesses should look at the plight of the people that they look after rather than their individual capacities. I think that is what Gary was trying to

say," said Nalumango.

# TIZ hopes FIC Amendment Bill isn't aimed at clipping centre's powers

TRANSPARENCY International Zambia (TI-Z) has wondered whether the Financial Intelligence Center amendment bill isn't targeting to clip the powers of the centre.

In an interview, TI-Z executive director Maurice Nyambe hoped that the amendment bill was not a smokescreen for weakening the functions of the FIC.

The Financial Intelligence Center amendment bill passed the first reading stage in Parliament on Tuesday.

"We have noted that the Financial Intelligence Centre (Amendment) Bill 2020 went through First Reading in Parliament on Tuesday and has now been referred to the parliamentary committee on National Security and Foreign Affairs. Our hope as TI-Z is that the proposed amendment is not a smokescreen for clipping the wings of the FIC. We have observed with amusement that the PF

government has not been happy with what the FIC has revealed through their Trends Analysis reports, particularly the 2018 one and there were incessant attacks made on the FIC and its leadership by senior government and PF officials in the wake of the release of the 2018 report," Nyambe said.

"Our hope is that the proposed amendment, whose first objective is 'to redefine the functions of the Centre', will not make it more difficult for the FIC to bring into the public domain incidences of financial misconduct particularly by Politically Exposed Persons. We also wish to emphasize that the significance of the FIC in dealing with money laundering and countering terrorism financing should not be diluted through this amendment. These two crimes are getting sophisticated by the day and the FIC should be empowered to meet all the international standards as outlined by the Financial Action Task

Force (FATF)."

Nyambe said TI-Z would not support any attempts that would turn FIC into a moribund institution.

"Further, the FIC has in the recent past touched on Environmental crimes as a means of money laundering and we are alive to the fact that the allegations of impropriety in the export of the Mukula tree continue to be made. Our hope is that this amendment is not one of the many reasons to try and cripple the FIC. The FIC has already seemingly been politicized by the PF government and it is our hope that these amendments are not intended to further weaken the institution. We will as TI-Z not support any attempts to turn this important institution into a moribund one simply because Political Exposed Persons are uncomfortable with the revelations of possible wrong doings involving them. We will be watching this space very closely in that regard," said Nyambe.

THE Council of Churches in Zambia (CCZ) says the conduct unprofessional of police officers against suspects perceived to be aligned to the opposition is a danger to national peace and security.

Acts of cruel, inhuman or degrading treatment of suspects are categorically forbidden under Article 15 of the Constitution of Zambia, Chapter 1 of the laws of Zambia and under international human rights law. Zambia is a democracy where citizens are guaranteed human rights, which must be recognised and respected by law enforcement agencies. Failure to respect the rights of suspects regardless of their

offence is a violation of the law," Fr Chikoya stated.

"After having studied this matter concerning Mrs Kambwili and her daughter, our understanding is that the unfortunate happenings that led to the duo's arrest arose from the fact that they were denied access to see their loved one, against their constitutional right. We, therefore, remind the police that it is both humane and constitutional for them to allow family members, relatives and friends to have access to their incarcerated loved ones. Denying them access to their incarcerated loved ones is a violation of the law. We would further like to remind the police command that failure on their part to run the police service professionally is a danger to national peace and security."

He also condemned the unprofessional, heavyhandedness and brutality by police on defenceless and unarmed citizens.

"We have noticed how the Zambia Police has been quick to arrest suspects, who are considered to be aligned to the opposition political parties, while tolerating those considered to be aligned to the ruling party, regardless of the crimes committed. This behaviour




If you don't vote during an election, you are surely voting indirectly against democracy and making way for irresponsible



KASAMA PF member of parliament Kelvin Sampa has asked the Lusaka High Court to stay proceedings in a case in which RL Extrem Investment Limited has sued him for allegedly failing to pay over K2 million after supplying him with more than 4,000 security boots.

Sampa wants the Court to stay proceedings and to refer the matter to arbitration.

He has stated that the claims brought before court by RL Extrem Investment Limited arise out of the sale of goods agreement which was signed between himself and the said company in

his capacity as the national chairman of the Patriotic Front party.

Sampa further stated that the said sale of goods agreement in clause 10 has an agreed dispute resolution mechanism, which is arbitration, adding that on account of the agreed dispute resolution, this is a fit and proper case for the Court to stay proceedings and refer the matter to arbitration.

This is according to



an affidavit in support of summons for stay of

proceedings, pending arbitration and to refer matter to arbitration, filed in the Lusaka High Court recently.

Sampa argued that the grant of such application will not prejudice RL Extrem Investment Limited in any way, but conversely the interest of justice will best be served.

And according skeleton arguments support of summons for stay of proceedings, pending arbitration and to refer matter to arbitration, Sampa stated that the Court had the requisite jurisdiction to stay proceedings in this matter and refer the case to arbitration

He added that it would, therefore, be in the interest of justice for the Court to grant his application as both parties intended to have their disputes resolved through arbitration and not through the courts.

In its statement of claim filed in the Lusaka High Court on September 21, RL Extrem Investment Limited had stated that it was involved in general supply of goods in Lusaka and elsewhere in Zambia.

It stated that by contracts in writing dated November, 2019, it supplied Sampa 226 security boots at K550 per pair totaling K124,300 on one hand and 4,200 security and safety boots at K430 per pair totaling K1,890,000 altogether coming to K2,014,300.


RL Extrem Investment stated that it was a term of the contract that upon delivery of the goods, Sampa would pay 50 per cent of the total amount.

It added that it delivered the goods during the course of November, 2019, which were duly received and acknowledged by Sampa.

The company, however, stated that Sampa failed to pay the 50 per cent or any other sum, as agreed.

"By a demand letter dated June 23, 2020, addressed to Sampa's advocates, the company through its advocates made its first demand in writing for the payment of K2,014,300. The defendant has either failed, refused or otherwise neglected to settle the claimed amounts," read the claim.

The company stated that it was entitled to claim the said sum of K2,014,300, together with interest and costs.

### There's a silver lining to the effects of COVID-19 — HIVOS

COVID-19 has brought about unexpected positive outcomes despite having affected many lives across the world negatively, says HIVOS Regional Advocacy Manager for sustainable food in Southern Africa William Chilufya.

Analysing Zambia's food and nutrition security situation amid COVID-19 and the extent to which the pandemic had affected people's lives in the country, Chilufya said the outbreak had taught citizens how to rely on themselves.

Chilufya said disruptions to global foods systems brought about by lockdowns and closures of international borders had also provided an opportunity for farmers to supply locally produced goods on a larger scale

"For me I think there is a silver lining to this whole situation; what COVID-19 has done is it has created an opportunity for us to begin realizing the value of our local food, why? Because the influx of food from out of the country has now reduced because of restrictions regarding exports and imports. So this has created an opportunity for us to benefit from what we have in our country. Therefore, for farmers, it might be an advantage in the sense that there will be available market ready for them. But then this can only happen when farmers decide to work together in form of cooperatives. But what we see here as HIVOS is an opportunity for our local farmers to supply locally produced goods at a larger scale," Chilufya said.

"COVID-19 has actually taught us to say, you and I [this reporter] should begin having a small garden at our house where we can get our vegetables from. Producing our own food is really important in the sense that these foods that you find everywhere, you don't know what chemicals they have. So it's important that we begin growing our food even if it's in a small backyard. If it's in a sack, grow something in a sack at home."

Chilufya said promoting the consumption of locally produced goods would contribute to people's easier access to healthy and sustainable diets.

"At household level, the issue has been about dietary diversification. The Ministry of Health has been talking about eating diversified foods at household level so that we can build resilience towards this coronavirus. If you have noticed, most of the people that are dying due to coronavirus these days also have something to do with nutrition and the type of food they eat. So what the government needs to do is to ensure that farmers and the consumers are actually involved and continue getting involved and they continue producing these local foods," Chilufya said.

Meanwhile, Chilufya insisted that it would be better to focus on the opportunities that had been created by COVID-19 as he assessed the extent to which the pandemic had negatively affected live

"It's really difficult to tell if food is in short supply because of COVID-19 or not. It's just the issue of movement, but Zambia hasn't had a closed market. We haven't had a lockdown, so food has been circulating in a normal way. But what we see is just an advantage that has been brought about because farmers now have an opportunity to supply. We are not competing so much now. Have you seen how local products like lemons and oranges have gotten expensive? It's because they are not coming in the country from outside. So if you are a farmer in Chipangali

(district of Eastern Province) and you are growing lemons, you have this opportunity. So for me I think we should look at this [COVID-19] in terms of what opportunities are coming up for Zambian farmers in terms and not focus on the negative side of things," said Chilufya.

And United Party for National Development (UPND) member of parliament in the Gwembe valley of Southern Province Attractor Chisangano suggested that government needed to consider introducing a mixture of food for distribution as relief to households that were struggling due to the effects of COVID-19.

"Food security has really been very poor, starting from last year till now. And now with the outbreak of coronavirus, some of the people who are into trading where they go and sale merchandise in town so that they can be able to buy food, it is becoming a problem. The restriction on movement of animals especially from Gwembe has also worsened the issue of food security in the area. Then the drought which we experienced last year, where most of the farmers and households had to selloff their animals so that they could be able to buy a bag of mealie meal has made things very difficult for many households. Now this time they are struggling whether to spend their money on food or save it to pay for school fees for their children. So it's like a mountain of problems affecting food security in the area," said Chisangano.

"So due to all these problems that people are currently facing, access to sustainable diets has also affected because there isn't enough locally available food. So families are unable to utilize the food that is locally available. And for us in a place like Gwembe where people didn't do much farming

due to the drought experienced last year, there isn't adequate food and therefore, people are not able to have diets which are sustainable, they are just eating what comes along. So really, when you are talking about sustainable diets in an area like Gwembe, it's very difficult. Then also when government is giving relief food, when you look at the quality of relief food, it's just mealie meal or maize. But we forget the other part, how do they eat the mealie meal or the Nsima? So if there was also a consideration from DMMU, they should to start giving a mixture of food as relief food; for example they would give mealie meal, beans, groundnuts... just a mixture of food so that people can have healthy diets, not the way it is now where relief food is just mealie meal or

Meanwhile, Agriculture Minister Micheal Katambo insisted that Zambia was still food secure despite the effects of COVID-19 and that there was variety of food for people to choose from in order to stay healthy.

"Have you heard anything like Zambia is asking for food supplies from other countries? No! We are secure, the country is food secure and even where there are emergencies or calamities, the Vice-President is taking care of that. We have a variety of food that people can choose from to remain healthy. The only othezr thing I must emphasise is the fact that it's very important that farmers begin to plan against eventualities because we don't know what tomorrow brings. Who knew that we would ever be hit by the coronavirus? Who knew that farmers would find it a problem to sell their produce due to restrictions on movement? So farmers need to be planning against such eventualities in the coming years," said Katambo in an
