POLICE in Lusaka have UPND detained member Anthony Bwalya on an unknown charge but have released party secretary Stephen Katuka after questioning at Police headquarters.

According to Lusaka lawyer Mulambo Haimbe,

Bwalya has been detained but his charge and holding place remain unknown.

"With regard to Mr Katuka, there was an interview that was undertaken and the police said they would request him to come back if they required more information. As for Mr Bwalya, he has been detained in custody, we have not been

told what the alleged offense he committed is, we have not been told which detention facility he will be taken to ultimately because at service headquarters there are no cells. All I can say as at now is that the police are claiming to be conducting some investigation of one sort or the relating, I believe, to the issue of national registration cards that was spoken of by Mr Bwalya and Mr Mubita Nawa on television about two, three, four days ago or so," said Haimbe, adding that the matter seemed to be a political issue which was being used for purposes of criminal persecution.

By press time, there was still no update on Bwalya's whereabouts and police had not vet confirmed his arrest.

Around midday, Tuesday, surrounded police the UPND secretariat in Lusaka's Rhodespark area where they had a warrant to search the premises for "piles of national registration cards".



Tongas have risen against us Easterners to take our presidency, we must fight - Dora

By Zindikilani Banda in Sinda IN this audio, Petauke Central PF member of parliament Dora Siliya says Tonga's have risen against Easterners in a bit to grab the presidency from them, adding that this is a war which must not be lost.

And Siliya has advised traditional leaders to lie that they are poor and vulnerable when they face Social Cash Transfer officers so that they can benefit from the fund to buy clothes and look smart.

Meanwhile Siliya told traditional leaders in Sinda that UPND leader Hakainde Hichilema was on TV where he vowed to remove the Chitimukulu once elected into power

Speaking on Sunday when she addressed about 300 village headmen, women and indunas at Mwala Hills, Siliva knelt down and asked the people to forgive government for the wrongs committed in the past five years.

She said Tongas must not be allowed to grab the presidency before Eastern Province exhausts the privileges that comes with it, and urged traditional leaders to make sure that the UPND is not given any votes.

Below is the English translation Siliya's from vernacular campaign address, which has also been reproduced verbatim at the bottom:

I have heard that you traditional leaders don't benefit from Social Cash Transfer (SCT). We are here to tap about issues that affect our lives, we must not forget. I have heard that you are not benefiting, but the government has said if that was the case, it must not continue. Headmen should be taking social cash transfer as well. So those of you who would like to benefit from SCT, you must go to the DC's office so that you can be told how to do it. They will ask you questions:

Does your house have iron sheets? Yes

Do you own cattle? Yes Do you own a bicycle? Yes How many times do you eat? You say we manage to eat four times a day...

As you are answering the thine is recording. It will say that you are not a poor person and you cannot benefit with such answers. Let me share some wisdom with you if you want to benefit from Social Cash Transfer. The DC will teach you that even when you live in a house with iron sheets, don't say the truth so that you can be included on the social cash transfer programme. That way you can have money to buy shoes and clothes so that you look presentable. As government we know that you traditional leaders need help.

I have also heard that you traditional leaders want to be paid. This started around 2015-2016. The laws of Zambia are contained in the Constitution. In 2016 we change the laws to the effect that the government

or the President must not be helping traditional leaders. Do you remember? But in 2017, some senior traditional leaders went to complain to the President that this law was bad and it must be changed. The president said 'I have heard but I need to ask the rest of the people of Zambia what laws they don't want from the Constitution. The minister of Iustice went round the country to collect recommendations. There are a lot of things that people demanded to change in the Constitution, over 20 things. All these things were put in a document called Bill 10. Have you heard about Bill 10? That's the document that has the changes which you want where government can be paying you.

But when we now took this document to Parliament to enact it into law, the UPND, the Tongas said 'this is a waste of time. They said 'why do you want to have a law for helping traditional leaders when in other countries like Tanzania, there are no traditional leaders. Why should we waste money?' Us PF want to help but UPND is saying that's a waste of money.

I am not lying, you saw when Hakainde was telling the Paramount Chief of the Bemba People, the Chitimukulu that when I become President, you will be the first chief I will remove from your throne. Are you listening? It was on TV, I am not making this up, he said when I become President, the first chief to remove will be Chitimukulu. So after he removes Chitimukulu will he not come to Eastern Province to remove you? This is why you must support Bill 10. The Bill will be debated on Thursday this week and that is the day when we will know if the laws of Zambia will change. If you see on TV, a lot of traditional leaders are supporting Bill 10 because they want government to be helping them. But the UPND is challenging the Bill because they feel helping traditional leaders is a waste of time. Is it a good things for UPND to say there must not be traditional leaders in Zambia? Are we not gong to lose our tribes and culture?

When the President helps you traditional leaders, he does it because he is a good man, but there is no law that savs government should help traditional leaders. So pray for us this week so that this Bill can

Our rivals in UPND are saying they don't want Bill 10 because it will prolong President Edgar Lungu's stay in power. But that is a lie. In Zambia a president can stay in power for 10 years, the law says if you only serve less than three years, that term doesn't count. So President Lungu's term only counts from 2016. So we need him to rule from 2021 to 2026 so that he can make it 10 years.

Beware of Defaulting on External Debt!

sovereign debt default occurs when a country fails to meet a single debt repayment obligation. This repayment may be towards its principal, interest, or a combination of both. Any country which defaults or suspends its interest obligations towards its external debt is said to be in a sovereign debt crisis-since this would indicate an inability to service its loans. By defaulting, a country would essentially be failing to meet the terms of a contractual agreement upon which it contracted the debt. Depending on the agreement, countries which have defaulted have lost their national assets to creditors and have also exposed themselves to a host of economic and trade sanctions.

There are number of notable consequences of sovereign debt defaults. These include loss of national assets, loss of reputation or creditworthiness, capital flight, and other economic impacts. Among all of these, the greatest incentivefor avoiding a default is associated with the loss of reputation or creditworthiness. Countries have an incentive to continue servicing their external debt, usually at the expense of domestic needs, in order to preserve their future access to international creditmarkets and international trade markets. This is because a country which defaults on its external debt repayments risks being excluded from these internationalmarkets. This exclusion

would make it difficult for such a country to access resources for investment and development.

Moreover, defaulting on sovereign debt may also undermine the country's capacity to obtain beneficial deals with nonmarket lenders such as multilateral and bilateral organizations. With credit market borrowing being next to impossible, due to exclusion, a country would switch to multilateral and bilateral organizations for funding. However, the bad credit reputation will limit its ability to negotiate for better loans. A County would, for example and mostly with bilateral lenders, be forced to provide national assets as colleterial for subsequent loans in order to assure itsnew creditors. Under these terms, in the likely event of another default, such a country would lose its national assets.

Following the exclusion from international credit markets and increased cost of debt contraction, a debt default may also lead to a debt overhang. A debt overhang occurs when a country borrows excessively to the point that it is no longer able to access further financing, even when such funding is meant for projects or investments which would improve its debt situation. In such a debt trap, a country would not be able to access sufficient commercial, concessional, or bilateral loans and would therefore experience significant economic and development challenges.

Finally, a default also has lasting effects on the country's economic growth, trade, and the financial sector through capital flight. It is general investment reasoning that a country that defaults on its external debt is also likely to default on its domestic obligations; such as domestic debt and domestic arrears. Furthermore, the poor credit reputation of the government would also translate into a poor credit rating for private firms within the country. Therefore, a sovereign debt default will eventually trigger capital flight and compromise the domestic financial sector. This would, in turn, lead to further depreciation in the exchange rate and a rapid rise in inflation.

Considering these serious consequences of sovereign debt defaults, it is in any country's best interest to meet its external debt obligations. It is also prudent to only contract sustainable debt in order to avoid debt defaults in future. Proper debt management should ensure that a county's debt is always within its ability to pay.

We've enough numbers to block Bill 10 - UPND

LEADER of the Opposition in Parliament Jack Mwiimbu says the UPND has garnered enough numbers to block Bill

And UPND chairman for elections Gary Nkombo says not all PF members of parliament want Bill 10 to

Central PF member of parliament Tutwa Ngulube claimed that Bill 10 would go through with the help of 10 UPND members of parliament who had agreed to support it.

Mwiimbu said Ngulube's statement was not tenable.

"We shall not vote for Bill 10 for the said bill is not in the interest of the people

of Zambia. Members of the public must realize that this is one particular bill that has been so contentious to the extent that the Church and other civil organizations have raised their concern pertaining to this particular bill. Because we are a listening party that works with the people, we have resolved not to support the bill. The statement that has been made by the rogue PF member of parliament for Kabwe Central is not tenable. As far as we are concerned, as UPND we have the number to block this bill. If they have excess funding to ensure that they purchase some of our members, that is their style of doing things in this country. He has indicated that the delay was due to the gazzeting, that is ignorance with horns!" said Mwiimbu.

"This bill was gazetted in 2019, there has not been any legal gazzeting of this bill, it shows his ignorance of the constitution making process. We have the numbers together with alliance partners to block this bill on behalf of the people of Zambia. We are aware of three MPs, they have made their decision consciously and as a party, we are not going to do anything against them, the people of Zambia and those in their constituencies will deal with them at appropriate time."

freedom fighter MPs who we

have stood together with from the beginning...Mr Ngulube is trying to excite the public on a matter that is clearly nonexistent but we will cross the bridge when we get there. Human beings as they are, you can only vouch for yourself but in my own frame of mind, I am very certain and sure that all the colleagues who have said no to Bill 10 are still in the same accord and we have not shifted an inch. So it is a wait and see situation," Nkombo

"We should not forget as MPs that we are not here serving people in our own accord but we are there courtesy of those people who stood up to go and vote for us. So sometimes it is not a matter of one's conscious and how much money you are paid by PF that you make a lone decision and decide to vote against your conscious."

Nkombo said there were also some PF MPs that did not want Bill 10.

"I can also tell you that

not all the PF members are in the same accord as those who are promoting Bill 10. The members in PF are stifled because they know the dictatorship in their backyard, they are petrified about the consequences if they listen to their conscience. We do talk to them and with the presidential pronouncement that some of them are not good enough to continue serving people as you heard the President saying in Chilubi. There is heavy despondency in PF from among PF members of parliament they have told us that. They even say 'bakai votele abene pali Bill 10 (they will vote for Bill 10 alone)," said Nkombo.

Govt must be ashamed to claim they didn't shut Prime, Post – Nyirenda

EMBATTLED National Restoration Party (NAREP) president Steven Nyirenda says it is shameful that Information and Broadcasting Services Minister Dora Siliya can deny that government closed Prime TV and The Post Newspapers when evidence clearly points to the contrary.

Last week, Siliya said it was a total abrication to argue that government closed Prime TV and The Post, insisting that government remained tolerant to independent news media.

But in an interview, Nyirenda insisted that government orchestrated the closure of the defunct media houses.

"I think sometimes some people daydream. How can they now say, it was total fabrication?' When it was clear, it was in black and white? It is the government that closed Muvi TV, that time the Minister of Information was Chishimba Kambwili. It was closed for two weeks and that brought problems to Muvi TV. Secondly, they came to close The Post, of course, they would say, 'The Post had a problem with taxes...' But government at that level has the will power to stop it. We know that it was orchestrated by the government. Where Prime TV is concerned, for somebody to say that it did not close Prime TV, it is a shame! Those people must be shameful! They issued threats and then they revoked the license.

And they have refused to have any audience with (Gerald) Shawa. If they were not the ones, they would have asked Mr Shawa to sit around the table and then say, 'how can we help you to make sure that you continue with your business?' So, it is shameful that people can make a pronouncement to say, 'government did not close any media," Nyirenda said.

"The leadership has no vision; they don't know what they are doing and where they are going. If the leadership has no principles, anything goes, mediocrity, corruption all these other things happen. They don't have integrity, they don't care. These people have got no vision at all so to cover up what they are doing, they intimidate the Fourth Estate. If you are going to intimidate them, it means you don't want to develop, you are doing bad things, so the easiest thing is intimidate them so that everybody shuts up and you can do whatever you want."

Meanwhile, Nyirenda bragged that he was gaining popularity as evidenced by the party's performance in the recent Mbereshi ward by elections.

"PF got about 800 votes, we got 216 and the UPND got 35 votes. It was a very good performance for us and we are sure that in those elections, the PF do everything that they can to make sure that others are disadvantaged, and at the end of the day, they manipulate the process. We don't consider PF because we know what they are doing, their wins are artificial. That is why we are happily saying, 'we beat UPND and we think we won the election," said

Debating the estimates of expenditure for the Ministry of Information and Broadcasting Services budget that stood at K46 million, Siliya refuted any assertions that government had been intolerant towards independent news media.

"Media houses are managed by the Independent Broadcasting Authority (IBA) and the IBA, in section 23 of the amended 2010 Act: they are the ones who are responsible for licensing. So, the Minister in person and, indeed, government is not responsible for licensing. The people who provided the law for licensing of Prime TV or any media house in this country is this House. And it is this House that demanded that laws must be observed. And when a media house is non-compliant, the IBA can only do what they were asked to by the members of parliament. So, for somebody to accuse, whether it is the Minister in person or government that we closed an institution is total fabrication because those laws are made by members of parliament. I hope that we can put this matter to rest. This goes to The Post as well that it is an issue of compliance to tax issues," argued Siliya.

And in a separate interview, Nkombo said Ngulube's statement wishful thinking. "Mr Ngulube's statement can be classified as wishful thinking which is allowed. We

Removing all partisan civil servants only way of improving efficiency — Sacika

ASKING civil servants who wish to aspire for political office in the 2021 general election to resign will not improve efficiency in the public service because some elements will still remain aligned to the ruling party, says Dr Sketchley Sacika.

But Zambia Congress of Trade Unions (ZCTU) secretary general Cosmas Mukuka says the rationale of removing politically-inclined civil servants is good as it will promote productivity in the public service.

In a memo issued by Secretary to the Cabinet Dr Simon Miti and addressed to the Secretary to Treasury Fredson Yamba; all permanent secretaries; the DMMU national coordinator Chanda Kabwe and the Inspector General of Police Kakoma Kanganja, among others, Dr Miti urged anyone wishing to aspire for political office next year must render their resignation by November 30.

"It has been alleged and generally observed that a number of public officers have become actively engaged in partisan politics. This has not only affected their performance to provide public services, but also goes against the public service code of ethics. In this regard, all public officers, including those serving in foreign missions, quasi-government, grant-aided institutions, and State-Owned Enterprises (SOEs), who have ambitions and intentions to participate in future elections, and in particular the 2021

general election, must indicate in writing and state their informed decisions to resign from the public office not later than 30th November, 2020, this is intended to protect the integrity and impartiality of the public service as it implements government programmes before, during and after the elections. Failure to adhere to this directive, appropriate actions shall be taken," the circular read in parts.

But in an interview, Dr Sacika, a former secretary to the cabinet, said the directive would not resolve anything because the public service was already led by numerous political appointees, who paid allegiance to the ruling party as the appointing authority.

"I think Dr Miti is trying to show the problem of a highlypoliticised and non-performing public service in the wrong way, and we sympathise with him. But this directive to public officers wishing to take part in elections next year to resign by 30th November will not solve the problem, which Dr Miti has highlighted. The biggest and fatal problem that the public service is facing today is that our public service institutions are highly-politicised. This high level of politicisation has come about because the people, who are appointed to run these institutions, are political appointees, who are affiliated to the party in power and people who have no long-term commitment to the public service. This is the biggest problem faced today," Dr Sacika observed.

He added that partisan

politics had penetrated the public service, hence the inefficiency in service delivery.

"And this problem has been created by government. If you look at what is happening, politics has destroyed our civil service. We don't have a functional civil service anymore. The whole thing is collapsing. Look at how a militia of a political party in power can victimise political opponents, look at the performance of our parastatal institutions, there is no single parastatal organisation, which you can point at and say, 'this parastatal is performing efficiently.' So, the whole public service system has been destroyed by very high levels of politicisation," he said.

He stressed that forcing civil servants to resign was not going to professionalise the public service due to its current structure of it being an extension of the ruling party.

"Coming to Dr Miti's directive, those wishing to expand for political office next year may heed Dr Miti's directive if they like, but this is not going to solve the problem. In my view, in order to solve the problem that has been complained about in the circular, I would recommend that all public officers, who are known to be involved in partisan politics, must be removed from the public service because doing so is contrary to the code of ethics. And this must be extended to everybody. Maybe they must undertake a comprehensive programme to depoliticise the operations of the public service

by doing away with political appointees, and by insisting public institutions are allowed to function as professional bodies and not just an extension of a political party in power. This is what is going to solve the problems in the public service and not what Dr Miti is proposing. If 10 or 20 people resign because they want to stand in the next elections, how is that going to improve the situation? It is not going to improve the situation at all. So, Dr Miti must take a comprehensive approach to resolve the whole problem," Dr

Sacika advised.

Meanwhile, Mukuka said Cabinet Office's intention was good, but it should have addressed civil servants who had no ambitions to contest next year's polls, but were actively involved in partisan politics.

"When we look at the circular, the intention is good and the best thing would be to look at it from all aspects, including the private sector. What it is is that, if you choose to do politics, that's a vocation you can still follow and that's a path, which should purely

come from your heart. You can't mix the two. But there are those who do not want to contest, but they are involved in political activities like in promoting political parties activities. You do not want to contest, but you are involved in political parties activities," said Mukuka in a separate interview.

Mukuka, however, expressed concern that the circular did not speak to those who had no intentions of contesting the 2021 general election but were still heavily involved in partisan politics.

US Embassy grants K2.5m to 6 NGOs to boost press freedom, civic participation

THE United States Embassy has awarded K2.5 million to six Zambian community-based organisations to help promote civic participation, press freedom, entrepreneurship and creative expression among the youth.

In a statement, Tuesday, US Embassy public Affairs Officer Sean McIntosh announced that the funds were channelled to six individual community-based organisations as grants.

"Today, the US Embassy announced the awarding of grants totalling over K2.5 million (US \$126,000) to six Zambian community-based organisations through its Public Affairs Section Small Grants Programme. The grants will promote civic participation, press freedom, entrepreneurship, and creative expression among youth," McIntosh stated. He outlined that US taxpayers were proud to support Zambia Free Press Initiative, among five others, to enable them participate in press freedom campaigns and entrepreneurship activities for the benefit of their communities.

"The American people are proud to support Zambian communities with the hands-on opportunities to mobilise their own ideas and resources, and expand their organisational and project management knowledge. The funds go directly to Zambian communities to respond directly to issues affecting their communities and, ultimately, enhance the welfare of Zambians," explained McIntosh, adding that the financial support was targeted at helping Zambian organisations address issues affecting their communities, which included improving health and education to advance democracy and good governance. Dear Honourable Members of Parliament,

CONSTITUTIONAL AMENDMENT BILL No. 10 of 2019

Kindly refer to the above captioned matter.

The Law Association of Zambia (LAZ) is a statutory body created under section 3 of the LAZ Act, Chapter 31 of the Laws of Zambia. Among our objectives and mandates under the said Act, is to promote the rule of law, seek the advancement of human rights and to further the development of law as an instrument of social justice and as an essential element in the growth of Zambian society. Within our objective, is the overall duty to ensure constitutionalism, constitutional legitimacy and Democratic governance in Zambia.

Our objectives beckon us to be mindful and take keen interest in the Constitution of Zambia. The process of making a Constitution, or indeed amending one, is a very delicate matter that ought never to be taken lightly. A Constitution should never suffer amendment on political lines. We would borrow the text from the International Round Table on Democratic Constitutional Development, employed by the renowned Constitutional Lawyer Muna Ndulo and say that:

"the process of constitutional-making is crucial. The Constitution is no ordinary law to be modified or replaced by ordinary legislation. It must be perceived as a higher law, authorizing and governing ordinary law and commanding adherence to constitutional precepts. While ordinary law may be adopted and altered by legislative majorities of whatever size, the adoption of a constitution and its amendment requires much more, widespread participation by the citenzenry and the achievement of a broad-based consensus." (Ndulo and Kent, 1996)

Though the process surrounding Bill 10 has been unduly politicised, LAZ is without doubt that the process lacked the critical ingredient of broad-based consensus. For so long as no consensus exists, it is immaterial how good or progressive the contents of

a proposed Bill to amend the Constitution may be because the enactment would have failed the test of constitutionalism.

LAZ is dismayed that notwithstanding the apparent lack of a broad-based consensus, the constitutional amendment process will proceed to second reading and voting on Thursday, 29th October, 2020. This is despite many calls from the general members of the public, civil society organisations and many other stakeholders that the Constitution of Zambia (Amendment) Bill (Bill 10) be withdrawn.

As Members of Parliament, we remind you that your primary duty is to the people of Zambia who elected you into office. Article 5 of the Constitution states that the sovereign authority lies with the people of Zambia and yours is the delegated power to implement the will of the people. It is unnecessary to go into specific provisions of Bill 10 to conclude that there is no consensus amongst the People of Zambia over Bill 10. We therefore, urge you to put the concerns of the Zambian people above all party or political interest. We implore you to do the right thing. Bill 10 must be taken off the floor so that an opportunity is given for broad-based consensus on the provisions contained therein. LAZ believes that there is still time to build consensus if Members of Parliament from across the political divide put the people of Zambia first.

LAZ assures you that its interests are born out of its sworn duty to preserve and protect the Constitution of Zambia and the principle of constitutionalism.

These Tongas, we don't hate them, let me make this clear. We don't hate Tongas, they are Zambian and so they are our relatives, but they have risen against us Easterners. They want to remove us from the presidency. If they remove us from the presidency, will we drill boreholes, will we build schools and hospitals? If you remember we had another Easterner, Rupiah Banda who was Chewa President, he used to give us eight bags of fertiliser, do you remember? But we were lazy and we made him lose the presidency. Here in Eastern Province we had over 700, 000 registered voters but only 244,000 went out to vote, so Rupiah ended up losing. In 2013 to 2014 we used to call PF as Paya Farmer (kill the farmer), because Michael Sata who was president believed in cassava as his staple food. But does cassava need fertiliser? So agriculture has started ticking again now that President Lungu has taken charge. This is because Edgar Lungu is one of us and he knows that our agriculture is centred on maize and maize is dependent on fertiliser. So if Edgar is removed from power, will agriculture progress?

So we must work hard to ensure that our province protects and holds on to the Presidency because we want fertiliser, dams and employment. So we need Edgar to continue so that we can also continue with the programme of developing our province.

We will decide to give the presidency to Tongas after we rule for 10 years. That's when we will tell them that we have done what we wanted now you can also do what you want with the presidency. They cannot stop us midway before we are finished. Even in a household, you cannot allow someone to come in and order you to stop what you are doing with your wife and you give him your wife just like that. You have to give it a fight, you cannot just stop and give up. So we have work to finish our projects.

We are not saying the presidency will never leave Eastern Province, but we are saying in the past we only had the presidency for three years and God felt pity for us and has given us another opportunity to rule again. So only after 10 years is when we will give the Tongas.

Voting will take place on August 12. This week that is coming is for registration of voters. We must all go and register to vote. Those old voters cards will be useless next year because they have expired. Everyone who is 18 years and above must go and register. We must not feel lazy like we did on our relative Rupiah whose presidency we lost. We thought since he is from Eastern Province, he would win, he can win here but if the votes are few, the Tongas vote in big numbers. That means he will win here but the Tongas will grab our presidency.

The 2021 elections are not

just about voting, it's a war for survival, we need to make sure that we vote so that the Tonga's don't get the presidency. Today I was looking at the number of votes for here in Sinda. In 2016, President Lungu got 7,000 votes and the UPND got 5,000. Our friends the Tongas, they meet as traditional leaders like we have met and they agree that 'we don't want Edgar Lungu so we will give him zero votes'. It happens, am I lying? Now us here we are meeting as traditional leaders, how can we allow UPND to get 5,000 votes from here? In Dundumwezi, Hakainde got 40,000 our president, got zero. So our friends the Bembas are laughing and asking us to say, 'you Dora and Kazungula, do you want the presidency to stay in Eastern Province or not? What are we going to tell them? When we go back to Parliament, what are we going to say?

I am begging you my traditional leaders, please! I know we do wrong things in government but you should be forgiving us, you should pray for us. We know that we have gone through problem in the past five years, but please we must not lose the presidency. If we lose the presidency, we will never get it back as Easterners. By the time the presidency will be returning to Eastern Province, none of us will be alive. We still want the leadership of this country so the we can finish the hospital and school projects. We are lucky that after Rupiah we have gotten back the presidency, but if we lose it, we will not be alive to a time when we will get it back.

Kampyongo mocks Saboi in Lungu's defence

HOME Affairs Minister Stephen Kampyongo says he is disappointed with NDC spokesperson Saboi Imboela's Facebook post in which she insinuated that President Edgar Lungu has no love for his wife, Esther.

And Kampyongo says Imboela believes in demeaning people, then he would also have the right to talk about how she sent her father's children to jail for forgery.

Meanwhile, Kampyongo says people should stop blaming him for certain decisions which police make because he doesn't micromanage them.

In her Facebbok post, Imboela stated that NDC leader Chishimba Kambwili was not like the Republican President who did not have love for his wife.

'Our President is not like the Republican President who doesn't love his wife and is busy impregnating girls from neighboring countries. Pretending to be married just for the sake of the presidency when a good number of us know the real situation behind the charade. Our President loves his wife and children and what has happened today is really a blow below the belt. Let your political fights remain with you in politicians and don't involve the wives and children. We know that for that man who has no love for his wife, this is nothing and so he lacks sympathy and empathy. But for CK, you've really gone for his heart, congratulations bamakaka...anyway, Fikapwa," read Imboela's

But speaking when he phoned in during Hot FM's breakfast show, Tuesday, Kampyongo said he was disappointed with Imboela's conduct.

"I was just disappointed with one of the items that you were discussing this morning about the NDC spokesperson where she was trying to justify the demeaning post that she did. She is saying she is a political scientist and she wants everybody to believe her afterthought kind of narrative that she is trying to create about who she was talking about. And to try and think that Zambians are so dull that they can't read between the lines is very unfortunate. And I want to share with her that you know, when you are in leadership,

you must be in leadership with responsibility. The same respect that she expects as a female leader of a political party is what she should extend to others," Kampyongo said.

He said Imboela should have been emotionally charged before sending her children's father to prison the same way she was when making the post against the Head of State.

"So, going back to the demeaning post that she did, let me give her a classic metaphor. If I said to you that there was a female artist who was seen with another artist in a very vibrant music outfit in 2012 and one of these artists was married to another fellow artist in the industry who was the husband and probably they had children. And this artist at one point took the husband to court and got this husband convicted for forgery, I can go on and on to describe that. Surely, can citizens not make a picture of who I am talking about? I could see that my dear colleague Saboi has been emotionally charged. How I wish that's how emotionally charged she could have been to send her own children's father to prison for forgery which are the same charges which my elder brother has been sentenced with," Kampyongo said.

Kampyongo also urged Imboela to be responsible when making public comments.

"I just want to say that let's be responsible even as we make public comments. What we use to measure others could be used to measure you. It was very disappointing that she could even justify and worse still dragging the foreign president into her discussion is not fair at all. And she knew even when she was talking about another president of another country within SADC that she was [making] a mistake. That shouldn't be the case. Let's do politics with responsibility and understand consequences of what we say and what we do," he said.

And Kampyongo said it is not true that he gives instructions to the police and that it is practically impossible for him to micromanage all the 18 portfolios that fall under his ministry.

"And I want to tell her and assure her that she was talking for example about a minister giving instructions to the police. What kind of thinking would that be? I have always said time and again that we don't micromanage institutions of governance. Ministry of Home Affairs is not Ministry of Police for example. There are more than 18 portfolio functions here that go with the institution and if I was to micromanage all these institutions, what super human being can I be? If I have to know who the police should visit? There is a prison in Kasama, Luwingu, who is being arrested in Chilubi? What kind of management will that be?" asked Kampyongo.



Mutembo entitled to report which informed Lungu's decision to fire him, rules ConCourt

THE Constitutional Court has ruled that President Edgar Lungu acted constitutionally when he relieved Mutembo Nchito State Counsel of his duties as Director of Public Prosecutions (DPP) in 2016.

The ConCourt says this is despite the fact that the letter of dismissal erroneously referred to Article 144 of Act No.2 of 2016 and not the repealed Article 58 of the Constitution of Zambia, 1991.

The ConCourt, however, has ruled that Mutembo is entitled to be availed the findings or report by the adhoc tribunal upon which the President based his decision to relieve him of his duties as

In this matter, Mutembo filed a petition in 2016, challenging his removal from office as DPP and cited the Attorney General as the respondent.

He stated that following his suspension from office, a tribunal was set up under Article 58, which was subsequently repealed by the Constitution [Amendment] Act No. 2 of 2016, to prob him on various matters. The tribunal proceeded to issue a report to President Edgar Lungu whose recommendations led to his removal from office as DPP pursuant to Article 144 of the Constitution as amended.

Mutembo challenged his removal from office and questioned the legality of denying him access to the said report.

But in a judgement delivered Tuesday morning by Constitutional Court judge Palan Mulonda on behalf of justices Mungeni Mulenga, Enock Mulembe, Margaret Munalula and Martin Musaluke, the court noted that the judgement was being delivered four years since the first petition was filed in court.

Judge Mulonda said it was the Court's firm view that while Article 144 of the Constitution as amended was the correct provision under the new constitutional order to exercise powers of dismissal

against an officer falling under its coverage, in this case the DPP included, the case at hand does not fall under its

He said this is so because the repealed Article 58 is what applied in the case at hand, adding that, that being the case, Article 144 of the Constitution as amended within the context of this case was a wrong provision to anchor the decision of dismissal in this case.

"It follows therefore, that the reference to Article 144 of the Constitution as amended was misplaced though the power exercised was covered by the repealed Article 58 of the Constitution of Zambia, 1991," judge Mulonda said.

He said the President's action thus cannot be said to be unconstitutional, illegal or null and void as alleged by

The court however, granted the declaration that Mutembo was entitled to be availed the findings or report by the adhoc tribunal.

"In conclusion, we wish to state that the President acted Constitutionally when he relieved the petitioner (Mutembo) of his duties as DPP despite the fact that the letter of dismissal erroneously referred to Article 144 of Act No.2 of 2016 and not the repealed Article 58 of the Constitution of Zambia, 1991," the court ruled.

'We further state that an affected party in a Constitutionally ordained removal process who has appeared before the relevant adjudicative body, in this case the adhoc tribunal constituted persuant to the repealed Article 58 was entitled to a copy of the reasoned decision of such proceedings. This in our view is in conformity with the principle underlying the mechanism for removal of constitutionally secured officers, who through such mechanism must be given justification for their disappointment."

The court ordered each party to bear their own costs.

Earlier, in the judgement, the court

gave a brief account of the matter which was that Nchito while serving as DPP in 2015 was arrested and detained in police custody at Chongwe.

This followed a bench warrant issued by the Chongwe Magistrates' Court.

Nchito before his arrest applied for leave to commence judicial review proceedings which leave was granted and was to act as a stay of proceedings.

However, the proceedings at Chongwe did not abate until Nchito obtained a High Court order nullifying the said proceedings at Chongwe.

Nchito was again the subject of fresh charges that were similar in nature with those at Chongwe, but this time before the Lusaka Magistrates' Court.

In the Lusaka proceedings, Nchito as both DPP and the accused person, personally entered a nolle prosequi and urged the complainants to have the matter investigated if they so wished.

Following the development, by letter dated March 10, 2015, the President suspended Nchito persuant to the now repealed Article 58(2) and (3) of the Constitution of Zambia, 1991, pending the findings of a three member adhoc tribunal which was appointed to probe

Whilst the tribunal was sitting, Nchito commenced proceedings before the Constitutional Court to continue his challenge of the tribunal's jurisdiction, but before the matter could be heard by the ConCourt, the tribunal concluded its proceedings and presented its findings and recommendations to the President.

The tribunal, however, did not avail Nchito a copy of the report.

Following the presentation of the report to the President, the President proceeded to relieve Nchito of his duties as DPP on August 9, 2016.

It is this removal from office that led Nchito to petition the ConCourt on August 10 alleging that his removal from office was unconstitutional.

THE Electoral Commission of Zambia has postponed the commencement of the mobile registration of voters to November 9, 2020.

And the Commission says the response to the online preregistration is not encouraging.

At a press briefing, Tuesday, ECZ chief elections officer Patrick Nshindano said the decision to extend the commencement of the mobile voters registration was arrived at due to the extension of days on the issuance of NRCs in the second phase.

"The Commission set 28th October, 2020 to 30th November, 2020 as the dates within which to conduct mobile voter registration throughout the country in various registration centres and stationed registration of voters at district centres and civic centres. The Voter registration exercise will be followed by the inspection of the Register of Voters before the Register is finally certified as a final register. The Commission continues to collaborate with the Department of National Registration, Passports and Citizenship (DNRPC), of the Ministry of Home Affairs, on the issuance of NRCs. The Commission has also noted that the DNRPC has extended the period of the mobile issuance of NRCs by 5 days from the 30th October 2020 to 5th November, 2020. The Commission has also noted concerns by the stakeholders and some members of the public on the need to acquire NRCs to enable them to register as voters," Nshindano

"Therefore, in order not to disenfranchise our people, the Commission has again found it imperative to reschedule the dates for the registration of voters which was scheduled commence tomorrow Wednesday 28th of October, 2020 to 30th November, 2020. Mobile NRC Issuance has been selective in Namwala – Lubezhi

NAMWALA UPND member of parliament Moono Lubezhi says the distribution of wards that have been captured in the ongoing mobile issuance of National Registration Card (NRC) in her constituency is not equitable as highlypopulated areas have still not been covered.

you remember we had another Easterner, Rupiah Banda who was Chewa President, he used to give us eight bags of fertiliser, do you remember? But we were lazy and we made him lose the presidency. Here in Eastern Province we had over 700, 000 registered voters but only 244,000 went out to vote, so Rupiah ended up losing. So we need Edgar to continue so that we can also continue with the programme of developing our province. We will decide to give the presidency to Tongas after we rule for 10 years. That's when we will tell them that we have done what we wanted now you can also do what you want with the presidency. They cannot stop us midway before we are finished. Even in a household, you cannot allow someone to come in and order you to stop what you are doing with your wife and you give him your wife just like

that. You have to give it a fight, you cannot just stop and give up. So we have work to finish our projects.

So this is what our democracy has come down to? It's now about Bembas and Easterners ganging up to defeat any other tribesman who wants to vie for the presidency? Where is the civility in this campaign message from the Chief government spokesperson? This is what we have been talking about. The PF has been labling others when in fact they are more tribal than any other political party.

As a matter of fact, the PF tribalism is so dangerous that it is responsible for dividing the country because it is fuelled by factionalism. What we

have in Zambia - and this has been the case for many years – is a faction of Northerners and Easterners wishing to perpetuate the monopoly of the power

to govern.


But this cannot be left to continue, especially as we head into next year's election campaigns. The PF should not be pointing fingers in the opposition over a 'crime' that they are guilty of themselves. They must first address the tribalism which is inherent within the PF itself. How can a minister go one such a tribal path without feeling a sense of shame? This tribalism has been looked at with a very casual approach, whereby the politicians who are gaining mileage out of this don't see how it is now penetrating the

workplace and the damage it is causing to national building.

Zambians must say no to this type of politics where big tribes try to dominate minority groups because this route will see this country denied an opportunity of being led by selfless, devoted citizens who hail from the so-called small tribes. It must stop before it engulfs our country. There is not a singe province in Zambia that belongs to one tribe.

In Eastern Province, it's not only the Ngonis or Nsengas or Chewas or Tumbukas that live there, there are Bembas and Lozis who were born there and that doesn't make them less easterners or less citizens. So this kind of campaign from madam Siliya must be rejected. What does she mean when she says: "bembas will laugh at us if we lose the presidency to a Tonga?" Does Zambia belong to two tribes only? Shame on Honourable Siliya.



Police search UPND secretariat for NRCs

Police in Lusaka have detained UPND member Anthony Bwalya on an unknown charge but have released party secretary general Stephen Katuka after questioning at Police headquarters.

According to Lusaka lawyer Mulambo Haimbe, Bwalya has been detained but his charge and holding place remain unknown.

"With regard to Mr Katuka, there was an interview that was undertaken and the police said they would request him to come back if they required more information. As for Mr Bwalya, he has been detained in custody, we have not been told what the alleged have not been told which detention facility he will be taken to ultimately because at service headquarters there are no cells. All I can say as at now is that the police are claiming to be conducting some investigation of one sort or the relating, I believe, to the issue of national registration cards that was spoken of by Mr Bwalya and Mr Mubita Nawa on television about two, three, four days ago or so," said Haimbe, adding that the matter seemed to be a political issue which was being used for purposes of criminal persecution.

By press time, there was still no update on Bwalya's whereabouts and police had not yet confirmed his arrest.

Around midday, Tuesday, police surrounded UPND secretariat in Lusaka's Rhodespark area where they had a warrant to search the premises for "piles of national registration cards".

According to lawyer Marshal Muchende, who witnessed the search, police did not find what they were looking for but ended up leaving with inconsequential documents from a party sympathiser.

"The search warrant was saying that they have reasons to believe that there are piles and piles of national registration cards at the UPND secretariat, that's what the search warrant was saying and that they had court to search the premises of the UPND secretariat for those suspected national registration cards and other documents. So my duty as counsel was to just verify as to whether the police were above board in executing that search and that is to say, do they have the relevant documents to allow them to infringe upon the constitutional right of privacy for the UPND and yes they did have that document and I took it a bit further as to confirm from court and I verified that the search warrant was authentic and was signed by Magistrate Judy Chiyaika. It was upon being satisfied that the document was authentic that I authorised

them to conduct the search,"

Muchende said.

"I allowed them in the premises and they did look for what they were looking for. The end of it was that they did not come across any NRCs whatsoever, they did not come across the principle material that they were looking for, and however, they started fishing. They went on a voyage of a witch hunt to start looking for documents that had nothing to do with NRCs and that is how they stumbled across certain documents by sympathetic members of the party who were advising the secretariat on how to protect the vote. The member of the public was saying that the biggest problem was that the was making recommendations on how to ensure that the votes are protected but the document itself was obsolete because it was in relation to 2011 and 2016 elections. So in as far as I was concerned, it was inconsequential and I advised my clients to allow the police to get it because there was nothing criminal about the document."

He added that after the search was done, youths at the secretariat became agitated with the police and snatched the documents from him despite letting them know that the documents were inconsequential.

"So however, the youths were agitated, they were not happy, they took it that police are an extension of the PF and whatever was going on was essentially a victimisation and intimidation of the opposition political party to the extent that when we were addressing the youths about the whole search, they actually pounced on me and grabbed those so called irrelevant documents, they were really irrelevant but they grabbed them away from counsel and they ran away so police were now on a man hunt looking for those youths that snatched the documents from my hands. That's the full report of what happened," said Muchende.

"So the police arrived at the scene at 12:00 o clock but they waited for counsel 14:30. So the search started in earnest at 14:30 and ended at 16:30. Then 16:00 hours it was a meeting now for signing off the documents that were received. Around 16:30 that's the time we were addressing the youths so that they don't lose cool, assuring them that there is nothing to worry about but really I don't think that message sunk in them because they perceived the police as an extension of the hand of the PF party, they are not seeing the difference between the party and the police."

By press time, police could not confirm the findings of the search but disclosed that Bwalya's house was also earmarked for a search.

Nkombo who wanted to know what the cause of the sudden erratic supply of fuel was, and what urgent measures government had put in place to address the crisis.

Nkhuwa said said among the measures government had put in place was police escort for fuel tankers.

"The Ministry of Energy in collaboration with the Ministry of Home Affairs is offering police escort to tankers for security and speedy delivery of products to their destinations. Government remains resolute

in ensuring that there is security of supply of fuel in the country. Government has put in place the following medium term measures (i) enhancing logistical arrangements regarding the importation of crude oil to ensure steady supply; (ii) government has given all OMCs waivers to import petroleum products; (iii) government will continue to enhance private sector participation by ensuring that citizen owned companies participate in petroleum supply chain," Nkhuwa said.

"In long term measures, the rehabilitation of the TAZAMA pipeline in order to improve its operational capacity; (ii) expanding construction of provincial fuel depots in all provinces will enhance fuel storage reserves; (iii) construction of finished petroleum products pipeline which will enhance our ability to meet growing demand of petroleum products in Zambia, notably the two projects that have reached the advanced discussions as the Tanzania-Zambia finished petroleum pipeline and the Angola-Zambia refined petroleum multi-product and natural gas pipeline."

Asked by Nkeyema UPND member of parliament Kapelwa Mbangweta when the situation was expected to normalise, Nkhuwa said: "it should normalize in the next one week."

And asked by Nkombo

on what grievances the fuel transporters had put forward, Nkhuwa said government did not own trucks.

"The situation is that we don't own trucks as government Mr Speaker, therefore we don't have grievances with the truck drivers. The trucks belong to private transporters who transport and I think they have got grievances with their employers. It's not government Mr Speaker," he responded.

Asked by Kantanshi independent member of parliament Anthony Mumba if the relationship between the government and the OMCs did not have an effect on the economy, Nkhuwa said the relationship was intact and that the confusion was being caused by a few disgruntled individuals.

"Mr Speaker through the Ministry of Transport and Communication, there are three truck associations that operate in this sector and they are recognized by the government. And jointly, me and the Minister of Transport and Communication did engage these unions and they don't have a problem with the government. It's just a few disgruntled people that started stopping trucks and stoning them and picketing. In short, the associations that are there don't have a dispute with the government or they don't have a dispute with their employers. They haven't declared any disputes," said Nkhuwa.

Bartomeu resigns

BARCELONA president Josep Maria Bartomeu has resigned with the entire board also stepping down from their posts.

Bartomeu's decisions come after several months of criticism in the wake of Barcelona's 8-2 Champions League elimination to Bayern Munich as well as Lionel Messi's shocking request to leave the club shortly after.

Although the club was able to keep hold of Messi, with the longtime Barca star staying to avoid having to take the club to court, Bartomeu's position has been under scrutiny for weeks,.

The president had been due to officially end his tenure next year with elections called for March, but the club's members called for a vote of no confidence in an effort to get Bartomeu out immediately.

A total of 20,687 votes were gathered for the motion against Bartomeu, passing the threshold of 16,250 signatures required for the vote to go ahead.

The Barca board repeatedly tried to suspend or postpone the vote but, on Monday, local authorities rejected the club's push to delay the proceedings.

As a result, the vote was set to go ahead in the coming weeks, but will no longer be necessary as Bartomeu and the board step down.

Bartomeu originally joined | Barca during Joan Laporta's

Nchanga Rangers face Konkola

presidency, and he ascended to the role himself in January 2014.

He replaced Sandro Rosell, becoming the fortieth President of Barcelona as he signed on to complete the rest of Rosell's tenure following his resignation.

During his time in charge, Barca won La Liga four times as well as the 2014-15 Champions League, but his tenure will largely be defined by the club's failings in his final seasons.

Having struggled in the transfer market since Neymar's departure to join Paris Saint-Germain, Barca finished the 2019-20 season trophyless.

Their 8-2 loss to Bayern only furthered unrest, with Messi's request to leave proving the final straw for the president.

Messi told Goal in September that Bartomeu "did not keep his word", with former Barca star Luis Suarez saying that he believes Messi will stay at Barca if a new board arrives.

Bartomeu said on Monday that he believed that Messi could lead Barca to titles this season, admitting that he could not let the Argentine leave for the good of the club.

And now, it is Bartomeu that is leaving, as he ends his time in charge of Barca after nearly seven years.

Barcelona are set to face Juventus on Wednesday in the Champions League. *GOAL*

WE HAVE PLAN B - MICHO

CHIPOLOPOLO coach Milutin 'Micho' Sredojević says he has already devised a plan to assemble a strong team in an event some foreign based players are not released for the Africa Cup of Nations qualifiers.

Earlier this month, Micho suffered a blow in his preparation for upcoming matches after Austrian club RB Salzburg refused to release starlets Patson Daka and Enock Mwepu on account of coronavirus fears.

With the European calendar experiencing fixture congestion, there is a possibility that some players may not be allowed to travel and honour

national team call ups.

Micho who arrived yesterday from Ethiopia where he guided Zambia to back to back victories over that country said the technical bench has planned for all eventualities.

The Serbian said he has honed his team in such a way that locally based players are ready for battle if their foreign based counterparts fail to make it.

"We have a clear projection of what is our first 11, in the best case scenario but we have a back plan, plan B, C, D upto plan Z ready for anything that comes.

"May be professional players will be blocked from coming due to the on-going situation with COVID – 19 we have made our locally based players our special commando forces ready for any challenge ahead of us," Micho said.

Micho refused to be curried away with the results posted in international friendlies.

Under Micho, Zambia has recorded five wins and one loss in six international friendly matches.

"You cannot talk about that [friendlies] this [qualifiers] is a totally different ball game, this was time of trying, testing and experiment," he said.

He said his players need to approach the game against Botswana without any complacency despite going into the game on the back of a good run of results.

"We need to approach Botswana with the highest degree of respect the same way as we are playing against Germany or Spain when they have the ball.


But when we have the ball we need to show ourselves, our talent and quality to get the desired results it will be very hard but I believe in what we do," he said.

Zambia takes on Botswana on November 12 as Micho seeks to revive the country's AfCON qualifier campaign which opened to the worst possible start.
