PF CHAIRMAN for legal affairs Brian Mundubile says the ruling party is confident the Constitution that Amendment Bill Number 10 of 2019 will pass Second Reading this Thursday because they have dealt with the contentious clauses.

In an interview. Mundubile said PF remained confident that the Bill would still pass Second Reading.

"We are very confident that it will go through because it is a good Bill. The numbers are there. Stakeholders, especially our friends in the opposition, they had raised issues to do with deputy ministers, coalition government and contentious clauses - Mundubile so on, so what Ministry of Justice did was to wait for the Committee to sit, and coincidentally, the issues that the opposition were raising are the same issues most of the stakeholders raised during the Committee sittings. So, what the Ministry of Justice did was just to accept the Committee recommendations, which predominantly dealt with

all the contentious issues. So, the opposition had given a condition that they can't support the Bill because of some of the clauses, so the moment we removed them, we didn't see any reason why they should continue not supporting it," Mundubile said.

"Then they raised an issue of trust, they said, 'we are happy with the clean-up, but how do we know you won't change mid-way?' So, again, the Ministry of Justice went out of their way to even gazette the amendment, something unusual, but it was done as an assurance. To show them that we will not change, we are gazetting these amendments. And the Minister of Justice (Given Lubinda), in his

policy statement on Bill 10, did something unusual in that he now pronounced the substantive amendment... you know why? Because we needed to give assurances to our colleagues in the opposition. So, that should give us confidence because all the contentious issues have been dealt with."

He stressed that Bill 10

would resolve youth and women-related problems.

"We know that our friends in the opposition are dealing with the same Zambian people that we are also dealing with: the women, youths, the disabled, the traditional leaders, and Bill 10 will resolve problems for the youth participating in governance issues, the disabled. It also resolves the wrangles in the chiefdoms. So, from that standpoint, the brave women and men in the opposition will stand up to do what is right, and that is to support Bill 10," he said.

And Mundubile insisted that the shifting of dates of tabling Bill 10 was due to "circumstances.

"When a Bill is presented for First Reading, Mr Speaker refers it to the Committee. So, for this particular Bill, the sitting took unusually long because we wanted to make sure that as many stakeholders as possible participated. When the Bill traverses two sessions you have to, first of all, move a motion to restore it on the Order Paper. It was started in another Parliament in August so when it came up in December, first of all, before we could debate it, a motion had to be moved for it to be restored on the Order Paper because it was crossing between sessions. The next time that it came, Parliament closed because of COVID-19. So, we haven't been shifting the dates, it has been the circumstances," Mundubile said.

He also said that there was nothing illegal about publishing Bill 10 amendments.

"Don't mistake gazetting a Bill to gazetting amendments. A gazette is just a publication through which the government informs people of its decision. So, what is illegal about publishing the amendment that Cabinet agreed to? So, there was nothing illegal. Those that had contested this thought that the Bill was re-gazetted, there was no Bill that was gazetted, what was gazetted were the amendments what were agreed to. And remember, it was not the decision of the Justice Minister alone, Cabinet sat and looked at the recommendations from the Committee. So, once Cabinet agreed to those recommendations that were proposed by the stakeholders, those are the ones Honourable Lubinda went and published," said Mundubile. "So, there was nothing illegal about gazetting the amendments. The long story on Bill 10 will be done, then, we can begin to look at other topics. I think even for you, as a journalist, this has been going on for some time and, obviously, it must come to an end so that we start something else."

Cancer treatment too expensive for ordinary Zambians - Rupiah

By Abraham Kalito FORMER president Rupiah Banda says cancer medication is very expensive and it is painful that the majority of ordinary citizens in his situation cannot access the necessary medical help they need.

In an interview with Gondwe Kennedv for his Studio Ken Youtube Channel, Banda said he was overwhelmed by the support he had received since he revealed his colon cancer diagnosis.


"After I announced that I had been diagnosed with cancer of the colon, life has been very hectic because they have responded overwhelmingly with sympathy, with me and my family. The question says that given that this is the third time we are dealing with cancer, yes it's the third time. Yes it's the third time it has directly affects me as Rupiah Banda. But we have had a lot of problems with cancer in my family, my father I lost my father to cancer of the throat," Banda said.

"And many other members of the family, brothers, children. But my direct family,

it's been very difficult because I lost my first wife, Hope Mwansa Banda to cancer. We did everything we could we took her to America it didn't work, she passed on. And then I re-married my young wife and then after we had twins she was diagnosed with cancer of the breast and so fortunately, looks like science has developed now and she survived. And she is on my right had side encouraging me that she did and I can do it too. Generally my family is very shaken by the situation, I'm the head of the family and also I have a bigger family Zambia."

Banda said he was extremely optimistic that he would win the battle but that he was, however, at ease with death.

"When you hear the word cancer then the word death comes next and I have been thinking about that too. But even in my old age, I had been thinking about death. Because at the age of 83, many of my friends and age mates are gone. But I also say to myself that I think God loves me that's why I also try to transmit this love to others, because 83 years is a long time and my health



is generally good, it's just this cancer which has been nagging and bothering me for the last few years I didn't know what it was. But to tell you the truth I'm very optimistic that we will overcome. Yes, the treatment is very tough," he said.

described He how aggressive cancer treatment was.

"I was diagnosed in the main hospital in Dubai where I went, with this cancer they would give me 12 chemotherapies. So what is happening now is that every two weeks, I have to go back to the hospital and get chemotherapy. On Wednesday, I got chemo, you can see my skin is all affected, turned black. So today on a Monday the doctors will come in and get my blood, then by a Tuesday the doctors will know the condition of my blood and on Wednesday at 08:00 I will go for my chemo. At the hospital, Dr Desai, where he is being supported by Doctors from UTH, the head of Oncology in Zambia Dr Banda, and other Doctors," he said. "I think three or four Doctors from the Ministry of Health plus nurses the three young Zambian nurses who have been trained here in Zambia and in South Africa in Pretoria and they all come to help. So I'm getting the best that the country can offer. It's very advanced. Because we really didn't know that I had cancer. Every six months the government sends me overseas for medical treatment. So, before the Coronavirus, they

discovered something funny in my internal organs and later they discovered it was colon cancer. And when you get news like that you become scared."

And Banda said he was aware that he was receiving special treatment which was not available to ordinary citizens.

"And then I realise that this is special, it's just for me that why it's so painful because if I can suffer like this, what about the other ordinary people? So that's what happens, and during the day of chemo, it's quite traumatic because you have needles all over and you go through various chemo, the main one is 46 hours which I carry over my neck and stay with it on my body. But I get other chemo during that period maybe from 5am to 9 o'clock in the evening. And you become very nauseas but they give you medicine to help and then by 5 o'clock in the evening, I get a big chemo and they release me to come home with it on my body and it drops for 46 hours. So during that time, it's very difficult. And from Wednesday, they come and take it off on Saturday and then I'm very weak after that, I can't walk and can't eat," Banda said.

Banda lamented that cancer treatment was very expensive and not everyone could afford it.

"...the first decision we made when I became President was to set up a cancer centre. But you know, it's one thing to set up a cancer centre and its another to have adequate medication, the necessary equipment. That is the biggest problem, cancer requires a lot of medication, very expensive medication and that is where we are facing problems and with problems that most of our economies are facing in Africa and the outside world, because we get help from the outside world but right now they are facing their oown problems with the Covid-19," said Banda.

"So it's very difficult for the ordinary Zambians to get the help they need. Especially in the rural areas they don't even have a little clinic, it's very painful, the way I am feeling is the way every leader in Zambia should be feeling. It's a very serious problem, this lack of medicines. And in cancer, it's just one disease and by the way despite the fact that I am tired, and don't take interviews anymore, but when vou asked me to participate, I said I had to join Zambians who are fighting this disease. It's a serious problem and we need help. And hoping that this Coronavirus thing will be over so that the world can go back to where it was before. But to answer the question I

To: All Members of Parliament

Dear Honourable Members of Parliament,

CONSTITUTIONAL AMENDMENT BILL No. 10 of 2019

Kindly refer to the above captioned matter.

The Law Association of Zambia (LAZ) is a statutory body created under section 3 of the LAZ Act, Chapter 31 of the Laws of Zambia. Among our objectives and mandates under the said Act, is to promote the rule of law, seek the advancement of human rights and to further the development of law as an instrument of social justice and as an essential element in the growth of Zambian society. Within our objective, is the overall duty to ensure constitutionalism, constitutional legitimacy and Democratic governance in Zambia.

Our objectives beckon us to be mindful and take keen interest in the Constitution of Zambia. The process of making a Constitution, or indeed amending one, is a very delicate matter that ought never to be taken lightly. A Constitution should never suffer amendment on political lines. We would borrow the text from the International Round Table on Democratic Constitutional Development, employed by the renowned Constitutional Lawyer Muna Ndulo and say that:

"the process of constitutional-making is crucial. The Constitution is no ordinary law to be modified or replaced by ordinary legislation. It must be perceived as a higher law, authorizing and governing ordinary law and commanding adherence to constitutional precepts. While ordinary law may be adopted and altered by legislative majorities of whatever size, the adoption of a constitution and its amendment requires much more, widespread participation by the citenzenry and the achievement of a broad-based consensus." (Ndulo and Kent, 1996)

Though the process surrounding Bill 10 has been unduly politicised, LAZ is without doubt that the process lacked the critical ingredient of broad-based consensus. For so long as no consensus exists, it is immaterial how good or progressive the contents of

a proposed Bill to amend the Constitution may be because the enactment would have failed the test of constitutionalism.

LAZ is dismayed that notwithstanding the apparent lack of a broad-based consensus, the constitutional amendment process will proceed to second reading and voting on Thursday, 29th October, 2020. This is despite many calls from the general members of the public, civil society organisations and many other stakeholders that the Constitution of Zambia (Amendment) Bill (Bill 10) be withdrawn.

As Members of Parliament, we remind you that your primary duty is to the people of Zambia who elected you into office. Article 5 of the Constitution states that the sovereign authority lies with the people of Zambia and yours is the delegated power to implement the will of the people. It is unnecessary to go into specific provisions of Bill 10 to conclude that there is no consensus amongst the People of Zambia over Bill 10. We therefore, urge you to put the concerns of the Zambian people above all party or political interest. We implore you to do the right thing. Bill 10 must be taken off the floor so that an opportunity is given for broad-based consensus on the provisions contained therein. LAZ believes that there is still time to build consensus if Members of Parliament from across the political divide put the people of Zambia first.

Police launch manhunt for Tembo's killer



By Julia Malunga POLICE in Lusaka have launched a manhunt for Lieutenant Nigel Mwaba, aged 33, of Zambia Army who is suspected to have murdered Dr Tasila Tembo.

In a statement, Wednesday, acting police spokesperson Danny Mwale announced that Dr Tembo's body was found in a decomposed state covered with leaves in an army training centre in Mikango area.

"Police in Lusaka received a report of a missing person in which it was reported that a female identified as Dr Tasila Tembo, aged 47, of plot number 1732 Meanwood, Ibex Hill, went missing. This occurred on October 24, 2020 around 16 hours. Investigations into the matter were instituted and on October 27, 2020, at 13:00. Police discovered the body of a woman, who was later identified as Dr Tasila Tembo. The body was found in a decomposed state covered with leaves in Nanking Army Training Centre in Mikango area," narrated Mwale.

"The body was temporarily buried at a traditional burial site in Mikango area awaiting post-mortem to be conducted today at the University Teaching Hospital (UTH). Police have since launched a manhunt for the suspect, who has been identified as Lieutenant Nigel Mwaba, aged 33, of Zambia Army in Lusaka. We appeal to members of the public, who may have the information of the whereabouts of the suspect, to report to any police station."

"It is difficult to fathom that 56 years after independence, our leaders still see tribe as the main selling point for their preferred candidate and what Hon Siliva is reported to have said to the people she was meeting in Sinda, in fact validates some of the petitioners who appeared before the Commission of Inquiry. The Commission received numerous submissions that politicians involved themselves in tribal campaigns, which significantly influenced voting patterns. Petitioners submitted that candidates and their supporters engaged in tribal and regional based campaigns - such as promoting the "son of soil, tribal cousin and wako ni wako" svndrome," Lifuka said.

KABWE Central PF member of parliament Tutwa Ngulube says there is no police brutality in Zambia, arguing that there is no way law enforcement agencies can just watch if UPND members break the law.

And Ngulube says the UPND are being ignorant in attempting to seek international intervention on police brutality because foreign actors cannot interfere in the internal affairs of sovereign states.

Commenting on the UPND's decision to write to the international community on the continued arrest and harassment of its members, Ngulube said UPND members were just law breakers.

"The issue of saying police brutality, there is no police brutality whatsoever; when you break the law, you expect that the country should just keep quiet? No! The UPND must learn to respect the law, otherwise, their problems will never come to an end. We have a lot of opposition political parties in Zambia, how come it is only the UPND who is breaking the law at will? So, we want to laugh at them, the levels of ignorance are alarming! The international community cannot do anything in Zambia. Zambia is a sovereign State and it has its own laws. The UPND is a political party and it is not a state, so how is it going to run to the UN? You are not a footballer, but you are insisting that you want to play? So, they should come for a lecture.

"First of all, it is very clear that they are very ignorant about how the international community works. You see, the international community does not interfere in internal matters. As far as we are concerned, Zambia has its own laws and it's got its own policies and international reputation. For instance, if they are breaking the law, are they insinuating that they can break the law and nothing should be done? Is the UPND the only opposition in Zambia? It is not. It is an act of desperation to say, 'we will break the law so when they arrest us we run to the international community,"

Ngulube said.

"As far as we are concerned, it is not the only opposition party and it is not the oldest political party. Otherwise, as far as we are concerned, even the UN wherever they are going to write it does not entertain until administrative mechanisms available in that particular country are resolved. So, here in Zambia, they must first go to court, when they have finished all the courts, even the Supreme Court, when they feel that even the courts are not fair to them, that is when they can go to the international community."

Meanwhile, Ngulube, who is also government Deputy Chief Whip, insisted that there was no sign of the UPND were forming government next year.

"Look at how they performed in the by-elections? There is no sign whatsoever that the UPND is anywhere near forming government. They have just been making noise, claiming that they are the next government. There is nothing to show that they are the next government. They have been losing all the by-elections and they can't even accuse anybody because they have just been losing," said Ngulube.

"They are just trying to massage themselves because

the international community they want to write, which agreement are they going to write, under which treaty did the UPND sign? Which treaty did the UPND sign to the international community for them to go and complain? When you talk about the International Court of Justice only state parties can run there; if you talk about the United Nations, only state parties can go there. They are just ignorant and it is the level of ignorance that is making them look so desperate. I think they live in a world of their own."

Being in the opposition is democratic country, now scary, laments Andyford laments Kang'ombe

PEOPLE'S Alliance for Change (PAC) president Andyford Banda says it is scary to be in the opposition PF can do anything they want and get away with it.

And Banda says it is a clear case of rigging an election when the PF can mobilise themselves freely, while those in the opposition are stopped by the police every time they intend to do the same.

Commenting on the ongoing harassment of the opposition by the State where politicians were deprived of freedoms to mobilise, while others were almost daily in and out of court, Banda said the PF government intended to gain political mileage by deliberately using intimidation, persecution and intolerance as gimmicks to create scary circumstances for opposition parties to operate in.

"There is a lot of nonsense that's happening! Actually, today, we saw two bail applications that have been granted where first of all, the UPND MP for Sesheke (Romeo) Kang'ombe, who has been granted a bail of K200,000 cash and there is Mr (Chishimba) Kambwili as well, who has been granted a bail of K300, 000 cash! Now, we have never heard of such bail conditions happening in this country. To be honest, it's frightening. It's scary! Because how many of us, if we are in that position, can afford to have that kind of money to be bailed out of police? But at the end of the day, what choice do we have? Should we give up because the guys have heightened their tactics," Banda said.

"But all these gimmicks and tactics are temporal, they will intimidate us as much as they want, but I still believe that there will be an end to this nonsense. And while it's frightening, it's also an opportunity for us in the opposition to be written down in the history books that we fought an intolerant regime and someone has to do it and we will do it. We will not stop no matter how many times they will intimidate us. I know a lot of people are now going to be scared to criticise the government of the day, but we have to make a choice...That choice is that the battle continues! And for us, as PAC, they should wait for us, we are coming, we have been quiet deliberately because we wanted to be prepared so that when the intimidation starts, we know what to do."

He said the deteriorating situation in Zambia called for the international community to come in and speak loudly against government as their actions were an assault on the country's democracy.

"And I think it's getting out of hand just looking at what has happened today, I think it's really getting out of hand and the PF are getting things out of proportion. And as such, there is need that the international community comes in. The international community need to begin to speak up now and speak up loudly because this is clear intimidation, this is an assault on our democracy and if the international community, like we saw last week, were donating money to the Electoral Commission of Zambia, you know, funding ECZ is one thing, but the system of rigging is a process," he said.

And Banda argued that next year's polls were already being rigged because the PF were allowed to mobilise their members freely, while those in the opposition were frequently stopped by the police.

"This issue where the opposition can't mobilise and yet the PF are mobilising freely without being persecuted, that's rigging! We are all supposed to freely move around the country without having to fear that the police are going to stop us. I think if the international community is really interested in protecting our democracy, then it's time that they speak up and add their voices. But I also think, as leaders of the opposition, we need to speak to the conscience of the people. I think we are not doing enough to speak to the conscience of the people," said Banda.

"So, I think for us as PAC this is what we want to start doing so that people know that this war is not about the opposition political parties, but for the whole country. When they understand that, people will start speaking up against all the wrongs that are happening."

SESHEKE UPND member of parliament Romeo Kang'ombe says he is not shaken by his arrest and will still remain an agent for change.

Last Friday, Kang'ombe was arrested for abduction and assault of a police officer in Mpika District, but pleaded not guilty to the charges.

But in an interview, Kang'ombe said Zambia was no longer a democratic country.

"I can just urge the people of Zambia to be strong and expect the worst from these people. This is no longer a democratic country, unfortunately. Otherwise, speaking for myself, I am not shaken by anything; I remain a villager under the UPND. I no longer know the definition of democracy, I hope I will after next year. For now, I don't know. You never know who the next victim is," Kang'ombe said.

Today, they have come for UPND, tomorrow, they will come for some PF members and there will be no one to speak for them." Kang'ombe urged Zambians to rise up and be true agents of change. "It is unfortunate what is happening, but I remain an agent of change under UPND. That is all. I am an agent of change, we have different magnifying lenses on how we define and see the change we wish to see in society. My lenses can only be well understood by those who are in the same cause with me and it is only those who are in UPND. I know we have some in PF, but because they feel they are PF, they are not trade unionists, they are not communists, but tomorrow, it will be everybody. I urge everybody to remain strong and protect the democracy and the future of this country," said Kang'ombe. "There has to be a few of us that will stand for the truth. Not everybody, but there has to be a few of us that the real change will be attained because many people will jump in the band wagon, they won't be scared of anything. POLICE have released National Democratic Congress (NDC) spokesperson Saboi Imboela without charge after being questioned for Defamation of the President.

In an interview, Imboela said after being questioned at Lusaka Central Police, Wednesday, police searched her residence where they seized her daughter's laptop and her school certificates.

"The police yesterday did call me that I should report myself at Central Police. So I ended up going today because yesterday I was not available. So

when we went today, they said they are investigating a matter of defamation of the president, a post I wrote on Facebook. Of course my lawyer and I did tell them that we never mentioned any president's name so we don't know why they put our Zambian president's name on my post. So after investigations, we even went home, all the way home to go and search my house. They searched my house, they confiscated my daughter's laptop and my certificates, grade 12, grade seven and university, hopefully they will give me a job for that, so they really had to make sure that the house

was mine where I took them," Imboela said.

Imboela said the police were looking for gadgets which they think she could have used to post the statement.

She stated that upon return from the search, police cancelled the warn and caution statement that was drafted and released her. "So after we came back from the house, they said they are going to release me without charge because before going to the house, they were adamant saying they are going to charge me and everything, they did actually even write a warn and caution statement but I think it more or less not, they didn't go ahead with it. They said for now there is nothing and if there anything, they will contact me through my lawyers," said Imboela.

And when contacted for a comment, police acting spokesperson Danny Mwale dispelled reports that Imboela was arrested saying investigations were still on going.

"Saboi is not yet arrested. Information circulating on social media that Saboi has been arrested is false. We are still carrying out our investigations, we haven't yet arrested Saboi," said Mwale.

Reject Bill 10, HH urges MPs

UPND leader Hakainde Hichilema has called on members of parliament to reject Constitution Amendment Bill Number 10 of 2019 saying it is poisonous.

Court of Appeal declines Pilato, others' application for judicial review

THE Court of Appeal has declined to grant Musicians Chama Fumba, alias Pilato, Maiko Zulu, Brian Bwembya and two others leave to commence Judicial Review proceedings against ECZ's decision to conduct a fresh registration of all eligible voters for the upcoming 2021 general elections within a period of one month and on a limited budget.

On September 29, this year, Lusaka High Court judge Gertrude Chawatama refused to grant Pilato and the others leave to commence Judicial Review proceedings against the said decision by the Electoral Commission of Zambia.

Judge Chawatama said in her ruling that the reliefs which Pilato and the others were seeking were similar to those in another case where UPND deputy secretary general Gertrude Imenda has sued ECZ over its decision to commence online voter registration without authority of law and further, to give a 30 days cut-off time for the voter

proceedings to proceed might lead to conflicting decisions by herself and High Court judge Mwila Chitabo who is presiding over the UPND matter, a situation that would bring the integrity of the court into disrepute.

And October 1, this year, the said matter before judge Chitabo was adjourned sine die following an agreement by the parties.

Judge Chitabo ruled that the matter would stand adjourned sine die with liberty to restore, awaiting pronouncements from the Constitutional Court in a matter in Chapter One Foundation Limited has petitioned the ConCourt, seeking an order mandating ECZ to carry out continuous voter registration between elections.

However, on October 5, this year, Pilato and the others renewed their application for leave to apply for judicial review before the Court of Appeal in respect of the decision by ECZ to require currently validly registered voters in terms of the law to participate in a process that registration. She said allowing the amounts to requiring them to

re-register as voters in a period of one month. They cited ECZ as the

respondent.

Pilato, Maiko, Bwembya aka B Flow and two youths: Nawa Sitali and Muleta Kapatiso, on behalf of the people, were seeking an order quashing ECZ's decision for being irrational, procedurally improper and illegal and an order, compelling ECZ to retake its decision and act within the powers vested in them by the law.

They further wanted if leave is granted, hearing of the Judicial Review application should be expedited and that it should operate as a stay of ECZ's decision which requires already registered voters to present themselves before a registration officer again or be precluded or prevented from voting in the 2021 general elections.

The applicants argued that the decision by ECZ which required currently validly registered voters in terms of the law to participate in a process that amounts to re-registration of voters in a period of one month was

It asked the court to dismiss the application for leave to commence judicial review, with costs.

However, when the matter came up for hearing of the renewed application for judicial review yesterday before Court of Appeal judges, Justin Chashi, Petronella Ngulube and Florence Lengalenga, the applicants through their lawyers Mutembo Nchito and Musa Mwenya, State Counsel, insisted that their renewed application for leave to commence judicial review should be granted.

But ECZ through its counsel, Bob Musenga asked the court to dismiss the application with costs arguing that the applicants were prematurely before court as they had not explored numerous avenues which were available to them within the electoral laws.

And in a ruling delivered the same day, the three Court of Appeal judges declined to grant the applicants leave to commence judicial review, saying if they were to grant the application, they could end up having three cases; before the High Court, Constitutional Court and Court of Appeal bordering on similar issues. Chashi Judge who delivered the ruling on behalf of the other two judges said each party would bear their own costs. And in a Facebook posting, Pilato said they would pursue every route possible to defend democracy. "The Court of Appeal has maintained the decision made by the High Court and has since indicated that we join the already existing cases before the High Court. We will pursue every route possible to defend our democracy and our constitution. To assume that we will give up is a liability for anyone," stated Pilato.



Police summon Diamond TV director, news editor over leaked budget speech

Avoid re-using hybrid seed varieties to maintain good yields, govt urges farmers

By Natasha Sakala MINISTRY of Agriculture Director for Agriculture Moses Mwale has dispelled assertions that multinational companies are patenting indigenous

seed varieties as they are not owned by anybody. And Mwale has advised farmers to avoid re-using

hybrid seeds so that they are guaranteed a good yield. Farmers recently

Farmers recently expressed concern that they were unable to re-use hybrid seeds as they could not afford buying new seed every year.

In an interview, however, Mwale said that companies can only patent what they produced as is the case with hybrid seeds.

"You can patent what you make. So, these multinational companies, the seed that they patent is what they make because

what it is, is: those are hybrids like the seed being sold by Zamseed, SeedCo and so on. They actually create it, in other words they go through a breeding process and because they made it, that's why they patent it to protect it. So, even for ZARI (Zambia Agriculture Research Institute), as a national research institute, they also do their own research to come up with varieties and what they do is that they combine what is there as traditional seed and then go through a breeding process and come up with a variety. And as ZARI, they patent what they also create, but what it is that, ZARI being a research institute, it's not into marketing so whatever they make, they then license out to seed companies to make certified seed to commercialise and sell

the seed, but you cannot necessarily patent the local varieties because seriously speaking, nobody owns it. It's there, it's indigenous and how do you patent something that you didn't make? So, that's where I think the issue is," Mwale said.

And he advised farmers to avoid re-using hybrid seeds so that they were guaranteed a good yield. "So, there are two

types of seed that you can

come across: there are selfpollinated varieties of crops like groundnuts, beans, rice and so on. So, those kinds of crops, like beans, you can actually grow the same crop the next year, the same seed you keep. Of course, when you go to hybrids, those are the ones, which lose viability over time because you see they are created through a scientific process, and that scientific process is supposed to last for just one year. Farmers may still want to grow in the second year, but they will definitely see a loss in yield in the second year, the third year, and at a certain point, it can't grow anymore because it's created for that purpose. Like I said, self-pollinated, even maize itself, there are some varieties, which are called local varieties so those you can actually grow year in, year out, as long as you keep it in a nice way in terms of maintenance and storage," said Mwale.

Patson in a race for fitness

STRIKER Patson Daka will be in a race for fitness ahead of Zambia's crucial Africa Cup of Nations qualifier against Botswana after straining his hamstring while on club duty.

The Austria based striker sustained an injury in the back of his right thigh during RB Salzburg's 3 - 2 loss against Spanish side Atletico Madrid in a UEFA Champions League tie.

Daka started upfront alongside Mergîm Berisha while compatriot Enock Mwepu was deployed in the wide areas as Salzburg were looking to collect their first win in the group stage.

However, Daka was tipped to be the main man but was forced out 27 minutes into the game after he limped off for Malian Sekou Koita.

It is not clear for how long the player will be out but the club reported after the game that a final diagnosis would be given after full examinations.

The injury would, however, come as a source of concern to Chipolopolo coach Milutin 'Micho' Sredojević ahead of the match against Botswana as Daka's availability is now in question.

Micho had previously indicated his desire to build the team around the 2017 Young African Footballer of the year.

In his recent interview, Micho, however, said he had prepared the team in such a way that local based players were ready to step up and perform in case some key foreign based players were not available.

"We have a clear projection of what is our first 11, in the best case scenario, but we have a back plan, plan B, C, D upto plan Z ready for anything that comes. May be professional players will be blocked from coming due to the ongoing situation with COVID - 19. We have made our locally based players our special commando forces ready for any challenge ahead of us," Micho said.

Zambia are bottom of Group H, having lost their two opening matches of the qualifiers and need to beat Botswana over two legs to keep their AfCON hopes alive.

Chipolopolo will play the Zebras on November 12 at home before traveling for an away tie four days later.
