Suppose the opposition (UPND) decides to strike a better deal with them what will remain of the PF if we don't take necessary political precautions? Why have we become so comfortable and relaxed forgetting that the pact was merely for 2016 elections and by now I am sure we have shared according to the agreement hence the need for the Patriotic Front party to get back to the drawing board and start putting its house in order," Max said.

"The Patriotic Front Party is a big party and with several developmental programs scored and massive infrastructure development registered which will attract investor confidence thereby creating business and employment opportunities which will then put more money in people's pockets in terms of salaries and revenue earned from businesses subsequently put food on the tables in line with our party manifesto. With the above mentioned milestone in terms of fulfilling campaign promises I expect the Patriotic Front party to start thinking of facing any opposition political party come 2021 without requiring the services of backup plan in terms of political pacts. We must understand that we won with approximately plus/ minus 110,000 votes, however to make it to 50+1% threshold it was merely plus/ minus 13,000 votes. When we look at the above figures and statistics we shouldn't even be comfortable because to me it clearly shows that we only managed to survive

by the skin of a tooth." He said there was need to concentrate of grassroots mobilization instead of relying on a pact with the MMD.

"Now any genuine and truthful politician will agree with me that should MMD decide to do us a 'DONCH KUBEBA' come 2021 due to failure on agreeing certain political requisites, with this comfortability I am seeing we shall definitely be the next opposition political party. There is need for us as a party to go back to the grassroots, gather information as in what people are complaining about, take it as raw information as it is study it and present it to the Secretary General of the party Mr Davies Mwila above all our distinguished

"I am a person who never sugarcoats and I know very much well that after party elections next year and the national convention in 2020 Front party should our

Like I have always said, Southerners have always been good partners of the Bemba people. It is just that a few people want to bring a rift which does not exist. From time immemorial, we have been partners. If you look at the political history of this country, Bembas and Tongas have worked together and even now we are working together and we shall continue working together whether one likes it or not, we don't bloody care about that," GBM said. "Our colleagues came to visit our incarcerated president and the president was quite excited to see Dr Kambwili and honorable Musenge. We went in at the same time and a lot was

discussed which I cannot reveal but all I can say is that they are insisting that HH should be released unconditionally. That's their plea to Edgar Lungu because they feel that the man has not done anything for it to warrant him to be incarcerated for this long, close to four months. Which I also agree with. I was part of that motorcade at the time that president Hakainde Hichilema was in Western Province and I saw nothing wrong, we never committed any offense whatsoever to warrant his incarceration. I equally say that he must be released immediately and unconditionally." He said the UPND was not petty. "You were talking about the reunion of the Kambwilis

and us the UPND, I think we are not petty as the UPND and we have never been petty. Look at how they welcomed me when Edgar Lungu expelled me from PF, they embraced me without any hitches. This is the same way they have welcomed Kambwili also. Earlier, Kambwili told journalists at Mukobeko that President Edgar Lungu was so scared he

would soon start accusing monkeys at State House of wanting to stand in 2021. "The man in State House is scared, scared to the effect that we may hear very soon that they are suspecting that those monkeys at State House want to stand in 2021. So they will start arresting monkeys if people are not careful. And I want to apologise to the people of Zambia that had I known that this is the behavior of the man that I went to campaign for the whole Zambia, ending up so sick, I was not going to do it. The man has got a bad heart," said Kambwili.

below is the full submission that the opposition political party has written to justice minister Given Lubinda. FDD's SUBMISSIONS ON THE

POLITICAL PARTIES BILL. Article 60 of the Republican Constitution provides for among other things the regulation and funding of political parties. The Ministry of Justice has come up with the Political Parties Bill in a bid to operationalise Article 60 of the Constitution. It must be noted that this bill is largely a copy and paste of the Kenyan Act.

As a Party we have extensively scrutinised the bill and we have made among others, the following submissions for consideration by the Ministry of Justice:

COMPOSITION OF THE 1. POLITICAL PARTIES BOARD. The composition of the Political Parties Board excludes Political Parties. Instead the Board is composed of representatives of the three church mother bodies, ZICA and Ministry of of Finance. As a Party, we submit that the Political Parties Board must be comprised of Representatives of Political Parties with representation in parliament and a representative from the Ministry of Finance and not representatives of the church and ZICA. 2. APPOINTMENT OF THE BOARD In the Bill, the appointment of the Board is to be done by the President. As a Party, we are opposed to this because the President is an interested party thus he should not meddle in the process of selecting who should and who shouldn't sit on the Board. We submit that each Political Party must nominate their own members to sit on the Board.

and undemocratic. Political Parties are independent associations registered under the Registrar of Societies hence each Political Party has the right to draft it's own constitution as long as it isn't ultra vires to the provisions of the Republican Constitution. The Minister has no right to prescribe what a political party should include or omit from its own constitution because such is the preserve of the members of that particular party.

4. QUORUM OF THE BOARD.

The Bill states that three members of the Board constitute a quorum.

We submit that the quorum of the Board must be 50% of the total number of the Board members.

5. VALIDITY OF PROCEEDINGS OF THE BOARD

According to the Bill, the validity of any proceedings, acts or decisions of the Board shall not be affected by any vacancy in the membership of the Board or appointment of any member or by reason that a person not entitled to do so took part in the proceedings. We wish to submit that the proceedings, acts and decisions of the Board are not only important but can have serious ruminations hence they should only be considered to be valid if the correct quorum and procedures were followed and that no an unauthorised persons took part in the proceedings.

Secondly, the concept of "good faith" is vague and susceptible to abuse; what is it that must constitute "good faith" and who determines an act or omission considered to be done in "good faith"? We therefore submit that this provision be scrapped off from the Bill to avoid abuse and to discourage wanton disregard of the rules, regulations and provisions of the eventual Act. OF 7.

DEREGISTERATION POLITICAL PARTIES

According to the Bill, the Registrar has powers to deregister a political party for instigating or participating in the commissioning of any electoral offence. The above provision is not only too abstract but it can prove to be problematic in its application. How do you define a Party? Who must be held accountable as a Party? Does it mean that if a member of FDD for instance, at a tarven in Namushakende or at a village pub at Nyere Ni Imbwa village gives a colleague a coin as a bribe to induce him into voting for

retribution from the ruling party. Secondly, why should the Registrar demand for the publication of pledges. Does it mean that if a Mr Petition Daka at Nsima Mbumbu village in Petauke pledges to donate a packet of Nyama Soya to FDD, that must be recorded and submitted to the Registrar? This demand is both cumbersome and frivolous. Of what value will such information be to the Registrar? 9. APPEAL TO THE MINISTER

The Bill states that a person or political party that feels aggrieved must appeal to the Minister of Home Affairs.

We fill that the Minister being a politician, himself, is an not the interested party and might not be the ideal person to appeal to because of probable bias.

We therefore wish to submit that in terms of conflict management, aggrieved parties must appeal to the Board and if they are not satisfied with the outcome of their appeal then they can accelerate the matter to a competent court of law. 10. REPORTING TO THE PRESIDENT The Bill calls for the Board to report to the President with regards to its proceedings and performance. We find this improper because the President is an interested party. We therefore submit that the Board must report to Parliament regarding its performance and proceedings. We wish to strongly appeal to the Minister of Justice to take into full consideration the submissions from stakeholders and not to use this consultative process for PR purposes only. We again wish to appeal to our Members of Parliament to debate this Bill from a broader nationalistic view as opposed to debating it based on narrow partisan interests. May God bless Zambia. popularity to test. It does not matter in what form or shape they come, they shall fall. PF will emerge victorious because the people of Luanshya know that services, self centered politics is what they need. We are happy that he has apologized for his insults against the Tonga people or Tonga tribe. "Let me take this opportunity to warn honorable Kambwili that the party, including youths and women will not take kindly on his childishness. Childish and provocative remarks targeted at President Lungu. He has the freedom to differ with President Lungu and not to become personally disagreeable. Let him take this warning seriously, otherwise he will find it very difficult to practice his politics if that is the route he seeks to take. We challenged him after he was expelled that 'since you are a political heavy weight, let's go in Roan, we face each other,' he ran to court. So he is a coward. We are still challenging him that time is still there, he can withdraw the case so that we face him in Roan. So the party is ready to defend its action against expelled Roan Member of Parliament honorable Chishimba Kambwili in court."

He also named Erick Silwamba, Bonaventure Mutale, and Simwanza Lungu as the lawyers to represent the party in the case against Kambwili in court.

"To this effect, the party has retained the services of the following in this matter; honorable Mr Erick Silwamba State Counsel of Erick Silwamba and company, and Mr Bonaventure Mutale State Counsel from Erick and Company, and we have Mr Simwanza Lungu. These are the ones who are going to represent the party in court. I told you we are on firm ground, we are ready to defend our decision," Mwila said.

He also dispelled rumors that PF Lusaka Province Youth Chairman Kennedy Kamba was suspended from the party. "He has not been suspended, that is why he is seated behind me. If he was suspended, he was not going to be here. He is still in charge of the youths and the provincial chairman is here," Mwila added. Mwila further revealed the names of selected candidates to represent the party in the forth coming local government by-elections in Muchinga, Northern, and Central provinces. "The following candidates have been adopted by PF to contest the local government byelections in their designated areas. Lavushimanda District in Muchinga Province, we have adopted colonel Peter Chipasha, we have also adopted Mr Chipalo Mwansa to stand in Kanchibiya District. In Lunte district of Northern Province, the party has adopted Lawrence Chanda as our candidate. In Itezhi-tezhi district of Central Province, we have adopted Namakau Kaingu who is a lady, so she will stand on our ticket," said Mwila.

3. PARTY CONSTITUTIONS

The Bill gives the Minister of Home Affairs authority to prescribe what must be contained in the constitutions of Political Parties.

We find this provision to be preposterous

6. IMMUNITY OF THE BOARD AND ITS STAFF

The Bill gives Board members and their staff immunity from prosecution for any act or thing done or omitted to be done in good faith in the exercise or purported exercise of their performance.

Firstly, the Board and it's staff exercise their powers in trust and on behalf of the people of Zambia hence they must be held accountable for what they do or omit to do in the performance of their duties. We therefore submit that these people must not enjoy any form of immunity from scrutiny or prosecution.

FDD then FDD as a Party must suffer deregistration? Is that fair? How about the problem of selective application of the law?

We therefore wish to submit that provisions that deal with offences that can result into the deregistration of a political party must be succinct to avoid abuse or conflict.

8. DECLARATION OF SOURCES OF FUNDING

The Bill demands that political parties must submit to the Registrar all the names and detailed particulars of everyone who has funded or made any pledge to the party.

While we don't have any problem with declaring our sources of funding, we wish to submit that the disclosure of such information must be limited to members' contributions and not extended to mere sympathisers of the party.

Siyuni has compromised the Office of the DPP, says Milupi

By Mirriam Chabala Alliance for Democracy and Development president Charles Milupi says Director of Public Prosecution Lillian Siyuni should resign from her position for failing to protect the interests of Zambians.

In a statement yesterday, Milupi wondered how the office the DPP failed to foresee that the case against former Lusaka Province Minister Obvious Mwaliteta would not stand.

"The acquittal of Obvious Mwaliteta and his co-accused by the Lusaka High court should trouble the conscience of a well functioning office of the Director of Public Prosecution (DPP). Mwaliteta and his colleagues have been in jail for one year, over an offence they never committed. 'The arresting officer's evidence was so discredited, disjointed and uncollaborated as he failed to investigate the alabi of Mwaliteta's co - accused', stated Judge Mwape Bowa before dismissing the case. Our understanding is that before a case is conveyed to the courts of law for prosecution, the DPP carries a thorough examination as to whether its merits overrides frivolity and certain hidden interests, by arresting officers," Milupi stated.

"The case in question was so unserious, trivial and unwarranted that a third level officer in the office of the DPP, would have dismissed it outrightly, unless of course there were political undercurrents, and that is where it is deeply troubling. This kind of behaviour by the DPP corrals her credibility to prosecute, and calls to question the propriety of her office."

And Milupi also wondered why the DPP was over taking cases involving employees of the state.

"As a matter of fact, the pattern of events where the DPP is taking over cases of supporters and employees of the State, on the pretext of protecting public interest, is scandalous and amounts to obstruction and abuse of the judicial process by the office of the DPP. There is currently a serious and disturbing pattern of conflict of interest and apparent collusion by the DPP and an invisible hand, which amounts to obstruction of justice. This state sponsored and well coordinated miscarriage of justice threatens institutional cohesion, and will degenerate into the breakdown of the rule of law, which may further threaten peace and stability of our Nation," Milupi stated.

He noted that there were too many people being taken to court without proper evidence against them.

"It undercuts the credibility of the office of the DPP and paralysises legitimate initiatives of credible legal players in the value chain. The Nation has in the recent past been treated to bizarre testimonies of arresting officers, who arrested without any basic aid of fact based evidence, other than mere assumptions. The arresting officer of the UPND President Hakainde Hichilema, made a decision to arrest for treason based on a video footage he watched on social media from the comfort of his home, without even visiting the scene of crime. The DPP ratified and sanctioned the case for 'prosecution'. How bad can it get? What kind of joke can this be?" he wondered.

Milupi said Siyuni had failed Zambians by compromising the autonomy of her office. "The DPP is supposed to maintain a certain degree of autonomy from the State, as a means to ensure prosecution independence. This unfortunately, is a farfetched dream for the current DPP. That's why we call upon her to resign because she has failed the Zambian people, whose interests



she's supposed to protect. In the early 1990's, after the Angolan civil war turbulence, poaching and illegal trophy hunting entirely wiped out Lions from the Liuwa Plains. The only survivor was the Lady Luiwa. Her first confirmed sighting was in 2002 and she wandered the plains for years in isolation. WWF Zambia Species and Protected Areas

Specialist Moses Nyirenda has described Lady Luiwa as a phenomenal lioness whose death is a loss to the ecosystem. "Lady Liuwa was a uniquely remarkable

from her kind drew her close to humans and she was always considered as part of the conservation family" He Said. Mr. Nyirenda explained how WWF's efforts in partnership with African Parks and the Department for National Parks and Wildlife contributed to reuniting Lady Luiwa with a new pride. Several efforts were made to reintroduce lions to the Luiwa Plains, many of them suffering major setbacks. In 2008, after safeguarding the park and ensuring improved law enforcement, WWF through its partners facilitated the introduction of a male lion to the Luiwa.

Tragically, he died in the process of translocation. A second attempt was made in May 2009 and this time two males were relocated to the Luiwa from the Kafue national park. They were both acquainted with Lady Luiwa but

unfortunately any attempts to produce offspring were unsuccessful. With time, it became clear that Lady Liuwa was incapable of producing offspring. This is particularly

unfortunate because Lady Liuwa is the last lioness of the Kalahari sun genes in the Liuwa national park. Although her exact age is unknown, she is believed to have been between 17-19 years old which is remarkable as the average lifespan of her kind is around 10-15 years.



Solicitor General opposes application to join Lungu to eligibility case

Solicitor General Abram Mwansa has opposed the joining of the Head of State to his 2021 eligibility case saying he enjoys immunity.

This is in a matter in which four opposition leaders want the ConCourt to determine whether or not President Edgar Lungu qualifies to re-contest in 2021.

The UPND has asked the ConCourt to join President Lungu to case as the matter had nothing to do with his executive functions and its outcome would directly affect him.

But the Solicitor General strongly objected to the application urging the court to dismiss it as the President could not be compelled to come to court.

The lawyer representing PF Secretary General Davies Mwila also opposed to the application to have him joined to the case.

However, UPND Secretary General Stephen Katuka, through his lawyers, insisted that President Lungu and Mwila should be joined to the petition as the two had publicly declared that President Lungu was eligible to contest the 2021 general elections despite having already served two terms.

After hearing submissions from both parties, ConCourt judge Professor Margaret Munalula reserved ruling to August 15, 2017 on whether or not President Edgar Lungu will be joined to the 2021 presidential eligibility case.



Treason case hearing strictly by accreditation – Judiciary

By Joseph Mwenda Judiciary public relations officer Veronica Chisambisha says no political party supporters will be allowed near the Lusaka High Court as the treason case involving UPND president Hakainde Hichilema and five others takes off on Monday next week. In a statement, Chisambisha said due to security reasons and limited space in the Supreme Court, the judiciary would accredit all people who will have access to the public gallery in the

courtroom. "No party cadres from any political party will be allowed on to the judiciary premises or in the vicinity of the judiciary. Organisations and political parties are free to approach the office of the chief registrar to obtain accreditation for their members. The office

of chief registrar will also facilitate accreditation for counsel, journalists and observers," Chisambisha said.

"Further note that cellphones, tablets, iPads, cameras or such similar devices will not be allowed in the Supreme Court room number one. This measure applies to journalists and legal counsel. Any breach of the said measure may result in accreditation being cancelled and the person in breach being ejected from the court premises."

Fuel price reduction too minimal to cause a drop in prices – EAZ

TIZ demands Public Interest Disclosure Act

By Sipilisiwe Ncube Transparency International Zambia president Rueben Lifuka says government must quickly implement the Public Interest Disclosure Act which deals with protection of whistleblowers.

Responding to a press query from News Diggers! after the Road Development Agency fired Loyce Saili and two others on suspicious of leaking information to the media, Lifuka observed that whilst some civil servants were appalled by some abuse they could be witnessing, they could not come forward for fear of victimization.

"We call upon Government $and {\it specifically the Minister}$ of Justice to provide guidance and ensure the full implementation of the Public Interest Disclosure Act which deals with protection of whistleblowers. It is considered our view that there are many well meaning public servants who are appalled by this impunity and abuse of public resources. But such public servants cannot come forward for fear of victimization. We also call on government to restore order and provide appropriate guidelines to all Boards of parastatal bodies and government agencies on their responsibilities resist these demands have been disciplined or have had their employment contracts terminated. We want to insist that serving on a Board of Directors for a parastatal body or government agency, should not be looked as a source of employment for those who are appointed, but they should consider this as a call to national service," he said. "Government Ministers should stop this tendency of populating Boards with ill qualified persons whose only credentials is loyalty to a political party. Some of these appointees have no idea of their expected responsibilities and they consider their tenure on such boards as a 'time to eat.' We want to underscore that such caderisation of Boards of Directors erodes the

central concept of proper

management oversight and introduces all sorts of vices including corruption. A Board Chairperson who solicits and receives unwarranted benefits, becomes compromised and in most cases, fails to fairly discharge his or her responsibilities."

Lifuka asked chief executive officers of parastatal organizations not to be vulnerable to manipulation.

"It is disheartening to note that such acts of impunity and disregard for good governance, corporate are also alleged to be perpetrated by some Ministers and Permanent Secretaries. This defies government's own desire to promote fiscal discipline - for Board Chairpersons to be demanding for new vehicles to be bought for them - even when such expenditure is not budgeted for. We call on the Minister of Finance, Secretary to the Treasury and the Industrial Development Corporation, to put an end to this wastage of public resources. It is also time that Chief Executives were protected from this undue influence of politically aligned Board members who use their political connections to intimidate management and harass them into acts of abuse of office, including disregard for Public Finance and Public Procurement regulations. Similarly, we call on Chief Executives not allow themselves to be vulnerable to such manipulation and we urge them to remain professional and resist such selfish conduct. As a people, we should not allow such personal aggrandizement at the expense of many other deserving national programmes," said Lifuka.

arresting Mr Hichilema to continue as the matter now takes off in the High Court. Let the witnesses prepare and remain bubbling with confidence as they go to take the stand and testify that the UPND leader tried to take over executive powers of the President of Zambia.

We say this because there has been so much fuss about this treason case, and the world has waited for so long to hear its merit. It has cost Zambia the identity as an icon of democracy in Africa. Lessons from S/African Parliament: Conscience and the courage to rebel

Prior to the motion of no confidence in President Jacob Zuma in the National Assembly, former Finance Minister, Pravin Gordhan, among others, urged the African National Congress (ANC) MPs to be guided by their conscience, implying that they should break ranks with their party and vote with the

was that the opposition was seeking unconstitutional "regime change". This was quite correctly challenged. The opposition pointed out that the motion had been put in terms of the constitution, and that they were seeking to replace the President and not the ANC government. And yet, although the ANC manifestly rgument was "rubbish" (to quote Wits academic Ivor Sarakinsky in commentary on a local television stations eNCA), the debate highlighted a very real tension at the heart of South Africa's democracy. Should MPs have the right to vote according to their conscience? The role of the political party Universally, the rise of political parties alongside the expansion of parliamentary democracy inevitably came at the cost of the independence of individual MPs. It is rare today for any individual not belonging to a political party to secure a seat in any parliament. Belonging to a political party has become a necessity except in the most exceptional of circumstances. In turn, belonging to a political party requires that MPs or representatives sign up to a Faustian deal. If they want to progress politically, they have to follow the party line, even on occasions where they disagree with party policy.

This is entrenched in the communist notion of 'democratic centralism' - once the party has 'democratically' made its decision, the individual is politically bound to implement it. In practice, however, party systems are not always so rigid as this implies.

the middle, party leaderships may try to resolve difficulties by suspending party directives and allowing a free vote (as during the Brexit referendum debate). On key issues, individual MPs who threaten to vote against their parties may be bribed by promises of bounty for their constituents or by compromises made relevant policy

Voters do not have individual MPs. They simply vote for a party. Under this system MPs are allowed minimal scope for conscience

But, ultimately, the ANC has no answer to the popular expectation that, when pressed on major issues, MPs should vote for what they think is right. They should vote against that which they think is wrong. They must be guided by their conscience rather than their pockets.

Is this why the ANC so forthrightly rejected the recommendations of the Van Zyl Slabbert Commission on Electoral Reform? The commission recommended a mixed electoral system whereby

The thrust of Gordhan's argument was that under Zuma the presidency had become corrupt and morally compromised. Therefore a vote against Zuma's continuance in office would be in the national interest.

The further implication was that voting for Zuma to go would be in the long-term interest of the ANC. The reasoning behind this was that, unless the party is to return to the values for which the liberation struggle was fought, it will wreak its own destruction. The counter-argument by the ANC hierarchy was that ANC MPs were bound by obligation to the voters who had elected them to vote the way the party instructed. MPs in the South African system are not elected as individuals, but merely as members of their party. To vote against the party line would be to overturn the logic of democracy. A further argument put forward by ANC speakers in the debate

Parliamentary histories are stuffed not merely with internal party rebellions but individual MPs voting against their own governments. Internal rebellions are prone to occur where party leaderships lose the confidence of their backbenchers (who are usually relaying extraparliamentary discontent). And individual MPs may choose to vote against their party's line - often for religious or ethical reasons. They may also do so because they see themselves as representatives of constituencies or interests that are offended by party policy.

Political parties handle such problems in different ways. Often they will seek to fudge policies so as to contain intraparty differences. Alternatively, minority factions within parties may grow to become a majority and secure a change in party policy.

Where parties are split down

proposals, although ultimately the threat of expulsion from the party lies in waiting.

Individual MPs may also be buoyed up by the honour that accrues to them if they are perceived to be standing their ground on matters of political or moral principle. They may earn the respect of their political opponents as much as the brickbats of their party colleagues. Challenge for the ANC

The variations, inconsistencies and flexibility built into modern party systems clearly stands as a challenge to the contemporary ANC mantra that MPs are slaves to their party's requirements. Yet the ANC position is by no means without logic. It is indisputable that under South Africa's electoral system, as it stands, MPs are elected as party representatives and not as individuals.

proportional National-list representation allows for no individuality of candidates.

Voters seem to expect that when MPs refer to each other as 'honourable' that they should indeed embody 'honour'. Yet equally, the public distaste for blatant political opportunism, as displayed during the floorcrossing episodes of yesteryear when minority party MPs jumped ship, mainly to join the ANC for personal and financial reasons, it is clear that voters expect MPs to respect the outcomes of elections. Discipline yes, but courage too Seemingly there is no consistent set of principles and practices which will satisfactorily resolve the tension between party demands and individual conscience. Yet what does become clear is that there is much more scope for flexibility, tolerance of dissent, and - yes - freedom of conscience in systems where MPs are directly MPs would be elected on party platforms but from multimember constituencies.

There is no escaping the necessity of party systems to get the job of government done. Voters understand the need for party discipline. Yet as the vote of no confidence also shows, they also want MPs to have the courage to rebel.

Special counsel Robert Mueller, who is heading up the main investigation into Russian election interference, left Mr Manafort's Alexandria home with "various records", the Washington reported Post on Wednesday.

The president, who is on a working holiday at his golf club in Bedminster, New Jersey, also told reporters he had not thought about the possibility of firing Mr Mueller, who was appointed as special counsel in May following Mr Trump's sacking of then FBI Director James Comey. **BBC News**

Kenyan opposition warned over claims

Kenya's electoral commission has warned the opposition that its claims of victory for its presidential candidate, Raila Odinga, could be deemed illegal.

The opposition has published its own figures, putting Mr Odinga ahead of incumbent President Uhuru Kenyatta.

This contrasts with provisional electronic results giving Mr Kenyatta a clear lead in Tuesday's poll. documents containing the real results were still being sent from constituencies to their national tallying centre.

Mr Odinga has said the IT system of the electoral commission had been hacked and Kenya was witnessing the worst "voter theft" in its history. But the commission said that while there had been an attempt to hack its system, it had failed.

Mystery illness hits Canadian envoy in Cuba

Canada's foreign ministry is investigating after at least one of its diplomats stationed in Cuba was treated for hearing loss and headaches.

It comes a day after the US said its diplomats in Havana were experiencing strange physical symptoms.

Reports suggest the envoys could have been targeted by a covert sonic device that causes hearing loss.

Havana denies the allegation, but the US has removed two Cuban diplomats from Washington DC in retaliation.

"Cuba has never, nor would ever, allow the Cuban territory to be used for any kind of action against accredited diplomats or their families," Cuba's foreign ministry said.

Global Affairs Canada, the country's foreign ministry, says the government is working with US and Cuban officials to find out what happened.

"We are aware of unusual symptoms affecting Canadian and US diplomatic personnel and their families in Havana," a spokesperson for Global Affairs told the BBC.

"The government is actively working - including with US and Cuban authorities - to ascertain the cause. At this time, we do not have any reason to believe Canadian tourists and other visitors could be affected."

The Associated Press reported that a US investigation determined that the American diplomats' hearing loss could have been linked to sonic devices which emit inaudible sound waves that can cause deafness. *BBC News*



Electoral commission chairman Wafula Chebukati told the BBC it was the only body legally allowed to count votes. He accused the opposition coalition of basic mathematical errors. International observers have described the election as free and fair.

Taylor Swift says DJ subjected her to long, 'horrifying' grope

Grammy-winning singersongwriter Taylor Swift testified on Thursday she was subjected to a "very long" and "intentional" grope by a Colorado disc jockey who appeared to be drunk during a photo session four years ago.

The 27-year-old pop star was testifying for the first time for a U.S. District Court jury weighing her accusation that David Mueller grabbed her bare buttocks during a preconcert fan reception in 2013 against Mueller's assertion that she falsely accused him and then got him fired.

Swift - one of America's most successful recording artists, whose hits include "Fearless" and "Fifteen" - spoke forcefully under questioning by Mueller's attorney, Gabriel McFarland. She said several times, "Your client grabbed my ass," at one point calling it a "devious and sneaky act."

"It was a definite grab ... a very long grab," she said. "It was intentional. He stayed latched onto my bare ass cheek. I felt him grab onto my ass cheek under my skirt."

Mueller, 55, testified on Tuesday that he may have made innocent contact with Swift but denied any inappropriate behavior. Asked if he grabbed her backside, the former disc jockey for Denver radio station KYGO-FM replied, "No, I did not."

Swift spent an hour on the witness stand on Thursday and said it appeared both Mueller and his girlfriend, who stood on the other side of her for the photo, had "had a few cocktails."

The photograph, repeatedly displayed in court, shows the pop star in a black skirt and top, flanked by Mueller and his girlfriend, all three smiling for the camera. Mueller has his right hand concealed behind her rear end, and Swift appears to have shifted her hip slightly away from him.

Asked by McFarland why her bodyguard did not step in when "this big drunk guy" groped her, Swift

Swift also sharply denied McFarland's suggestion that Mueller was the victim of mistaken identity. "He had a handful of my ass. I know it was him," she fired back. Swift's account was backed by subsequent testimony from her photographer, Stephanie Simbeck, who recalled seeing Mueller "put his hand on (Swift's) butt" through the camera's viewfinder. She said it was clear to her that Swift "was trying to get away" from Mueller.

Once he and his girlfriend left, Simbeck testified, Swift said aloud: "Dude, that guy grabbed my ass," to which Simbeck responded, "I knew it. I have the photograph."

They quickly found the Mueller image in her camera, and Swift said, "That's him," Simbeck told jurors.

Explaining why she did not report the incident to her managers and security detail right away, Swift said she still had more fans to meet and "didn't want to ruin their concert experience."

had been fired, Swift replied,

"I just never wanted to see him again. And here we are years later, and I'm being blamed for the unfortunate events in his life."

Mueller initiated the litigation, claiming Swift fabricated the story and put pressure on KYGO to fire him from his \$150,000-a-year job. Swift then countersued for assault and battery, asking for symbolic damages of \$1. Swift asserts she never demanded Mueller be fired. The former DJ is seeking lost earnings and to clear his name, telling the court this week that it was humiliating to be accused of "something so despicable."

Following Swift to the witness stand was KYGO manager Robert Call, who fired Mueller two days after the alleged incident, acting on a complaint from Swift's liaison to radio stations, Frank Bell. Call testified that he had known Bell for many years and had no reason to doubt him.

Call said Mueller at first denied to him that he had touched Swift at all. But when shown the photo in question, Call said, Mueller responded: "Well, if it did happen, it was accidental."

Call said he fired the DJ because of his shifting accounts of the incident, and because the photo showed that Mueller's hand was "not where it was supposed to be."

Swift, who has 85 million followers on Twitter and 102 million followers on Instagram, earned \$170 million in the year to June 2016 following a world tour and her best-selling "1989" album, according to Forbes Magazine. *Reuters*

Goat crowned King in Irish town

For a few days this week a goat will be king of a small town in Ireland's rural south west. Billed as one of Ireland's oldest festivals, the Puck Fair sees locals in the town of Killorglin pluck a wild mountain goat from its habitat and crown him 'King Puck' for the duration of the event. This year's king was paraded through the town on Thursday,

where he was crowned by the Queen of Puck - an honor bestowed on a local schoolgirl. He appeared relaxed, if occasionally bemused, during his coronation.

"I've seen it for the last 11 years so it's nothing new but when I first moved here from England I thought it was strange," festivalgoer Ben Henry, 25, of Killarney told Reuters.

"I heard a fella today saying he's been coming to Puck for 57 years so that says a lot!" he added. The festival will feature music, street performers and a horse fair.

The origins of the event are unclear, though there are many local theories from a harvest festival to tales of a lone goat

fleeing Oliver Cromwell's troops into the village.

Organizers say historical references to the festival date back to the early 17th century. As for King Puck, organizers say he is to be treated royally during his brief reign with a diet of ash tree branches, water and cabbage to sustain him until he returns to his mountain home following his dethronement ceremony.
