UNZA hikes accommodation, tuition fees

The University of Zambia has hiked tuition fees by between K3,000 and K5,000 across all programmes.

And UNZA has hiked accommodation fees from K1,200 to K3,900 per year.

When called to explain the hike, UNZA public relations officer Damaseke Chibale couldn't give a position, but invited this reporter to his office on Monday. Chibale however told a

university platform called UNZA Network that the hike in accommodation fees was as a result of increments in electricity and water bills.

He justified the decision, saying UNZA was one of the public institutions where accommodation fees remained low in spite of other increments. "Honestly I don't think that K3,900 is a lot of money considering the fact that this fee is paid only once a year," said

Chibale. However, UNZA students complained about the hiked fees, accusing the institution of being inconsiderate.

RTSA considering Benz Sprinter as replacement for Hiace commuter bus

RTSA chief executive officer Zindaba Soko says the agency is considering a Mercedes Benz Sprinter model and the Toyota Quantum, as among the safer vehicles to replace Hiace commuter buses which are being phased out. At a media briefing today, Soko however, said the agency would engage stakeholders to discuss what model of buses was acceptable.

"For us to see how we can make the transport system safer, we are looking at the period of three to five years. When we talk of a specific model of a bus, we are looking at a model that will have seat belts, enough leg room, enough head room and ventilation so that the severity when there is a crash is reduced on the commuter," Soko said.

Chikwanda echoes IMF findings on Zambia's debt

Former Minister of Finance Alexander Chikwanda says the International Monetary Fund's concerns on Zambia's debt are not far-fetched.

And Chikwanda says it does not make sense for a country like Zambia to have a GDP of \$26 billion.

Meanwhile, Chikwanda says inflation figures are unrealistic because they do not take into account factors like rentals or transport but only basic food items.

On Tuesday, IMF observed that Zambia's ballooning external debt put the country at high risk of debt distress.

The IMF said although the near-term outlook for the Zambian economy has improved in recent months, the country's fiscal imbalance has remained very high.

When asked for his interpretation of the IMF statement at a PF Interactive Forum today, Chikwanda, who also chairs the PF Committee on Finance, admitted that Zambia needed to slow down on borrowing.

"The IMF has expressed worries about Zambia's debt profile, those concerns are not far-fetched but anyway, somehow our debt profile is high and going in future, going forward we should be a bit more prudent especially those loans which are not for projects which are single sourced, where there is no tender and so on and so we have to be careful and I think government is doing just that," Chikwanda said.

Chikwanda however said that government had never defaulted on repaying debt, adding that there was a possibility that when the bonds were due, there was a possibility that they could be rolled over.

"But you know, even in government there are some skills which some citizens may not be aware so the guys in the treasury, they have been very good at managing the debt, there's not a single day we have faulted on debt repayment which will mean that we can use that track record going forward for instance when the next bond is due, and I think officials from the Ministry of Finance have already made reference to that, it can be rolled over because the people who have invested in these bonds are making a lot of money," Chikwanda said.

"Just look at the bond yields in the other developing countries, in the US, the yield is between 2 and 2.4. In Germany, the 10 year bond is .46 as of this morning so investing bonds in developing or emerging countries like Zambia, even at 6 or 7 per cent, you are making a healing so the people who have invested in our bonds are actually long term investors, they are a pension fund, they are not in a hurry to get paid like yesterday so there is a possibility."

He said going forward, there was need for the country resources.

"But going forward, we must really be a bit more reticent, a bit more prudent and the consolation is that okay, all the money has been borrowed to take the country forward. If there was no borrowing, the country would have stood still and Zambia needs to grow at higher rates, not five per cent, we need growth rates in double digits and some of the borrowing will facilitate that," he said.

He observed that the people who benefited the most from infrastructure projects were contractors who operated on inflated prices.

"But as I said, some of the big infrastructure investments, they don't create employment in the immediate because they are very capital intensive. In fact, the people who get rich are the suppliers of earth-moving equipment which they take out of our country," Chikwanda said.

He explained that if the IMF approved the \$1.3 billion for Zambia, it would be for balance of payments and not project support.

"What the IMF are saying justifiable but you know, they will make available the \$1.3 billion. Now there are even some of the educated Zambians joining in misleading people, that money is not for project support, that money is for balance of payment support. Support our balance of payments for the imports and so and reserves that the Bank of Zambia will increase by that amount and that's the purpose of that. It is not for project support, the IMF don't lend you for project support, you will go to the World Bank, you will go to the other institutions, Indian Investment Bank and so on and so forth," Chikwanda

"So that loan we get from the IMF, I don't know, maybe it is paid over 10 years, may be paid in six months installments which means if it is paid in six months, every six months we have got to find \$60 million to pay. That whole cost increases the country's debt service burden and so when the IMF express concern, it is partly they are worried about whether we will be able to service the debt we get from them and my inclination is that we will be," he said.

Chikwanda said it was unfortunate the 60 per cent of the budget was spent on emoluments.

"But what is happening now, between emoluments, emoluments account for an excessive proportion of the budget, more than 50 per cent of our revenue goes on emoluments for the bloated civil service and then debt servicing, between debt servicing and emoluments, you are talking in terms of about 80 per cent of the budget, of the revenue, which left to run the government including the armies and the police so there is a strain in service provision but government is doing the best and I think that the officials we have entrusted to manage our economy, they could be a little more resourceful but they do manage," he said.

And Chikwanda said it does not make sense to have a GDP of \$26 billion in a country like Zambia.

"Zambia's Gross Domestic Product is about 26 billion according to our officials who refuse to think, and the World Bank economic indicators of 2015 puts Zambia's GDP at 26 billion using the atlas route and at 55 billion using the purchasing power. But my own considered view is that Zambia can't be less than 60 billion GDP, this would internal and external debt as a proportion of GDP is less than 20 which raises our bank ability in the global financial market place. And I thought I heard in the budget speech that the combined debt ratio [both] external and internal was 47 per cent, this is because we are using the figure which is our diligent civil servants maintain but we need to complete Zambia's GDP and institutions like the IMF are all prepared to help," he said.

"Otherwise ordinary people including here in Lusaka if you go round, you will see the massive construction that is going on, people have not borrowed from banks, they have no mortgages so there must be money in the economy. We can't have a GDP of K27 billion it just we are officials who take pride in putting a caveat in thinking that GDP is 27 billion."

Meanwhile, Chikwanda says inflation figures are unrealistic because they do not take into account factors like rentals or transport but only basic food items.

"What government should be worrying about now is how we get the economy to a higher level and how we relieve the hardships. You know people are really feeling the squeeze, the cost of living is high and although we are told inflation is only six per cent, but the way inflation is computed in every country, there is a basket, items which you put in that basket, you will put in food items but you have not included transport, rent, which are costly and so whether in Zambia or in America or England or in Russia or China, they have an aura of unreality because they only put few items in the basket," said Chikwanda.

"It doesn't mean that all the prices in the economy are kept at bay. The prices of food, kapenta and so on, maybe the prices have only gone up by six per cent but other things, have gone up, even charges by people working in the informal sector. So it is not a measure of everything."

Chikwanda also said job creation had to be elevated to a serious crusade because the population was growing

Chikwanda further observed that those who had appointed themselves anti-corruption crusaders were the high priests of corruption.

Mumba told News Diggers! in an interview that the IMF's remarks that Zambia's external debt was likely to put the country at high risk of debt distress if borrowing was not slowed down, proved that Mutati was not honest when he told Parliament that the country's debt stood at \$7.2 billion earlier this

"I am very grateful that the IMF has echoed the concerns that we raised a couple of months ago. I did mention to the nation that Mr Mutati had lied to Parliament and to the nation about the true debt stock of our country. I hope that Mr Mutati did receive the numbers which we got from his officers at the Ministry of Finance that brought the actual debt to about \$23 billion. I asked him to prove us wrong by giving us the tentative figure, and show us how they arrived at the \$7.2 billion, he never replied to that," Mumba observed.

"A month later, I wrote another letter reminding him (Mutati) that it was my right as a citizen to receive a response from the minister of finance, but again he disregarded that letter. He has not

replied. So we are very encouraged and vindicated by the IMF when they raised the same concerns that we have raised earlier on about the country's correct debt. This [IMF] reports proves Mutati

And Mumba said it was wrong for Mutati to use the pettiness of politics and escape questions from the MMD on pretext that he was the rightful president of the former ruling party.

"I think that this minister (Mutati) must learn that that Ministry is a public office and it has nothing to do with emotional concerns of him fakely being called president of MMD. It cannot be that because I am also president of MMD then he is not going to answer the letters I write to him, I think it has nothing to do with that petty belief. So we demand that he tells us the truth about Zambia's debt position," Mumba said.

"So what we are going to do now is that we are going to go back to his office when he comes back from Washington DC and sit with him with our numbers so that he can help us understand what our debt stock is. Then we are also going to write to the IMF again, asking them

not to honour their programme with Zambia at the moment until the debt stock is revealed. Until the governance record is improved.

He urged Zambians to mount pressure on the government to reveal the true debt position.

"We have to put pressure on this government. All they are going to say like Mr Chikwanda (former finance minister) has rightly put it, is that 'the country's economy is under stress'. This means that the numbers of debt are not accurate and the budget that was just given is a distorted budget. There is no proof in terms of the numbers given in that budget," said Mumba.

"I want to warn this government that they can do all the politics they want They can stop us from having our freedoms and liberties of meeting as opposition political parties. They can keep imprisoning us for challenging their corruption. But I want to assure them that numbers don't lie. they can manipulate all of us but numbers don't lie. Soon the truth will come out to embarrass and their legacy will be totally distorted."

Visiting South African President Jacob Zuma today gave a moving tribute of late African National Congress (ANC) leader Oliver Reginald Tambo when he joined his Zambian counterpart Edgar Lungu in unveiling the "O.R Tambo Heritage site" in Lusaka.

Tambo's Remembering contribution to the liberation struggle, Zuma said if the late ANC leader was involved in the freedom negotiations with the Apartheid regime, South Africa would have gotten a better deal. "OR Tambo was an extra ordinary leader recognised by many. He had already worked, they knew his power, his strength, his capability. And this is what brought such questions to many of us particularly at the point when it was clear that negotiations in south Africa were no longer a far-fetched reality. We needed this man, we needed this leader to be part of that process. Yes the process went on very well but to many who knew him, there could have been elements that he would have put to be at another level," President Zuma said.

President Zuma said Tambo supported a campaign for the release of political prisoner in South Africa.

"I thought I should say this because it is indeed an emotional moment that takes us back to our struggle to its different levels and contribution made by our leaders. But amongst them, OR Tambo, implementing the decision of the national executive committee, he traveled the world and mobilized the world to support the Africa National Congress, to support a campaign to release the political prisoners which included a big potion of the leadership. He finally convinced many and the world began to move in one direction leading to the United Nation declaring apartheid as a crime against humanity," he recalled.

"One foreign secretary in the United Kingdom who met him for the first time towards the end of her struggle confessed that 'I should have met you president Tambo earlier than now because you have changed me today'. He was a debater, he was a mathematician, a scientist. You could not argue with him. I often tell young people that one time in Angola in the meeting of the national executive committee, we were arguing all of us against him, he defeated us in the argument."

"I said to him during the break that president you were today using your mathematics, your English, your law to defeat us. At the end, he compromised and explained why he had to compromise. He carried the ANC united under most difficult conditions. ANC is a big organization complex, he understood it inside out. And therefore honoring this man

and having site that we touch his name is one of the most important contribution to the freedom fighters of south Africa." President Zuma said he would never forget the role Zambia played in helping South Africa liberate itself.

"Let me thank you Mr President and the people of Zambia for this wonderful opportunity to jointly launch the OR Tambo heritage site today in the presence of the first and former president of the Zambian Republic our father Kenneth Kaunda and indeed the two delegations from both countries and the personalities form Zambia. It is an act that speaks volumes for

our relationship, we will never forget Zambia and its role that it played. And I also want to thank our father president Kaunda because by being here, you have blessed us and blessed this occasion. This occasion today your Excellency the President Mr Lungu is a bond of the powerful symbol between our two countries and people," said President Zuma.

Meanwhile President Edgar Lungu said the honouring of late president Tambo marked the celebration of South Africa and Zambia's own heritage.

"Dr Kaunda allocated this house to Oliver Tambo and African National Congress as a safe house for south Africa's liberation struggle. This occasion signals our long journey of tracing our legacies that speaks the history of the Southern Africa Development Committee (SADC) and Pan Africanism. We have for a long time been reading history written by others as you have already heard and the heritage recognised by colonialists. Time has come for us to celebrate our own heritage," said President Lungu

Forgive Lungu, Pukuta asks church

Evangelical Fellowship of Zambia (EFZ) executive director Rev Pukuta Mwanza has asked members of the clergy to accept President Edgar Lungu's apology, and to forgive the Head of State for accusing the church of being political.

Reverend Mwanza has however asked President Lungu to meet the church leaders whom he offended by challenging them to join politics, so that he could render his apology and receive forgiveness.

Earlier this year when the

State incarcerated opposition UPND leader Hakainde Hichilema, church leaders, especially from the Catholic diocese described President Lungu as a dictator whose unwillingness to dialogue with his political competitors had caused a national crisis. But the Head of State reacted angrily and challenged the bishops to join politics. He said the church leaders had become political in order to justify their pay masters'

expenditure.

"What crisis are they talking about? This crisis exists in their heads because they want to justify what they are getting from their pay masters. If they want issues to be discussed between me and whosoever, let them table the issues by way of explaining the issues to be discussed," President Lungu demanded.

"I have got too many things to do, I am a busy person. I cannot waste time because some civil societies want to justify their pay masters expenditure, I am too busy. So if you have nothing to do, let them find something better to do... Let them join politics, I am ready to face them"

But when he met the clergy in Lundazi this week, President Lungu said he was wrong to accuse the church of being political.

"When you tell us this is wrong, we shouldn't say 'the church has become political'. Obviously, I was one of those, in those days, who used to

believe that the church was political when they correct me. I remember responding to one colleague who was talking to us to say 'join politics', but I think that was wrong. Politics and religion are the same," said President

Reacting to President Lungu's apology, Rev Mwanza, who has a soft spot for the Head of State, said forgiving was

the natural thing to do.

"Somebody has apologised, if this was not solicited and he has realised on his own that those remarks could have hurt other people and he has offered an apology, the natural thing is to accept the apology and to forgive him," Rev Mwanza said.

"But the President can also go further and meet the people he offended by those remarks or actions, to say 'I am sorry' and in that case then we can realise the intention of this season of prayer, forgiveness and reconciliation."

He said President Lungu had taken lead in asking for forgiveness ahead of the National Day of Prayer and Reconciliation, adding that other people should take a leaf

"What I am saying is that everyone else should take a leaf from this and emulate what the President has done by also looking at their own personalities and looking at the people they have hurt and be able to apologise.

Meanwhile, Rev Mwanza invited the UPND leadership to take part in this year's National Day of Prayer.

'I think that there are number of praying people in the UPND, there are Christians there and I know that they value prayers. That's why at one time prayers were made in support of the release of the UPND leader (Hakainde Hichilema). So I think that since they value prayer, they can take advantage of this time just to contribute to bringing healing to the nation," said Mwanza.

"Moreover, we are not praying to an individual, we are praying to God. Prayer also heals those who are grieving, if you are hurting, once they forgive and seek the forgiveness of God, they will enjoy the peace of God as well, instead of continuing to have hurt feelings."

Residential plots under Zesco poles shock Kapata

Zesco spokesperson Henry Kapata says the power utility is worried with the increasing cases of vandalism-related electrocutions recorded on the Copperbelt.

And Kapata wondered why tho local authorities were giving residential plots under Zesco poles.

Speaking during a workshop for Ndola Councillors today, Kapata expressed concern that the rainy season would bring about more cases of vandalism.

"We are here on the Copperbelt to engage the councillors because they work directly with our people. A lot of vandalism happens during this period of rainy season because areas become dark," Kapata observed.

He said a lot of people on the Copperbelt were getting electrocuted because of doing illegal things on the Zesco poles.

"Last year during this period we recorded 14 electrocutions involving people who were tempering with our poles. People cut trees under our lines without engaging us. We don't want to loss lives. That is why today we engage the councillors to talk to our people,"

Kapata said.

He said it was shocking that people had title teeds on plots that were under Zesco jurisdiction.

"If people are given plots and title under Zesco poles, then who is doing this? We can't have structures under the Zesco poles. We are losing K5 million to replace our vandalised poles," lamented Kapata.

"Scrap metal dealers are the ones who buy these products. We are concerned with high rate of vandalism on our cables. So we are also going to engage them." 4. Local News Friday October 13, 2017

"Minister, certain traditional acts are unbiblical, for instance being half naked, and also witchcraft. Is it a good example or reasonable for the Head of State from a Christian nation to go and watch half naked women in Swaziland?" wondered Kambwili.

But Rev Sumaili defended the President saying he went to appreciate African cultures.

"We have different cultures in Africa. Swaziland, Botswana, Tanzania and Zambia, have different cultures. And it is in order for us to appreciate our cultures," she said.

And Mazabuka Central UPND member of parliament Gary Nkombo wanted to know if it was right for the Patriotic Front to continue preaching about prayer and reconciliation when they did not show any practice themselves.

"Honourable minister, it is a fact that prayer without action is nothing. It is also a fact that those who preach one thing and mean the exact opposite are hypocrites... And you want to call us to come and close our eyes at your prayer meeting and yet you stopped us from praying at the Cathedral of the Holy Cross when our leader was released from incarceration. I would like to find out from you madam minister, when your government will start practicing the things they normally say. I'm not coming there until we show steps of reconciling this country," said Nkombo.

But Rev Sumaili said only prayer could transform Zambia.

"Prayer changes things. What will transform this nation is prayer. I agree with you that prayer without action does not avail much unless mixed with action. If we want this country to be united and for you to be an effective leader, you have to love the people. People are looking at us and seeing our actions. Zambians love God and when they don't see their leader to the

place of God, they will start questioning that 'is our leader serious about bringing reconciliation?' Those who aspire to rule this country must show that they love God," she said.

Rev Sumaili also said that borrowing was productive for the country because even the bible allows it.

She was responding to Katombora UPND member

of parliament Derick Livune who said: "The Bible is against debts. Now that the national day of prayer has been called, I want to find out how well the prayers will be received by the Lord if the country is going there with debts that have continued to accumulate?"

In her response, Rev Sumaili said debts were productive.
"I don't know where that

is, were debt is forbidden. Because in the same Bible there is an account of a widow whose husband had died and needed to be helped. She was advised by a prophet to go and borrow containers as much as she could and use them. Madam Speaker, if debt is borrowed, it will bring productivity to improve the welfare and lift the living standards of the

people and to strengthen the economy." she said.

Rev Sumaili said prayers on October 18 would prepare grounds for dialogue.

She was responding to Chitambo PF member of parliament Chanda Mutale who wanted to know if alarmists peddling lies in the country would also be invited for prayers.

"There are alarmists in this

nation who are peddling lies. Is there a special invitation to invite these particular individuals to the prayers? Because if we pray as the nation these people will repent and change their behavior," said Mutale.

In response, Sumaili said prayers would help prepare the grounds for the dialogue process.

'This is a wonderful opportunity for us as the nation to come together in unity and pray to our God. They are talking about dialogue, the people demand that their leaders come together and move together. These prayers are so critical to prepare the grounds for those talks that we have been preparing for. As leaders we have a responsibility because we are presiding over people who want us to be together. I encourage all the members of this house to go for prayers on 18th October," she said.

Meanwhile, Rev Sumaili announced in a ministerial statement yesterday that national prayers would be held in Kitwe.

"It will be held under the theme 'repentance, promoting peace and reconciliation, consoling national unity in diversity'. Madam Speaker, the national prayers will be held in Kitwe at Nkana Stadium. I encourage all members of parliament in their respective constituencies to come out in numbers and to pray together on this special day," said Rev Sumaili.

We have the Mercedes Benz Sprinter buses and Toyota Quantum buses as part of models that we are looking at. But that will be after members of the public, owners and the major stakeholders have agreed to and strike a balance that this is a better model to go for. After that is done, incentives are given after a period of time to sensitize you to give in your Hiace bus at a cost, so that we use it as a way of moving them out of market. It can't be something that is immediate or sudden. A transition takes

a lot of time but we need to start from somewhere and this is where we are starting," Soko

"We want to do a lot of consultation firstly with the general members of public and then work out models with the Ministry of Finance on how

to be able to purchase a more reasonable, comfortable and safer bus at the same cost that they are purchasing the Hiace buses."

He said those who owned Hiace

the public can be sensitized

busses had up to January 2019 to ensure that they had seat belts and proper seats.

"There is no issue with those who have already purchased buses which have seats and seat belts. But those buses which were panel runs and have been made into Hiace buses to transport commuters, should have seat belts by January 2019. The option of Hiace minibuses which is here is that they must have correct seats and seat belts. You will find that a bus can come with eight seats [when bought], but then they will remove the eight seats so that the bus can carry 16 people hence causing a safety challenge," Soko said.

He said that it was unfortunate that the issue of phasing out the Hiace buses was being politicized when it was for the safety of the general public.

"You will agree with me that with the nature of the Hiace minibus once you sit in it, the

risk of you dying out of the crash is very high because all the commuters in the bus are squeezed. There is no leg room or head room and the injury rate gets enhanced because of the way that bus is engineered. What has been happening in all these crashes is that even when a crash has happened at a lower speed, you discover that because the passengers are so close to the body of the bus, they will get crashed or injured. So as RTSA we want a model that commuters will enjoy to ride without any problem. It is unfortunate that people have politicized this move when the idea is to make it safe in the country," Soko said.

"This is a bus that carries goods in other countries and in here we get it and fabricate it to carry commuters. We are trying to sort out this problem which has been a big one because when the economy was liberalized, everybody could come in with whatever business and that was the time that type of transport came in. We had no control measures then to look at what would be the best for the nation."

D/Speaker demands ministerial statement on Chengelo bullying

In his point of order, Nkombo said: "Madam Speaker, Last week, on social media, and out of social media, and we have now seen this on print media... There is a school in central province called Chengelo Primary School and Chengelo Secondary School. There is a trending matter of pupils bullying each other to a point of brutalisation. What makes this particular case worse is that the pupil who is a victim of this brutalisation is of caucasian nature, he is a white young boy who is alleged to have been assaulted brutally by two Zambian boys, pupils at that same school," Nkombo observed.

"As you know social media has no boundaries madam speaker. I have gotten calls from friends of mine from Canada and Japan where they are now saying 'we have been hearing about violence in your country and now it has escalated even to schools."

He asked the Deputy Speaker to rule the general education minister out of order for

being silent on the matter.

"Madam Speaker, is it in order for the minister to sit so comfortably here without coming to this assembly to inform this house about the facts relating to that assort and what remedial measures his Ministry has taken in order for us to reclaim if we are able to, our standing on the world stage. Because what is going on out there is that we are racists and we are a violent group, is he in order to keep quiet and just sit the way he is seated without coming here?" asked Nkombo.

In her ruling, Namugala said although government was not obliged to respond to social media reports, the Chengelo issue was of national interest.

"The ruling of the chair is that while the government will not be expected to comment on every news item. On this particular matter, especially that it has been reported even in the public media, print media. I will request the Honourable Minister of General Education to shade light on this matter through a statement indicating government's position next week, Thursday. That should be sufficient time for the Honourable Minister of General Education to prepare himself to come and give that statement. That is my ruling," said Namugala.

SLOW DOWN ON DEBT CONTRACTION – CTPD URGES GOVERNMENT

The Centre for Trade Policy and Development urges government to take seriously the red flags raised by the International

Monetary Fund if Zambia is to move towards the Economic Growth and stabilization path. The conclusions of the IMF's Article IV consultations

demonstrate the need to consider slowing down on debt contraction and minimize wasteful

expenditures in order help improve budget credibility. This seems to be the underlying reason

for the failure to secure a deal, and the Government needs to priorities getting a grip on debt

in order to accelerate progress toward agreeing to the IMF financing CTPD have longargued

Zambia needs.

In their analysis and conclusions, the Board of the International Monetary Fund observed that

despite recording some improvements in economic performance, public debt has been rising

to unsustainable levels and this is negatively affecting lending towards private sector players. According to the IMF, the outstanding publicly guaranteed debt rose sharply from

36% of GDP in 2014 to 60 % at the end of 2016 driven by external borrowing and the impact of exchange rate depreciation.

Recently, the Minister of Finance presented the 2018 National budget before parliament, the

proposed 2018 national budget comes at a time Zambia is still facing a number of economic

challenges, it is highly anticipated that if well implemented, the budget can help steer the

country to a path of growth and stabilization as espoused in the recently launched seventh

National Development Plan that seeks not to leave any one behind. The theme for the 2018

National Budget is accelerating fiscal fitness and growth without leaving anyone behind, drawn

from the 7NDP, the budget continues to try foster fiscal fitness while embracing the five

strategic growth areas of focus under the seventh National Development Plan of promoting

economic diversification, poverty reduction, reducing inequality, enhancing human development, and creating a conducive governance environment for a diversified and inclusive economy.

It is CTPDs hope to see a properly structured economy that will see the creation of decent

jobs, better health care service delivery, enhanced social protection and overall fiscal prudence

in the management of public resources. From the speech delivered, CTPD notes that government has stipulated the macroeconomic objectives for the 2018 national budget, which

will be to: achieve real GDP growth of at least 5%; preserve single digit inflation within the

range of 6.0% to 8.0%; attain domestic revenue mobilization of at least 17.7% of GDP, limit domestic financing to no more than 4.0% of GDP and maintain international reserves of at

least 3 months of import cover.
While we appreciate the ambitious projected macroeconomic indicators, the revenue and

expenditure estimates for 2018, CTPD is equally deeply concerned with the growing public

debt. The Honorable Minister in his address to parliament told the nation that Zambia's total

debt level is now at US\$ 12.45 billion (ZMW 114.9billion in kwacha) , this is outstripping the

total 2018 budget which stands at ZMW 71.6 billion) representing 47% of GDP.

CTPD has noted the jump in interest payment to 23.0% in the first half of 2017 compared to

6.7% in 2012. The rate of contracting debt is what has skyrocketed the debt repayment and

this has suffocated expenditure on critical social sectors such as education, health, and social

protection that could uplift peoples' livelihoods. During last year's (2017) budget presentation

to parliament, Finance Minister, Hon. Felix Mutati made a pledge to the effect that Zambia

was not going to spend what it did not have. However, CTPD notes that Zambia has not lived

up to that pledge. Further, we also noted that in 2017 government had exceeded the debt

ceiling on domestic borrowing which crowded out private

sector participation thereby worsening the vulnerability of the economy.

CTPD would like to appeal to Government to seriously consider slowing down on debt

contraction and minimize wasteful expenditures in order help improve budget credibility and

fiscal prudence. Instead of acquiring commercial loans at high interest rates, we urge government to priorities finalizing the bailout package

finalizing the bailout package from the International Monitory Fund, this will help improve the

balance of payments as well as offer technical assistance on macroeconomic policy design and implementation. Beyond developing a debt management strategy, it is very important to adhere to provisions of the strategy because left on its own terms, it becomes a mere policy document that may not touch light of day

On the other side, IMF must give a clear position on Zambia's request for a bailout package,

there has been a lot of uncertainty around the outcomes of the negotiations which have

dragged for quite some time now, as a concerned Civil Society, we would like to know in clear

terms whether Zambia will be granted the bailout or not, if yes, when exactly?

"Please, please whatever happens, do not be distracted. Because we are so easily distracted, we voted in someone, and I keep saying it that we voted in someone who was not ready to become President. Of the people that Edgar Lungu stood against in PF, there were better people there. But this ability to bully people into silence, they chose the worst of the eleven. And then after that, he came in and he became President. He is absolutely failing us, he is running this country into the ground. Nobody asks questions because we have been frightened. Let us not be frightened, this is our own country," Miti said.

She charged that the current government was in power just to make money.

"This is the first time there has been such personal viciousness I must say, I have never experienced consequences [for protesting], why now? The reason is because probably we have touched a nerve. The reason why subsequent governments have been in office was say 'to use public space to develop private wealth.' For the first time they

are beginning to think 'wow! This cash-cow!' Someone is beginning to touch the space that is important to us. They don't come into power for us, they come into power to make money. So right now I think the anger is that we are beginning to touch the white space that is important to them. And I am saying, do not be obstructed, let me fight this bully and while they are fighting me, please keep asking about the 42 for 42, about the selling of NRDC, ask about the budget," Miti said.

And Miti asked government not to pressurize whistleblowers because they would end up manufacturing evidence.

"It is government that has started this narrative of citizens being the ones to provide evidence and you have seen people try, I mean you have seen maybe Saviour Chishimba coming out to say 'I have got this, I have that' but the truth is that unless government is transparent and opens up these systems to scrutiny, government will always say they are lying. The evidence is in the hands of government. We need to insist that the systems that



is in the institutions whose mandate is to investigate, should do their job and they should do it in such a way that it is transparent. The 42 for 42 should have an audit. The Auditor General should actually carry out that audit,"

"The Auditor General's report should actually have come out by the end of September. What has happened to it because I am beginning to think that it has been embargoed or maybe it has got more information to it. But it is issues like that

where the institutions and the time line of democracy is easily ignored. Why hasn't the Auditor General's report come out? The Auditor General's office itself is able to carry out a forensic audit on the 42 for 42. So let's not put pressure on those who are asking to provide the evidence because I will be making it up, where will I get it? I will get it sent to me in my inbox, that is not valid evidence. We should insist that government opens itself up to scrutiny."

Meanwhile, Mwape observed that if President Lungu was serious about the fight

against corruption, he would access the evidence needed to prosecute those found wanting.

"The President has so much power to be more accountable and also foster accountability. So being the person that has so much power given to him constitutionally, he is the one who is suppose to lead, he is suppose to be the first man whistle blower. So once we get it from the Head of State, it means that all the systems will begin to be aligned in a more transparent and accountable way. So we are demanding from the President to lead the anti corruption campaign and not the citizens. You can't ask the citizens to provide evidence when you as the President who calls the ACC Director General everyday cannot have that evidence, cannot give that evidence. Then who is Saviour Chishima or Chishimba Kambwili to give all such evidence?" Mwape asked.

He said that the attacks on citizens who demanded accountability were a clear indication that government was shielding itself from corruption allegations.

"The attacks that we are receiving is as a result of a corrupt system. The corrupt system thinks that the way they act, the way they pay for the crowd for people to follow them, these cadres that we see being paraded, they are always paid because they have the money...So now whoever asks a question is an enemy of government. If people are not ready for being occupying political offices, I think they better leave quickly. You shouldn't use archaic laws to say no 'the President has been defamed'. Even when somebody says 'Lungu' I was just saying that now it looks like every Lungu is a President in this country. So if you say Lungu it means you have defamed the President. Even when am calling my colleague Lungu Phiri, they say you have no respect which is unfortunate," said Mwape.

Over 60,000 refugees enter Zambia

Home affairs minister Stephen Kampyongo says the number of refugees who have entered Zambia has risen to about 60, 000 following an influx of asylum seekers fleeing from the Democratic Republic Congo into the country.

In a Ministerial statement delivered to Parliament today, Kampyongo announced that Zambia was facing a humanitarian emergency of persons of concern following an influx of asylum seekers coming into Zambia from the DRC since January this year due to the unstable political atmosphere in that country.

"Madam Speaker, I wish to inform this House and the nation at large that our country is facing a humanitarian emergency following the influx of asylum the Democratic Republic of Congo. Most asylum seekers Madam Speaker are entering the country mainly through Chiengi district in Luapula Province, we have registered 3,700 asylum seekers since August 2017, the number of Congolese refugees who have entered Zambia since 2017 has since risen to over 6, 100. This is the highest number of refugees to enter the country over the past five years. The total number of Congolese refugees in Zambia has now increased to about 30, 000 in total. These together with refugees from Burundi, Rwanda and other countries will bring the total number of persons of concern in the country to over 60, 000," Kampyongo said.

Kampyongo said the number of asylum seekers entering

Zambia from DRC could increase to about 40,000 if that country's security continued to deteriorate.

"Madam, the main cause of asylum seekers from the DRC is instability in that country arising largely from the protracted governance that schedule. There seems to be widespread unrest and violence perpetrated by ethnic and political groups which has forced many Congolese to seek safety across the boarder and especially in the Luapula Province of Zambia. Madam Speaker, about 25 to 100 people have been crossing from the DRC into Zambia everyday since September 2017, this trend is expected to continue as the situation in the DRC is projected to remain volatile. The number of asylum seekers entering Zambia from DRC could however increase significantly with any deterioration of security in that country. Worst scenarios suggest a massive influx of asylum seekers of more than 40, 000 from the DRC alone into Zambia," Kampyongo said.

And Kampyongo said some of the refugee children were suffering from malnutrition while others had died due to inadequate health care.

"The majority of asylum seekers received so far have been predominantly children and women and children including expecting mothers. The asylum seekers have strained the health and other social structures particularly in Chiengi and Nchelenge districts in Luapula. There

is also lack of shelter and adequate clean water supplies especially on entry boarders and indeed in the refugee temporal settlements," said Kampyongo.

"Madam this influx of asylum

seekers into Zambia calls for proactive preparedness on the part of government and its partners, this is because the situation is likely to deteriorate further into a humanitarian emergency."

Transport and Communications Minister Brian Mushimba says he has made it a habit to use public transport from Lusaka's Chilanga area to town every weekend in order to observe how the sector operates.

Speaking when he featured on 5FM's The Burning Issue programme today, Mushimba also said there was a lot that needed to be done in order to sanitize the transport sector.

"I actually make it a point on weekends to use public transportation. I live in Chilanga at the moment and I jump on a public mini bus, the Hiace buses from Sandy's Creation there to come into town. I usually have a hair cut believe it or not, I have some hair cut, I usually cut it on weekends, and then I go back home. So I experience public transportation almost on a weekly basis. It (public transport sector) needs a lot of work and that is squarely in my domain and I have been thinking through how we can sanitize public transportation a bit, the behavior of some of our drivers and the conductors, the equipment that is being used, its just abusive to the public," Mushimba said.

Mushimba highlighted some of the progress made in the aviation sector.

"You will see that maybe in the previous governments, there was a lot of investment in the road sector and not as much in the other sectors. You will also going to notice that in the PF government, there has been the spreading of resources into each one of the four modes of transportation in the country roads, railway, water transportation where we have water bodies, and

aviation. You have seen equal investments in all these because we want to make sure that as a country. at a certain time, all modes of transport are available to the people. And when all modes of transport are available to the people, the appropriateness of travel, then can be a conversation in the country. Those things that need to move by railway will move by rail because it will be available and it will be efficient enough. Those things that need to move by air can move by air," Mushimba

He said government has the vision to make Zambia the hub of transport and communication in the SADC region.

"The investment, coming to your question that has been done in the aviation sector, the new airport terminals, the new raider system that is now automatically navigating planes in our air space, the provincial airports that are being worked on, Kasama, Mbala, the Ndola international airport, the new terminal Harry Nkhumbuka Mwaanga international airport which I had a privilege of commissioning last year, Nfuwe airport we are just finishing discussions to upgrade that as well. There are discussions on Kasaba Bay airport. There is a lot of investment, a billion

dollar plan that has been put in the aviation sector," Mushimba added.

"And as government, the vision is to make Zambia the hub of transport and communication in the SADC region. We feel we can be that central country that everything can come through and filter to the rest of the countries through here and we want by 2030 to be that. And these investments we are putting in all these sectors are speaking to that vision." Mushimba said Cabinet would soon deliberate

the modalities for the reintroduction of the national airline.

"We also as government have plans to reintroduce the national airline. What we have done as government through is not to rush this conversation. We have been very methodical, very analytical and exhaustive in our scenario analysis to make sure that the best and the most sustainable way of re-establishing the national airline is the one that is picked. My ministry has finished these scenario analysis, financial modeling and sent a memo to Cabinet to make a decision on which path among the several scenarios presented each with its advantages and its its disadvantages," he said.

"Once Cabinet applies its mind and makes a decision, that decision will be announced to the people in terms of how we will establish a national airline or if we establish a national airline. But we have made a very good case that we need a national airline because we have done the work. We want to make sure that if

we build a nice house with a nice garage, we also have a car to park in the garage, not a neighbor's car to park in our garage."

Mushimba said government was working hard to diversify the economy.

"There are several scenarios that have been put on the table but obviously the arching objective is for Zambia to be in the skies because we are diversifying the economy and we are not just giving lips service to this word 'we are diversifying the economy' under His Excellency the President, we want open tourism corridors, we want to do farming blocks in the agricultural value chain and products, and to do these things we certainly need a national airline. And this national airline will be for the people of Zambia on behalf of the people of Zambia," Mushimba said.

And Mushimba disclosed that close to 45 per cent works on the upgrading of the Kenneth Kaunda International Airport had been done.

"Kenneth Kaunda international airport is far much more advanced than the Copperbelt and for obvious reasons that we started earlier on KKIA. The last I checked, we were close to 45 per cent completion and slightly ahead of schedule to the completion date of 2019 for that terminal. For the Copperbelt international airport, His Excellency just commissioned the project and activities have continued," said Mushimba.

2018 budget is insensitive to the poor - CSPR

CSPR says the 2018 national budget is insensitive to the needs of poor the people because it has focused more on resource mobilisation through increased taxation.

Responding to a press query from News Diggers! today, CSPR executive director Patrick Nshindano urged government to introduce universal social protection coverage so that all citizens could be covered.

"It has been observed that despite the budget increase in social investment, the 2018 budget has remained insensitive to the poor and focused more on resource mobilisation on the fiscal measures with regards to taxation, which has failed to provide relief, both in terms of the PAYE and also other tax measures that affect the poor despite the increase in the cost of leaving. We are urging government to introduce universal social protection coverage so that all citizens can be covered both under non-contributory and contributory systems including pensions that extend towards the informal sector where most of the labour force is," Nshindano stated.

"Further, it should be noted that the country is far from being out of the current fiscal challenges and continues struggling to reduce a fiscal deficit with a target of 6.1% of GDP for 2018, and growing public debt of 47% per cent of GDP. Therefore, the 2018 national budget should continue to respond and address these economic challenges to maintain stability and investment in essential public services such as health and education."

He however, commended government's continued investment in social sectors as announced in the 2018 national budget by finance minister Felix Mutati.

"The Civil Society for Poverty Reduction welcomes the continued path of fiscal fitness and investment in social sectors in the 2018 budget. In keeping with the objectives of the 7th National Development Plan, the 2018 budget focuses on growing the economy but also ensuring that the poor are not left behind. We are pleased to note the increase in allocations to key social sectors such as health and water and sanitation accounting for 9.5 per cent and 0.78 per cent from 8.9 per cent and 0.68 per cent respectively. Noted also is the nominal increase in budget allocation to education which has

however recorded a decline as a share of the budget from 16.5 to 16.2 per cent. Further to this, allocations to basic social protection which is key for the provision of necessary safety nets but also social investment for the poor and vulnerable, has continued to receive an increased allocation. This not only builds resilience but also the household and local economy," Nshindano stated.

He further noted that the increased budgetary allocation to school feeding programs would enhance the ability by children to excel in their education and to escape the poverty trap.

"Under basic social protection all key programs such as the Social Cash transfer, the Public Welfare Assistance Scheme and Food Security Pack have seen an increase in budgetary allocation. For example, the social cash transfer program has seen an increase in both the amount and coverage of the transfers from 590,000 to 700,000.00 beneficiaries. Further to this, the scale up of the school feeding program from 956,000 to 1,500,000 children is commendable given the high level of poverty and

malnutrition in the country. School feeding programs have continued to encourage school attendance for children coming from poor households but also assist in reducing malnutrition and increase cognitive ability of children to allow them excel in their education and become productive citizens in future as well as escape the poverty trap," Nshindano stated.

Meanwhile, Nshindano urged government to accelerate the enactment process of the planning and budgeting bill.

"We urge the Ministers of Finance

and National Development Planning respectively to accelerate the planned fiscal reforms in line with planning and budgeting, especially the enactment of the planning and budgeting bill and also the review of the public finance act to ensure adherence and also punitive measures for erring officers respectively. These reforms were mentioned during the 2017 national budget but are yet to be actualised and it's critical that we do so, as these provide for a legal framework for successfully implementing the of the budget and indeed the 7th NDP," stated Nshindano.

Let's discuss Lungu's succesor now!

We mean no malice to late president Michael Sata and his family, but Zambia is in its current political state of affairs because Michael did not want to leave a proper succession lineage. He knocked out those who were perceived to be next in line after him, while keeping the weak, less ambitious and 'humble' vey close.

We cannot speculate about the motive behind late Michael's political strategy, but what we know is that the succession dispute he left behind has brought us where we are today. Because the PF president did not want to have a co-captain on standby, the ruling party was left in the hands of a man who - by his own admission - never desired to rule our country; thus Mr Edgar Chagwa

It is a fact, not only in Zambia, but in many African countries that a ruling party candidate normally stands a 75 per cent chance of winning an election. This is mainly so because of two reasons: Rigging by the state machinery, and because the party in power has easy access to internal and external sources of campaign funds. In fact, sometimes a ruling party candidate may not even have a strong appeal to attract voters, but those who already have government jobs work with government contractors to manipulate and influence the will of citizens in order to protect their own interests.

Mr Lungu was adopted PF presidential candidate on December 3, 2014 and in less than seven weeks, he was pronounced Republican President after the January 20, 2015 election. This was made possible because of one, or all the above stated reasons. This reality of African politics, makes us hold the view that the ruling party must at least give citizens an opportunity to know ahead of time, whom they would be voting for in the next election.

We hardly care about the MMD or UPND candidate because the opposition never rigs elections. If they were to win, like the PF did in 2011, it would be because the Zambian people resolved to vote for regime change. It is the ruling party candidate who has the capacity to 'win' an election even when the majority of citizens vote otherwise; so the time is ripe for the Zambian people, non PF members, to start asking who the PF candidate will be in 2021.

We are lucky, as a country, that our incumbent Head of State, says he is enjoying quality health and has since announced his intentions to recontest the presidency in four years time. Fortunately or unfortunately, we are told that it is not up to him to decide his availability because the law doesn't categorically

support his desire.

That is why we are concerned with the slow pace at which the Constitutional Court is moving on this very important issue. We have heard opposition aligned lawyers in Zambia like Mr Wynter Kabimba and Mr Elias Chipimo saying the Constitution does not permit President Lungu to stand again. We have also heard PF aligned lawyers like Mr Frederick Imasiku and other state advocates saying the amended Constitution permits the Head of State to stand again. Zambians deserve to know who is right. We do not agree with lawyers like Mr Tutwa Nguluba who are saying "now is not the right time to discuss the topic". We need this debate now. It would not be fair to keep the voters in suspense until a few months before the next election.

In demanding this, we are not insinuating that our incumbent President is ineligible to stand in 2021. We are not asking the Constitutional Court judges to announce a decision that rules out President Lungu. We understand that there are some Zambians who love Mr Lungu so much that they would want him to be President of Zambia for 12 years or more. But we are also aware that there are citizens who will need to psychologically adjust to the fact that this particular President will be in power for that long.

It is for this reason that we are asking those who have been given the national duty of interpreting laws and settling legal disputes, to give the country direction. A country governed by laws should never run out of answers. If our current Constitution was meant to stand the test of time, how can it be so hard to interpret a term of office?

This might appear to be a premature topic of discussion for people like the Kabwe Central member of parliament, but it is too soon to forget how the PF succession dispute in 2014 paralised the entire governance system. What happened in the ruling party then, was the beginning of a long journey to the present day. George Weah takes early lead in Liberia elections

Partial results from Liberia's presidential election show former football star George Weah has taken an early

Figures from the National Commission Elections (NEC) put Mr Weah ahead in 11 out of 15 counties, although most votes have yet to be counted.

His main rival, incumbent Vice-President Joseph Boakai, leads in one county and is second in most others. A candidate needs more than 50% of the votes for outright victory.

If no-one achieves that, a second round will be held in November.

The election is to choose a successor to Ellen Johnson Sirleaf - Africa's first elected female president and a Nobel Peace laureate.

As the results came in, the manager of Arsenal Football Club, Arsene Wenger, was apparently duped by false reports that Mr Weah had won.

"I would like to congratulate one of my former players, who became president of Liberia," Mr Wenger told reporters.

"It's not often you have a former player who becomes president of a country. So well done, Georgie.

NEC Chairman Jerome Korkoya hit out at false reports and said his officials were doing their best to get accurate official results out as quickly as possible.

"This commission has not declared any winner," he stressed.

However, parties supporting three of the 20 candidates have alleged irregularities and said they would contest the result, Reuters reported. Ms Sirleaf, 78, who is stepping down at the end of two terms, hailed the

"We believe that all Liberians are ready for this process. I thank them for participating in this process," she said.

Liberia, which was founded by freed US slaves in the 19th Century, has not had a smooth transfer of power in 73 years.

Ms Sirleaf took office in 2006, after her predecessor, Charles Taylor, was forced out of office by rebels in 2003, ending a long civil

Taliban hostages freed after five years

Pakistani soldiers have freed

a North American family of five who were being held hostage by the Afghan Taliban.

Canadian Joshua Boyle and his US wife Caitlan Coleman were kidnapped while backpacking in Afghanistan in 2012. They had three children while in captivity.

They were rescued after a US tip-off during an operation near the Afghan border, the Pakistani army said.

US President Donald Trump said it was a "positive moment" for US-Pakistan

"Ms Coleman gave birth to the couple's three children while they were in captivity," Mr Trump said in a White House statement. "Today, they are free."

He added: "The Pakistani government's co-operation is a sign that it is honouring America's wishes for it to do more to provide security in the region."

Who are the Taliban?

Videos of the couple were released by their captors, the Taliban-aligned Haqqani network, during their captivity. The insurgent

group has been demanding the release of three of its prisoners in Afghanistan.

The latest video, released last December, showed the couple with two young boys. In it, Ms Coleman - who was pregnant when she and Mr Boyle were abducted begged for an end to what she called their "Kafkaesque nightmare".

The Pakistani army said US intelligence agencies had been tracking the family in Afghanistan, and reported that on 11 October they had moved across the border into the Kurram tribal district of Pakistan.

In a statement it said: "The success underscores the importance of timely intelligence sharing and Pakistan's continued commitment towards fighting this menace through co-operation between two forces against a common enemy."

In a video statement released to the Toronto Star newspaper, Linda Boyle said she and her husband Patrick had spoken to their son Joshua by telephone after his release.

"That's the first time in five years we got to hear his voice," she said. "It was amazing."

The couple offered thanks to the Pakistani soldiers who had "risked their lives" to rescue the family.

They said Joshua had said his children were looking forward to meeting their grandparents, and that he hoped to see them within

However, Reuters news agency quotes anonymous US officials as saying that the US military had been ready to fly the family out of

Pakistan - but Mr Boyle had refused to board the aircraft. Mr Boyle was once married to a woman who espoused radical Islamist views and is the sister of a former Guantanamo Bay inmate, Omar Khadr. CNN suggested he might fear prosecution by the US authorities.

Asked about this, Canada's Foreign Affairs Minister Chrystia Freeland said: "Joshua Boyle is not the subject of an investigation. Our focus is very much on the safety and the security of this family."

Ms Freeland also said Canada did not pay any ransom for their release.

Earlier, she had said her government was "greatly relieved" the family had been released and was safe, and thanked the US, Afghanistan and Pakistan.

"Joshua, Caitlan, their children and the Boyle and Coleman families have endured a horrible ordeal over the past five years. We stand ready to support them as they begin their healing journey," she added. BBC

'mid-air collision' Three dead after

Three skydivers have died in Queensland after they apparently collided mid-air, say Australian authorities.

Paramedics and police were called to Mission Beach, a popular skydiving spot about 140km (87 miles) south of

Two men in their 30s, and a woman in her 50s, were found dead at the scene, said Queensland police in a statement.

Police said initial investigations found one person may have had collided with tandem skydivers, and their parachutes failed to deploy correctly. Australian Broadcasting Corporation reported one local resident as saying that the three

people fell on the lawn of a property about 1.5km north of the usual landing site. An unnamed eyewitness told The

Cairns Post that he saw one of the skydivers falling. "You could see one chute was tangled and it wasn't opening."

"I was just watching him in free fall

until he went behind the trees, and that was the last I saw," he said.

"It wasn't good to watch. I had my heart in my mouth."

The area's local mayor John Kremastos told the ABC that the incident was "horrible news", saying: "Three people in one accident is very, very sad."

Skydiving is a popular tourist activity in the area, with many of the backpackers who travel the Queensland coast stopping by Mission Beach. BBC News

Was Musonda right to rant about being badly treated by Chelsea?

Charly Musonda Jr's ambition spilled over into frustration this week as the Chelsea youngster took to Instagram to express his bitterness over a lack of game time with the first team.

"You sacrifice, you work hard, harder, you give more than what's expected, and often more than you can, because you love what you do and clearly more than you should," he fumed, "and what do you get back?

"Literally, nothing...done. "However, with this being said, I will continue with same dedication and commitment to this great game."

The 20-year-old has since apologised for the manner of his outburst but his post polarised Chelsea fans. Some believe that Musonda was right to complain about a lack of first-team opportunities, while others are unhappy that he reacted in such public fashion. Despite the controversial comments, the Belgian youngster will remain a hugely popular figure among the Stamford Bridge faithful due to his exciting style of play, which he was able to show off on his first start for the club, the 5-1 hammering of Nottingham Forest in the Carabao Cup. He scored in a man of the matchwinning display alongside Eden Hazard and Michy Bathsuavi.

Musonda understandably wants more chances to shine and he's not the first academy player from Chelsea to be left unhappy with a lack of game

Nathaniel Chalobah, Nathan Ake, Bertrand Traore and Dominic Solanke all felt that their careers would be better while Ruben Loftus-Cheek is presently on loan at Crystal Palace. And these are just the academy player departures to have happened in the past few months!

Musonda is another incredible talent that has been developed a Cobham Training Centre. The Belgian could have left west London this summer, with Celtic keen to take him to Glasgow on a permanent deal, but he felt he was good enough to become a regular in Antonio Conte's side.

However, that is proving a tough - and, evidently, a frustrating - challenge.

Musonda is competing for an attacking midfielder spot with proven, international-class players such as Eden Hazard, Pedro and Willian.

Indeed, it is worth noting that he hadn't started a professional first team match for 362 days until his recent cup display. Approaching his 21st birthday on Sunday, Musonda has only two goals in his 27 professional matches and, at his age, Hazard was already a Ligue 1 winner with Lille with around 150 senior games under his belt.

Still, while the Brussels native can hardly be blamed for his lack of experience in such a competitive environment, he can give himself a better chance of breaking into the first team. Conte has asked him to bulk up, as well as hinting that Musonda needs to be more versatile.
