Kampyongo regrets burning of Zambian trucks in SA

By Sipilisiwe Ncube Home Affairs Minister Stephen Kampyongo says it is regrettable that there have been incidences where some Zambian trucks have been burnt to ashes in South Africa. And Mwamba says there are some "little foxes" in the vineyard that are trying to spoil the bilateral relations between Zambia and South Africa.

Speaking in Pretoria, South Africa, when he paid a courtesy call on Zambia's High Commission to that country Emmanuel Mwamba, ahead of the scheduled bilateral engagements between his Ministry and that country's Ministry of Police, Kampyongo said government was committed to facilitating trade and strengthening relations between the two countries.

"In facilitating trade, how do we ensure that security is not compromised? How do we ensure that those ingredients in facilitating trade are not frustrated by law breakers, and you have had incidents where property, such as trucks, and those trucks that carry certain goods, especially the Zambian trucks, have been caught up in activities to the extent where some of these trucks have been burnt to ashes. So, these are matters of concern and those that drive those vehicles, it's also a concern to them. And so on both sides, we need to make sure that the investments that are coming from South Africa into Zambia are protected and it is a responsibility of law enforcement of the Zambia Police to ensure that...so sum it up, you know that, the Zambia Police is now chairing the SARPCCO (Southern Africa Police Chiefs Cooperation Organization), which is an organ of police chiefs in the region," Kampyongo said in footage captured live on Smart Eagles.

He stressed the need for the two nations to collaborate more in order to deal with certain issues.

"And further, we are now, Zambia, chairing the Troika of SADC, which deals with matters of politics, defence and security. So, it is very important that we collaborate. And for South Africa and Zambia, now we have had the bi-nation agreement done and so each nation will have to interface in between nations for us who are in the security cluster we have to make sure that we start collaborating a little bit more with our counterparts in the Republic of South Africa," Kampyongo added.

And Mwamba said there were some "little foxes" in the vineyard that are trying to spoil the bilateral relations between the two nations.

"You are aware that South Africa is our largest trading partner and for South Africa, Zambia is the largest regional trading partner and with that volume of trade and movement of people, there will be a lot of issues, and before we didn't have mechanisms in which to resolve the issues. So, the bi-national commission sets the stage to resolve the issues, but, however, His Excellency

President Edgar Chagwa Lungu has sent Honourable Stephen Kampyongo, Minister of Home Affairs, to come and resolve some of these urgent issues. They are like little foxes in the vineyard that are spoiling these relations and they relate to migration issues, issues of security and the Minister will attend to these issues because they are threatening these good relations. Honourable Minister will meet his colleague at the Ministry of Police and his colleague at Ministry of Home Affairs and we hope that some of these urgent matters that we have can be resolved even before we have the bi-national commission in November," Mwamba said.

And asked about the ban of Zambian-made honey into the South African market, Mwamba said there would be a high-level meeting between technical officers from both nations.

"We are engaging South Africa at a bilateral level [and] we will call for an emergency meeting between the technical officials at the Department of Trade and Industry and the technical officials at Ministry of Agriculture to come and meet with our officials at Ministry of Commerce and Ministry of Agriculture. We have also written a strong letter to indicate that the disease they purport to have banned the honey on, doesn't exist in Zambia. Zambia was

declared a free area of that disease, the American full brood (paenibacillus larvae), it doesn't exist in Zambia. So, we think that this is a matter of aggregate maybe from the traders who like to aggregate honey from all over the world and they mix it. We hope from the excellent relations that we enjoy with South Africa, that this matter will be resolved quickly and urgently," replied High Commissioner Mwamba.

Last week, the South African government imposed an export ban of Zambian honey to South Africa on allegations that the consignment was found to be contaminated with the named disease.

Namibian in court for rape

The Lusaka Magistrates' Court has sentenced a 20-year-old Lusaka man to 12 months imprisonment with hard labour for assaulting his friend.

And a 23-year-old Namibian national, studying at Apex University, has pleaded not guilty to a charge of rape. Particulars of the offence are

that Andrew Mweemba of Avondale, on May 10, 2018 in Lusaka, did assault Kelvin Mwanza thereby occasioning him actual bodily harm. Delivering a ruling Monday, magistrate Nsunge Chanda said assault was a serious offence and the court would be failing in its duties if it did not give a custodial sentence. She sentenced him to 12 months imprisonment with hard labour.

Meanwhile, a 23-year-old Namibian, Wensel Sheende, student at Apex University, has pleaded not quilty to a charge of rape.

In this matter, it is alleged that Sheende, on July 31 in Lusaka, had unlawful canal knowledge with a named female without her consent. When the matter came up before principle resident magistrate Ireen Washimanga, Monday, Sheende applied for bail pending his trial.

In response, magistrate Washimanga granted the accused bail in the sum of K5,000 in his own recognizance, with two working sureties in the like sum.

The court however ordered the accused person to surrender his passport to the clerk of court.

The matter has been adjourned to September 3, 2018 for commencement of trial.

30 ngwee Internet tariff double-billing – ZACCI

Government's 30 ngwee a day tariff on Internet calls could lead to double-billing consumers, the Zambia Chamber of Commerce and Industry (ZACCI) has warned.

Commenting on the Statutory Instrument (SI) that introduced a 30 ngwee a day tariff on Internet calls, ZACCI president Michael Nyirenda stated that the move could lead to double-billing owing to the fact that consumers are already subjected to paying for bundles.

He also feared the Internet tariff will lead to an increase in the cost of doing business.

"ZACCI has reservations because it adds to the cost of doing business. Further, any possibility of double billing or double taxation for users must be avoided given when one buys a data bundle it grants them the leverage to use the same for either voice e.g. WhatsApp calls or texting e.g. WhatsApp messaging. Thus, we suspect that the consumer will be charged both on the top-end as well as on the lower-end," Nyirenda stated in a press release issued in Lusaka.

"The anomaly we find as a private sector is that it is not possible to use WhatsApp and Facebook without a telecommunications/network provider through their designed product packages where some include data packages permitting multiple services."

He noted that government appeared to believe calls made via social media platforms were free when in fact not.

"However, by introducing the tariff on Internet phone calls, it appears that government is somewhat assuming that a data-call is free. WhatsApp calls appear to be free when viewed from the perspective of government, but they are not free when viewed from the perspective of the consumer. The consumer/caller has to have a valid Internet bundle they would have purchased from Airtel/MTN/ Zamtel in order to make that call,"

Nyirenda explained. "Taxes are paid by the caller on that purchase. Taxes are collected on airtime and this is where data bundles come from, introducing a tariff only double taxes the product." He appealed to government to confront the factors constraining ICT sector growth other than doublebilling consumers. "At this stage we recommend that government confronts the elements that are causing the constraints in real-ICT growth, which has seen poor service delivery vis-à-vis quality of service calls and the targeting of the ICT sector as a cash-cow," he said. "As an immediate intervention, we call upon the government to undertake the following measures: restructure Zamtel splitting/unbundling by

the organisation into three real profit-making units i.e. Mobile GSM company, fixed line company and fibre & tower infrastructure company. All 3 must be allowed to run profitably with independent boards and options to attract private sector finance. The organisation is believed to be technically insolvent and government cannot continue subsidizing a loss-making entity.

He further pleaded for government to reconsider waiving the Internet 30 ngwee charge, warning of its consequences.

"The measure of introducing a 30-ngwee cost on Facebook/ WhatsApp calls is far from what we should be addressing at this point. We encourage government to confront the elephant in the room. It's the failing public utility and monopolistic structures in the sector, where an ISP is paying over US \$1,500/month for tower space that should be less than US \$600/month. Coupled with the high tax rates, the costs of communication cannot come down and the 30-ngwee will just be passed on to the consumers," stated Nyirenda. "The point ZACCI continues to raise is that the Zambian authorities know the cost of finance and taxation is very high. We request for a holistic review of the cost elements in the ICT sector and promotion of increased fair-competition for the government, service providers and users."

PF pledges to reinvigorate dialogue. reconciliation

The Patriotic Front (PF) says the party will conduct internal consultations aimed at invigorating a conclusive position on the national dialogue and reconciliation process.

Mwila has also reaffirmed that the party secretariat has also been working in the background to galvanise a position based on past pronouncements by the President and the party leadership over the dialogue and the Party Secretary General will in the next few days issue a position paper that will be as a result of full consultation within the party leadership over the draft position," read the statement.

Chibamba told Diggers! in an interview in Lusaka, "Usually, when is public outcry about something that is when they reverse the decision and sometimes they even carry it with impunity even if the people are opposed to it. I can give you an example of the National Health Insurance Bill. Chibuyu Finance most expensive lender – BoZ

Chibuyu Finance Limited has been found to be the most expensive lender of loan facilities among the 33 non-bank financial institutions with a total effective annual interest rate of 262 per cent. According to a publication charges, fees and of commissions compiled and published by the Bank of Zambia (BoZ) as at June 30, 2018, Chibuyu is the most expensive lender of credit charging consumers an annual interest rate of 262 per cent among the 25 micro-financing companies, and total 33 non-bank financial institutions. BoZ data reveals in a demonstration of the cost of borrowing K1,000 for one year across all 33 entities, Chibuyu ranked the most expensive lender with a total cost of borrowing amounting to K2,400 in interest for a small loan of K1,000. 'YesCash' Zambia Limited ranks in second place with their interest rate at 214 per cent, with clients charged K761.20 for the same loan amount of K1,000, while Moneta Finance Limited's interest rate peaks at 120 per cent for the same loan amount placing the company as the third highest microlender. In addition to the interest cost of K717.57 for the loan amount of K1,000,

Moneta charges its clients a K20.00 administration fee. On the cheaper end of the scale, Zampost Microfinance offers the cheapest loans of K1,000, with their interest rate pegged at 28.16 per cent, making the company the cheapest lender among the 25 micro-lending institutions, and third cheapest out of the total 33 non-bank financial institutions behind the Zambia National Building

(ZNBS), Society the lender, mortgage and Focus Financial Services Limited, one of three lease finance institutions. Other microfinance lending companies K1,000 below 100 per cent include: Betternow Finance Company, whose interest rate was pegged at 77.9 per cent; Bayport at 44.52 per cent; Izwe Loans at 40.89 per cent and Meanwood Finance at 69 per cent, among others. Among the country's two leading building societies, | ZNBS charges customers an effective annual interest rate for a K1,000 loan at 21.40 per cent compared to Finance Building Society's 36.58 per cent for the same amount. between And the Development Bank of Zambia (DBZ) and Natsave, the latter was found to more than double its interest rate for a K1,000 loan at 67 per cent compared to

the former's 30.6 per cent. According to the BoZ, the difference in the effective annual interest rate on loans obtained from different financial service providers arises from factors such as differences in the frequency of compounding interest, differences in the effective loan periods and differences in the average principal outstanding amounts during the effective loan periods.

Because I don't expect Lungu to be talking about corruption when he himself is corruption. Yesterday he behaved, congratulations Mr President. Please avoid talking about corruption because you are part of the corruption. So what Lungu did yesterday, not to talk about corruption, atleast his conscience is telling him that 'ba bwana imwe ka corruption kena is part of your game'. Congratulations and well done President Lungu," he said. Meanwhile, Kambwili questioned who the PF government was trying to fool with austerity measures when Vice- President Wina

was in Turkey with PF cadres on her entourage. "Austerity measures, who are you trying to fool Lungu and your government? The Vice-President is in Ankara, Turkey, with PF cadres paid for by the state. PF cadres on the entourage! I have seen about three, four provincial chairmen, Mumbi Phiri, on a government program. This is not a party and its government. This is not one party state. Please Zambians let us ask for accountability. There is no way these people can be looking at us like fools. The Vice-President travels all the way to Turkey carrying along PF cadres. We want to know how much has been spent on those PF cadres, who is paying the allowances, who paid for their flight and who is paying for their accommodation. Zambia is not for PF but Zambians. I have a lot of respect for the Vice-President, you are the last person I expect to carry PF cadres on an government important trip," said Kambwili. "And by the way, in these austerity measures I don't think there was anything urgent about concretizing, cementing bilateral Turkey. relations with What do we benefit from Turkey because Turkey is a country that is grappling with debt. And to think that a country that is in debt can help another country that is in debt, is not thinking correctly and I don't think that is right." Lusaka Earlier, the Magistrates' Court adjourned matter а in which Kambwili is charged with contempt of court to allow him seek medical attention after his lawyer Christopher Mundia told the court that his client couldn't manage to sit through the day's proceedings as he was unwell. In this matter EPP leader Chilufya Tayali, 44, alleged that Kambwili tampered with evidence in a case in which the latter is facing three counts of forgery, uttering false documents and giving false information to a public officer. The matter has since been adjourned to September 20, 2018, and October 11 and 16, 2018, for continued trial. Kambwili was accompanied by his party members, his son and daughters who went to offer him solidarity.

ConCourt upholds Kapiri Mposhi MP's election

By Zondiwe Mbewe The Constitutional Court has upheld Stanley Kakubo's election as Kapiri Mposhi UPND member of parliament and dismissed all the grounds of appeal by the PF losing candidate Chrispin Siingwa, saying they lacked merit. And the Lusaka High Court has adjourned a matter in which UPND president Hakainde Hichilema is alleging that his rights to be heard in the presidential election petition were violated, and has ordered UPND lawyers to meet the costs of proceedings. Siingwa had appealed the High Court's decision to uphold the election of Kakubo as Kapiri Mposhi

member of parliament. And delivering judgement, Monday, Justice Enoch Mulembe said there was no ground upon which to reverse the findings of the lower court. "The appellant has not given the court any basis upon which to fault the trial judge's findings who listened to and observed the demeanor of witnesses," said judge Mulembe. Justice Mulembe said the trial judge correctly interpreted the law and applied it. He said all the grounds of appeal by Siingwa unmeritorious were and thereby dismissed the appeal. And the Lusaka High

Court adjourned a matter in which UPND president Hakainde Hichilema is alleging that his rights to be heard were infringed. In this matter, Hichilema and his vice Geoffrey Mwamba want the court rule that their rights were infringed upon in the presidential election petition which was dismissed by the Constitutional Court in 2016 for want of prosecution. Recently, the Supreme Court dismissed with costs, an appeal by Hichilema and Mwamba in which they wanted Judge Mwila Chitabo to recuse himself from handling the matter. The Supreme Court said Hichilema and Mwamba

used a wrong mode of appeal instead of appealing to the Court of Appeal, they appealed to the Supreme Court who had no jurisdiction. The Attorney General had raised preliminary issues on the appeal and submitted that the Supreme Court had no jurisdiction to hear an appeal of that nature. After considering submissions from both parties, the Supreme Court that sat in Kabwe dismissed the appeal with costs because it no jurisdiction had to hear the appeal. The State had also argued that since the appeal was on the recusal and not the Bill of Rights, it was supposed to go

to the Court of Appeal and not Supreme Court. The Lusaka High Court then set Monday as date for hearing the matter.

Kambwili, who is also NDC political consultant, then turned to News Diggers! to express himself over the bitter exchange.

"This world is very shocking! First and foremost, that boy Amos should be the last person to insult me and call me all sorts of names because at the time he was supposed to be fired by Mr Sata, I am one of the people that went and spoke to Mr Sata to have him sent in foreign service and today, he has forgotten where he came from and he can have the guts to call me all sorts of names and insult me openly like that. I used to enjoy a very good relationship with that young man. You know that my wife lives in England and every time I went to England when he was first secretary for press, he would come, pick me up, drop me home and we would talk nicely. He had a lot of respect for me but today, this is how corruption and theft makes people big-

headed," Kambwili said. "That boy, prior to being at State House had lost his job. Govt should listen more and more

John Maxwell, a leadership guru whose brand am licensed to trade says, 'When you listen more, you stop problems from escalating'. This message is for families, business executives, civic and church leaders as well as government authorities. Listening involves the ability to take into consideration viewpoints and concerns raised by those either reporting to you or even your opponents. Former Manchester United Manager Alex Ferguson writes in his recent book on leadership that he often broke into dress rooms of the opposing teams to listen to their various opinions. This helped him to change strategy and tactics.

I recently had a deep conversation with one of the diplomats about Zambia's economic prospects government's capacity to respond to some of the most pressing issues such as debt. I was also asked about why the critical voices that should properly guide government out of this malaise are silent. It is true. Many voices who have regularly advised government are not talking; at least publicly. I believe these voices could be talking to government privately but the beauty of publicly speaking out is that it helps those without a voice know something is happening; someone has spoken for them and they should wait for the outcome. A few professional colleagues think I am slowly becoming a government stooge because my own voice is not heard. I do not think so. I have vigorously engaged government both in public through press interviews as well as in private. As I write, the minister of Finance may be looking at a lengthy email considering some of the proposals I have made to government. I am sure she

Road Transport and Safety Agency (RTSA) Executive Director Zindaba Soko says the agency will not waive fines slapped on speeding motorists following the installation of speed cameras on selected roads but the payment period will be extended by a month.

And Soko says the agency will re-register all vehicles before the end of the year, in accordance with the Road Traffic Act which demands that vehicles are re-registered every 10 years. Speaking at a press briefing in Lusaka, Monday, Soko said the agency would only extend the payment period and not waive fines slapped on speeding motorists. "The Road Transport and Safety Agency (RTSA) today Monday 20th August 2018 commenced the enhancement of the existing signage of speed. While this action is one of the first tangible elements of the Road Safety Management System launched on 7th February, 2018 RTSA recognizes that photo or video-based enforcement will have limited effect pending the implementation of a secure number plate

will respond because she has done that twice before. There are other voices that are scared to speak out. They are now doing business with government institutions and would rather let sleeping dogs lie. Unfortunately, this is being naïve, short-sighted and selfish. There is no economy that remains same and offers sustainable opportunities when industry players are quiet. Strong economies embrace strong voices of commerce. These are the ones who make SADC a reality because it exists for them and not for the policymakers.'

In the same vain, government should seriously listen to critical voices. Not everyone offering advice is an enemy of the state. If anything, even enemies of the state should be listened to so that we develop effective strategies that make government policies relevant. I recently contended with an official from the Road Traffic and Safety Agency (RTSA) that just as much as you have a duty to enhance safety for all citizens, listen more. You will never perfect a system and institute effective change without listening more. You can have all the power and authority that is backed by law but still fail to institute the desired change as long as public voices are not with you.

I also confided with another senior government official over the 30 ngwee charge on internet calls that it is such small things that incapacitate government authority. You may be thinking the 30 ngwee is inconsequential but if a small glow of matches in lit in an atmosphere saturated with gas, it blows out of proportion. There are many voices in these compounds that are not talking but with leaking gas of frustration. There are many entrepreneurs who are not too pleased with the numerous levies and taxes loaded on their incomes. These are very miserable entrepreneurs but without a voice to express themselves. The best government can do is listen to these people; listen to the numerous voices coming from farmers, street vendors, motorists, internet users and begin to institute policies that are on a platform of win-win. I personally want government to win. A government that is succeeding helps me to succeed too. It is not only healthy for me but for my children in future. However, government, with all its authority and power, will never succeed without my support. Government needs the support of all citizens so that it can effectively fulfil its mandate. It is even more crucial now than ever before giver the debt burden facing us. That debt will not be repaid from donors. The Bank of Zambia equally has not authority to print money to pay the debts. The money will come from citizens. This is why I feel government needs to engage its citizens in a very strategic manner, with all required humility so that we can together reshape the country. Complaints of no real time x 2. On the infringement notices by sms, Speed alignment and speed zone upgrades among others. 4. Visibility of signage 5. Messages. I wish to inform the general public and the concerned motorists that we have a huge problem of crashes coupled with the fatalities and serious injuries as a result of excessive speed. As RTSA we have embarked on a process of managing various bad driver attitude by the use of ICT's and the difference we will have is that this will be electronically monitored," Soko said.

"The placement of aligned signage including camera speed signs shall later be extended to other major highways before the implementation of the road side speed cameras enforcement is rolled out to other parts. However, The Road Traffic (Speed Limits) Regulation Statutory Instrument No.90 of 2016 states that the prescribed speeds are as follows: 1. Within the area of a Local Authority 40 KM per Hour; 2. Built up area outside the Local Authority -60KM per Hour; and 3. In any other part of Zambia (Trunk Roads) 100 and 120 respectively on the other hand, modalities are being put in place to address concerns associated with the enforcement of road side speed camera."

And Soko said the agency would re-register all vehicles before the end of the year, in accordance with the Road Traffic Act which demands that vehicles are re-registered every 10 years. "As you may be aware, the current RTSA vehicle database has a population of 765,000. However, only fifty per cent of these vehicles appear to be active and hence re-registration exercise that the Agency is currently working on the process of implementation. The re-registration of Motor Vehicles exercise countrywide is in accordance with the provisions of the Road Traffic Act No. 11 of 2002, which demands that a re-registration must be undertaken every 10 years. Therefore, vehicle owners will be required to re-register their motor vehicles and trailers once the Agency announce the commencement date of this exercise. The re-registration of motor vehicle and trailers will enhance electronic motor vehicle registration with secure number plates and Radio Frequency Identifier (RFID) and it will be done at reduced fee," said Soko.

The usefulness of useless people

outrage took a break as netizens were thrown into the "was Lusambo wrong or right" debate. Without the aim of helping the PF to divert public attention from the much more governance serious scandal, we would like to reiterate our opinion on corruption in the Zambia Police Traffic department.

In our recent prophetic opinion, we described exactly what Minister Lusambo found on Mungwi road - police officers reaping off erring motorists in broad daylight for their own survival. That is how a majority of our police officers survive because their little salaries cannot sustain their families, especially in cities like Lusaka.

In our view, the institutions that are tasked to curb corruption in the Traffic Department addressing are not problem. the real They are trying to force behavioural change among police officers, forgetting that motorists are more willing to pay a bribe than pay for the offence committed, because the charges are too exorbitant.

Take "driving uninsured motor vehicle" for example. While it is indisputable that a car insurance disc on the windshield does not protect the life of neither the driver nor the passenger of a vehicle, traffic police are obliged to charge you as much as K450 for failure

to display insurance cover. Failure to fasten seatbelt is K300 per passenger; touching your cellphone while driving is K450 etc.

How many motorists can afford to pay for these exorbitant traffic offences? That is why it is always cheaper to pay a bribe than to pay for the offence. That is where the problem is. So if our government wants to end corruption in this sector, let them compel the Road Transport and Safety Agency (RTSA) to be reasonable.

You cannot charge a motorist K300 because her car is missing а reflector, which is worth K10 only. That is encouraging corruption. If such an offence would attract a K15 fine, people would prefer paying admission of guilt, than paying a K50 bribe to a traffic officer. That is the only way.

In fact, in Malawi, there are several traffic offences where officers are encouraged to exercise 'mechanical' leniency. What this means is that if your car has a broken headlamp or the tyres are near bursting, the officer will impound the car and force you to go and buy the needed replacement so that you fix the car in their presence. After that, they let you go without necessarily paying anything to the officer or the state.

Now back to last week's traffic scandal. While the development was not new to us

because we see it on the roads all the time. our take on the issue is that the minister displayed the highest level of hypocrisy. We were shocked to hear him say that catching the officers proved that politicians are not corrupt but are here to serve the people.

Mr Lusambo thinks we have forgotten that in March this year, he caught himself in corruption а conversation with some Chinese. This is the same government official who accidentally recorded himself assuring a contractor that he would use his ministerial flag to make sure the Chinese get the deal.

Whatever that deal was, we know that it was not as little as the K2,000 which the traffic officers collected from motorists to go and buy kapenta. Like former Attorney General Musa Mwenye stated, grand corruption is happening in the top government offices, but we are targeting only the weak and vulnerable culprits.

Anyway, we will still applaud the Lusaka Province Minister, though even his corruption stunt was nothing more than a distractive nuisance. That is the usefulness of useless people.

"Sang Chol!" 92-year-old Lee Keum-seom exclaimed, as she fell into her long lost son's arms at a holiday resort in North Korea Monday.

Lee had been waiting 68 years for this moment, after the two became separated during the Korean War and became trapped either side of the demilitarized zone (DMZ) which now splits the two Koreas.

Sang Chol was four when she last saw him. He is now 72, himself an old man. On Monday he sat waiting for Lee's arrival with his wife and daughters, who have never known their grandmother.

Theirs' was one of multiple emotional family reunions taking place at a resort near Mount Kumgang, where buses full of South Koreans drove early Monday.

They were the 89 lucky families selected from the more than 57,000 who had applied for the reunions, agreed to under the Panmunjom Declaration signed by South Korean President Moon Jae-in and North Korean leader Kim Jong Un during an historic summit earlier this year.

More than 60% of those seeking reunions are over 80 years old, and are being

"What shall I ask?" she said. "Oh, I should ask him what his father told him about me. His father must have told him about how we got separated and where our house used to be. I should ask him about that."

On seeing him however, there was no hesitation, and the two elderly Koreans embraced each other tightly, both in tears. During the whole reunion, they did not let go of each others' hands. CNN

Greece leaves bailouts behind

After years of tough austerity measures, Greece emerges on Monday from its third and last bailout, although officials warn the country still has a "long way to go". The European Union, the European Central Bank and the International Monetary Fund loaned debt-wracked Greece a total of 289 billion euros (\$330 billion) in three successive programmes in 2010, 2012 and 2015.

The economic reforms the of its gross domestic product (GDP) evaporating over eight years and unemployment soaring to more than 27 percent. But Greece has now returned to growth, its once vast public deficit has been turned into a solid budget surplus, and the jobless rate

The economic reforms the creditors demanded in return brought the country to its knees with a quarter of its gross domestic

has fallen below 20 percent, officials say.

"For the first time since early 2010 Greece can stand on its own feet. This was possible thanks to the extraordinary effort of the Greek people, the good cooperation with the

current Greek government and the support of European partners through loans and debt relief," said Mario Centeno, board chairman of the European Stability Mechanism (ESM) in a statement.

"It took much longer than expected but I believe we are there," Centeno added.

Greek households, however, continue to feel the effects of unpopular and stinging austerity. "The reality on the ground remains difficult. The time for austerity is over, but the end of the programme is not the end of the road for reform," EU Economic Affairs Commissioner Pierre Moscovici said at the weekend. BBC

Pregnant New Zealand minister cycles to delivery ward

New Zealand's Minister for Women Julie Anne Genter has taken the cycle of life to a whole new level, biking her way to hospital for the birth of her first child.

The hearings by a panel led by the country's second highest judge, Deputy Chief Justice Raymond Zondo, will probe allegations of corruption and fraud in the public sector during former president Jacob Zuma's tenure.

Although the panel does not have powers to arrest or prosecute, evidence it collects can be used in any future prosecution.

Zuma appointed the judicial inquiry into the alleged graft in January on the orders of a high court.

A month later, on February 14, he was forced to resign

scandals. State corruption in postapartheid South Africa was first exposed formally two years ago by the country's former ombudswoman Thuli Madonsela, who issued a damning report and called for a judicial inquiry into Zuma's relationship with a wealthy business family.

Zuma was accused of being in the sway of the Guptas - a wealthy family of Indian origin - allegedly granting them influence over government appointments, contracts and state-owned businesses. Pravin Gordhan, a former minister, finance but now responsible for state companies, has estimated that practices.

Justice Zondo has vowed that the investigation into the socalled "state capture", will be carried out thoroughly regardless of who is being investigated.

"I will investigate anybody and everybody no matter who he or she is. This commission will do its job properly. We owe that to the people of South Africa." he said earlier this year.

The first witnesses to appear before the commission include a former deputy finance minister Mcebisi Jonas, an ANC lawmaker Mabel Mentor and the former government spokesman Themba Maseko. The local Sunday Times said Zuma has been "invited" to

newspaper report. Initially tasked to probe and conclude its findings within six months, the commission has asked for an extension of up to two years.

Zuma's successor as president, Cyril Ramaphosa, has vowed to crack down on government corruption, which he has admitted was a serious problem.

"I would hope that the inquiry gets to the bottom of how the South African state was captured in the way it was and what can be done to prevent this from happening again," David Lewis, the executive director of South Africa's nonprofit organisation Corruption Watch, told AFP. AFP

Ronaldo, Modric and Salah up for UEFA Player of the Year

Cristiano Ronaldo, Luka Modric and Mohamed Salah make up the threeman shortlist for the UEFA Player of the Year award for the 2017/18 season, European football's governing body announced on Monday.

Ronaldo -- the winner in each of the last two years -and Modric both starred for Real Madrid as the Spanish giants won the Champions League for the third year running, while the latter also won the Golden Ball for the best player at the World Cup after inspiring Croatia on their run to the final.

Meanwhile, Egyptian star Salah scored 10 times as Liverpool made it to the Champions League final, before losing 3-1 to Real in Kiev.

Salah was forced off with a shoulder injury in the first half of that game after a clash with Real defender Sergio Ramos.

He also netted 32 goals in his debut Premier League season, with that tally a record for a 38-game campaign.

Lionel Messi came fifth in the voting by a jury of 80 coaches from clubs who played in the Champions League and Europa League, as well as 55 journalists representing each UEFA member nation.

The Barcelona star came second to Ronaldo last year but also failed to make the final three-man shortlist in 2016.

Atletico Madrid's France star Antoine Griezmann, who scored twice as his club beat Marseille 3-0 in the Europa League final, just missed out in fourth.

The winner will be named, along with the UEFA Women's Player of the Year, in Monaco on Thursday, August 30, the same day as the draw for the Champions League group stage.

The nominees for the award women's are Amandine France's Henry and Norway's Ada Hegerberg, who both won the Champions League with Lyon, and Denmark's Pernille Harder, who lost in the final with Wolfsburg. AFP

Los Blancos had their worst home crowd since before the CR7 era, but got the result they wanted on the pitch with Gareth Bale finding the net The post-Cristiano Ronaldo era at Real Madrid

began the way the pre-Cristiano Ronaldo era ended, with a half-full Santiago Bernabeu.

Goals from Dani Carvajal and Gareth Bale against Getafe got Julen Lopetegui's side off to the perfect start in the 2018-19 La Liga season, but the lack of home fans was as conspicious as the absence of their former talisman.

Just 48,466 people came through the turnstiles for the first home game of the season, which should have attracted both hardcore fans and football tourists to see some of the biggest names in world football.

The last time, Real played in front of such a paltry Santiago Bernabeu crowd was the final home game of the 2008-09 season, which came during a fivegame losing streak that was started by the historic 6-2 Clasico defeat to Pep Guardiola's Barcelona, who had both Thierry Henry and Lionel Messi scoring braces. After that loss, Los Blancos slumped to second place in the table and decided to take the risk of breaking the world transfer record to sign a certain Portuguese attacker from Manchester United. Ronaldo moved to Madrid in June 2009, spending the next nine seasons at the club where he won four Champions League titles but just two Ligas. With Ronaldo now gone to Juventus, fans failed to turn up for Madrid's first game of the season, with the five-time Ballon d'Or winner's shadow cast large over the empty seats in the stadium. AFP

"I deeply apologise for our careless act that has brought disgrace on not only basketball fans but also all of the Japanese people," Sato told a news conference after the

players returned to Tokyo on Monday.

Nagayoshi, wearing a black suit and tie, said he "can't imagine" playing basketball again. Japan Basketball Association chief Yuko Mitsuya said it will wait for a report from a special committee of lawyers before formally punishing the four. *AFP*
