*By Abraham Kalito* Agriculture Minister Michael Katambo says the Food Reserve Agency (FRA) has failed to purchase the targeted 500,000 metric tonnes of maize because farmers have opted to sell their produce to alternative buyers who are offering higher prices.

And Katambo says government has not banned the export of maize, but has instead put an administrative restriction, which will halt the export of maize for a limited period.

Responding to a query from Kalomo Central member of parliament Harry Kamboni, who wanted to know how many metric tonnes of maize the FRA had purchased and whether the agency would meet target, Katambo its government is said monitoring the food security situation, but that the agency would not manage to purchase 500,000 metric tonnes of maize.

"As of 11th October, 2018, the Food Reserve Agency has procured 166,831 metric tonnes of maize. This represents 33.4 per cent of the targeted amount of 500,000 metric tonnes of maize. A comparative assessment of previous seasons' purchases, and this season indicates that, the Food Reserve Agency may not meet the target of 500,000 metric tonnes of maize. Currently, the national strategic food reserves held by the Food Reserve Agency are at 479,727 metric tonnes of maize, which is composed of

this year's purchases and carry-over stocks. The stocks held by the Millers and Grain Traders' [Associations] of the Zambia, National Farmers Union, are estimated at 473,343 metric tonnes. This brings the total in the country's stock to 953,090 metric tonnes. Farmers are also holding on to maize stocks for their own consumption to see them until the next harvest. I urge the farmers not to offload all their stocks to the market. The government, through National Stocks Monitoring Committee, continuously is monitoring the maize stock in the country in order to ensure food security of the nation. Government has restricted the export of maize and mealie-meal," Katambo announced. "Madam Speaker, FRA like I said, may not meet the targeted 500,000 metric tonnes. Madam Speaker, there could be several reasons why the FRA would fail to meet the target. I would cite one or two; the private sector are offering

higher prices [of maize]

meaning our farmers

have opted to go and

sell their maize where they are offering higher prices. And also, holding farmers in expectation of higher prices could also contribute to this effect. Madam Speaker, we are not treading on a dangerous path. It is important to note that, FRA stores maize in strategic reserves for three to four to five years, that is why there is a recommendation of 12.5 moisture content when FRA wants to buy. Madam Speaker, the national and human consumption is estimated at 131,374 metric tonnes, the total maize required for human and industrial [consumption] is also estimated 165,469 metric tonnes."

And Katambo added that government has not banned the export of maize, but has instead put an "administrative restriction," which will halt the export of maize for a limited period.

"This will talk about feed production for livestock or poultry and other productions that are required in these in our strategic reserves when FRA is selling maize. This maize is for strategic reserves, but for the next six to eight months from now when we shall have another marketing season, then we shall have sustainability where food consumption is needed. There is no export ban, but only administrative an Therefore, restriction. there is no SI (Statutory Instrument) that has been issued to ban the export of maize and mealie-meal. The country needs to be food secure that's why we have put these administrative restrictions so that we can sustain ourselves and be able to have enough stocks as country. Madam а Speaker, it's a liberalised market. Farmers are able to sell where they can find good market," Katambo narrated.

"Others are buying as high as K90 while us, under FRA, we are buying at K70 per 50 kg bag. This has not affected the price of maize, as other stakeholders and commercial private buyers are buying at a higher price. FRA has been restricted to procurement of only 500,000 metric tonnes of maize each season to avoid a crowding out of the private sector. Madam Speaker, the

factor is that the private sector is able to offer a higher price than FRA is, indeed, an indication that the private sector has been stimulated by the restriction of FRA to purchase only 500,000 metric tonnes. This should be noted, Madam Speaker, that there should be some budgetary implications of increasing the FRA price; if it were to be increased, there would be need for a supplementary budget if what has been allocated in the resource envelope in the Yellow Book was to increase the price."

Meanwhile, speaking to journalists during a press briefing to coincide with World Food Day, Katambo asked citizens to change their eating habits in order to effectively fight malnutrition and hunger.

The Minister also stressed the need for farmers to diversify their crop production so that citizens could have a wider range of food choices.

"There is need to promote cassava and all these other types of crops instead of constantly depending on nshima as a staple food. Increase agriculture equipment; the promotion of irrigation, especially for emerging and small-holder farmers; the promotion of improved storage of agro-products. This minimises food wastage. Enhancing water resource management and construction of other resilient agriculture infrastructure.

Diversified crop production. People should change eating habits," Katambo told journalists at Taj Pamodzi Hotel in Lusaka on Tuesday evening.

"Let me take this opportunity to recognise the investment by global citizens and Zambia, Civil Society Scaling Up Nutrition and other organisations for the support rendered to our government in promoting food and nutrition security in the country. Our efforts would be futile without your involvement. We look forward to continue our partnership with you to ensure that we fight food insecurity and malnutrition in the promotion of nutrition in Zambia. We should be the global generation that can celebrate defeating hunger and malnutrition together."

that they have to make any donations towards the event," Kock stated in the letter.

He, however, urged those that had the capacity to raise a small donation to instead support the Mkushi Hospital as well as the Maranatha Orphanage.

"For those who have the capacity to raise a small donation, we have recommended that they specifically support the donations to the Mkushi Hospital as well as to the Maranatha Orphanage, as the two sectors specifically link in with our objective to support the health sector as well as the vulnerable in society. With regard to support for the prisons, we have asked our farmers to consider providing support at a later time in the year, and when their budgets might allow, and hopefully once they have undergone their upcoming bank reviews, which will decide their respective fates. Farmers who support local organizations within their respective areas have indicated that they are continuing to help these despite their dire financial conditions (these include local schools and health centres), and we commend them for this, in these trying times. We are also very aware that our struggles are intricately linked to those around us and that as we go through these times, the whole community will also be suffering, and we feel for their plight," he explained.

And Kock stated that it was the association's prayer that farmers' cries to improve the dwindling farming conditions would be heard.

"We continue to hope that our cry for assistance will be heard, as farming (at all levels of the sector) has become increasingly difficult over the past three years. Prices for our produce have been low (even in the face of shortages), expenses have been climbing, and our interest rates continue to remain high. Several farmers are also operating on low water capacity due to regional drought, which has left some dams low on water. We hope you understand our predicament. As an association, we have provided developmental support to the new Mkushi Hospital this year, and we also participated in a big way in the [Central Province] Investment Forum and Expo, in the hope that it might help to improve the sector for all those who reside here, as our supporting businesses are also finding economic climate the challenging," stated Kock.

Deputy police spokesperson Rae Hamoonga, who confirmed the separate incidents in a statement, Tuesday, stated that police in Eastern Province had arrested a 31-year-old woman of Nthambo village for allegedly murdering a 29-year-old man using a hoe handle. He disclosed that the murder allegedly occurred after the two picked up a quarrel when the deceased proposed love to her, but she turned him down.

Asked if he was going to punch him if there were no people to restrain him, Sikazwe said he was going to punch Kambwili hard because he is a stupid man. "Yes I would have punched him seriously because he is very stupid," said Sikazwe. And reacting to Sikazwe's admittance, Kambwili said, "It just shows you the kind go leader that he is. You see, leadership is about

### Nthambo woman murders man after denying his love proposal

"Police in Eastern Province have arrested Rabecca Daka, aged 31, of Nthambo village, Chief Ndake of Nyimba District for the offence of murder. Rabecca Daka is alleged to have murdered Christopher Zulu, aged 29, of the same address. This occurred on October 14, 2018, at around 20:00hours. A hoe handle is believed to have been used during the act; this was after the two picked up a quarrel when the deceased proposed love to the assailant who turned down the proposal. The body of the deceased is lying in Nyimba District Hospital awaiting postmortem," Hamoonga stated. And he added that police in Petauke District arrested three Zimbabwean nationals from Bulawavo and a Zambian for theft of cash from motor vehicles.

He revealed that the suspects allegedly targeting were people withdrawing large sums of money from Barclays Bank, Petauke. "Meanwhile, Police in Petauke District have arrested three Zimbabwean Nationals from Bulawayo namely: William aged 38, Linas Chuma, aged 32; Pengosi Chuma, aged 37, and a Zambian, Thomas Mafuta, aged 38, of Kabwata in Lusaka, for the offence of theft of cash from motor vehicles. This occurred on different dates between March, 2018, and September 4, 2018, in Petauke District, Eastern Province. Brief facts of the case are that the suspects are alleged to have been targeting people withdrawing large sums of money from Barclays Bank, Petauke," he added. "The latest theft of K40,000 from a motor vehicle for Wilson Tembo of Njati

area in Petauke. This is the case that led to the arrest of the four suspects after the motor vehicle they used was identified as a Toyota Allion Registration number, BAD 9110. The suspects were found with sophisticated implements, which they have been using to unlock the motor vehicles. Investigations in the matter are ongoing and the suspects will appear in court soon." He appealed to members of the public to desist from moving around with huge sums of money, but rather use the various electronic banking services as much as possible to transact. Meanwhile, a 35-year-old woman, Nomai Ngango, was allegedly murdered by her brother-in-law on around Monday 01:00 hours and sustained two deep cuts on her head.

Hamoonga stated that her body was currently lying in Kalabo District Hospital Mortuary awaiting post-mortem. "Police in Western Province received a report of murder in which female, Sikapo Mbechi, aged 60, of Mukwalala village, Chief Namakayo, reported that her daughter Nomai Ngango aged 35 of the same address was murdered by her brother in law, Mwangu Mwiinga whose age is unknown. This happened on October 15, 2018, at about 01:00hours," stated Hamoonga. "Brief facts of the case are that, the victim sustained two deep cuts on the head, and a pounding stick is alleged to have been used. The body of the deceased is lying in Kalabo District Hospital Mortuary post-mortem. awaiting Investigations in the matter have been instituted."

Like I said yesterday, I will not take any action, Parliament has got CCTV, they watched obviously and surely, if parliament wants to take action, they should not wait for me to complain. The man committed an offense which he has accepted in the newspaper," Kambwili said. Asked if he was physically strong enough to take on any PF member, Kambwili said he was not a violent man and his strength was in his mouth. "I am just a gentleman, I don't fight. For me, I talk policy and issues. My strength is in the mouth, not physical because people who go physical are abnormal. I mean, at our age fighting? What are we teaching the young ones? It is not a weakness but it is a mark of leadership," said Kambwili. "I am neither a physical giant nor a weak giant. I don't even know when last I fought so I don't know if I can win a fight or lose a fight. It is not my preoccupation to fight so to talk about either win or lose, it is a waste of time because I will never fight. It has never been my nature. I have been married to my wife for 25 years, I have never beaten her, not even a slap, you can ask by beautiful wife Carol, I am a gentleman, I believe in talking. So for those who want to go physical, to me they are lunatics. That's failing to reason.

And Ambassador Foote says he has tried to tell President Edgar Lungu and UPND leader Hakainde Hichilema to sit and have a conversation on how they can united Zambia which is politically divided, but he has not succeeded. Meanwhile, the US envoy used his courtesy call on Kabwe Diocese Bishop Clement Mulenga to share his upbringing as a naughty child from upstate New York, and how he doesn't like to be treated like such a big deal because of his revered diplomatic title. "I can assure you that keep on fearing God at every stage because many are the times that people will pretend to love you but in reality they are not with you. I am seeing already [that] you are rising. And you have to be careful because when you begin to rise, a lot of things come your way, just be careful which type of people are coming along because sometimes it is not everything good which attracts good people. Sometimes good things attract bad people. May God give you wisdom. What I am seeing are reshuffles. It is also our prayer that if God willing, He can give you as our president according to his time. It is a great revolution and we are praying that may God continue to use you," Pastor Tembo said.

By Mukosha Funga University of Zambia lecturer Dr Austin Mbozi who was arrested on Monday on allegations that he insulted President Edgar Lungu, was released on police bond yesterday after being charged with a different offence of "showing hatred, ridicule and contempt."

His lawyer Mulambo Haimbe told News Diggers that it was illegal for the police to detain his client for three days without charging him.

"Dr Mbozi has finally been charged with the offence of showing hatred, ridicule or contempt because of race, tribe or origin of colour, contrary to section 70 of the Penal Code. He was released on Police bond today (yesterday) and is expected to appear in court on October 26, 2018," said Haimbe.

On Monday police picked up and detained Dr Mbozi Woodlands Police at station over an article he wrote blaming President Lungu for Vespers Shimunzila's death.

In the article, Dr Mbozi also highlighted the dangers of tribal voting, saying an outcome of such voting was having irresponsible leaders.

In a video recorded before Dr Mbozi, a lecturer in Philosophy of Good Governance, availed himself to police, which you can watch on https:// www.youtube.com/watch ?v=xiaakiR1U4o&feature =youtu.be&app=desktop the lecturer admitted saying President Lungu was ultimately responsible for Vespers' death.

Dr Mbozi, however, said there was a doctored version of his article which was circulating online.

"I wrote a statement criticising the PF regime over the killing of the UNZA student. Then, on the internet, another one is circulating saying that I have insulted the President and the police are looking for me. There is a criminal, a psychopath who cannot reason with me who must have written that and put there and said that I said it," said Dr Mbozi.

"But it is true I did say that the President is ultimately responsible for the death, it is also true that I did say that tribal voting is the reason why people are being killed. People keep voting for tribes rather than merit, there is nothing criminal about that, it can just be annoying but it is not a criminal offence." Below is Dr Mbozi's full article:

### **Arrested UNZA lecturer out** on bond after three days in detention for "insulting Lungu"

Mr President Edgar Lungu and your tribal voters, stop killing our hungry children

#### By Dr Austin Mbozi To you Mr President

I do not know whether you personally or your hard core supporters, will take kindly to what I want to say here. But saying it gives me some inner healing after seeing you or your police kill our children for asking you to give them food. I live within UNZA. The whole Saturday night, I was hearing hungry UNZA students mourning their colleague near my house.

You say you have no money to feed them. But you yourself have eaten and you have money to buy bullets to kill hungry children. You may be right in saying that it is police and not you who killed the girl but even police did not intend to kill. Presidents 'kill', intentionally or not, by sending police to stop problems which they themselves cause. Even apartheid presidents and Adolf Hitler never personally killed any person. Vespers, the girl who was killed, was not making any public trouble on the road side at the time she was killed because she was killed from her room. Advising you or warning you does not help. My conscious does not allow me to keep quiet when I live around people like you. After saying this, if at all your administration will arrest me for it, I need my own time to reflect on what kind [of] action I need to take in order to manage to co-exist with people like you, given that nature placed us in one country.

#### To you Vespers Shimunzhila

If I had a way of knowing that you voted for PF, I would have said you reaped the fruits of vour foolishness. I had withdrawn from talking politics because I have decided that it is alright for voters of PF to suffer the consequences of their foolishness. I am not economically suffering myself.

But I suffer inside when non-PF voters also suffer. So here is how I can put it. If you voted for Michael Sata and Edgar Lungu, I have no kind words for you. You will only become a hero if you shall become a warning to your fellow young people that President Lungu is an ungrateful person. Youths of your generation should from today onwards learn a lesson that voting for irresponsible leaders is suicidal. The Germans suffered for voting for Adolf Hitler in 1933. But if you did not vote for PF, you are a shining example of shining intellectualism, a student who could distinguish irresponsible leaders from responsible ones. It hurts to lose people like you. You may not have heard me, but in 2011. I warned Zambians that Michael Sata was the worst of leaders that were standing in that election. And today, you can see for yourselves. ### **Govt reinstates 4 of 8 suspended** from Community Development

The forensic audit has completed at the Ministry headquarters but the auditors have now moved to Zampost head office in Ndola to complete this administrative inquiry which was undertaken in the Ministry of

Community Development with regards to the alleged misapplication or misappropriation or theft of funds meant for social cash transfer," said Chanda.

"But I can announce here that of the eight employees that were suspended to allow for smooth investigations, four have been reinstated and have resumed work because the administrative inquiry did not find them wanting. The minister, honorable Olipa Mwansa Phiri informed the President that the four have since resumed work and the others remain on suspension to allow for further investigations."

### **UN Security Council asked to meet** The United States and eight on Myanmar atrocities report

other countries on Tuesday requested a UN Security Council meeting on Myanmar to hear from a UN fact-finding mission that has accused the country's military of atrocities against Muslim Rohingyas.

The request is likely to run into opposition from China, which has friendly ties with Myanmar's military and has sought to shield Myanmar from action by the Security Council.

In a joint letter seen by AFP, the nine countries said the mission's chairperson should brief the council to allow it to "receive further information on this situation and its implications for international peace and security."

The UN fact-finding released mission an explosive report last month that called on the council to refer the Myanmar situation the International to Criminal Court in The Hague, or to create an ad hoc international criminal tribunal, as was done with the former Yugoslavia.

The fact-finding mission Myanmar's said that generals, including top Commander-in-Chief

Tanzania will not seek foreign assistance in its investigation over the abduction of billionaire Mohammed Dewji, deputy Home Affairs Minister Hamad Masauni has said, local media reports.

He had been responding to calls by opposition MP Godbless Lema who said the government was not doing enough to find the tycoon.

"If you look carefully at the statements made by the government and the police in particular... You'll see an utter lack of seriousness on [the government's] response on the issue at hand," privately-owned Daily Nation newspaper

quoted him as saying. Mr Dewji, reportedly Africa's youngest billionaire, was taken by masked gunmen in the Tanzanian city of Dar es Salaam on Thursday last week.

The abduction took place outside a swanky gym in the affluent neighbourhood of Oysterbay.

The kidnappers fired shots in the air before driving away with the billionaire,

The ambassador repeated Myanmar's complaints that the report was "one-sided", based on "narratives and not on hard evidence".

Support from the nine countries for the request means that China would likely fail to block a meeting through a procedural vote. Nine votes are required at the 15-member council to approve an agenda item and vetoes do not apply.

Trudeau himself admitted in 2013 to having smoked pot five or six times in his life, including at a dinner party with friends after being elected to parliament.

He has also said that his late brother Michel was facing possession marijuana charges for a "tiny amount" of pot before his death in an

avalanche in 1998, and that this influenced his decision to propose legalizing cannabis.

But Trudeau's office told AFP he "does not plan on purchasing or consuming cannabis once it is legalized."

In total, Statistics Canada says 5.4 million Canadians will buy cannabis from legal dispensaries in 2018 -- about 15 percent of the population. Around 4.9 million already smoke. Stores in St. John's in the Atlantic island province of Newfoundland were due to open their doors to pot enthusiasts as of 12:01 am local time (0231 GMT) on Wednesday.

"I'm going to have a lot more variety than the black market dealers, so you have a lot more choice at our store. The prices are very comparable," Thomas Clarke, owner of THC Distribution store, told public broadcaster CBC just prior to the big event. AFP

### Chinese woman kills herself and children after husband fakes death

about his alleged plan and she believed he had died. She later jumped into a pond with their children surrendered himself to after writing an online

suicide note. The man, who police said was surnamed He, police in Xinhua county in

Hunan province last Friday. He has been detained on charges of insurance fraud and intentional damage to property, Xinhua police

said in a statement on WeChat - a social media platform.

In early September Mr He bought an insurance

plan worth one million yuan (£110,000, \$145,000) without his wife's knowledge, police said.

According to a report by state-run Voice of China radio, his wife was named as the beneficiary.

On 19 September, Mr He used a borrowed vehicle to fake his own death in a car crash, police said. He was found to have loans of more than 100,000 yuan.

On 10 October, the bodies of his 31-year-old wife, their four-year-old son and three-year-old daughter were found in a pond near their home, according to the Voice of China.

In a suicide note on WeChat, she wrote that she was coming to "accompany" him, adding that she had "only ever wanted our family of four to be together", the Voice of China added.

Mr He turned himself over to police two days later.

### France's Macron reshuffles cabinet amid scandals, plummeting popularity

A year and a half into his first term, French President Emmanuel Macron is looking for a new start.

He reshuffled his cabinet Tuesday and made a rare televised address to assure France that all is well after a bruising summer which has seen his popularity rating plummet amid protests, scandals and gaffes.

"Europe is tipping almost everywhere toward extremes and again is giving way to nationalism, we need all our energy to succeed. I have confidence in us," Macron said.

His approval rating fell to 29% in September, an all time low, after a summer of protests over proposed economic reforms and scandals involving his security aide Alexandre Benalla.

Benalla was filmed wearing a police helmet and beating May Day protesters in July, after which he was dismissed. Last month, a selfie of him posing with a gun during Macron's campaign led to another investigation and questions over the President's judgment.

Macron has also been hit by resignations of key cabinet officials, especially environment minister Nicolas Hulot, who quit the government during a live radio interview in frustration at Macron's failure to tackle climate change.

"I don't want to give the illusion that my position within the government suggested that we are answering these problems properly, so I'm leaving the government," Hulot said. "I no longer want to lie."

Interior minister Gerard Collomb also announced his intention to leave the cabinet and return to his old job as mayor of Lyon. He was replaced by close Macron ally Christophe Castaner in the reshuffle Tuesday.

Even as he has courted international public opinion -- delivering a pointed rebuke to US President Donald Trump's isolationist message at the United Nations -- Macron has faced growing criticism at home for pursuing unpopular policies that many perceive as benefiting France's richest and cutting into the country's treasured social protections.

Public services ground to a halt in July amid mass protests and strikes against Macron's proposed economic reforms, which would slash public spending and see over 120,000 people laid off.

"Macron is implementing an agenda that aims at destroying all the benefits conquered

throughout the past half-century: pensions, protections against unfair dismissal, terms and conditions in both private and public sector," Axel Persson from the CGT union's rail workers branch told CNN at the time. "If he gets his way, we will be back to square one in terms of workers' rights in France."

This agenda has led to criticism by figures on the left, particularly from France Unbowed leader Jean-Luc Mélenchon. Police raided Mélenchon's offices this week over alleged misuse of European Union funds, prompting a furious protest from the 67-year-old who has accused the investigation of being politically motivated.

A veteran left-winger, Mélenchon came a close fourth in last year's Presidential election, less than two percentage points from making the run-off which Macron eventually won.

On the other side of the political spectrum, the other person in that run-off, National Front leader Marine Le Pen, has also ramped up pressure on Macron's administration, fanning anti-immigrant and anti-EU sentiment even as the French President has emerged as one of the bloc's strongest proponents. The Report of the Auditor General on the Accounts of the Republic of Zambia for the financial year ended 31st December 2017 is out with glaring irregularities in the various Ministries, Provinces and other spending agencies.

The Report which was taken to Parliament on Tuesday has highlighted a sharp increase in unaccounted for funds that has risen from K386, 000 in 2016 to K31 million in 2017. misappropriations of Funds from K3 million in 2016 to 5 million kwacha in 2017 and overpayments from K1 million in 2016 to K7 million in 2017. The irregularities in some instances represent an increased by more than 500 percent.

But the report also shows that there was some reductions in unaccounted for revenue from K3 million in 2016 to K873, 000 in 2017, unvouched Expenditure from 170 million kwacha in 2016 to 14 million kwacha in 2017 and Undelivered materials from K116 million to K1 million among others. According to a statement released by Auditor General's Head of Public Relations Ellen Chikale, although the misapplication of funds seemed to have reduced from K162 million in 2016 to K61 million in 2017, it remained the highest ranking irregularity for the period under review and continues to be an area

September, 2018. 24th It is also worth noting that the Office interacted and communicated with Controlling Officers whose accounts were audited at various levels. The purpose of this interaction was to provide an opportunity for the Controlling Officers to clarify and take corrective action on the findings of the audits by so doing demonstrate the value and benefits of the Supreme Audit Institution (SAI).

The Report contains seventy (74) paragraphs four consisting of sixty one (61) paragraphs on audit matters whilst thirteen (13) paragraphs are on other matters. In addition, the Report contains audit recommendations which are aimed at addressing the issues raised during the audit process."

### **Police give Tayali 'painful protection'** after beating by UPND cadres at court

**By Zondiwe Mbewe** Political commentator PF and government sympathiser Chilufya Tayali yesterday got an ironically rough and painful escort by paramilitary police who rescued him from a beating by angry UPND cadres outside the Lusaka Magistrate's court. Tayali was expected in court to take plea in a matter where he is charged with publishing defamatory matters against opposition UPND leader Hakainde Hichilema.

But a mob of well built UPND youths that was also at court to give solidarity to their leader, landed on the outspoken EEP president to settle their scores before the court could hear him.

Police quickly swung into action with a brutal protection of the victim, that almost interrupted all court proceedings, as a result of the commotion. The officers were seen grabbing Tayali by his torn jacket and necktie, and dragging him to a court room where he was locked

#### up for safety.

After a few minutes, the police managed to calm the situation and Tayali appeared in the dock, entering the court room from a different entrance. When the indictment was read to him, Tayali denied the charge against him after earlier complaining to the court that he wasn't ready to take plea because his body was in pain as a result of the beating.

Tayali's lawyers had told the court that their client's mental faculty was not in order because of the punches he had received hence he was not ready to take plea.

In this matter, Hichilema has dragged Tayali to court for publishing defamatory matters against him.

It is alleged that Tayali on dates unknown but between October 1, 2018 and October 9, 2018, in Lusaka, did unlawfully publish defamatory matter concerning Hakainde Hichilema, with intent to injure his reputation by exposing him to hatred, contempt and ridicule and to damage him in his profession, trade and standing in society.

Tayali allegedly published defamatory matter concerning Hichilema in form of a facebook post and by publication on various media including through videos and on radio where he said "Ba Lungu please wake up, HH wants to usurp power using civil disobedience and violence..."

This matter is being privately prosecuted by lawyers: Nelly Mutti, Jack Mwimbu, Mulambo Haimbe, Lastone Mwanabo and Zevyanji Sinkala.

Tayali's lawyers include: Osrbone Ngoma, Towela Nkhoma and Jonas Zimba. The prosecution and defence argued back and forth over Tayali's condition and whether he was ready to take plea or not.

At one point, Tayali stood up and showed the court his torn jacket and saying he was in pain.

But magistrate Felix Kaoma instructed his lawyers to tell their client to behave himself, saying it was his court and not a political rally hence he needed to follow the court's rules.

His lawyers then apologized and asked the court to order that security was heartened for both the defence and prosecution team in the wake of the attack on Tayali.

But Hichilema's lawyers objected to the application on grounds that there was no medical proof that Tayali was unwell.

However, magistrate Kaoma ruled that Tayali should go ahead and take plea since he already had instructions from his lawyers.

After the charges were ready to him, Tayali denied the charge.

The court then adjourned the matter to November 30 and urged Tayali to avoid making commentaries on the matter in court.

He also urged Hichilema to guide his supporters.

"Accused must not make commentaries in relation to the matter before court. If at all the attackers are known, let them be reported to the police. President of the party let's guide our followers. No one should attack another person I believe we are a civilised nation," said magistrate Kaoma.

Madagascar, for the first time, Senegal and former champions Tunisia and Egypt sealed places at the Africa Cup of Nations finals Tuesday with two matchdays to spare.

Njiva Rakotoharimalala scored four minutes before half-time to earn Madagascar a 1-0 Group A victory over Equatorial Guinea on the vast Indian Ocean island.

In the same mini-league, Senegal left it late in Sudan to win 1-0 with Sidy Sarr heading the lone goal four minutes from time in Khartoum.

Senegal and Madagascar have 10 points each from four matches, seven more than nearest rivals Equatorial Guinea with two rounds left, and the top two finishers in each section qualify.

### United won't win league with Lukaku - Scholes

Manchester United may never win the league with Romelu Lukaku as their main striker, according to former midfielder Paul Scholes.

"I'm just not sure you are ever going to win the league with a goal scorer like him," Scholes told ESPN . "I don't think his play outside of the box is good enough.

"I'm not sure if he works hard enough but he's still a young man who has done well and scored a lot of goals. He's quick and strong, but Lukaku is one of many United players who look like they're short of confidence.

"I don't think he realises how good he can be, but he needs help because who else can play centre-forward at United now?"

Indeed, Scholes does not believe that either Anthony Martial or Marcus Rashford are able to step into the fold when Lukaku's form dips, with Jose Mourinho insistent on playing both out wide.

And the former England midfielder believes that competition for places is key, pointing to the fact that Sir Alex Ferguson had four centreforwards he could call upon when the club won the treble in 1999.

"Maybe, but they look like wingers," he replied, when it was put to him that Martial and Rashford can play through the middle.

"And they're getting slagged off by the manager. We had four centre-forwards - [Andy] Cole, Teddy [Sheringham], Ole [Gunnar Solskjaer] and [Dwight] Yorke

### Asian MMA star slams 'shocking' Las Vegas brawl

Asia's highest-ranked mixed martial artist said fighters must remember they're idols for children as he slammed last week's "shocking" scenes after Conor McGregor's defeat to Khabib Nurmagomedov.
