

### **Roll call at Day of Prayer** annoys civil servants

KPMG, the globally-renowned audit, tax and advisory services firm, has warned that government's insistence to introduce Sales Tax next April will create uncertainty in the Zambian economy, which would be very injurious to business.

And KPMG says government should not have introduced the scheme three months into a financial year as its implementation and administration will be a huge challenge as well as a nightmare to companies.

Meanwhile, Consumer Trust Unity Society (CUTS) coordinator Chennai Mukumba noted that the Sales Tax roll out would have a negative impact on lower-income consumers.

Last month, Mwanakatwe told Parliament that government intends to abolish the Value Added Tax (VAT) and replace it with a non-refundable Sales Tax, which, according to her, is simpler to implement.

Government proposes to introduce the sales tax on April 1, 2019, in a bid to avoid paying VAT refunds, especially to mining companies, who demanded close to US \$1 billion, thereby straining government coffers.

Speaking during **Economics** Association of Zambia (EAZ)-British Chamber of Commerceorganized public discussion in Lusaka, KPMG tax partner Michael Phiri cautioned government against rolling out Sales Tax next year because it will bring uncertainty in the local economy, which would be "very injurious" to business.

"My first remark would be, uncertainty is very injurious to business; tax

systems need to create certainty if we are to promote investment as a country. And to have measures announced, the rate not known, the scope not known...all we know is that, it is going to take effect on 1st April [2019]. Essentially, it stalls business activity until certainty is created," Phiri told a packed auditorium at Pamodzi Hotel in his concluding remarks, Tuesday evening. "No investor would want to invest and put money in an uncertain environment; so, the quicker we create certainty, the better."

He stressed on the need for government to dialogue with all stakeholders before they rush to implement the controversial Sales Tax.

"My second intimation would be that, dialogue doesn't mean that you lose your final authority; it doesn't demean anybody if they dialogue, you don't lose your ministerial portfolio if you engage and listen to people. It's important that we dialogue and hear what the complaints of the people are and be able to listen," Phiri advised.

"I would regret to be a Minister of Finance who passes a bill today and only have to reverse it six months down the line."

Earlier, during a keynote presentation, Phiri said the Sales Tax was a trial and error scheme by government, adding that the scheme could backfire terribly and cause the economy to collapse

completely.

"But the [Finance] Minister [Margaret Mwanakatwe] has indicated that Sales Tax is coming whether we like it or not. It reminded me of another meeting that was held here where the then Minister of Finance, ABC (Alexander Bwalya Chikwanda), and I was making an indication to him that the proposal to increase MRT (Mineral Royalty Tax) to 20 per cent wasn't just going to work because the mines will not continue to operate. And then I was labelled a 'Trojan Horse,' but I was vindicated six months later," Phiri recalled.

He outlined that Sales Tax was a mistake by government because it would cause a cascading effect, which would force an increase in the tax rate and the cost of production. "We have had Sales Tax before and it had problems, which were cured by VAT. And, essentially, we are going back to where we were. And so, why it matters is that this tax gets directly to the consumer on purchase on non-exempt goods. The problem is that, it grows with time and it can increase the cost of doing business and we know that they are trying to exempt some institutions," Phiri said.

"This is really another trial and error that could back fire and cause the economy to collapse! The other thing they should consider is the increased cost of doing business across sectors. Because I'm sure that they have not considered the impact that this sales tax can have on companies that are currently contributing cooperation tax at 35 per cent. Because when you have all your costs, including Sales Tax and if your level is high enough, then you cannot expect that companies that are making any profits will continue to make any profit. So, they need to consider the increased cost that this will have across all sectors. The other thing they should consider is that, Sales Tax will only address that VAT problem; it will not address tax compliance. I do think that they need to make their recent measures in terms of CCTV's, TPIN's, just all those things that we want them to do to broaden

the tax base."
And Phiri said government should not have introduced the scheme three months into a financial year as its implementation and administration would be a huge challenge as well as a nightmare to companies.

"In a nutshell, the problem with Sales Tax is that if you are a wheat farmer, and those who administer VAT know that wheat is standard-rated, and so, the intimation now is that all standard-rated products will be subject to Sales Tax. And so where we have a problem is that, if you are a wheat farmer, they will expect you to pay sales tax on that wheat.

And primarily, you will be selling your wheat to a miller, and that miller, too, is expected to charge Sales Tax. And that miller will not consume the milled wheat, they will look to add value added to that milled wheat and sell it to a bakery; and the bakery when they are selling that bread and buns they are expected to charge Sales Tax. And then, you move from the bakery and you know they will not sell to individuals. They will redistribute these through supermarkets; they, too, will be expected to charge Sales Tax. And then, now, you have the people who are selling in the retail shops also charging Sales Tax on the consumer," narrated Phiri.

"So, when you look at that cascading effect, and the impact it will have on the consumer, like you and me, it just goes towards increasing that cost significantly. we had a problem with this proposed sae tax because of its potential to cascade the Sales Tax rate to much higher rates as a result of its nonexemption mechanism. Maybe they will allow for some exemption, some certificates, but going by the way they had challenges in administering issues like withholding VAT, which provides for those certificates, it doesn't inspire much hope that the Sales Tax system will be able to work. It's a bigger cost, it causes tax on tax, it increases costs, it neglects investment in a country. VAT remains the best tax system in the country, but since the Minister is hellbent on introducing Sales Tax, what we are proposing to them is that they must consider, you cannot change such a significant midstream months into a financial year because we know that system implementation is a challenge and I am sure that it is even for the Zambia Revenue Authority. And to have it happen in the middle of the year creates a nightmare for business because not all businesses trade in two, three goods, some have several lines."

Meanwhile, Mukumba noted that the Sales Tax would have a negative impact on businesses and low-income consumers.


"What we would see is this cascading effect, which would have some of the most direct impacts on consumers. Given some of the issues that we are dealing with; the poverty, inflation, [it] would have negative effects, particularly lower-income consumers," said Mukumba.

While the EAZ sent out an invitation to government, no official was present to speak on behalf of the Ministry of Finance and to answer and explain the pending Sales Tax proposal.



"The Human Rights (HRC) Commission condemns the harassment of Economic and Equity Party (EEP) president, Mr. Chilufya Tayali, by some suspected United Party for National Development (UPND) sympathisers at the Lusaka Magistrates Court Premises where he had gone for a Court Session on 17th October 2018. However, the Commission hasten to salute the Zambia Police Service for their alertness and quick protection of Mr. Tayali from further punishment by guaranteeing him his right to personal security. The harassment and roughing up of Mr. Tayali within the court premises, which resulted in tearing

up of his jacket, was deeply regrettable and must be condemned as an act of lawlessness that should not be allowed in a democratic country such as Zambia.Mr. Tayali had been sued by the UPND President, Mr. Hakainde Hichilema, for alleged criminal defamation and he had lawfully gone to answer to the charges as directed by the court. It was therefore regrettable that he was almost physically manhandled, and his clothes torn before the Police rescued

him," he said.

"After speaking to some of the eye witnesses, including some UPND sympathisers and Mr. Tayali himself as a victim, the Commission is of the view that the perpetrators of violence against Mr. Tayali exhibited some level of intolerance and lacked self-restraint as expected in a multiparty democracy. The Commission is therefore calling upon all those who may be aggrieved by the alleged utterances and actions of Mr. Tayali to refrain from taking the law into their own hands but exercise patience and allow the law to take its own course. Suing the EEP President was one of the civilised forms of redressing grievances in a democracy. To this effect, it is important to allow justice to take its course uninterrupted by any form of human rights violation such as physical, psychological or verbal abuse of either parties and/or their agents or witnesses."

He said the violence

against Tayali has potential to undermine a conducive environment for protection of human rights and freedoms.

"Mr. Tayali, like any other individual, has the right to equal protection and benefit of the law through the courts of the law. Therefore, those aggrieved by either his utterances or action should not take any slightest opportunity to arbitrarily punish him because that would be a violation of his constitutional rights. The

Commission, therefore, calls for absolute restraint from any form of extrajudicial action against Mr. Tayali during future court sessions because such action would be incompatible with respect for the rule of law, human rights and constitutionalism. The Commission is against any form of breach of law and order such as violence because it has potential to undermine a conducive environment for protection of human rights and freedoms."

Ministry of Defence Permanent Secretary Stardy Mwale that the Ministry, through the Zambia Air Force (ZAF), purchased five planes and explained that one of the planes would be used for VVIPs, one for maintaining airspace and monitor poaching, while the other three would be used for commercial

however, rubbished the Africa Confidential exposé, which revealed that the Zambian government had gotten a US \$400 million loan to procure an anti-missile VIP jet for the Head of State, but admitted that the defence modernisation committee had been investing in the latest military aircrafts to replace the old fleet.


Musenge warned that Zambians will not spare the PF for going ahead in purchasing extravagant aircrafts without seeking approval from the masses. "It was a misplaced thought and a misplaced priority and I think on this one, government has missed it. If they purchased them, they have probably gotten a loan to purchase those planes. The truth of the matter is that the Zambian people will not spare them for doing that because they have just exhibited huge levels of arrogance towards their masters who happen to be the Zambian people who elected them. And, definitely, 2021 is not very far, they may exercise so much power and think they are masters over their masters, but time will soon catch up with them," Musenge warned. observed that government misplaced priorities.

But in an interview.

"You know, the problem that we have is when you have leaders who think that they were just elected for themselves and forget that they are answerable to the people that elected them. The problem that we are experiencing as a nation has been because those who know that they

should be in government have opted not to engage their masters who happen to be the Zambian people in very important decisions that they make. For example, the purchase of the five air planes that we are hearing about, the purchase of a jet for the President and those other jets for ZAF. We are in a very difficult economic situation where our current leaders who are purchasing such expensive machines are calling for austerity measures of managing the country. How do you expect the Zambian people to support you?" wondered Musenge.

"On one side, you are saying, 'things are not okay' and then on the other side, you continue contracting huge debts on behalf of the Zambian people and yet we all know that such debts will affect the majority of the Zambian people, including the unborn children. So, for me, government has not performed very well and the purchase of those aircrafts needs serious consideration. If anything, they need to be cancelled. You need to inform the Zambians to say, 'we are doing this, we feel this is extremely important for two reasons."

## Auditor General's report details how Social Cash Transfer money was squandered

latest Auditor The General's Report has revealed how over K30 million disbursed ZAMPOST to pay 144, 142 poor and vulnerable citizens under Social Cash Transfer programme did not reach the beneficiaries and the money vanished before it was even deposited into the ZAMPOST accounts. And the report which covered the year ended December 2017 further reveals millions meant for the Social Cash Transfer money allocated to Luapula and Western Province under distribution agreement with ZAMPOST were diverted to Copperbelt, Northern and Muchinga Provinces among other areas outside the contract; but it still did not reach the beneficiaries.

Meanwhile the Auditor General has revealed how the Zambia Army spent millions to procure utility vehicles which were never delivered.

The Report further details how the University of Zambia paid over K19 million in meal allowances millions to over 3,800

students who are not on the government bursary programme.

During period under review, the Ministry of Community Development remitted totalling amounts K109,386,458 ZAMPOST for payment to scheme beneficiaries to districts in Luapula and Western Provinces only, according to the contract.

"It was however observed that for the September/ October 2017 Cycle the Ministry remitted funds in amounts totalling K30,947,320 ZAMPOST disbursements to North Western, Northern and Muchinga Provinces and Masaiti and Lufwanyama on the Copperbelt which were not included in the contract. In her response dated 14th September 2018, the Controlling Officer stated that having noted that the contract did not adequately cover the provinces in question, the parties signed an addendum on 26th April 2018 after it was cleared by the Attorney General's Office. However, the inclusion of North Western, Northern and Muchinga Provinces and the two districts on the Copperbelt was done in October 2017 before the addendum was signed," The report revealed.

"During the period under review, the Ministry amounts remitted totalling K30,947,320 **ZAMPOST** the September/ October 2017 cycle to 144,142 beneficiaries in Northern, Muchinga and North Western. However, as at 31st August 2018, ZAMPOST had not paid the beneficiaries and the funds were not accounted for in that there was no evidence of banking and no cash was found on hand. Contrary to the Appropriation Act of 2016, amounts totalling K116,893 meant for Social Cash Transfer Scheme activities were spent on activities such as Grants for juvenile conveyance, purchase of furniture and contribution towards traditional ceremonies among others, activities not related to the purpose for which the funds were appropriated."

Under the Ministry of Defence, the report revealed that that the Zambia Army bought cars which were never delivered.

"On 16th July 2017, Zambia Army entered into a contract with a local supplier, Edat Ecosan Development, for the supply and delivery of 15 second hand Toyota Crown motor vehicles at a contract price of K2,400,000 with a delivery period of four to eight 8 weeks from the date the contract was signed. The terms of payment were that the advance payment of 25 per cent of the contract price shall be paid within 30 days of signing the contract, 50 per cent to be paid within 60 days on receipt of the goods and upon submission of the documents, while the 25 per cent balance to be paid within 60 days after the date of the acceptance certificate. On 19th October 2017, the contractor was paid the advance payment of K600,000 being 25 per cent of the contract price. However, as at 31st July 2018, only 10 vehicles had been delivered. In addition, there was no evidence that the Army had taken any action

against the contractor

for the failure to deliver the remaining vehicles," reported the Auditor General.

"Zambia Army entered into a contract with Razz Exports of South Africa for the supply and delivery of an ambulance at a contract price of K952,018 122 (R1,356,538) with delivery period of six to eight weeks. 9th October 2017, the contractor was the advance payment of K238,005. However, as at 31st July 2018, the ambulance had not been delivered. In his response dated 17th August 2018, the Controlling Officer stated that the supplier had delivered an ambulance with wrong specifications which was rejected and sent back, and that the supplier had been given up to end of June 2018 to deliver the ambulance. However, as at 31st August 2018, the ambulance had not been delivered."

And the report revealed how Maina Soko military Hospital in Lusaka spent over K1.3 million without authority from the Secretary to the Treasury. "An examination of accounting and other records maintained at the Ministry Headquarters, Defence Services Commands, Maina Soko Military Hospital and Staff Colleges and physical inspections of selected projects carried out in March 2018 revealed the following: On 31st December 2017, Maina Soko Military Hospital had a bank balance of K1,304,589. It was observed that the Hospital had raised cheques between 27th and 30th December 2017 amounting K1,304,589. Since these funds were committed the Treasury could not mop them at the end of 2017. However, in January 2018, the cheques were cancelled without any apparent reasons and the funds were later utilised without authority from the Secretary to the Treasury," the report

And the report explained that the University of Zambia billed government for funds paid to students who were not in the bursary data base.

"A comparison of the invoices from UNZA for sponsored students to the database of Bursaries Committee supported students revealed that 3,568 students were appearing the on UNZA invoice but not on the bursaries list of Government supported students. As a result, the University over billed Government in amounts totalling K71,082,937 for the 3,568 students. In addition, it was observed that there were 3,191 students who appeared on the bill but were not on the overall registered GRZ Sponsored students database," revealed the Auditor General.

"During the year under review, meal allowances in amounts totalling K19,503,068 were paid to 3,864 students who did not appear on the list of students on the University Invoices. As a result, it was not possible to ascertain whether the payments were made to intended students."

## Kambwili asks Lungu, Sikazwe to forgive him

NDC leader Chishimba Kambwili has asked President Edgar Lungu to forgive him if he has wronged him by accusing him of things he has not done, apart from theft, which he he says is a provable fact.

Meanwhile, Kambwili has also apologized to Presidential Affairs Minister Freedom Sikazwe for calling him a witch doctor in Parliament on Tuesday evening, saying the remark was meant to be a light moment in the House.

Kambwili was speaking at a press briefing held at his house yesterday.

"Let me be the first one to say that, to you, my brother

President Edgar Lungu, if I have wronged you in anyway, today is National Day of Prayer and Reconciliation, I ask for forgiveness. If I have wronged you President Edgar Lungu, forgive me. If I have wronged you, president HH, president Mulongoti, forgive me. And I want also to ask all those I have wronged in one way or the other, that let this day reflect as a genuine day of reconciliation and repentance. I would not go before God to ask for repentance if I do not ask for forgiveness from all the people that I have wronged," Kambwili said.

Asked if by asking for forgiveness from President Lungu he was also reversing

the theft accusations against the Head of State, Kambwili insisted that he wasn't withdrawing those sentiments because they were facts.

"No, no, no! A thief will always be a thief! If President Lungu has been stealing like he has been stealing, I don't withdraw those sentiments and I have no apologies to make. I mean that, if I have hurt him in anyway where he has maybe not done something wrong and I accused him of something he has not done; if I have wronged him in anyway, which, maybe, led to my expulsion from PF, because I don't know what I wronged him for him to expel me from PF, if I had wronged him, I'm

asking for forgiveness. But for stealing, I'm very sure he steals and I have facts, for that I'm not apologizing," Kambwili replied. "And let me also appeal to my brother, Honourable Sikazwe, who almost turned into a boxer two days ago when I, as some kind of light moment, I said he was supposed to be a witchdoctor in some village, he got very upset! To you, my brother also, I say from deep down my heart that I'm extremely sorry if I hurt you. I did not mean any malice or impunity. My words were just meant for a light moment in Parliament. And I also appeal to the other leaders also to ask for forgiveness to all the people that they have wronged."

Minister of Finance Margaret Mwanakatwe has insisted that the PF government shall not default on any of its debt obligations, adding that to every debt that is being repaid today, a school, health facility, road and market has been built.

And Mwanakatwe says the increase in debt servicing in the 2019 budget is largely driven by infrastructure development projects that government has delivered and is still delivering to Zambians.

Government's spending on serving external debt has drastically leaped to nearly K15 billion in next year's budget, more than double the amount of K7.26 billion allocated in the 2018 budget.

But Mwanakatwe defended the increase in debt servicing delivering a statement on the closure of debate on the 2019 budget speech.

"The Honourable rightfully members observed the projected increase in debt servicing in 2019; let me clarify that, this is largely driven by the infrastructure development projects that the government has delivered and still delivering to our people to enhance public service delivery, as well as unlock economic growth in the various sectors," Mwanakatwe said.

"My colleagues will agree with me that, when the PF government came into power in 2011, this nation had a huge infrastructural deficit. There therefore, a serious need to accelerate our investment in this area in order to speed up economic growth. In this regard, this government opted to leverage on resources in the credit market as a quicker, effective model of erecting this muchneeded infrastructure." She observed that for every debt that was being repaid by government, there was a school and health facility, among other amenities, that had been built, insisting that government would not default on any of its debt obligations.

"In view of the increase in debt service, government has proposed realignment of some expenditures in the short-term in order to ensure fiscal sustainability. Critical

expenditures relating to health, education, water and sanitation and social protection, have been safeguarded. This includes, amongst others, grants to facilitate the operations of schools and hospitals, as well as social safety net," Mwanakatwe added.

And on the increase in this year's allocation in the defence budget, she observed that one of the most prized possessions Zambia had was its reputation for peace and stability, and that it was cardinal to invest in modern defence equipment.

Government has proposed to increase the Ministry of Defence's budgetary allocation next year to around K5.1 billion, from K3.5 billion in this year's budget

This represents an increase of over K1.5 billion and gobbles around 5.8 per cent of the 2019 national budget, while also more than doubling the allocation for social protection whose funding is only K2.2 billion, down from K2.3 billion allocated in the 2018 budget.

"One of the most prized possessions Zambia has is its reputation for peace and stability. It is cardinal to invest in modern defence equipment to allow the Zambian defence forces to meet the standards required under the UN peace-keeping missions, Mwanakatwe argued.

She said government would continue with institutional capacity-building interventions aimed at modernising tax administration

and strengthening tax compliance.

"I have taken note of the various suggestions regarding the need to enhance domestic revenue mobilisation so that our development path is fiscally sustainable. Revenue mobilisation will remain the cornerstone of this government's broad-based inclusive development. We continue with institutional capacitybuilding interventions aimed at modernising tax administration and strengthening tax compliance," Mwanakatwe said.

And she said government would continue to streamline the tax incentive structure to ensure it was sustainable and well-aligned to their development efforts.

She said it was in that context that she had proposed to abolish customs duty rebase for construction of shopping malls.

"In the same vein, government will continue to streamline the tax incentive structure to ensure it is sustainable and well-aligned to our development efforts. It is in this context that I have proposed to abolish customs duty rebase for construction of shopping malls. We shall also continue to put in place measures that are aimed at addressing profit-shifting and tax base erosion. It is for this reason that I have proposed limitation of interest deduction," she explained.

And Mwanakatwe said she had no doubt that the revenue measures she had proposed in the 2019 budget presented a winwin solution that would secure maximum benefits for the nation.

"I'm pleased to inform the House that Zambia Revenue Authority has already commenced collaboration with local authorities and independent tax agents to assist with broadening of the tax base to the informal sector. Other initiatives, such as the roll out of land titling, will continue so that we can enhance property taxation, as this is one of the most stable sources of public resources. I have no doubt that the revenue measures I have proposed in the 2019 budget present a win-win solution that will secure maximum benefits for our nation," said Mwanakatwe.

## We cannot abandon borrowing now, allow Lungu to borrow more for the economy - Malozo

Muchinga Province Minister Malozo Sichone says it is suicide to abandon borrowing at this stage because many economic sectors need investment for them to make returns.

And Sichone has appealed to Zambians to support President Edgar Lungu and allow him to borrow enough for this country. Meanwhile, Home Affairs Minister Stephen Kampyongo says people like Chishimba Kambwili should avoid breaking the law if they know that they faint when the same law visits them.

The duo were speaking when they debated the 2019 national budget in Parliament, Wednesday.

"We have a situation in this country, and this talk about borrowing will continue; we are basically dwarfing the economic development or growth that we have been experiencing all these years. So, are we going to begin to fight middle-way so that we abandon to plan to borrow and invest properly and fully in these

economic sectors? If we are going to abandon at this point, Madam Speaker, that is suicide because some of these sectors will not begin to give us returns. Can we allow this government, let's give this government support, let's give the President of the Republic of Zambia support so that we borrow enough and ensure all economic drivers start to roll so that we start getting returns from these investments," Sichone argued.

He added that President Lungu does not do a lot of press briefings because those are only "talk shows.

"We need to do more than talking and that is why you have seen the President, His Excellency, doesn't even spend time on press briefings because that is talking. Those are talk shows. We are saying can we be serious and start to work. Madam Speaker, I discovered why the opposition will always be the opposition. The opposition is not practical, they simply criticize! Can we bring matters or issues that will help

us grow this economy because once this economy is injected or stimulated, you will discover, Madam Speaker, that the future of this country will be smooth," Sichone added.

And Kampyongo said Kambwili should avoid being a law-breaker if he is not strong enough to face the law.

"And I am surprised today; I hope the Minister of Justice has taken judicial notice of the Honourable member of parliament for Roan who we know as MP for PF [and] today was declaring that is opposition. It's understandable that those who break the law must be brave to face the consequences! But if you break the law and when they visit you, you breakdown, you faint as if you didn't know the consequences...you have heard about witchcraft this afternoon. Madam Speaker, to reduce the investment in law and order to canisters is shameful because here we must be knowledgeable to give accurate information to those that have sent us to this August House," Kampyongo said.

Meanwhile, Kampyongo said that most finance ministers have received pressure from Cabinet if they don't consult on the budget components before presenting it. "The challenge that we have had, Madam Speaker, and in all the previous ministers of finance will attest to this, is the pressure they get from their colleagues in Cabinet if there is no consultation. The pressure that is mounted on them is what makes them veer off their trajectory. I must also register my disappointment on the hypocrisy that characterised the debate of this motion and it's at a time, Madam Speaker, where we remember former MPs like one MP for Bweengwa, Honourable Highvie Hamududu, because when he stood here this time around to talk about the budget, to analyse the budget, to criticize and to offer solutions, we all said, 'yes, indeed, job well done,' because he was not only criticizing baselessly, but he was criticizing and ensuring that he provided solutions," recalled Kampyongo.

People's Party president Mike Mulongoti says cases of theft of public funds will continue increasing in the Auditor General's Report every year because Zambia does not have leaders of integrity to superintend over its resources.

And Mulongoti says he decided to stay away the so-called National Day of Prayer yesterday because he would not have felt comfortable to start seeking God's help over man-made problems.

Commenting on the recently-published Auditor General's report, which has revealed a sharp rise in unaccounted for funds that has increased from K386,000 in 2016 to K31 million in 2017, and misappropriation of funds from K3 million in 2016 to K5 million in 2017, Mulongoti warned that things would only get worse under PF because the current leaders lacked integrity.

## Zambia has no leadership that can stop theft of govt funds, says Mulongoti

Auditor General was on the Accounts of the Republic of Zambia for the financial year ended December 31, 2017.

"The reason is that when leadership is dishonest, the civil servants are watching what the leadership is doing and they are simply following suit. So, you can't blame them. If they see a corrupt Minister, like what happened to the Permanent Secretary in the Ministry of General Education (Henry Tukombe), they are learning that all the top officials and politicians are thieves and because

of that...I mean why didn't they do that when Mwanawasa was there? It's because Mwanawasa had integrity and the basis of integrity, everybody followed suit. When you [have] leadership that's go no integrity, it cascades to everybody else. So, the challenge we have is that, who is going to set an example, because the culture of consequence can only be enforced by an upright leader. But if the leader is corrupt and he is a thief, how does he enforce the culture of consequence? Because soon as he does that, the person punished will turn around and say, 'but you also doing the same things!' So, it weakens your moral standing, and I think that's the challenge that PF is facing," Mulongoti told News Diggers! in an interview.


He advised that the best way out the current situation for the country was to find an interim arrangement where people of integrity got together to look at leadership potential and then clean up the whole system through an election. "In the current circumstances, the current

leadership is unfit to continue to superintend over the resources of this country. The solution is one, to find leadership of integrity; this cannot be done at once by going through the polls because if you go to elections with the same crooks who have amassed so much wealth, they will use the same money to bribe and pay people. The best thing is to find an interim arrangement where people of integrity must get together like we did in 1991 over MMD, get together and look at leadership potential, look at the challenges that are being faced, and on the basis of that, start a cleaning up process first," Mulongoti

argued. "It's not an election that will clean up the mess, first of all, it's to clean up the process by ensuring that all the crooks and whatever are eliminated and those who need to be prosecuted are prosecuted. Once you've done that, then you can start afresh by saying, 'let us go to elections so that people can have free and fair elections.' You can't have free and fair elections with people who have amassed so much wealth from corruption because they will use the same money to corrupt people, so that's not the solution. We must first target all the criminals and clear them, once that is done, then we can have free and fair elections, and then we can have a decent government where people can work using honest behaviour and outcomes can then be predicted."

And asked why he had decided to shun the National of Day of Prayers slated for October 18, Mulongoti said he did not want to be a hypocrite like those in PF.

"If you look at the subjects for the prayers, they are all man-made. So, I don't think I will feel comfortable to go and ask God to help me sort out problems that we created ourselves; it's a matter of hypocrisy. Honestly, how does God intervene in corruption? How does God intervene in police brutality? All these are issues that we don't need to go to God for, we must do introspection ourselves and ask whether what we are doing is right and go to God and seek for forgiveness quietly on our own. Now, President Lungu is drunk 24 hours every day, is it possible for him to have communication with God in that manner? No! That's hypocrisy," said Mulongoti. "Most of those guys going there (for the National Day of Prayers) are with hangovers, they will just be dosing the whole time they are there and their minds are elsewhere. No, I cannot be part of that. I know how to pray, I pray at home, I pray at church and that's what's most important. I even hear that Mr Lungu is threatening to dismiss civil servants who won't attend the prayers. Mr Lungu made an instruction for all civil servants to go and pray, I think I heard this on the news, on ZNBC news. But come on! Do you have to force people to go and pray? No! But you see, PF have lost touch and they are now desperate, they are in panic and they think that by doing all those things, it's going to help them. But now, time has caught up with them."

### Speaker must restore decency in the House - Lifuka

Transparency International Zambia president Rueben Lifuka says Speaker of the National Assembly Dr Patrick Matibini must restore decency in the House. And Lifuka says it is high time President Edgar Lungu began to demand for exemplary behavior from members of his Cabinet.

On Tuesday, Presidential Affairs Minister Freedom Sikazwe attacked Roan PF member of parliament in the House after the latter called the former a witch.

But commenting on the fracas in a statement, Lifuka observed that such vigilante behavior was not expected from a minister.

"The recent incident in Parliament which involved a physical altercation between Hon

Chishimba Kambwili and the Presidential affairs Minister- Hon Freedom Sikazwe, is not only sad but an embarrassment to this nation. Differences in opinion are to be expected but certainly it will not do for our leaders to resort to physical fights to settle differences."

And Lifuka stated that President Lungu was duty bound to instill discipline in his Cabinet.

"President Lungu is equally duty bound to instill discipline in his Cabinet. It does not reflect well on him when his own Presidential Affairs Minister finds nothing untoward with his conduct and is not remorseful. President Lungu should begin to ask for better and exemplary behavior from the men

and women that are in Cabinet. The insulting language, sarcasm and demeaning language should come to an end. The people of this country did not elect you to go and engage in school boy or party vigilante like conduct- they expect a high level of seriousness and commitment to finding solutions to the many problems that they face. Our ministers and Members of Parliament have no luxury to busy themselves with minutiae. People continue to lose lives as you engage in banter and other irrelevant activities. We demand an apology from both Hon Sikazwe and Hon Kambwili- please take us seriously as the electorate. We are tired of our elected leaders trivalising the problems that the majority of the people face.

We equally want to hear from the Speaker of the House on the measures he is putting in place to restore order in this August body," stated Lifuka.

Veteran politician Dr Vernon Mwaanga says it is unfortunate that Zambia currently has a crop of political leaders who do not want to sit and talk about the problems the country is facing.

He was gentleman among gentlemen and never failed to rise to challenges he faced from time to time. Once again, the cold hand of death, has robbed our country of a valuable national asset, professional whose accomplishments can at best, only be matched, certainly surpassed. Our deepest condolences go to his wife Jayne, the children and grandchildren on their sad loss. We can only ask God to comfort them during this difficult time and give them strength in the full Christian belief, that God's will has been done. May the angels open the gates of Heaven, so that this humble servant, can be granted eternal peace by his creator," mourned

Dr Mwaanga.

# Attendance roll call at Day of Prayer annoys civil servants

Judicial and Allied Workers Union of Zambia (JAWUZ) president Peter Mwale says it is unacceptable for government to conduct a roll call at the National Day of Prayer just to ensure that civil servants were in attendance. On Tuesday, Kabwe District Commissioner Dominic Mulenga extended an invitation letter to the District Education Board Secretary (DEBS) in which civil servants were urged to attend the prayers at Godfrey Chitalu Stadium without fail, warning that a roll call would be conducted at the prayers.

President Edgar Lungu gazetted October 18 every year as the National Day of Prayer, Fasting, Repentance and Reconciliation. "As Central Province, our National Day of Prayer, Fasting, Repentance and Reconciliation will be held at Godfrey Chitalu Stadium from 06:00 hours to 18:00 hours and will be officiated by His Excellency, Mr. Edgar Chagwa Lungu, the President of the Republic of Zambia. The theme for this year's commemoration is 'facing

the future as a reconciled, united and prosperous nation under God's guidance.' In this regard, I request that you make sure all teachers attend this important function a roll-call should be done," instructed Mulenga.

But commenting on the matter in an interview with News Diggers! Mwale said there was no need to force anyone to attend the prayers because Zambians had been praying even before the declaration of October 18, as the National Day of Prayer.

"I don't think it is in order for people to be forced to go and pray! Us, as civil servants, we pray every day. Even before the National Day of Prayers was declared, we were praying to God. We didn't even need the day of prayer ourselves because we have been praying everyday due to the suffering that we go through. We know that it is only God in Heaven who can hear our pleas and cries, so the forcing of everyone to go for prayers is not applicable in the civil service. We can't be forced to pray because we have always been Christians and we have always been praying. So, on behalf of all civil servants, and especially those in the Judiciary, I can confirm that we pray every day because we suffering and we want our conditions of service to change. Everything is just bad, the cost of living, the cost of fuel, the cost of food, the housing allowance that we are getting, the salaries are very low. So, to us we have been praying to God, even before the National Day of Prayer. And we didn't need anyone to clear it because we have already resolved that we shall believe in the Almighty God," Mwale said.

"Personally I can't go for those prayers and I don't think I will ever attend them because I have always been praying. A genuine Christian prays every day and for us in the Judiciary, we worship God on a daily basis because we know that God commanded the people that believe in him that; 'you shall worship me ceaselessly,' so you don't cease to worship God. I know that people go [to church] on Sundays and Saturdays, but prayer is something that a

genuine Christian should do every day. We pray when we are going for work, we pray when sleeping, we pray when we want to do anything and we praise God for everything he has given to us every day. So, we don't need one special day for prayer because to us, every day is a special day in the Judiciary and in the civil service."

He insisted that government was mocking God by inviting citizens in prayer when the country had so many unresolved issues.

"Let us not mock God here, I mean, what does it amount to for us to go out there and pray and fast because it's National Day of Prayer, Fasting and Reconciliation, yet we have so many issues that we haven't resolved as a nation? Civil servants are getting peanuts for their salaries and they cannot even take care of their families properly, then this nation is just divided politically. And then, today, you want people to come and join in prayers? The same people whose cries you don't want to listen to? It doesn't work that way," said Mwale.

We would like to start by acknowledging the humility of the American Ambassador to Zambia Excellency Mr Daniel Foote. This is not a man who has been very well known to us because he has mostly been loudly silent since he took over office from Mr Eric Schultz. But we have just realised that his deliberate low-key presence in this country has been granting him abundant time to interact with low-key Zambians the ordinary citizens who usually never have opportunities to meet with such distinguished foreign envoys.

While other diplomats accredited to Zambia have taken off the gloves to trade verbal punches with our government leaders in the fight against corruption and embezzlement of donor aid, Ambassador Foote has been extending his footprint across breadth of this country, getting to understand the lifestyle and challenges of the local people. But his low profile approach is fast being challenged by the overbearing recklessness of our government. The American Envoy can't shy away anymore from the elephant in the room because Zambia has now just pricked his heart.

During that meeting with Bishop Mulenga, the American Envoy had a an entertaining way of bringing up his frustration over the failure by President Edgar Lungu and UPND's Hakainde Hishilema to dialogue and unite a politically torn country.



## Female students in Senegal's schools sexually exploited by teachers, HRW says

Fanta was just 16 when she began having sex with her 30-year-old teacher. A year later, she found out she was pregnant by him. The teacher denied he impregnated the student when her father tried to make him accept the pregnancy. Fanta lives in the Sédhiou region of southern Senegal, an area

with high teen pregnancy

She abandoned her education as the pregnancy progressed. Fanta is one of the dozens of girls who told rights group Human Rights Watch (HRW) that they were coerced into having sex with their teachers in Senegal's secondary

schools.

"I felt humiliated in front of my classmates," she told HRW.

In a new report titled, "It's Not Normal: Sexual Exploitation, Harassment, and Abuse in Secondary Schools in Senegal," female students -- some as young as 16 years old -- said their teachers lured them

to have sex in exchange for better grades, food, mobile phones, and new clothes.

Sixteen-year-old Aïssatou, whom HRW is not identifying by her real name, told the rights group that her teacher lured her to his house.

He threatened to lower grades when she refused

his.

"One day, he asked me to go to his house. When I went to his house, he offered to give me money and resources. And I told him no. ... He became nasty, (he said) he was not going to give me good grades," she said.

Students who got pregnant by their teachers have had

to drop out of school, the advocacy group said.

School-related sexual- and gender-based violence is a serious problem in Senegal, HRW said in the report.

CNN has put in multiple requests for comment to the ministry of education in Senegal but has yet to receive a response. *BBC* 

## China has finally announced the opening ceremony for the world's longest sea bridge, which will connect Hong Kong, Macau and the mainland, but critics hit back Thursday over the secrecy surrounding the project.

Construction started in 2009 on the 55-kilometre (34-mile) crossing, which includes a snaking road bridge and underwater tunnel, linking Hong Kong's Lantau island to the southern mainland Chinese city of Zhuhai and the gambling enclave of Macau, across the waters of the Pearl River Estuary. It has been dogged by delays, budget overruns, corruption prosecutions deaths and the construction workers.

While supporters promote it as an engineering marvel, others see the multi-billion dollar project as a costly white elephant designed to further integrate Hong Kong into the mainland at a time when Beijing is tightening its grip on the

Local media received invites from Beijing's liaison office in Hong Kong

Wednesday to an "opening ceremony" in Zhuhai on Tuesday, with no further details given.

China's President Xi Jinping is reported to be attending the event, but there has been no official confirmation whether the bridge will go into operation that day.

Hong Kong's transport

department had no immediate answer Thursday when AFP asked whether it would be fully commissioned Tuesday. Bus companies supposed to be operating on the bridge complained they were in the dark.

"At such short notice and without any details, how can we make the necessary logistic arrangements?" Eddie Choi, a spokesman for coach operator One Bus Hong Kong Macau, told the South China Morning Post.

The operator's website lists the schedule and prices for the bus rides, but a staff member said the transport bureau had not confirmed the opening date with the firm and information about ticketing was not yet available.

An official from the mainland-based bridge authority told AFP the bridge would be "considered open" from Tuesday and confirmed there would be access that day to registered cars and buses, but did not elaborate.

The China Daily newspaper cited a source familiar with the matter saying the bridge would be open to traffic later in the day, after the opening ceremony.

Pro-democracy lawmaker Kwok Ka-ki who sits on the Hong Kong government's transport panel said he only learned of the launch ceremony from media reports Wednesday and had not received an invite to the opening. *AFP*

## Brazil: Temer's lawyers attempt to block corruption charges

Lawyers for Brazil's President Michel Temer have asked the country's top court to annul a federal police report that recommended he and his close associates be charged with corruption and their assets confiscated.

Police have been investigating Temer for allegedly taking bribes in return for helping shape a decree regulating Brazil's ports, and in particular for extending concessions in the port of Santos to benefit companies owned by close associates.

Temer maintains his innocence. He has faced several corruption allegations but is immune from prosecution while in office, unless the Supreme Court decides to strip his immunity. The president's defence team argued that the federal police should not be able to charge Temer without the authorization of the Supreme Court or the public prosecutor's office.

Temer's term - during which he has become one of the most unpopular Brazilian presidents in decades - ends on January 1, and with it his immunity from prosecution. Congress voted twice last year to block Temer from standing trial in the Supreme Court on three corruption charges levelled against him

The federal police report recommended that Temer, his daughter Maristela, former adviser Rodrigo Rocha Loures and eight others face charges and have their assets confiscated for their role in allegedly laundering bribes through real estate transactions.

Carlos Marun, Brazil's minister of government, said on Wednesday that Temer, who took office in 2016 after former President Dilma Rousseff was impeached, was "outraged and shaken" by the police report.

Supreme Court Justice Luis Roberto Barroso, who is overseeing the case, said on Tuesday he would wait to see the findings of Brazil's public prosecutors office before deciding on how to proceed. *AL JAZEERA*

But Bolt's agent Ricky Simms said he had opted against a move to the Maltese Premier League team, which is backed by a group of investors from the Sanban Group in the United Arab Emirates.

"There is a lot of interest in Usain playing football," he told ESPN.

"We regularly receive similar approaches. I can confirm Usain does not wish to pursue this opportunity in Malta."

Valletta chief executive Ghasston Slimen told the broadcaster: "We wish Usain Bolt all the best with his football career. The Valletta FC offer is always on the table."

Australia's domestic A-League season starts this weekend, with the Mariners in action on Sunday away to Brisbane Roar. With no contract, Bolt is not eligible for selection.

Club chief executive Shaun Mielekamp said this week the Jamaican "will continue

Reports suggest Mariners are waiting for governing body Football Federation Australia to decide whether it will contribute to a potential Aus\$3 million (US\$2.1 million) offer to the 100m world record holder.

It said the 32-year-old, who regards Australia as a second home, might consider accepting less money if it means locking in a contract. Coach Mike Mulvey was reluctant Thursday to talk about Bolt, saying he was not involved in contract negotiations.

"I'm really not interested in it (contract speculation) to tell you the truth," he told reporters.

"He's been great among the guys and I was very happy for him last week with the two goals he scored, but we move on."

Mariners captain Matt Simon dismissed suggestions the chronicles of Bolt were distracting the squad ahead of their A-League opener.

"He's been here for a couple of months now, so everywhere we go with Usain, everyone's talking about him," Simon said.

"We've just been down to business, concentrating on the season and putting into practice what we've been doing at training for the last 12 weeks." AFP

## Vidal fined 800,000 euros r Munich niahteluh fia

Barcelona midfielder Arturo Vidal has been hit with a 800,000 euros (\$921,812) fine by a Munich court after being found guilty of assault during a nightclub fight last year.

Munich district court fined the Chile international based on 80 days worth of wages, calculated to be 10,000 euros per day for the Barcelona player, who left Bayern Munich in August after three years with the

German giants.

The 31-year-old was not in court in Munich to hear the judge's verdict as he played in Chile's 1-0 win over Mexico on Wednesday, which "professionally prevented" his appearance in Bavaria, his lawyer said.

Vidal and his half-brother were both found guilty after attacking another man at Munich's Crowns Club in September 2017, which was


