And Kalaba says that Zambia has collapsed due to rampant corruption, which has become endemic.

Speaking when he featured on Muvi TV The Assignment programme, Sunday, Kalaba said that he would only enter an alliance with other political parties ahead of next year's general election if it led to a meaningfully beneficial mutual relationship.

"We have said we have got

nothing wrong, we have got no qualms with any alliance, there is nothing wrong with being in an alliance. What we are refusing, as Democratic Party, is to be in an alliance where the DP will be like, you know, at a wedding, tukabe kwati nifwebo ba (we should be like a) flower girl nangu nifwe ba (or we should be like a) page boy abaku shindika bashibwinga baya mukulila elo ifwe tube be (to just escort the bride and groom and they go to enjoyment or maybe like a) knife girl. What we want, as DP, is a relationship that is mutual, is a relationship that will respect both sides. But then, in this country, when

you talk of an alliance, you are thinking of only one particular political party. No, bafwile bali muli alliance nailya (with that) political party, that's not the way we behave ourselves, there are several political parties that we are talking to that we can't mention names here. We are talking to them because we want to form an alliance; we want to be stronger because they say, united you stand and divided you fall. So, we know ourselves that we will not be in a hurry to go in alliances with

those who think we should be the ones to escort them so that when they win, they start settling scores, no. For us, we are not winning the election next year to come and start punishing people, we will be wasting time doing that, there will be the ACC, DEC to deal with those issues," Kalaba argued.

And he bemoaned that corruption in the country had become institutionalised.

"Corruption has become endemic in this country, it

has been institutionalised; you can't get anything without oiling somebody for something to move, unless somebody has gotten a kickback. It is that kind of behaviour that is coming to an end. We should be careful because the Office of President must be an office of integrity," he added.

"Some leaders in the PF work genuinely, there are some who work genuinely hard, it's the case of one bad groundnut when you are chewing, it spoils everything. We have leaders

there, whom I know myself, who carry themselves with a lot of dignity. I would love to mention them here, but the moment I mention them, they will say, 'they are working with Kalaba, let's punish them!' Then there are others who are in the majority, who are literally looting and making sure that government systems are undermined at all costs. Appoint somebody you know will be doing what you want them to do..."

Accessing COVID-19 supplies a major challenge – ZNPHI

ZAMBIA National Public Health Institute (ZNPHI) says the major challenge which the institute is facing is where to get COVID-19 supplies from because every country is looking for them.

And the Institute says Minister of Health Dr Chitalu Chilufya will relaunch a reviewed strategic plan which will make non adherence to COVID-19 prevention measures punishable by law.

Speaking when h

appeared on ZNBC TV's Sunday Interview, ZNPHI Country director Professor Victor Mukonka said there was a challenge of supplies.

"In terms of the diagnostic side, we have had major challenges. I must confess it is not only us but globally. The issue we have is where to get the supplies of the commodities because every country, they are looking for them. So there is high demand globally and because of that, we have to be very careful of

what we have, what is the best way we can utilize. The ideal situation would have been to test everyone and know the status but in the reality, that is very difficult. So what we are advising people basically is that if you have been exposed, isolate yourself for at least 14 days. Should you have any symptoms, get in touch with us very quickly. The problem is that we don't have the capacity, challenges of supplies," Prof

And Prof Mukonka said non-compliance of COVID-19 regulations would be punishable.

"We have reviewed in

Mukonka said.

terms of our key interventions in the recent past and in the coming week, our honorable Minister of Health will be relaunching our reviewed strategic plan to move in very aggressive, equal force to the way the numbers are coming in terms of the pandemic. In the new strategy, our focus now is at a community level, public engagement. To ensure that they are part of the response and they do their part. So basically, what we want to do is to first make the public aware of the magnitude of the problem in the country and the severity of it. But more importantly, the key actions each individual needs to do to stop the transmission. And we will also put the issue of non-compliance will become quite aggressive now. Both with the health inspectors, we will work closely with the local authorities and Home Affairs to ensure there is compliance. Meaning if you have a shop and you allow people without, a mask, we will not only charge those people but we will also take you accountable for allowing it. If you are in a market, you don't sell to a person without a mask because that person is causing danger to you. So we want to strengthen on the issue of compliance. That's the only way we can protect the nation. If we don't act and act now, we will end in a catastrophic situation," he said.

Prof Mukonka said the

Institute planned to use politicians to help fight the pandemic.

"This is why we have to use whatever platform available to us. Number one, we need to use our political leaders, Parliament adjourned and we are hoping that MPs are in their constituencies helping sensitizing the public. Secondly, we have said let's work with traditional leaders. They have a lot of influence at community level. We have said let's work with our religious leaders every Sunday if one is preaching, give about 5-10 minutes to ensure compliance is done in church. Because once they see that, they will take it home. The media, you have been instrumental to change the behaviour. The more you run these programs, it's making a difference. We have had some of our colleagues who have been exposed and recovered who can give testimonies. So we need to use all the various avenues available to us to bring the change," Prof

He appealed to Zambians to comply with the COVID-19 regulations.

Mukonka said.

"The number of calls we are receiving have totally doubled. In fact, they have gone four times than in the beginning. People have become conscious. If you go to private hospitals, you see a lot of higher class moving in. Even our call centres have overrun. We are even planning to expand it. Which is a good sign. But compliance is our weak point now. We have tried our level best to manage our brothers and sisters so that they don't die. What we are seeing is something unusual. We have never seen in a day 21 people brought-in-dead. Zambians to take action is what I am asking for. If they are afraid and not doing anything, they will die. What is important is for them to take a brave stance. COVID is a clever virus, it is playing around with us. And also we need equal force to sort it out," said Prof Mukonka.

Nkana Water lost K72m in 2yrs due to high administration costs – AG

THE Auditor General's report has revealed that Nkana Water and Sewerage Company (NWSC) Limited incurred losses of K37,970,000 in 2017 and K33,888,000 in 2018 due to high administration expenses, bringing the cumulative amount to nearly K72 million over two years.

According to the Auditor General's report on the accounts of water and sanitation companies for the financial year ending December 31, 2018, the high administration expenses accounted for 92 per cent and 95 per cent of the turnover for 2017 and 2018, respectively.

"As can be seen from the Statements of Comprehensive Income, the Company incurred losses of K37,970,000 in 2017 and K33,888,000 in 2018. The losses were attributed to high administration expenses, which accounted for 92 per cent and 95 per cent of the turnover for 2017 and 2018, respectively," the report read.

It further revealed that Nkana Water operated with a negative working capital of K151.1 million in 2017 and K119.5 million in 2018, indicating that the company had challenges meeting its short-term obligations as it took 274 days in 2017 and 166 days in 2018 to pay its trade payables.

"The current ratio measures the ability of an entity to meet its current financial obligations using its current assets. It is determined by comparing current assets against current liabilities. The NWASCO recommended current ratio for the sector is a minimum of 1:1. During the period under review, the

current ratio for the company was 0.4 in 2017 and 0.6 in 2018, which were below the recommended ratio. As a result of the poor ratios, the company had challenges to meet its short-term obligations as and when they fell due. Further, analysis of the current assets and liabilities showed that the company operated with a negative working capital of K151,129,000 in 2017 and K119,540,000 in 2018. The negative working capital indicates the challenges of the company to meet its short-term financial obligations. In this regard, it was observed that the company took 274 days in 2017 and 166 days in 2018 to pay its trade payables," the report read.

The utility was also reported to have been inefficient in its debt recovery as receivable days for the period under review increased from 255 days in 2017 to 282 days in 2018.

"According to the Company's Debt Management Policy No. 10, the company will withdraw service to a customer when there is default in settlement of bills for a period of 14 days and above. It was observed that the company was not efficient in collecting receivables from its clients as the receivable days for the period under review increased from 255 days in 2017 to 282 days in 2018. Further analysis of the receivables revealed that an amount of K184,436 was owed by members of staff and had been outstanding for periods ranging from one to 60 months," it read.

"Collection efficiency is a proportion of the total billed amounts against actual collections. Billed amounts in this regard refers to the revenue that a utility company expects from the provision of water and sanitation services and excludes charges like reconnection fees, penalties and meter charges. The acceptable NWASCO benchmark for collection efficiency is 85 per cent. The company failed to meet the benchmark as it only achieved 69 per cent in 2017 and 72 per cent in 2018."

And the utility wastefully spent K434,411 on a procurement module that was later abandoned because it failed to meet the requirements of users even after conducting detailed scoping and agreeing to specific system requirements between the supplier and the company.

"On 12th December, 2013, NWSC engaged Advance Net Pty Limited a South-African based company to supply and deliver a SUNFLOW procurement module at a total cost of K314,237. The scope of works included supply of 33 sunflow licences, documentation and development of procurement process by the supplier, administrator training in South Africa for IT/Procurement Super Users and End user training in Kitwe and deployment (Go live). As at 31st August, 2019, the supplier had been paid amounts totalling K434,411 comprising the contract sum of K314,237 and associated license fees of K120,174. It was, however, observed that the system was never used as it failed to meet the requirements of users, even after conducting detailed scoping and agreeing to specific system requirements between the supplier and the company. As at 31st December, 2019, the sunflow procurement module had been abandoned rendering the expenditure of K434,411 wasteful," read the report.

THE Ministry of Finance has revealed that the country recorded a 43 percent increase in the use of public transport in 2019 due to the increased fuel pump price which hiked the cost of travel for private motorists.

And the report stated that the wholesale and retail industry accounted for the highest share of GDP at 22.4 percent with the mining sector contributing 13.2 percent in 2019.

According to the 2019 annual economic report, the use of public transport increased because it was a cheaper alternative mode of commuting.

"The number of passengers transported by registered public service motor vehicles increased by 43.0 percent to 81,864,720 in 2019 from 57,230,580 in 2018. The increase was explained by the opening of new routes both local and intercity bus terminus. In addition, the upward adjustments of fuel pump prices, which increased the cost of travel for private motorists, also made it cheaper to use public transport as an alternative mode of commuting," the report read.

The report revealed that the subdued GDP growth which was recorded at 1.9 percent for 2019 was due to the lower growth in agriculture and mining sectors which contracted by 7.5 percent and 5.5 percent, respectively.

"Preliminary data showed that real GDP growth in 2019 based on three quarters was 1.9 percent compared to 4.0 percent recorded in 2018. The outturn was largely attributed to lower growth in agriculture and mining sectors which contracted by 7.5 percent and 5.5 percent, respectively. In addition, the electricity sub-sector recorded lower growth due to reduced electricity generation which also affected all other sectors of the economy. This notwithstanding, information communication sector grew by 18 percent, while the

The growth was attributed to the increased marketing of Zambia as a tourist destination through various platforms with increased international arrivals at airports and land based ports of entry.

"Preliminary data indicates that the tourism sector grew by 7.1 percent compared to 1.7 percent in 2018. The growth was attributed to increased marketing of Zambia as a tourist destination through

and hosting of international conferences, as well as provincial expositions. The utilization of digital marketing and the eVisa online services also contributed to the growth. Preliminary data indicates that international tourist arrivals increased by 12.9 percent to 1,209,898 in 2019 from 1,072,016 in 2018 (see Table 2.13). International tourist arrivals at Harry Mwanga Nkumbula, Kenneth Kaunda and Simon Mwansa Kapwepwe International Airports increased by 9.6 percent, 6.0 percent and 4.5 percent, respectively. Mfuwe, however, recorded a decrease of 29.9 percent. Similarly, land-based ports of entry Jimbe, Mokambo and Nsumbu recorded notable increases of 377.7 percent, 148.1 percent and 378.8 percent, respectively. Kasumbalesa, however, recorded a decrease of 12.6 percent despite it being traditionally a high traffic border in the region. This was on account of rerouting of traffic from Kasumbalesa to Jimbe and Mokambo," it read.

However, despite increase in tourists, visits to the Victoria Falls decreased while visits to the Mutanda, Unawake and Ntumbacushi Falls increased by 49.7 percent, 29.4 percent and 13.5 percent, respectively.

"Tourist visits to waterfalls generally decreased by 22.3 percent to 173,103 visitors from 222,713 visitors in 2018. Visits to Mutanda, Unawake and Ntumbacushi Falls increased by 49.7 percent, 29.4 percent and 13.5 percent, respectively, while visits to Nyambwezu, Kundalila, Chipoma, Lufubu and Victoria Falls decreased by 63.4 percent 50.4 percent, 39.7 percent 30.2 percent and 24.0 percent, respectively," it revealed.

And the report revealed that there was in increase in the mobile penetration rate which increased to 99.1 percent with MTN Zambia limited continuing to dominate the market with a market share of 43.7 percent of total mobile subscriptions.

"As a result of the increase in mobile network subscription. the mobile penetration rate which represents the number of mobile subscriptions over total population increased to 99.1 percent from 91.6 percent in 2018. In terms of the mobile subscription market, MTN Zambia Limited continued to dominate with a market share of 43.7 percent of total mobile subscriptions. Airtel Zambia Limited and Zamtel had market shares of 33.9 percent and 22.4 percent, respectively," the report

The report further revealed that in the year under review, severe malnutrition increased to 2.7 per 1000 population from 0.5 per 1000 population and underweight prevalence among children 0 to 23 months increased to 0.8 percent from 0.6 percent in 2018.

Meanwhile, it was revealed that in 2019, the country recorded a 418 percent increase in fish and fish products export

"During the year under review, the country recorded a 418 percent increase in fish and fish product export quantities from 532 Mt in 2018 to 2,756MT in 2019 as shown (see Table 2.6). The exports were valued at K1.46 billon compared to K8.53 million the 2018. The Democratic Republic of Congo continued to dominate the export market for Zambia's fish and fish products. Other common export destinations Fresh frozen or chilled Tilapia constituted the largest exported fish as well as dried or smoked Tilapia. On the other hand, the quantity of imported fish and fish products dropped from 103,202 Mt to 95,536 Mt between 2018 and 2019 representing a 7.4 percent reduction. The imports valued at K50.14 million compared to the 2018 figure of K1.16 million. The major import sources were Namibia, China, Zimbabwe and South Africa," read the report.

PF's decision to claim NRC registration as party exercise beginning of rigging - Kabwita

NATIONAL Democratic Congress (NDC) national youth chairperson Charles Kabwita has called on the church and civil society to rise up and ensure that the issuance of NRCs is available to all and not just the preserve

And Kabwita charged

that PF's announcement that it takes the issuance of NRCs a party program is the beginning of rigging.

In an interview, Kabwita said the careless talk by PF secretary general Davies Mwila, if not carefully handled, had the potential to divide the nation.

I therefore appeal to all wellmeaning civil society, church and political parties to rise against this pronouncement by Davies Mwila and condemn this pronouncement in strongest terms. This is uncalled for and if not carefully handled, will divide the nation. Because look, if I am not PF and I do not have an NRC in my possession, it will be very difficult for me to obtain an NRC because from what Davies Mwila is saying, preference will be given to the

"Unfortunately, Zambians are so docile, if it were in other countries like South Africa, today as we are talking, people would have been on the streets and demonstrate against this careless talk by Davies Mwila, but anyway, we all understand who Mwila is. PS to pay K100,000 in a case he is accused By Zondiwe Mbewe (ii) That the first co-respondent be

MINISTRY of Foreign Affairs permanent secretary Ronald Simwinga and Lusaka businessman Lombe Okpara have entered into an agreement that the PS be removed from the case where he is accused of committing adultery with the latter's wife on condition that he pays K100,000 as full and final settlement of the matter.

In this matter, Okpara has dragged his wife, Musamba Mulenga, an investments officer at the Development Bank of Zambia, to the Lusaka High Court for dissolution of their eight-year marriage for allegedly engaging in adultery with Simwinga and former Central Province deputy Permanent Secretary Patrick Mwanawasa.

He has also cited Simwinga and Mwanawasa as first and second corespondents in the case.

But according to a consent order filed in the Lusaka High Court, August 4, 2020, Simwinga and Okpara have agreed that the court orders that the first co-respondent pays K100,000 as full and final settlement of the matter and that he be struck out of the proceedings.

The said consent order is, however, pending authorisation of Lusaka High Court judge Nicola Sharpe-Phiri.

"By mutual consent of the petitioner (Okpara) and first co-respondent (Simwinga) hereto, it is hereby agreed as follows; (i) That the first co-respondent shall pay the sum of K100,000 as full and final settlement of this matter in regard to the claims against the first co-respondent.

and is hereby struck out from these proceedings as first co-respondent and that the petitioner shall not commence any other action based on the same or similar previous facts against the first co-respondent upon execution of this consent Order.

(iii) That the petitioner shall not avail evidence linking the first co-respondent directly in regard to the settled matter. (iv) That each party shall bear his own costs in regard to this consent Order," read the document which has been signed by both Simwinga and Okpara.

According to his petition for the dissolution of marriage, Okpara claimed that his wife admitted committing adultery with Simwinga and Mwanawasa.

He further claimed that on November 3, 2018, his wife and Mwanawasa spent time together at a short-term rented duplex apartment situated on Lukanga road in Roma township.

Okpara stated that his wife and Mwanawasa spent about five hours in the said apartment from 17:00 hours to 21:45 hours after which Mwanawasa allegedly complained of pain on his manhood following the alleged sexual encounter.

He also cited unreasonable behavior, among other reasons, claiming that his wife arranged and hosted a party for Simwinga at her sister's house and convinced him that it was a kind gesture to appreciate Simwinga for the favours that he did for her family.

Okpara claimed his wife asked him

of adultery

to be present at the party and entertain the guests, and little did he know that the primary guest was actually his wife's sexual partner.

But in his answer, Simwinga denied committing adultery with Mulenga, and that he shall put Okpara to strict proof over his allegations against him.

He also denied ever being invited for a party, adding that he would state at trial that he had only attended a luncheon at the home of Mulenga's elder sister, with whom they are good friends.

Simwinga argued that Okpara had failed to show how he and Mulenga allegedly committed adultery in his

In his reply to the petition, Patrick also denied Okpara's allegations, saying Mulenga was a mere friend whom he had the privilege of discussing business with by virtue of their employment.

Patrick added that at no time did he rent an apartment as alleged by Okpara in the petition and further stated that Okpara's allegations were malicious and not tantamount to adultery which was the main issue in the petition.

He urged the court not to award Okpara damages and costs as it would amount to unfair and unjust enrichment.

Patrick stated that Mulenga was an adult and no one would take peculiar advantage of her as a married woman.

Creating Climate of Dissent in Board Meetings

SIT on a board with Ms Sherry Thole, a former banker and permanent secretary. Over time, I have come to incredibly value her level of independence in board meetings. Whenever she moves her fingers on the board paper, flattens them while starring broadly across the board room, you know she has a dissenting view on a given subject matter. She will start as follows, 'But Chair.' The Chairperson, who is equally effective in his role, will immediately create that environment to allow her to express her mind, 'Go on Director Thole.'

The room would be attentive, anticipating a diverse viewpoint on a defined subject matter. The beauty of it is that we would now all be ready for debate and discussion. She has a way of opening everyone of us to come out of groupthink.

That is what an effective board should be about. Ms Thole and I often times disagree on a few subject areas, at times it gets heated and then we smile at each other. At tea break, she will serve me coffee. It signals that everything we may have disagreed on ends there. We have done our job as directors, ensuring that every material matter with the potential to disrupt the company is dealt with amicably. Such robust discussions are attained only when the Chairperson is effective.

To have an effective board meeting, some procedural issues are important. First, there should always be a climate of trust. The board is a team. Trust is important because almost all boards have diverse membership with diverse interests. This is critical in public bodies where the Act usually demands diverse representation on the boards. Some of the members are union leaders, the usual suspects whenever there is some leakage. I recently shared how in one of the board meetings, the matter under discussion started featuring on social media even before the board meeting had concluded business. Since it had to do with the board's rejection of salary increments, the immediate suspect was the board member representing unions.

I also participated in board meetings where the CEO, Board Chairperson and the Company Secretary were always in conflict. The CEO felt the constant collaboration between the Chairperson and the Board Secretary (usually without his knowledge) had contributed to the board's hostile stance on his performance. The issues got so tense that at one time, there was a near punch up. This kind of conflict happens in boards where trust is absent. Trust among boards means that everyone believes contributions or actions are in good faith and of noble intent. In other words, there is nothing personal in disagreements, it's all business.

The second important procedural issue is that the board should constructively evaluate strategic options available before it. In my previous articles, I highlighted one finding to the effect that most boards spend very little time on strategic issues of the business. Strategic issues are about how the business will be positioned in future given the existing climate and anticipated opportunities. This is where many boards lose a huge opportunity for business growth in Zambia. We are not prepared to discuss issues of strategy. As a result, companies are not maximising available opportunities in a timely manner.

The questions boards ask themselves in evaluating strategy are: Do we have the right strategy, given what we do well? Is our strategy matched to the external environment (economy, social expectations, etc.)? Are we capable of executing the strategy? Do we have the right top management team? If the answer to one or more of these questions is "no," what do we need to change? These questions are part of the template on corporate governance training.

Where there is an effective board, members will frankly debate and discuss available options and some resolutions can be terminal in the same that they can lead to a total abandonment of the business's mission. Just two weeks ago, Bridges Limited was involved in the strategy formulation process for one of the large statutory bodies. Members raised very critical strategic issues that changed the entire future goals of the organization. Through an open discussion, that

is critical. Determining risks that can face the organisation, particularly strategic risks, requires broad thinking. There are many decisions that have been made for most public entities in Zambia that would never have been made if the directors had personal financial stake in those organisations. Individuals will not mind a bad decision provided it does not cost them individually.

My observation is that in Zambia, we do not want to create conflict in board meetings even when doing so is in the interest of the business. There is conflict that is healthy, especially when some members are privy to information that would be beneficial to the business. The chairperson should deliberately encourage constructive dissent by those who feel otherwise. Personally, when I chair a board meeting, I look at body language. Since I know and have chemistry with all board members, I would quickly know when some members are not agreeing with the resolution. I will encourage them to speak out their mind based on historical experiences, intuition, and facts. At the end of the day, we should arrive at a resounding resolution.

The final procedural issue is that every board member should be aware of their individual

accountability to decisions made. It is the responsibility of the chairperson to remind members of the board that they owe it to themselves to exercise independence though decisions are collective. There are individuals who cede their responsibilities to the most influential or talkative members of the board. There are board members who

involved senior government civil servants, there was strategic focus to the extent the organization now has very clear and easy to measure strategic objectives and KPIs for management. That is how it should be. The chairperson has the responsibility to open the flow without intimidation so that individual can challenge the status guo.

Third procedural issue, and the focus of this article, is the need for the board chairperson to foster or encourage constructive dissent. Jonah Bailey, a process designer writes, 'Disagreement from within the ranks can be a great resource for a leader. A functional organization allows people to voice disagreement, debate the issues, and then commit. Disagreement lets you know that the people you lead trust you enough to be honest with you about how they're feeling. When engaged in properly, disagreement can offer teachable moments to leaders and followers alike.'

One of the roles of board leadership is providing the oversight role in which risk oversight

are easily subdued by permanent secretaries because of the influence the latter wield. Unfortunately, the fear to express oneself and make a contribution does not make anyone immune to any possible backlash.

I love what James Klusman, a corporate governance advisor, says on the subject, 'Personal accountability may also be enhanced when board leaders exercise their roles on a personal level. Restricting the bulk of board members' interaction to board meetings, especially in the case of a large board, reduces both their perceived responsibility and sense of personal accountability. But, when the board chair communicates personally with other directors, outside of board meetings, the increased individual attention and opportunity for interaction can increase expectations of accountability.'

HOLDING MEETINGS IN THE BUSH

STRANGE phenomenon is developing in Zambia where people have resorted to holding meetings in the bush to run away from a repressive regime. Examples abound. Recently, youth in Lusaka decided to hold their gathering in the bush after police refused to allow them to hold their protest even after following the laid down procedure under the Public Order Act.

The United Party for National Development (UPND) has also been a victim of police infringement on the rights of its members to freely assemble and carry out political activities.

One of these political activities is the holding of elections within the party. The Constitution of Zambia demands that for a political party to participate in the presidential and general election, it must first hold internal democratic elections within its party.

In order to fulfill the requirements of the Republican Constitution, the UPND has been trying to hold intraparty elections at ward, constituency and district levels to usher in democratically elected representatives of the members at the lower organs of the party. After holding these lower organ elections, the party will proceed to hold elections at the provincial and national level.

It is interesting to note that the ruling Patriotic Front is also in the process of holding its intra-party elections.

PF Secretary General Davies Mwila recently told a press briefing that his party will go ahead to hold elections in six remaining provinces despite the prevailing COVID 19 situation.

This revelation by the PF Secretary General confirms two things. One is that the PF has been holding infraparty elections without interruption from the police. Two is that the PF will proceed with the internal elections with or without Corona Virus.

The UPND been notifying the police to hold its meetings for the purpose of holding internal elections but police have been refusing because they have "instructions from above" not to allow UPND to hold meetings. This instruction from above is unlawful. It offends the provisions of the Republican Constitution.

The UPND has had so many cases where police have not only denied its members their right to assemble but. also abused police powers to arrest innocent members of the party. Recently, police on the Copperbelt arrested UPND Chairman for Research and Policy Dr Choolwe Beyani and several others for holding intra- party elections. The implications of this action is to stop the UPND from holding internal elections so that come 2021, the party will not qualify to participate in the presidential and general elections. As a party, we are seeing through this scheme by the PF and its government.

We will not allow that to happen.
We have had many cases where our members have been forced to hold their meetings in the bush to hide from the police. In places like Eastern Province, our members have been told that they cannot hold meetings because it is a PF bedroom.
Our members have devised strategies to beat the PF regime in their so-called bedroom.

But why should Zambians be subjected to holding meetings in the bush to run away from the police more than half a century after gaining independence in 1964? Our fathers, mothers and forefathers and foremothers fought for independence from colonial rulers because they wanted freedom of assembly, freedom of association, freedom of speech and many other rights and freedoms. By today, these rights and freedoms should have been A GIVEN. Why

should we be fighting for rights and freedoms which we already won from the colonial rulers?

In case, the PF and its government have forgotten, suppressing people's rights and freedoms is not a guarantee to continued stay in power. The white colonial rulers had the army, police, messengers and other instruments of power but failed to suppress the Africans whose only weapon was the mouth and brain. In urban areas, people will devise methods of meeting to beat the regime. Some are meeting in buses, churches, workshops and other allowed places to discuss their plight and find a way forward.

It is shameful and embarrassing for the government to be seen to be oppressing its citizens in such a manner in this time and era. Pictures and videos have gone viral on social media about oppressed Zambians holding meetings in the bush. What image does it show to the world about the state of democracy in Zambia? The country has become a dictatorship similar to or worse than colonial rule. The solution is very simple: restore people's rights and freedoms. You can suppress the people once, but you cannot suppress them forever.

It is composed of lawyers, and its leadership is elected by associated legal practitioners, but the association itself was established to serve the interests of the people of Zambia, thereby making the citizens of this country interested parties of the organisation.

This is so because the Law Association of Zambia does not draw its mandate from the elected executive, but from an Act of Parliament through which it was established. Parliament, being an assembly of the people's representatives, we can safely say that the leadership of the association is, therefore, also answerable and accountable to all the people of Zambia rather than just lawyers.

According to the LAZ Act, the association was established for the following (top three) reasons: (a) to further the development of law as an instrument of social order and social justice and as an essential element in the growth of society; (b) to provide a means by which all lawyers, whatever their particular field of

There will be many temptations along the way. Politicians will, if they have not already done so, approach you with an agenda to help them win the





THE Ministry of Health has announced that the country has in the last 24 hours recorded 125 new COVID-19 cases out of 454 tests done and six deaths, five of which were brought in dead cases in

And the Ministry says the Home Affairs ministry will deploy police officers to ensure that people are following COVID-19 prevention guidelines.

Meanwhile, the Ministry has announced that President Edgar Lungu has directed all non essential workers to work remotely to avoid contact among individuals in work

Speaking during the daily COVID-19 update, Monday, Minister of Health Dr Chitalu Chilufya said 104 persons had been discharged in the last 24

the cumulative number of COVID-19 cases to 8,210. The cases that we have picked include 66 that have been identified through routine screening in Lusaka and Solwezi, Ndola and Kitwe. So 34 in Lusaka, 19 in Solwezi, Ndola, 11 and two in Kitwe. 23 contacts to known cases in Lusaka, five in Ndola, two in Chingola and 21 had been identified through hospital screening. 10 in Lusaka, eight in Ndola, two in Kitwe and one in Solwezi and three are health workers. We have recorded five brought in dead cases from within Lusaka and these are coming from the high density compounds. The deaths also include one facility death in Ndola. Therefore, we

have recorded six deaths in the last 24 hours. At the moment we have 72 patients admitted to the levy Mwanawasa isolation centre, 30 of these are on oxygen support and two are critical and are in the intensive care unit. We have discharged 104 persons in the last 24 hours and that brings our recoveries to 6,802. Looking at the cumulative numbers, our deaths now stand at 241 of which 72 deaths are due to COVID-19, 132 are covid related, we are still classifying 37 deaths. The COVID-19 associated deaths are those in whom covid was detected but is not the primary cause of death," he said.

Dr Chilufya said police and law enforcement officers would now be deployed to ensure adherence to COVID-19 guidelines and presidential directives.

"This morning, President of the Republic of Zambia His Excellency President Edgar Chagwa Lungu addressed Cabinet and took note of the covid situation in the country and has directed, through Cabinet, immediate escalation in the response to stop the spread of COVID-19. The measures will include the following; the Ministry of Home Affairs will deploy police and other security officers in public places to ensure the enforcement of covid public health measures and presidential directives. Further, the Ministry of Local Government will aggressively



and non compromisingly enforce adherence health and presidential directives particularly in markets, trading places and bus stops. The operation of bars and night clubs that has been seen to resume in some parts of Lusaka will be frowned upon and security agencies will be on board to ensure that these do not operate. We are not issuing licenses or permits to operate bars neither are we allowing restaurants to operate as bars and these are places that are, these are places were people are getting covid from. So I wish to remind the public that in line with the presidential directives, all bars and night clubs still remain

closed," said Dr Chilufya.

"The President has also directed through, Cabinet, that all non essential workers will operate remotely in order to minimise personal interaction in work places. The Secretary to Cabinet will issue guidelines on this score and the public is encouraged to use alternative non contact modes of conducting business activities including electronic transactions. The President has further stressed the need to preserve commerce and trade even as the President encourages non contact in work places, he encourages leveraging of technology to ensure continuity in service delivery and non disruption

in trade and commerce.

So that delicate balance is emphasized."

Meanwhile, **ZNHPI** executive director Dr Victor Mukonka emphasised the need for members of the public to adhere to laid down guidelines and avoid crowds as has been observed where people are patronizing bars indiscriminately.

He added that the current windy weather could lead to an increase in cases as particles can quickly move from one place to far distances.

And Ministry of Health permanent secretary Dr Kennedy Malama urged people to use masks properly by ensuring that both the nose and mouth are covered and not removing them while talking.

"...Going to the director to ask them for favours that are beyond them, 'can you give us this, can you do that,' natumako abo bantu mubatandize, mubapase (I have sent those people, give them), all those kinds of things. This country has collapsed, the system has collapsed."

He also complained about how some citizens were eulogising corrupt politicians.

"Where we have gone wrong is that, we have started eulogising politicians, who are taking from you and you are busy saying aba nibamuna (these are men), stop that kind of thing. Those are not to be celebrated, those are to be taught a lesson next year, get them out of power and a lot more that you want to know will come out. But if you want to bring it out here, they say, 'never tell a crocodile it's got an ugly face before you cross the river.' If you want to tell the crocodile, you are still in the canoe you are peddling, ati ah, chi crocodile ichi, nichoipa ichi, (this crocodile is ugly) it will deal with you! So, you don't start saying, 'ba ACC I have got this case, I have got that and that case,' no. Wisdom sometimes should play a hand, you look at issues and say nature has got a way of equalising. One day these things will come out. Umulandu taubola (crime does not rot), it can take 20 years, but if there is crime that has been committed, it will have to be rectified," Kalaba said.

"Where I come from they say, amenso yamupundilwa yengi (when you are in public office, people are watching you from different angles), people are seeing you from different perspectives so you have to be very careful. Look, the way corruption is being handled in this country is very cosmetic. I told you that even His Excellency, the President, doesn't believe in the fight against corruption; I told you right here that the only time the President fights corruption is when he is reading a speech written for him by government officials then he comes across a sentence on corruption, then he reads it, it doesn't come from within because if it did, we would have seen ministers who have been involved in corruption being shown the exit like president Sata did."

Meanwhile, Kalaba, the former foreign affairs minister, insisted that it was very embarrassing for President Lungu being mentioned in the Rwanda court case.

The issue of Rwanda is an embarrassing episode for Zambia that our highest diplomat, the President, was mentioned, that was sad and very regrettable. I have always said that Zambia has been known for a good name, not for a bad name, Zambia has been a haven of peace, which is why we have people coming in from the east, west, north south, coming into Zambia; it's because of our impeccable record that we have had as a peaceloving nation. Our role in this country has never been to get involved in the territorial issues of other people's sovereignty. Our role has always been to heal the divide, we have always played that meaningful role: in Angola, the DRC, I can sav even in the region we stand tall. So, to hear that the President is being implicated in those things is not only sad, but its an embarrassing chapter," said Kalaba.

Atletico Madrid confirm Correa, Vrsaljko have tested positive for coronavirus

two coronavirus cases reported in the Atletico Madrid camp have both been returned by first-team players Angel Correa and Sime Vrsaljko, the Spanish side have confirmed.

News broke on Sunday that two members of the party set to travel to the Champions League quarterfinals in Portugal had tested positive for the virus, but there was no further indication whether those affected were members of the playing or backroom

Goal learned that two members of Diego Simeone's squad were responsible for the two positive tests and on Monday the identity of these players was made clear. As such, they will not travel to Portugal or take part in the remainder of the competition.

They are in a stable condition and are observing isolation protocols in their own homes.

In response to the two positive tests, a fresh round of testing was carried out on Atleti's first team and members of staff who will travel, while there were also checks made on those who have come into close contact with the players.

The club confirmed, however, that these new tests did not throw up any unwelcome results.

"The first team and members of coaching staff underwent new tests yesterday [Sunday], the results of which have been negative in all of them," the club stated.

UEFA's medical protocol indicates that as long as there are 13 available players from the A list, the match will take place, with Atleti confirming on Monday that 21 members of the first-team squad will travel alongside academy players Alex Dos Santos, Manu Sánchez, Riquelme and Toni Moya.

Meanwhile, Sevilla defender Jules Kounde, who is currently in Germany with his side as they seek to win the Europa League,

SUPER Division champions Nkana's Ghanaian defender Richard Ocran says players are not bothered by insinuations that the club did not deserve to win the league this season.

The flow of the league this season has not gone according to script, with a number of boardroom decisions and unplayed games watering down the integrity of the campaign.

Ocran said in an interview yesterday that Nkana players would give little thought to those criticising their eventual crowning as champions.

"We are not the ones who decided to cut the league, everyone knows why they decided to cut the league. If the different team was on top the time they cut the league, they would have been the champions. We deserve to be the champions, it is our title, the heart is clear, the cup is for us. Everything went in our way and we worked hard for it," Ocran said.

The former Ashanti Gold Sports Club player said he was happy to have been part of the team that delivered the club's record 13th title.

"I feel great, I am happy that the team won its 13th title; it has been long since we won the league so it feels great to be part of that team that has made history," said Ocran.

Meanwhile, Forest Rangers coach Tenant Chilumba has called on his players to forego the disappointment of missing out on the league title to Nkana.

Forest were left hard done after playing to a goalless draw against Zanaco when all they needed was a win to bag their maiden title.

"We need to go back to the drawing board, work hard again and ensure that we wait for the Champions League and have a good run. We have to work on our fitness," said Chilumba.
